



Geoff Lanigan – Background:

Motorcycling – I have been involved with motorcycles in both competition and administration since I was 14 years old, now 68 years old, but still fit and healthy. I started at Maffra-Sale club in the 1960's, was drafted into the army in 1968 for 2 years, including service in the infantry in Vietnam and thereafter moved to Melbourne and joined Oakleigh Motorcycle Club in 1974. Whilst in Oakleigh club, I was actively involved in motocross and road race sidecar in the 1970's, followed by trials and later classic road racing in the 1990's. I am a life member of the Oakleigh Motorcycle Club.

I joined East Malvern MCC 4 years ago to pursue my interest in classic motocross, adventure and red plate rides commonplace in that club, although I never get as much time as I would like to spend on rides as I would like.

I enjoyed enduro competition in the 1970's and 1980's and I am still an active social trail rider which is where I spend most of my time on a bike, including regular off road rides overseas most years over the Xmas break.

I was delegate to MV from Oakleigh MCC for 15 years, served as MV Assistant Secretary and then Secretary for the 10 years up until my resignation in 1995. I have also been involved with the Broadford property since 1978, and designed and supervised construction of the road race track with assistance from Rob Watson (Preston MCC) and the dirt track with assistance from John Coleman (then Property Manager).

I am a Life Member of Motorcycling Victoria.

Business (Skills/Abilities): - I am a qualified civil engineer and have a successful civil engineering consulting engineering practice in Braeside which has been operating for the past 13 years, and prior to that a previous consultancy for 17 years – which I believe will bring sound business skills to the board of MV if appointed.

Although I resigned as MV Secretary in 1995, I have always provided advice and drawings to MV up until the end of 2014, skills which I believe MV needs to continue to develop Broadford in a sustainable and economic manner. I honestly believe those skills are sorely lacking within the current MV Board, and I believe that a combination of my business and consulting skills, plus my love of motorcycling and long history of involvement and understanding of the sport will be of great benefit to MV.
