Russel & Aitken Papers finding aid (40) Papers of Sir Gilbert Stirling, 1773-1853

The finding aid for the Russel & Aitken Papers has been divided into 63 parts. This part contains a list of records relating Sir Gilbert Stirling.

Family history

Sir Gilbert Stirling (2nd baronet of Mansfield, Ayrshire) of Larbert House was born c1770 and died on 13 Feb 1843. He was the son of Sir James Stirling, whose early career was in Jamaica, working for Stirling of Keir, and who later became Secretary to the Governor. On return to Scotland Sir James joined the Edinburgh banking firm of Mansfield Ramsay & Co and married Alison Mansfield, daughter of the senior partner. He had three terms as Lord Provost of Edinburgh and was made a Baronet. He and his wife had five children, four of whom pre-deceased Sir Gilbert, who became the 2nd Baronet.

Sir Gilbert had a military career under Abercromby and Wellington. He purchased Larbert Estate in 1821 from Sir James Riddell of Ardnamurchan. During the Riddell ownership the property was known as Mount Riddell. Sir Gilbert commissioned David Hamilton, Architect, of Glasgow, to design Larbert House which was erected between 1822 and 1825.

Sir Gilbert did not marry and the baronetcy became extinct on his death.. He left a succession of testamentary instructions from 1818 to 1841. His executors were Lord Abercromby, Sir Michael Bruce of Stenhouse, Thomas Dundas of Carronhall, Thomas Mansfield, accountant, Edinburgh and Alexander Mackenzie, Younger, of Muirton. He entailed his lands and estate to the heirs of his cousin, Mrs Chalmer, the heir being Gilbert Stirling Chalmer, b, 18 Jan 1843. The Trustees retained the estate which Chalmer sold in 1870 to John Hendrie, coalmaster, Glasgow, who then sold it to Sir John Hatt Graham, merchant in Glasgow, in 1883.

Scope & Contents Note

Titles, writs, accounts, inventories and papers relating to various occasional matters, such as a court case about poaching, debt collection, superiority questions, business accounts from Russel & Aitken, tacks and small conveyancing matters.

Russel & Aitken did not act as principal agents and on Sir Gilbert's death, titles and important papers were transferred to the principal agents of the Trustees, Messrs Mackenzie & Innes, WS, George St, Edinburgh.
