If no objection is received by BWF by Thursday 5th July 2018 (second day after the entries closing day) 23.59 hours BWF Headquarters time (+08.00h GMT) following the close of entries, the entries shall be deemed to be correct. No complaints / objections shall be entertained after this point.



Media Obligation: NOTE

- that all players are required to participate in media engagements should they be requested in Pre-Tournament Media. They will not exceed one hour in total on the day prior to their first scheduled match of the tournament.
- It is also a condition of entry that each player must be willing to give oncourt interviews for television immediately after the match has been won or lost, and to attend a post-match press conference on request.
- In order to assist with the promotion of the tournament and game in general, it is a condition of entry that each player must be willing to participate on request in at least one appropriate activity of not more than one hour (such as autograph signing, participating in 'meet the public' question and answer sessions, etc.).

Any issues with the visa application need to be dealt with directly to the respective Vietnam Embassy who is dealing with your application. We accept no responsibility for withdrawals made due to late or unapproved visa applications. Where required, courier costs to post letters of invitation will be recharged to your Association. All players and officials who require visas to enter Vietnam should submit passport details in the Visa Form to email <u>vanphong@caulongtphcm.com.vn</u> no later than July 10th, 2018. Please complete all required information, otherwise we will not able to issue the official invitation letter (for visa application). Players from Malaysia, Indonesia, Laos, Singapore, Cambodia, Thailand, Kyrgyzstan, and Kazakhstan do not need a visa to stay in Vietnam for up to 30 days. For players from Belarus, Russia, South Korea, Japan, Denmark, Sweden, Norway , Italy, Germany, France, United Kingdom , Spain, Finland - free visa for 15 days And players from Brunei, Myanmar - free visa for 14 days
