WHEREAS by Order in Council Number O.C. 2398/97 certain portions of Highway 62 in the Township of Monteagle, under the jurisdiction and control of the Ministry of Transportation were transferred to the Corporation of the County of Hastings and were vested in and under the jurisdiction and control of The Corporation of the County of Hastings.

AND WHEREAS the said highway was added to the County Road System and designated as a County Road pursuant to the Public Transportation and Highway Improvement Act, (R.S.O. 1990, c. P-50 as amended).

AND WHEREAS pursuant to Section 44(9) of the Public Transportation and Highway Improvement Act, (R.S.O. 1990, c. P-50 as amended), the County may remove a road from the County Road System thereby vesting the said road in the local municipality in which it is situate;

THEREFORE The Corporation of the County of Hastings enacts By-Law No. 98-21 as follows:

- 1. The Road, as described in Order in Council Number O.C. 2398/97 and shown on Plan P-2333-37 copies of which are attached to this by-law are removed from the County Road System and vested in the Corporation of the Township of Monteagle.
- 2. This By-law shall come into full force and effect on April 15th, 1998.


