Opening of the GA

Report of the Board

Bernhard Hayden, Secretary General, reports: Looking for funding for a summer camp didn't work out in the past. Created a work plan for next year for a copyright reform campaign and got a grant from the Council of Europe for that.

Kajsa Larsson, Board Member, reports on European Voluntary Service (EVS): Didn't end up working this year, going to give it another try in the next periods boosted by the interest of our newest member.

Report of the Auditors

Florian Zumkeller-Quast, Auditor: There was no financial report, though there were no financial transactions other than income in membership fees with the only outcome being bank account costs. There is no recommendation by the auditors.

Discussion of additional motions

Statute changes

Motion to change the statutes proposed by #hyperlinks, Austria (Proposal 1):

Both in Germany and in Austria, the member organisations of YPE have split with the respective Pirate Party in the country and have repositioned themselves as non-party-affiliated, political youth organisations working for progressive change in the area of digital rights, but also other fields. I think I can speak of both organisations, that we value the cooperation with YPE and its other member organisation and think that this cooperation should be upheld in the future. To facilitate this change on the level of YPE statutes, "#hyperlinks" suggest the adoption of the following changes to the Statutes of Young Pirates of Europe:

§ 2, First Paragraph, shall be changed to "The main goal of YPE is to bring together European youth organisations that work on digital issues as well as their members, improving not only the coordination of their political work, but also supporting cultural and personal exchange. As a federation of youth organisations, education and personal development of young people as well as the exchange of ideas and support of each other is an equally important aim of YPE. YPE supports access to information and education, copyright reform and the protection of fundamental human rights."

§ 3 (1), Second Paragraph, shall be changed to "Eligible as members are youth associations in any state in Europe as defined by the Council of Europe which work towards the policy goals of YPE."

Counter proposal proposed by Ung Pirat, Sweden (Proposal 2):

§ 2, first paragraph "The main goal of YPE is to bring together European pirate youth organisations and other youth organisations that work on digital issues and for transparency in government, participating democracy and civil rights as well as their members, improving not only the coordination of their political work, but also supporting cultural and personal exchange. As a federation of youth organisations, education and personal development of young people as well as the exchange of ideas and support of eachother is an equally important aim of YPE. YPE supports access to information and education, copyright reform and the protection of fundamental

human rights."

§ 3 (1), Second Paragraph, "Eligible a members are youth organisations of Pirate Parties and youth associations in any state in Europe as defined by the Council of Europe which work towards the policy goals of YPE."

Intensive discussion on the two proposals.

First vote between the two proposal, and then second vote on the chosen proposal to enact the statute changes (requires at least twice as many yes-votes as no-votes).
