You must stop retirement pay to avoid indebtedness. If the retired Sailor was receiving pay from another source due to a disability from the VA or civil service retirement from the Office of Personnel Management, contact that agency to return the payment. If you fail to do this, you will have to repay it later. You may also report the death online at <u>www.dfas.mil/retiredmilitary/forms.html</u>.
