INITIAL CALL

P.O. R. Fletcher reports...

On 03/28/06 at approximately 0024hrs, I responded to West Allis Memorial Hospital for a report of a sexual assault. As I responded to WAMH, dispatch informed me that it appeared the assault took place in Florida. I arrived at WAMH and was directed to the privacy room adjacent to the emergency room waiting area. I met and several of her family family members. advised that she was the victim of a sexual assault. Sgt. Evenson asked if she would talk with officers without family members present and she agreed. Sgt. Evenson and the family members left the privacy room, so I could speak Tenfel.

STATEMENT OF

VICTIM - RECORDED ?

I asked if the assault occurred in Florida and she said, "Yes." I asked to tell me how she ended up in Florida and about the events which led up to the assault. agreed to provide a statement. According to her cousin, is an acquaintance of Nick Carter of the "Backstreet Boys" band. Carter phoned from Florida and told fly her and a friend to Key West, Florida for the weekend. he could and she agreed to go to to Florida. contacted

and flew on Northwest airlines from Milwaukee to Miami and then connected to Key West, Florida on a Continental airlines flight. Due to flight difficulties, the females did not arrive in Florida until 1600hrs on 03/26/06. An unknown M/W met them at airport, the females and the male took a taxi cab to 314 Simonton Ct., Key West, FL 33040. The females left their belongings at the residence and went to a Denny's restaurant. At the restaurant, the females met Nick Carter, (Back Street Boys band member), a male hispanic only known as "Rob" and a female white only known as "Mary".

The group spent several hours with a real estate agent looking at houses and went to dinner. After eating dinner, the group returned to the house on [REDACTED]

[REDACTED] indicated that during dinner and back at the house, Rob continuously placed his hands on her shoulders and back. Initially, she felt this was harmless but as it continued she would move her body away from Rob to remove his hands from her body. [REDACTED] described Rob as approximately 6', chubby, with dark hair and [REDACTED] skin. She indicated he appeared hispanic and has small scars on his face. [REDACTED] estimated his age at 28-30 years old.

[REDACTED] Carter and Rob drank at a bar in the house. [REDACTED] estimated she drank 6 shots of "X-rated" and a blue vodka type shot. She felt "buzzed" but does not believe she was intoxicated. As the group drank, [REDACTED] took a picture of Carter using her cell phone. After taking this picture, Carter stated he needed a picture of her. Carter told her he wanted a picture of her ass. [REDACTED] turned around and Carter approached her pulled down her pants and somebody took a picture of [REDACTED]. This made [REDACTED] feel uncomfortable but she "shrugged it off."

While the group drank, [REDACTED] phoned and text messaged her boyfriend back in Wisconsin. According to [REDACTED] her boyfriend was angry that she was in Florida. They fought over the phone and he told her that he would break up with her. Carter and Rob told [REDACTED] her boyfriend was wrong for being angry and she should enjoy herself.

On 03/27/06 at approximately 0000hrs, [REDACTED] Carter and Rob went to a bedroom in the residence. Once in the bedroom, Rob attempted to kiss [REDACTED] told him that she had a boyfriend and did not want to kiss him. At one point, Carter and Rob pulled [REDACTED] a "tube top" off of her and both males touched her breasts. She continued to tell them that she was not that kind of girl, has a boyfriend and wants to save herself for marriage. Rob continued to rub [REDACTED] on her stomach underneath her shirt. She continued to tell Rob she was "not that kind of girl". Carter approached [REDACTED] unbuttoned her jeans and slid his hand down her jeans and underpants. [REDACTED] indicated Carter briefly inserted his fingertips into he vagina. Carter pulled his hand out of her pants and stated, "You're lying you are not a virgin."

Carter and [REDACTED] continued to talk in the bedroom and [REDACTED] went into the bathroom. Rob followed her into the bathroom and stated, "If you won't do that, you have to do this." Rob pushed [REDACTED] to her knees and exposed his penis. Rob pushed [REDACTED] s head towards his penis and inserted his penis into her mouth. Rob used his hands to push [REDACTED] s mouth back and forth on his penis. [REDACTED] cried but did not take any other action because she was afraid. Carter entered the bathroom and approached Rob and [REDACTED] Carter exposed his penis, grabbed onto [REDACTED] s shoulder and directed her mouth onto his penis. Carter inserted his penis in [REDACTED] s mouth and realized [REDACTED] was crying.

At this point, Carter removed his penis from her mouth and started to yell at Rob. Carter yelled, "You always make your women cry. You can't make your women cry." Rob and Cartet left the residence at this point.

1 phoned her sister and boyfriend in Milwaukee and told them she needed help. did not leave the residence because she did not know Rob and Carter's whereabouts and she was afraid that they would hurt her. locked the bedroom door and then unlocked the door because she did not want to make the males angry.

Carter and Rob returned to the bedroom and pretended to be asleep. Rob approached her several times with his penis exposed and attempted to roll her onto her back. pushed Rob away and told him she did not want to do that. Eventually, Mary entered the room and convinced Rob to sleep on the floor next to her.

went to the Key West airport in the morning and eventually returned to Milwaukee on 03/27/06 at approximately 2330hrs. Her sister drove her home from the airport. Initially, did not want to report the incident because she felt she should have handled the situation differently and did not want to deal with filing a complaint against somebody famous. However, 's sister convinced her to report the incident. They stopped at WAMH because their family has used the hospital for medical treatment in the past.

informed me that she did not receive any injuries during the incident. Further, neither male ejaculated in or on her person. During the course of the interview, appeared to be very upset and embarrassed by the incident. She blamed herself for being in the situation but was scared that Rob or Carter would hurt her if she protested any further.

CONTACT WITH PATRICIA WANGERIN

On 03/28/006 at approximately 0230hrs, I met with Patricia Wangerin, R.N. of the Sexual Assault Treatment Center. I advised Wangerin of the situation. Wangerin stated hse would contact her supervisors regarding her agencies policies for dealing with a sexual assault occurring in another state. Wangerin indicated she would contact WAPD if she collected any evidence. I provided Wnagerin a business card.

CASE DISPOSITION

I reviewed the case with Sgt. Evenson and created a report for record. I informed that I would create a report for record and informed her the report would be forwarded to WAPD detectives. Also, I informed that the police in Key West would need to investigate this incident because the acts occurred in their jurisdiction. stated she understood. Report to be forwarded to the Sensitive Crimes Unit.
