B.TECH. (EVENING) ADMISSION-2017

Delhi Technological University will hold Common Entrance Examination for admission to first year of the four year B.Tech. (Evening) Degree Program in Civil, Mechanical, Electrical, Electronics & Communication Engineering, for the academic year 2017-18 on 16.07.2017 (Sunday). The admissions shall be made under two categories: **DIRECT** and **SPONSORED** The candidates, who

Have three year regular diploma in any branch of Engineering for **DIRECT** category and relevant branch for **SPONSORED** category, awarded by any state board of technical education/diploma recognized by AICTE, Delhi with a minimum aggregate (aggregate of all six semesters/three years) of 55% (45% for SC/ST) shall be eligible to take admission in B. Tech (Evening) Program being offered by DTU.

However for the admission under **SPONSORED** category shall be available to the candidates having more than 5 year of experience as on 1st September, 2017 in reputed organizations registered under company act or having valid TIN/GST No. and located in the **National Capital Territory of Delhi and contiguous industrial areas** within 50 KM distance i.e. Bahadurgarh, Ghaziabad, Faridabad, Sonepat, Gautam Buddha Nagar (Noida & Gr. Noida) and Gurugram. Such candidates have to submit NOC from the employer. The self sponsored candidates shall not be eligible for admission under **SPONSORED** category.

The Bulletin of Information containing details of the admission procedure, Application form and Syllabi of the Entrance Examination shall be made available on the web site of university (<u>http://www.dtu.ac.in</u>) w.e.f. 05.06.2017 (Monday). The duly filled application form along with Crossed Bank Draft/pay order of Rs. 1,000/- drawn in favour of 'Registrar, Delhi Technological University' payable at Delhi should reach the Deputy, Co-ordinator (Admn.) on or before 05.07.2017 (Wednesday) latest by 7.00 pm either in person or by post.

Applications received after 05.07.2017 will not be considered, in any case.

Bulletin of Information B. Tech. (Evening) Entrance Admission – 2017

Delhi Technological University (Formerly Delhi College of Engineering) is one of the premier Engineering Institution in India. It has a chequered history spanning over 75 years. Established as Delhi Polytechnic in 1941 by the then Government of India, it became Delhi College of Engineering (DCE) in 1963 which has now been reconstituted as Delhi Technological University (DTU) vide Delhi Technological University Act 6 of 2009.

As per the DTU Act, Delhi Act 6 of 2009, the DTU is a non-affiliating teaching and research University focusing on "growth with quality", offering new programs in emerging areas of engineering and technology, ensuring synergy between science and engineering, will attract the very best and qualified faculty in its fold and contribute effectively to cutting edge technology development and foster world class innovations. The DTU thus aspires to be a leading World Class Technology University, a key node in National and Global Knowledge Network thus empowering India with the Wings of Knowledge and Power of Innovations as per its vision.

Delhi Technological University (Formerly Delhi College of Engineering) imparts education and training in 15 branches of engineering at under graduate level during morning session, 4 B.Tech (Evening) programs are being offered in evening session with an intake of 240. Full time and Part time postgraduate programs are offered in 22 specialized fields of engineering and science. Ph.D. programs are offered in all the branches of engineering, applied sciences and management. An MBA program with focus on Technology Management and Supply Chain Management is also being offered under Delhi School of Management (DSM) of DTU.

1. About B. Tech. (Evening) Program

B.Tech. (Evening) program is of four years duration. The classes are held six days a week in the evening from 6.00 p.m. to 9.00 p.m. Some of the classes may be scheduled to be held on holidays, including Sundays, during the day time. The detailed information about B. Tech (Evening) program is as under:

- I. The admission to B. Tech (Evening) program shall be made in two categories: **DIRECT** and **SPONSORED**.
- II. The candidate having three year regular diploma in any branch of Engineering for **DIRECT** category and relevant branch for **SPONSORED** category, awarded by any state board of technical education/diploma recognized by AICTE, Delhi with a minimum aggregate (aggregate of all six semesters/three years) of 55% (45% for SC/ST) shall be eligible to take admission in B. Tech (Evening) Program being offered by DTU.
- III. The candidates admitted under **DIRECT** category shall be allowed to seek campus placement through Training & Placement, DTU. However, the candidates admitted under SPONSORED category shall not be allowed to seek campus placement through Training & Placement, DTU.

IV. The admission under **DIRECT** category shall be available to candidates as per clause (1) without any requirement of experience and NOC from employer, However for the admission under **SPONSORED** category shall be available to the candidates having more than 5 year of experience in reputed organizations registered under company act or having valid TIN/GST No and located in the **National Capital Territory of Delhi and contiguous industrial areas** within 50 KM distance i.e. Bahadurgarh, Ghaziabad, Faridabad, Sonepat, Gautam Buddha Nagar (Noida & Gr. Noida) and Gurugram. Such candidates have to submit NOC from the employer. The self sponsored candidates shall not be eligible for admission under Sponsored category.

The condition of 5 year experience shall be determined by 1st September 2017.

- V. For **DIRECT** category, the candidate having diploma in any branch of Engineering may seek admission in any branch of his choice offered in the Evening program. However, for **SPONSORED** category, the students having diploma in relevant branch may seek admission in relevant B. Tech (Evening) program only.
- VI. The present intake in each branch is 60 out of which 40 and 20 seats shall be offered to **DIRECT and SPONSORED** categories respectively. Accordingly, the detailed distribution of seat matrix is as given below:

- VII. For **DIRECT** category seats, there shall be one combined merit list based on common entrance exam (CEE) for admission to B. Tech (Evening) program for all branches. The candidate having diploma in any branch may seek admission in any branch of his choice from the available seats strictly as per the rank in merit list of relevant category. In case more than one candidate have same rank in the CEE, the marks obtained in the qualifying examination as stated in the eligibility conditions will form the basis of merit for admission. In the event of marks in the qualifying examination also being equal, the candidate born earlier will be given preference.
- VIII. For **SPONSORED** category, the branch wise merit list shall be based on the marks awarded at diploma level and admissions shall be offered strictly in compliance of branch wise merit list. In the event of marks in the qualifying examination being equal, the candidate born earlier will be given preference.
 - IX. The vacant seats in open and sponsored categories are interchangeable.

2. Reservation

- (a) The reservation in admission for all the B. Tech. (Evening) Programs for SC/ST/OBC shall be provided as per the policy of Govt. of Delhi approved by the Board of Management of DTU. 15%, 7.5%, and 27% of the total seats in each program are reserved for SC, ST and OBC category respectively during session 2017-18. Candidates seeking admission under these categories must produce the SC/ST/OBC certificate issued by Govt. of NCT of Delhi. A list of approved authorities is given below:
 - District Magistrate/ Additional District Magistrate/ Deputy Commissioner/ Collector / Additional Deputy Commissioner/ Deputy Collector / I Class Stipendiary Magistrate/ City Magistrate (Not below the rank of I Class Stipendiary Magistrate)/ Sub-Divisional Magistrate/ Taluka Magistrate/ Executive Magistrate/ Extra Assistant Commissioner.
 - (ii) Chief Presidency Magistrate / Additional Chief Presidency Magistrate/ Presidency Magistrate.
 - (iii) Revenue Officer not below the rank of Tehsildar.
 - (iv) Sub-divisional Officer of the area where candidate and / or his / her family normally reside.
 - (v) Administrator / Secretary to administrator / Development Officer (Lakshadweep).
- (b) One seat in each program is reserved for employees of Delhi Technological University/Netaji Subhash Institute of Technology/ ITIs / Polytechnics under the direct control of Department of Technical Education, Govt. of NCT of Delhi. Such candidates also have to appear in the CEE and compete amongst themselves for a seat in each branch. Candidates applying for staff seat should route their applications through the Registrar, DTU / Directorate of Technical Education, Govt. of NCT of Delhi in the case of Polytechnics / ITIs.
- (c) 3% of the total seats in each program are reserved for person with disabilities candidates. These 3% reservations may be allocated as follows: 1% for persons with low vision of blindness, 1% for hearing impaired and 1% for those with Locomotor disabilities and/or cerebral palsy. Candidates seeking admission in PWD category shall have to appear before a medical board to be constituted by DTU.

(d) The seats belonging to General category will be filled as per open rank in the merit list.

Note:

- I. In case of seats reserved for SC candidates mentioned at (a) are not filled due to non availability of the candidates, the seats will be transferred to ST* candidates. Similarly the ST* seats will be transferred to SC candidates, if ST* candidates are not available for admission. However, even after interchanging the seats if neither SC nor ST* candidates are available for some reserved seats, then the seats will be treated as unreserved and will be filled by the open rank candidates. In case of seats reserved for OBC candidates mentioned at (a) are not filled due to non availability of the candidates, then the seats will be treated as unreserved and will be treated as unres
 - a. *Reservation as per the policy of Govt. of Delhi shall be applicable.

- II. In case sufficient number of eligible candidates from the categories mentioned at (b) and (c) above are not available, then the seats will be treated as unreserved in the respective branches.
- III. Please attach attested copies (by Gazetted Officer) of all original certificates and work experience certificates from the present and previous employers which fulfill your eligibility criteria. Applications without attested copies shall be summarily rejected without any intimation to applicants.
- IV. No admission shall be made directly to the second or subsequent years of B.Tech (Evening) program.

3. Procedure for obtaining the application form for B.Tech. (Evening) program:

- **a**) All candidates seeking admission to B.Tech (Evening) programme in DTU are required to download application form, available at **www.dtu.ac.in**
- b) Duly filled application form along with a Demand Draft of Rs 1000/- (Rupee One Thousand Only) non-refundable drawn in favour of "Registrar, Delhi Technological University, Delhi" payable at Delhi, shall be submitted to the Dy. Coordinator (Admn.), B. Tech. (Evening) admission-2017, B.Tech. (Evening) Office, 1st Floor, FW1-FF4, Electrical Engineering Department, Delhi Technological University (Formerly Delhi College of Engineering), Bawana Road, Delhi-110042 on or before 7.00 P.M. of 05-07-2017 (Wednesday). Incomplete information may lead to cancellation of candidature. The University will not be responsible for any postal delay or loss in transit. The candidates must ensure that the University receives the application on or before the last date. All applications received after the last date stand rejected automatically.
- **Note:** The candidates are advised to ensure that they fulfill all the eligibility conditions before they submit their applications for the Entrance Examination. Attested copies (by Gazetted Officer) of the documents should be arranged in the following order along with the application form : Acknowledgement Card, Admit Card, Address Slip, Application Form, Date of Birth certificate, Diploma certificate, Mark Sheets, Appointment letter, Experience certificate, No Objection Certificate from present employer, Caste Certificate (in case applicable). Three self addressed envelopes should be attached alongwith the application form.
- (c) The Admission Tickets may be downloaded from DTU website: <u>www.dtu.ac.in</u> just before the scheduled date of the Entrance Examination. However, the Admission Tickets may also be collected in person by 15th July 2017 (Saturday) from B. Tech. (Evening) office, 1st Floor FW1-FF5, Electrical Engineering Department.

(d) Unless otherwise notified, the Centre for the Common Entrance Examination will be Delhi Technological University, Shahbad Daulatpur, Bawana Road, Delhi - 110042.

(e) The medium of examination shall be English. The relevant syllabi are given in the Appendix. The entrance examination (**based on general aptitude**) shall be of two hour duration. The test will comprise of only objective type of questions. Each question will have multiple (four) choices with one correct choice. Each correct answer will be awarded four marks, whereas one mark will be deducted for each incorrect answer.

The Entrance Examination will be conducted as per the schedule below:

- (f) Instructions to the candidates with regard to the conduct of Examination will be communicated along with the Admission Tickets.
- (g) Candidates are expected to see their result on their own on the Notice Board of B. Tech. (Evening) office situated at 1st floor, FW1-FF4 in Electrical Engg. Block. Tentative date of declaration of result of Entrance Examination is 20-07-2017 (Thursday). The result of the Entrance Examination will also be displayed on the website "<u>www.dtu.ac.in</u>". No separate communication regarding the result will be made to the candidates.

3. Procedure for Admission :

- (a) The admission to B.Tech. (Evening) Program shall be done by Delhi Technological University on the basis of the rank secured by the candidates in the Common Entrance Examination. In case more than one candidate have equal marks in the Entrance Examination, the marks obtained in the qualifying examination as stated in the eligibility conditions will form the basis of merit for admission. In the event of marks in the qualifying examination also being equal, the candidate born earlier will be given preference.
- (b) The successful candidates up to the specified rank in each category and branch should present themselves for admission before the admission committee on the dates and time as specified below:

Further they are also advised to report on **11.08.2017** (**Friday**) by **2.30 PM** to explore the possibility of getting admission against

withdrawals.

(c) The candidates reporting for admission are required to bring the following documents along with one set of attested copies by **Gazetted Officer**.

- i. Original Class 10th certificate (indicating the Date of Birth)
- ii. Original Diploma certificate.
- iii. Original Mark sheets of each year/sem of Diploma.
- iv. Original SC/ST/OBC/PWD certificate.
- v. Original Appointment letter.
- vi. Employer's Company profile.
- vii. Original Experience certificates

Note: Item number (vi) is not required for candidates employed in Govt. /Semi. Govt./ Public Sector Undertakings.

- (d) The candidate seeking admission under sponsored category must bring the photocopy of Sale Tax Clearance Certificate / ITCC / Company Registration Certificate / any evidence which shows that the company in which they are working, works for any Government / Public Sector Undertaking/ Local Government Bodies.
- (e) If the candidate fails to bring the above documents mentioned in (c) & (d), the admission committee reserves the right to cancel his/her claim for admission to B. Tech. (Evening) Program.
- (f) The decision of the Delhi Technological University regarding the eligibility of admission of any candidate shall be final.

The fee is to be paid through Demand Draft drawn in favour of "Registrar, Delhi Technological University, Delhi" payable at Delhi. No part payment will be accepted. No other mode of payment is acceptable.

- (h) The university prospectus can be obtained at the time of admission on payment basis from the Stores Office.
- (i) If a candidate does not report for admission on the scheduled date, at the specified time either in person or through his/her nominee or if he/she does not pay the fee on the day of admission, his/her name will be deleted and he/she will cease to be a candidate and henceforth will not have any subsequent claim to a seat in B.Tech. (Evening) Programme, academic session 2017-18.
- (j) The original certificates will be returned to the candidate after one year or on withdrawal of the admission, whichever is earlier.
- (k) The last date for closing of admission is August 11, 2017 (Friday).

(l) **Refund Rules:**

The candidates who withdrew admission during **30.07.2017 to 07.08.2017** may take the refund of Admission Fee & Security Deposit from the Coordinator, B. Tech. (Evening) Admission Committee after paying Rs. 1,000/- in cash as processing fee provided the seats vacated by them get filled. However in case a candidate withdrew his admission on **11.08.2017** and seat vacated by him / her remained unfilled he / she will be refunded the refundable security of Rs 5,000/- only.

Those applying for withdrawal of admission after 11.08.2017 only the refundable security i.e. Rs. 5000/- will be refunded.
