### **VOTING IN BY-ELECTION**

#### TO ALL MOOSE CREE FIRST NATION ELIGIBLE VOTERS

Please be advised that there is <u>no provision for Mail in ballots</u> in the upcoming By-election. As stated in Section 15.4 of the Election Regulations "General Election rules, <u>with the exception of Mail in Voting</u>, shall apply". This means that the procedures for general elections are followed except for the Mail in Voting.

As noted in the Election Regulations, the following forms of voting shall be carried out:

#### **Mobile Voting Section 6.3 (2)**

The Electoral Officers shall visit the local hospital or any residence in Moose Factory or Moosonee so that Voters can cast a vote. (For voters who are confined in the hospital or home due to illness or disability).

#### Advance Polls Section 6.4 (2)

The Electoral Officers shall conduct an Advance Poll in Moosonee and Moose Factory one week prior to Election Day.

Advance Poll shall be held in Moose Factory on October 3, 2018 at the Moose Cree Complex. Polls will be open from 10:00 am to 6:00 pm.

Advance Poll shall be held in Moosonee on October 4, 2018 at the Northern College Foyer. Polls will be open from 10:00 am to 6:00 pm.

#### **By-election Day 15.2**

A By-election must occur at least 30 days after the appointment of the Chief Electoral Officer.

The By-election Day will be held in Moose Factory on October 11, 2018 at the Moose Cree Complex. Polls will be open from 10:00 am to 6:00 pm.

Therefore, a By-election shall be held to fill the vacant Councillor positions.

#### **ELIIGIBILITY FOR COUNCILLOR POSITION**

Candidates for the position of Councillor must:

- (a) be Members of the Moose Cree First Nation; and
- (b) if they do not ordinarily reside in Moosonee or Moose Factory, undertake in writing to Relocate to Moose Factory or Moosonee within 3 months of being elected to a position; and
- (c) be at least 18 years of age at the time of nomination.

#### NOMINATION PROCEDURE

<u>Candidates shall be nominated through the completion of a Nomination Form</u> as prescribed in Schedule 1 of the *MCFN Election Regulations*. The Chief Electoral Officer may be contacted by any Voter in person, by telephone, by e-mail, or by Canada Post to obtain a Nomination Form. <u>A Nomination Meeting is not required for By-elections</u>.
