1. The Sovromtransport Company was organized to carry out the commercial operations as specified in the 19 July 1945 Convention between the USSR and Rumania. Its chief function is to administer and control all river and sea transport, and the maintenance of shipping vessels. It is also reported the Company serves as a cover for Soviet intelligence activities in Rumania.

6. Lev Efimovich Krasnov who was hired on a Soviet recommendation, is the Director General of the Company. The Assistant Director General, Inspector General Sabin Saceanu, is a Rumanian engineer and Director of the PCA (sic). Alexandru Sergheev is the Company's chief accountant and Nicolae M. Ionescu has been treasurer of the Company since 29 October 1945.
