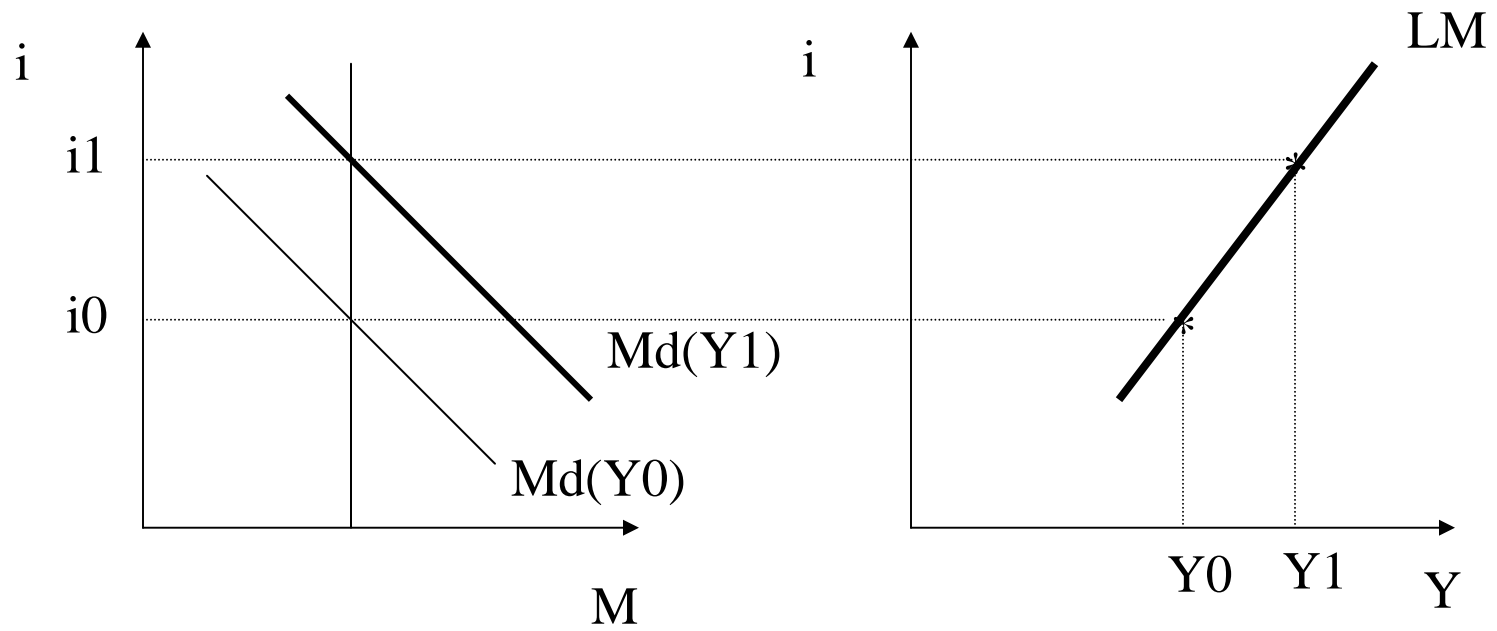

$$\text{OLD: } Y = C(Y-T) + I + G$$

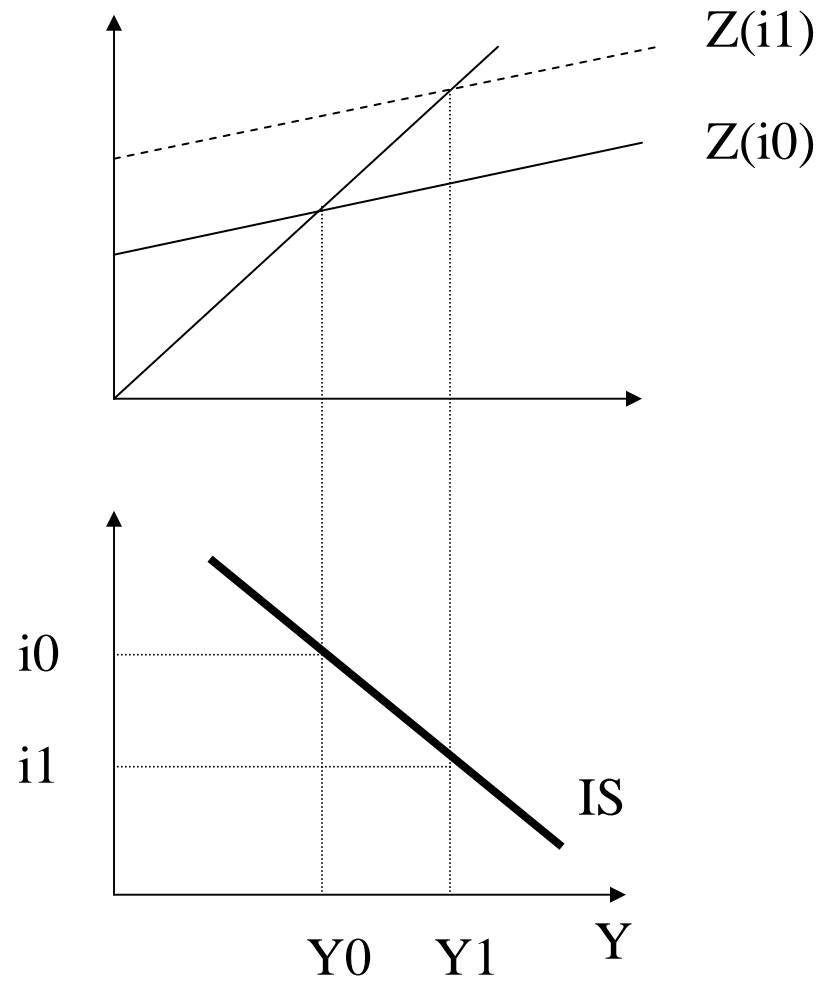
$$I = I(Y,i)$$

$$\text{IS: } Y = C(Y-T) + I(Y,i) + G$$

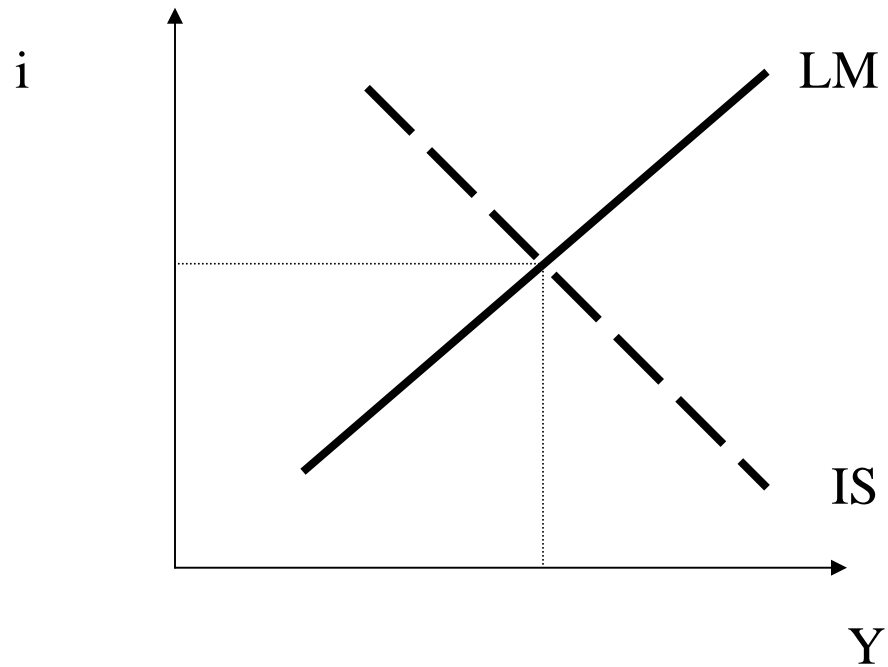

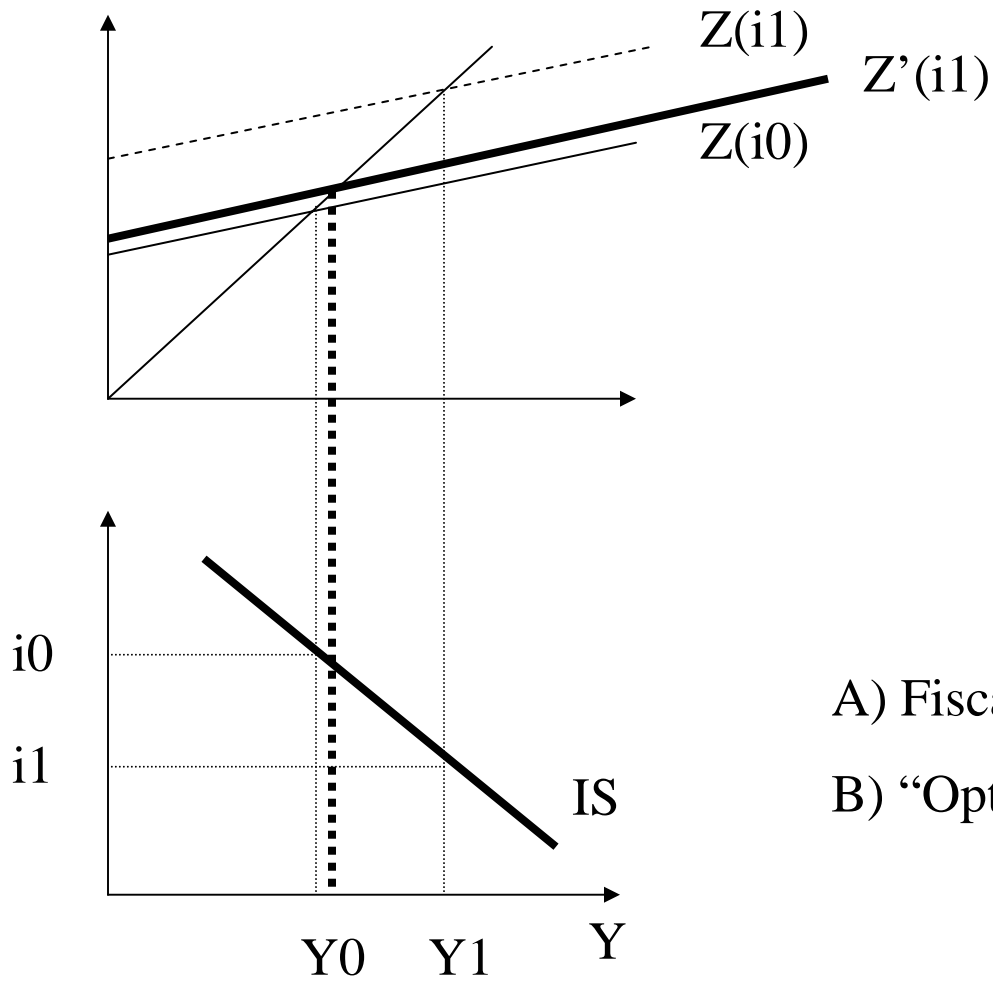
IS-LM Model



A) Fiscal policy; B) Monetary policy; C) Mix

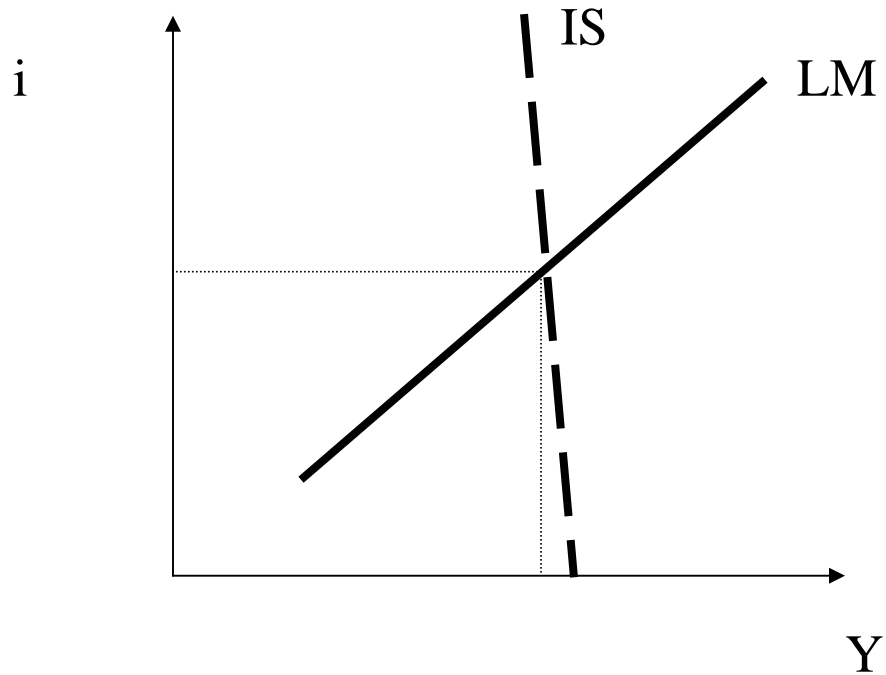
Parameters (slopes): L' ; I_i ; c_1

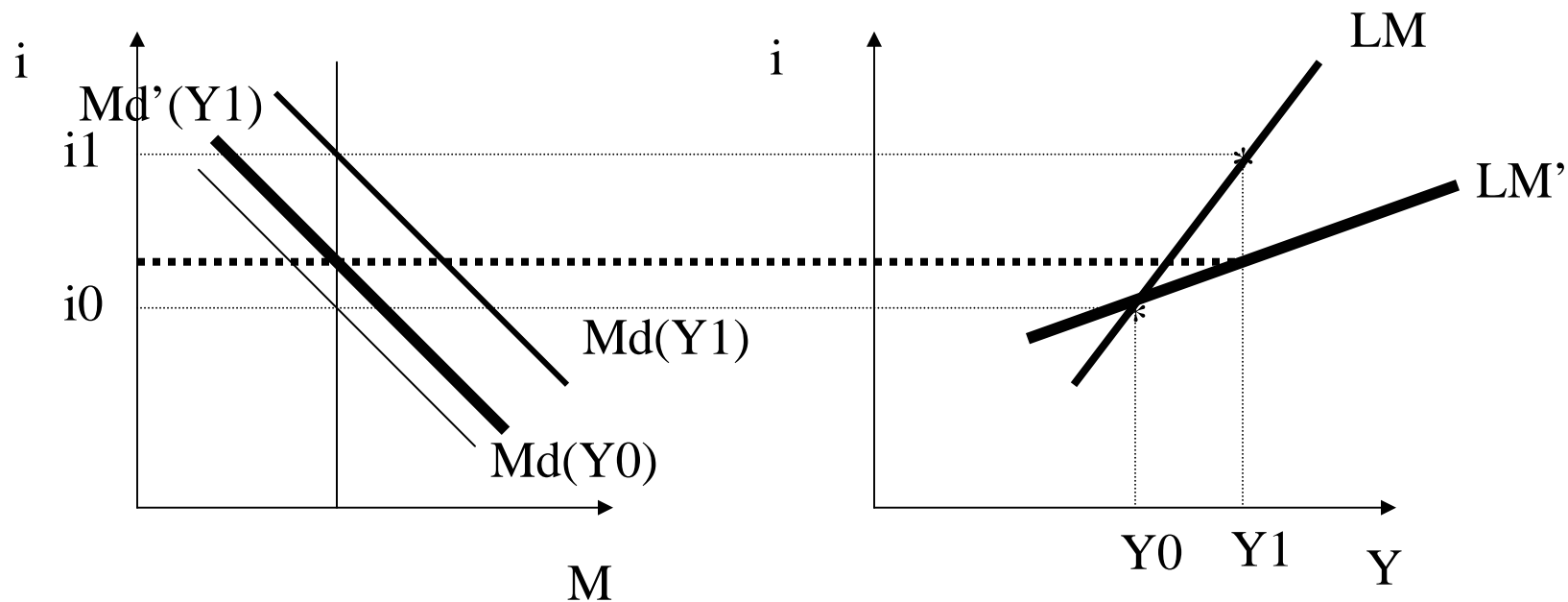

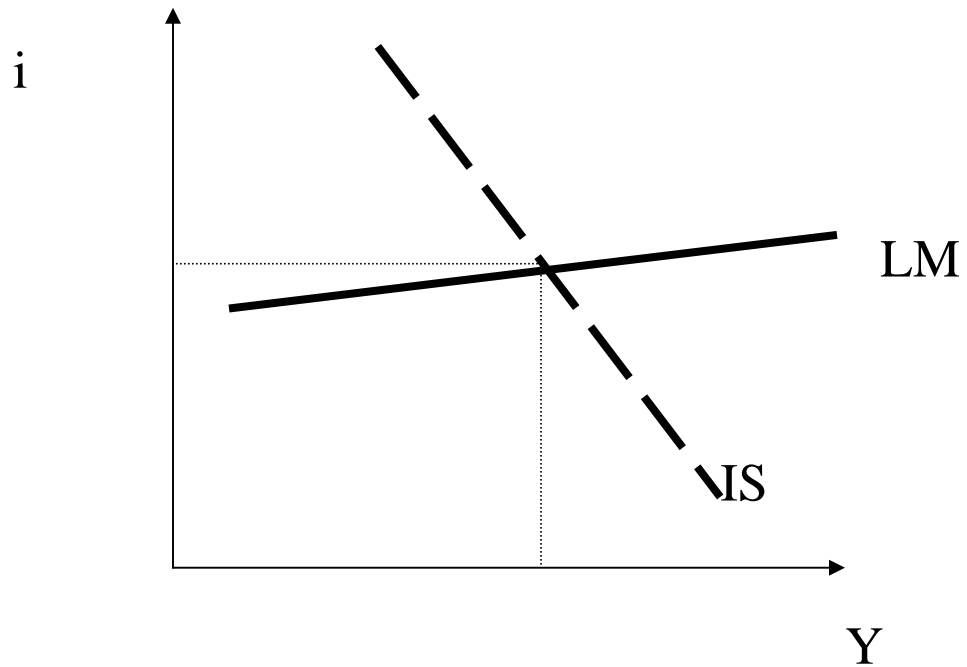
