Athlete Eligibility
<p>All athletes must comply with the provisions of the Olympic Charter currently in force, including but not limited to, Rule 41 (Nationality of Competitors). Only those athletes who have complied with the Olympic Charter may participate in the Minsk 2019 European Games.</p> <p>Age Requirements All athletes participating in Cycling in the Minsk 2019 European Games must be born before 1 January 2002 for Track events and before 1 January 2001 for Road events.</p> <p>Medical and Anti-Doping Requirements To be eligible to participate in the Minsk 2019 European Games, all athletes must satisfy the medical requirements according to the EOC Medical and Anti-Doping Guidelines. To be eligible to participate in the Minsk 2019 European Games, all athletes must comply with doping control process in accordance with the EOC Medical and Anti-Doping Guidelines and the EOC Anti-Doping Rules.</p> <p>Additional European Cycling Union (ECU) Requirements All athletes must have a valid UCI international license. To be eligible to participate in the Minsk 2019 European Games, all athletes must hold a valid UCI license issued by a National Federation.</p>

Host NOC Allocation

Allocation Process

The Host NOC is guaranteed the following allocation subject to meeting the eligibility requirements detailed in **Section C** and subject to acceptance from the UEC Technical Delegate:

20 Male Places:

- Six (6) places for Team Sprint (3 athletes), Sprint (1 athlete), Keirin (1 athlete), 1km Times Trial (1 athlete);
- Nine (9) places for Team Pursuit (4 athletes), Individual Pursuit (1 athlete), Scratch Race (1 athlete), Point Race (1 athlete), Omnium (1 athlete), Madison (1 athlete);
- Five (5) places for Road Race (including Time Trial).

19 Female Places:

- Five (5) places for Team Sprint (2 athletes), Sprint (1 athlete), Keirin (1 athlete), 500m Times Trial (1 athlete);
- Nine (9) places for Team Pursuit (4 athletes), Individual Pursuit (1 athlete), Scratch Race (1 athlete), Point Race (1 athlete), Omnium (1 athlete), Madison (1 athlete);
- Five (5) places for Road Race (including Time Trial).

Universality

Allocation Numbers

Seven (7) Male Universality Places are made available to eligible NOCs at the Minsk 2019 European Games in the Men's Road Race (including Time Trial).

Three (3) Female Universality Places are made available to eligible NOCs at the Minsk 2019 European Games in the Women's Road Race (including Time Trial).

The Universality places cannot be allocated to NOCs that have obtained a quota place in relevant events.

To be eligible for a Universality place the athlete must have participated in Qualifying Event or Ranking in Cycling.

The EOC will confirm, in writing, the allocation of Universality places to the relevant NOCs after the end of the qualification period by 15 March 2019.

E. Confirmation Process for Quota Places

MEGOC on behalf of the EOC and the UEC to inform, in writing, the NOCs of their allocated quota places on 20 March 2019.

NOCs will inform, in writing, MEGOC by 1 April 2019 whether or not they intend to use the allocated quota places and participate in the Minsk 2019 European Games.

The UEC will reallocate all available quota places and inform, in writing, MEGOC by 15 April 2019.

F. Reallocation of Unused Quota Places

If obtained through the qualification process and allocated quota place is declined by the NOC or is not confirmed by the NOC by the deadline, the quota place in that event will be reallocated to the next best ranked NOC, not yet qualified.

This process will be repeated until all places are allocated.

H. 2020 Summer Olympics Qualification

The UCI Ranking points will be allocated to each discipline according to the category of each one counting towards Tokyo 2020 Olympic Games qualification system.
