HE SAID HE USED TO WONDER BECAUSE THEY DIDN'T USE ANY PROTECTION

▲ NEVER MENTIONED ANY OTHER PLACES WHERE THEY HAD SEX.

VICTIM SAID:

IMPLY THINGS -- DIDN'T REALLY COME OUT AND SAY ANYTHING, SHE LAUGHED ABOUT SITUATION WHERE AISHA CAME IN

TALKED MORE ABOUT COLLEGE AND SPORTS.

HAE SAT NEXT TO ME AT LUNCH, EATING

SHE WAS QUIET IN CAFETERIA -- A LUNCH

TALKING ABOUT BIRTHDAY PRESENT TO STEPHANIE:

STUFFED REINDEER

REMEMBER WHERE EVERYONE WAS

(CHART DRAWN)

BELIEVED HAE MAY HAVE HAD A LIGHT COLORED SHIRT ON.

ADNAN WOULD SOMETIMES COME TO CAFETERIA

BUT NOT EAT ANYTHING

SAW HAE -- DRAMA TRY OUTS, WAITING FOR MY SISTER TO
GET FINISHED

AISHA AND I WERE WALKING DOWN HALL

DRAMA BY GYMNASIUM

WALKING DOWN 1ST FLOOR HALLWAY COMING INTO OFFICE

TO GET TRANSCRIPTS FOR COLLEGE

HAE ON SAME SIDE OF HALL WITH ME, ▲ PASSING ON THE OTHER

SHE SAID HAE'S MOM CALLED HER.

FRIDAY.

DIDN'T TALK TO ▲ THURSDAY AT ALL. TALKED TO ▲ AT CRISTA MYER'S BIRTHDAY PARTY -- 15TH, LIBERTY ROAD, FIREHALL, 30 PEOPLE.

SPOKE TO ▲: HE WAS DANCING, TALKING ABOUT SISTER'S HAIRCUTS, COMPLEMENTING ME ON FIXING HER HAIR, ▲ DANCED WITH MY SISTER (16 -- DIANE WALKER) ▲ SAID SHE WAS A GOOD DANCER - (NO SLOW DANCES)

SOMEBODY BROUGHT HAE UP DURING PARTY, MENTIONED SHE WASN'T THERE. WE ALL ASSUMED SHE WAS AT DON'S HOUSE -- HER BOY FRIEND AT THE TIME.

▲ TALKED ABOUT DON A LITTLE. BEGINNING OF JANUARY. HAE GOT FREE TICKETS FOR OWINGS MILL MALL MOVIE THEATER. INVITED ADNAN, AISHA . STOPPED BY MALL. HAE SAID -"ISN'T THAT GUY CUTE" (MEANING DON) ADNAN SAID -- I'LL GIVE A GUY CREDIT IF I THINK HE LOOKS GOOD, BUT I DON'T THINK SO. ALL WERE LAUGHING.

HAE QUIET AT LUNCH -- HAE SAID I'M JUST THINKING ABOUT DON.

HAD PHOTOGRAPHY 1ST PERIOD, 2ND SEMESTER, MS. MUSE

ON TUESDAY THE 19TH, 1ST DAY BACK TO SCHOOL. SOMEONE MENTIONED THAT OFFICE CALLED DURING HER 2ND PERIOD CLASS AND ASKED IF SHE WAS THERE.

AFTER SCHOOL, IN PHOTOGRAPHY ROOM - DEVELOPING FILM. ADNAN STARTED TALKING ABOUT IT, GETTING WORRIED BECAUSE SHE WAS NOT COMING TO SCHOOL AND TO THE PARTY WHICH WAS A BIG DEAL. SCHOOL REALLY IMPORTANT TO HER. FIGURED SHE WAS AT DON'S

IDEA OF HER GOING TO CALIFORNIA DIDN'T COME UP UNTIL
LATER

MS. BUTLER SAID -- SHE TOLD ▲ AND I SHE THOUGHT HAE WENT TO CALIFORNIA. TWO WEEKS BEFORE HAE HAD SAID, "IF THINGS GET BAD, I'LL JUST GO TO CALIFORNIA TO VISIT DAD"

TUESDAY IN PHOTOGRAPHY CLASS, AT THAT POINT, WE DIDN'T KNOW SHE WASN'T IN SCHOOL

▲ DIDN'T DO ANY WORK IN PSY.

UNCOMMON FOR HIM NOT TO DO ANYTHING
BEFORE HE HAD BEEN DOING EVERYTHING.

▲ WOULD CRY A LOT -- WHENEVER WITH ▲ AND WITH OTHER FRIENDS

▲ WOULD SEE PHOTOS OF VICTIM AND START CRYING. SAID HE STARTED PRAYING FOR HER

ONE TIME IN PSY. -- HE PULLED OUT A PHOTO OF THEM TOGETHER, BEFORE BODY FOUND, HE WAS JUST LOOKING AT IT. HE DIDN'T RESPOND. HE WAS COMPLETELY IN HIS OWN WORLD. MS. PAOLETTI TOOK PHOTO -- GAVE PHOTO BACK. TAKEN OUTSIDE ON BRICK WALL IN BEGINNING OF YEAR. WE WOULD ALL SIT THERE AFTER LUNCH, BOTH DRESSED UP, SHE HAD A SKIRT ON, HE HAD A SHIRT AND TIE. THEY WERE SITTING TOGETHER.

HAVE PHOTOS OF THEM TOGETHER, PHOTO OF PROM

DON'T THINK HAE WOULD HAVE TOLD ANYONE IF SHE WAS PREGNANT. AISHA AND I DISCUSSED IT, DON'T THINK SHE WOULD HAVE TOLD ANYONE.

EARLY FEBRUARY -- ▲ CAME TO HOUSE -

CRISTA, AISHA, SEAN, AISHA'S BOYFRIEND AND I PLANNED ON GOING
OUT TO DINNER

CALLED ADNAN -- TALKED TO HIM ON PHONE, INVITED ▲

▲ AT FRIEND'S HOUSE IN HOWARD COUNTY

(HE CALLED MY HOUSE) HE SAID HE WOULD COME TO MY HOUSE.

WE WOULD DRIVE TO CRISTA'S HOUSE. HE CAME AND PICKED ME UP
AND WENT TO CRISTA'S. CRISTA TOOK US ALL TO DINNER.

IN BEDROOM AFTER DINNER, LOOKING AT PHOTOS OF _____

SAW HIM GETTING TEARY EYED. WE LEFT, HE DROVE ME HOME.

NOT THAT LONG BEFORE HE WAS TOLD THEY FOUND HER.

ON WAY HOME HE WAS QUIET AT 1ST. SOMEONE CALLED HIM
ON CELL PHONE -- IT WAS A GIRL -- HE SAID "WHY WOULD I SAY

THEY WERE PLAYFUL WITH EACH OTHER. SHE WOULD JOKE
ABOUT HER EASE AT FINDING OTHER GUYS.

NIGHT BEFORE HIS ARREST,

PEOPLE DIDN'T REALLY LISTEN.

DAY AFTER THEY FOUND HER, HE DROVE TO WESTERN MARYLAND.

SQUARE MALL, JUST PAST FOOD COURT IN MALL.

DEFENDANT CAREFUL ABOUT HAIR, DIDN'T WEAR HATS OR SCARVES
EVER.

DEFENDANT WOULD GO TO TRACK

SOMETIMES LATE TO TRACK -- DOING THINGS HERE

STAYING LATE TO MAKE-UP WORK

ONE DAY TUESDAY AFTER, 19TH, HE KEPT SAYING I NEED TO GET TO
TRACK, ANOTHER PERSON THERE TALKING ABOUT HOW THE COACH
WOULD BE MAD, BUT THEY STAYED ANY WAY.

HE DIDN'T LEAVE UNTIL APPROXIMATELY 3:30. TRACK

USUALLY STARTED BEFORE

COACH JUST TELLS PEOPLE WHAT TO DO, THEY NEVER RUN ALL
TOGETHER.

COACH WOULD NOTICE IF REALLY LATE

SOME LATENESS NORMAL

PEOPLE STRETCHING UNTIL REALLY LATE
