4. If you are unemployed:
Proof of date of lay off or loss of job in the form of a letter from your last employer, or:
Letter of certification from the unemployment office, or:
A signed statement from the person supporting you, or:
Proof of public assistance, medical assistance AFDC, Social Security or Supplemental Security Income (SSI) you are receiving.

The Office of the Public Defender accepts applications for representation weekdays from 8:30 a.m. to 4:30 p.m. Appointments are preferred, but not required.
