ON 10 FEBRUARY 1999, AN POST MORTEM EXAMINATION WAS PERFORMED ON THE REMAINS OF AN ASIAN FEMALE WHO WAS LATER IDENTIFIED AS HAE MIN LEE F/A/18 10/15/80. AT THE CONCLUSION OF THE EXAMINATION, DOCTOR AQUINO ASSOCIATE MEDICAL EXAMINER RULED THE DEATH A HOMICIDE BY STRANGULATION.

DURING THE LAST WEEK OF FEBRUARY 1999, SEVERAL WITNESSES WERE INTERVIEWED AT THE OFFICES OF HOMICIDE. THESE WITNESSES PROVIDED INFORMATION CONCERNING THE DEATH OF HAE LEE. ADDITIONALLY, THESE WITNESSES INDICATED THAT THE ABOVE NAMED DEFENDANT STRANGLERED THE VICTIM TO DEATH AND BURIED THE REMAINS WITHIN LEAKIN PARK. THESE WITNESSES WILL REMAIN ANONYMOUS UNTIL TRIAL.

Received information that a body was buried in the 4400 block of Franklinton Road. Upon discovering the remains, members of the Armed Services Medical Examiners Office responded and disinterred the body. On 10 February 1999, an Post Mortem examination was performed on the remains of an Asian Female who was later identified as Hae Min Lee F/A/18 10/15/80. At the conclusion of the examination, Doctor Aquino Associate Medical Examiner ruled the death a homicide by strangulation (continued)

During the last week of February 1999, several witnesses were inter-viewed at the offices of Homicide. These Witnesses provided information concerning the death of Hae Lee.

Additionally these witnesses indicated that the above named defendant strangled the victim to death and buried the remains within Leakin Park
