## **Territory of Guam – Typhoon Dolphin FEMA-4224-DR**

## Declared June 5, 2015

On May 27, 2015, Governor Eddie Baza Calvo requested a major disaster declaration due to Typhoon Dolphin during the period of May 13-16, 2015. The Governor requested a declaration for Individual Assistance, Public Assistance, and Hazard Mitigation for the Territory of Guam. During the period of May 17-23, 2015, joint federal, territory, and local government Preliminary Damage Assessments (PDAs) were conducted in the requested areas and are summarized below. PDAs estimate damages immediately after an event and are considered, along with several other factors, in determining whether a disaster is of such severity and magnitude that effective response is beyond the capabilities of the territory and the affected local governments, and that Federal assistance is necessary.<sup>1</sup>

On June 5, 2015, President Obama declared that a major disaster exists in the Territory of Guam. This declaration made Public Assistance requested by the Governor available to the territory and eligible local governments and certain private nonprofit organizations on a cost-sharing basis for emergency work and the repair or replacement of facilities damaged by Typhoon Dolphin in the Territory of Guam. This declaration also made Hazard Mitigation Grant Program assistance requested by the Governor available for hazard mitigation measures for the Territory of Guam.<sup>2</sup>

Information collected is used by the State as a basis for the Governor's request for a major disaster or emergency declaration, and by the President in determining a response to the Governor's request (44 CFR § 206.33).

Stafford Disaster Relief and Emergency Assistance Act, as amended (Stafford Act) is under review, a number of primary factors are considered to determine whether assistance is warranted. These factors are outlined in FEMA's regulations (44 CFR § 206.48). The President has ultimate discretion and decision making authority to declare major disasters and emergencies under the Stafford Act (42 U.S.C. § 5170 and § 5191).
