## 2015 Session Report

The 2015 legislative session adjourned on Friday, July 10 after a record-setting 176 days and three special sessions. The Governor signed a \$38.2 billion state operating budget that includes closing several tax exemptions, suspension of the voter-approved I-1351 class-size initiative and compensation increases for state employees. In addition to education reforms including reducing college tuition at public colleges and universities, the Legislature made investments in mental health, emergency drought response, and reforms related to medical marijuana.

Legislators also passed a \$3.9 billion capital budget and a \$16 billion transportation budget that includes an 11.9 percent gas tax increase phased in over the next two years.

## Legislative Affairs

The Office of Legislative Affairs drives legislative efforts with elected officials, agencies, organizations, and key stakeholders who play a role in advancing and supporting WSBA-related priorities. Legislative Affairs coordinates WSBA and judicial interests within government relations activities, as well as the activities of the Board of Governors (BOG) and WSBA Legislative Committees.

During the legislative session, efforts are prioritized around Board-approved legislation, but other bills that may impact the practice of law and the administration of justice are also closely monitored. During the interim, Legislative Affairs works towards meeting emergent legislative goals and prepares for future sessions through a collaborative process with internal constituencies and key external stakeholders.

## Legislative Engagement

WSBA is engaged in the legislative process in a variety of ways. After a thorough GR 12.1 analysis, a Section may determine a bill warrants further action. In accordance with the WSBA Legislation and Court Rule Comment Policy, Sections and members may weigh in publicly regarding a legislative proposal after approval of at least 75 percent of their executive committee and final approval from the BOG Legislative Committee.

Positions used to inform legislative action, in cooperation with the Legislative Affairs Manager, may include the following:

- **Support** – A Section has determined formal support for a bill. Potential further action may include legislative testimony, etc.
- **Concerns** – A Section has determined formal concern about a bill. Potential further action may include proposing amendments, communicating with legislator(s), etc.

- **Opposed as drafted** – A Section has determined opposition to a bill in its current form, but notes that it may be fixed. Potential further action may include bill amendments, communicating with legislator(s), collaboration with stakeholders, etc.
- **Opposed** (*used sparingly*) – A Section only determines formal opposition to a bill if “oppose as drafted” cannot be used. Potential further action may include communicating with legislators and stakeholders, etc.
- **No Position** – A Section determines “No Position” on a bill if an executive committee vote wasn’t necessary or the required 75 percent was not reached. There is no further action.
- **FYI/watch** – A Section was assigned a bill to review and determine if further action was needed.
