# The Arun District Council (Reorganisation of Community Governance) Order 2019 No. 1

Made 12 March 2019

Coming into force in accordance with article 1(2)

Arun District Council ("the Council"), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 ("the 2007 Act"), has undertaken a community governance review and made recommendations dated September 2018.

The Council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The Council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section:

The Council makes the following Order in exercise of the powers conferred by sections 86, 98(3), 98(4) and 240(10) of the 2007 Act.

#### **Citation and Commencement**

- 1. (1) This Order may be cited as the Arun District Council (Reorganisation of Community Governance) Order 2019 No. 1.
  - (2) It shall come into force on 1 April 2019.
  - (3) Articles 6 and 7 shall come into force on the ordinary day of election of councillors in 2019.
  - (4) For the purposes of:
    - (a) this article and
    - (b) proceedings preliminary or relating to the elections of parish councillors for the parish of Barnham and Eastergate to be held on the ordinary day of election of councillors in 2019;


this Order shall come into force on the day after that on which it is made.

# Wards of the Parish of Barnham and Eastergate and numbers of parish councillors

- 7. (1) The existing wards of the parish of Barnham and of the parish of Eastergate will be abolished.
  - (2) The parish of Barnham and Eastergate shall be divided into two (2) wards which shall be named Barnham and Eastergate parish ward and Fontwell Village parish ward.
  - (3) Each ward shall comprise the area designated on the map by reference to the name of the ward and demarcated by orange lines.
  - (4) The number of councillors to be elected for Barnham and Eastergate parish ward shall be twelve (12) and for Fontwell Village parish ward shall be one (1).

#### **Annual meeting of Parish Council**

8. The annual meeting of the new parish Council in 2019 shall be convened by the Parish Clerk. The meeting shall take place no later than 14 days after the day on which the councillors elected to the new parish Council take office on 8 May 2019.

#### **Electoral Register**

9. The registration officer for the district of Arun shall make such arrangement of, or adaptation of, the register of local government electors as may be necessary for the purposes of, and in consequence of this Order.


#### Transfer of Property, rights and liabilities

- 10. (1) The land, property, rights and liabilities described in Schedules 1 4 shall transfer from the Barnham Parish Council to the Barnham and Eastergate Parish Council on the date specified in column (2) of those Schedules.
- 10. (2) The land, property, rights and liabilities described in Schedules 5 9 shall transfer from the Eastergate Parish Council to the Barnham and Eastergate Parish Council on the date specified in column (2) of those Schedules.

#### **Order Date**

11. 1 April 2019 is the order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.


