



D. & J. FOWLER (AUSTRALIA) LTD.

BRG 14 Series List

The business was founded as a retail establishment by David Fowler in 1854. A cost and price book for 1857-62 documents the rapid expansion of the business, which became a leading wholesale and indenting firm in South Australia. By the 1880's, in addition to D. & J. Fowler's London Office (6 East India Avenue, E.C.), there was also a branch of the firm at Fremantle. The importation of a wide variety of foodstuffs was balanced by the export of such staple items as wool, wheat and flour, wine, meat, butter, copper, copper ore, bark, etc.

Series 15 (Letters received, 1884-88) in itself has considerable interest for the social history of South Australia. Amongst those who supplied themselves from D. & J. Fowler's were some of the Murray River traders - Joseph Maultby of the S.S. Hero, Andrew Willcock of the S.S. Tolarno, J. Bickers of the Annie Brown, and Thomas Burta of the Emily Jane. The records of sales in the name of James Pickford of Port Darwin are a sidelight on the history of Northern Territory development. At this period there was also a relatively high volume of trade with Broken Hill (Murton & Buck, G. Kraft & Co., and others), and with Birdsville (Percy, Burt & Co., R. Frew, and possibly others). 'Send tobacco for Burt by train immediately. Camels waiting', reads one telegram from Hergott Springs.

The same series includes a letter of 1886 from Dr. John Riccardo Stephens, later a well-known resident of Gumeracha, at that time a stockowner near Hallett. The firm and its customers extensively used the electric telegraph for quick communication. Correspondence with Reuter's Telegram Company, situated at the Exchange, Adelaide, helps to illustrate the procedure followed by Reuter's in the 1880's.

The firm's interests and holdings were extensive and varied: they included the Adelaide Milling Company (purchased in 1895), the Robur Tea Company (purchased in 1931) and its subsidiary the Oriental Tea Company, Adelaide Bottle Company (1912), Waltons Ltd. (1931), to name but a few.

In 1982-83 D. & J. Fowler Ltd. was taken over by the Adelaide-based Southern Farmers Ltd.

The principal records of D. & J. Fowler were transferred to the Archives in December 1983.

Material relating specifically to history of the firm is contained in Series 72.

Volume 5: Employee register by department, 1911-1960. Contains details similar to above.

Volume 6: Contains Employee pay register, 1942-1946. Contains details similar to volume 4.
