

## **Caighdeán an Aitheantóra Aonfhoirmigh Acmhainne (URI) de chuid an Aitheantóra Eorpaigh Reachtaíochta (ELI) do Ríomhleabhar Reachtanna na hÉireann (eISB).**

### **Cad é?**

Is réiteach séimeantach gréasáin<sup>1</sup> é an tAitheantóir Eorpach Reachtaíochta (ELI) a chumasaíonn rochtain dhíreach ar reachtaíocht shonrach náisiúnta trí aitheantóir struchtúrtha solúbtha. Cruthaíonn sé córas comónta chun reachtaíocht agus a meiteashonraí a aithint. Leagann ELI aitheantóirí uathúla, meiteashonraí agus ointeolaíocht mholta amach a chuireann tagairt struchtúrtha ar reachtaíocht ar fáil atá so-aitheanta, soláite agus intuigthe do dhaoine agus do ríomhairí nuair a chuirtear i bhfeidhm é ar reachtaíocht ar líne, rud a ligeann do mhalartuithe níos mó agus níos tapa sonraí agus faisnéise.

### **Cén tionchar a bheidh aige ar rochtain ar Ríomhleabhar Reachtanna na hÉireann?**

Ní athróidh rochtain ar Ríomhleabhar Reachtanna na hÉireann (eISB). Nuair a bhíonn faisnéis nasctha leis an eISB leis an seanchóras seolta, cuirfidh próiseas atreoraithe rochtain ar fáil go huathoibríoch ar an reachtaíocht ag an seoladh nua. Le caighdeán URI an ELI curtha i bhfeidhm, bainfidh gach tagairt atá nasctha le reachtaíocht ar an eISB úsáid as an gcaighdeán nua.

### **Trí cholún an Aitheantóra Eorpaigh Reachtaíochta**

Tá trí chomhbhall ag sonraíochtaí an ELI. Tugtar na trí cholún orthu:

**Colún I: Reachtaíocht a aithint:** Teimpléid URI HTTP ag an leibhéal Eorpach, náisiúnta agus réigiúnach, bunaithe ar shraith shainithe de chomhbhaill.

**Colún II: airíonna meiteashonraí a dhéanann cur síos ar acmhainní dlíthiúla:** Sainmhíniú ar shraith meiteashonraí agus a léiriú in ointeolaíocht fhoirmiúil.

<sup>1</sup> Is éard atá sa Ghréasán Séimeantach (ar a dtugtar Gréasán 3.0 freisin) ná líonra sonraí a chumasaíonn maisíní chun séimeantaic (.i. brí) na faisnéise a foilsítear ar an nGréasán a thuiscint. Síneann sé an líonra de leathanaigh Gréasáin atá inléite do dhaoine (m.sh. atá foilsithe in HTML) trí mheiteashonraí atá inléite do mheaisíní a ionsá faoin bhfaisnéis foilsithe sin agus conas mar a bhaineann sé leis an ábhar ar leathanaigh eile. Cuireann sin ar chumas uathghníomhaithe rochtain a fháil ar an nGréasán ar bhealach níos éirimiúla agus tascanna a chur i gcrích ar son úsáideoirí.

**Colún III: na meiteashonraí ELI a sholáthar le go mbeidh siad in-athúsáidte ar mheaisíní:** Comhtháthú na meiteashonraí sna suíomhanna gréasáin reachtaíochta.

### **Cathain a rachaidh an chéad chéim den ELI beo ar an eISB?**

Chuaigh an chéad chéim d'fhorfheidhmiú an ELI .i. caighdeán d'Aitheantóirí Aonfhoirmeacha Acmhainne (URI) beo i Meán Fómhair 2015.

### **Céard faoin dara agus an tríú colún?**

Críochnaíodh an dara colún trí na hairíonna ábhartha meiteashonraí ELI a bhaineann leis an eISB a aithint agus tá na luachanna sin doiciméadaithe anois san **ointeolaíocht meiteashonraí eISB** ar leathanaigh 11 agus 12.

Críochnaíodh an tríú colún, a bhaineann le meiteashonraí a shrathú (.i. atá marcáilte go cuí in RDFa agus atá leabaithe sna leathanaigh HTML), i gcomhair Achtanna ó 2013 agus i gcomhair Ionstraimí Reachtúla ó 2014 agus déanfar nuashonrú air le haghaidh reachtaíocht nua amach anseo. Tá sampla den mharcáil seo ar fáil ar leathanach 13.

Is féidir na meiteashonraí RDFa a fheiceáil trí shíneadh brabhsálaí. Sampla amháin ná Lorgaire Struchtúrtha Sonraí OpenLink (OpenLink Structured Data Sniffer - OSDS). Is síneadh brabhsálaí é le haghaidh Google Chrome, Mozilla Firefox agus Opera (le tiomnaithe beartaithe i gcomhair Apple Safari agus Microsoft Edge) a nochtann sonraí struchtúrtha meiteashonraí-bhunaithe atá leabaithe i ndoiciméid HTML.
