## Detroit Rose Rips `Liberal' Mogk

DETROIT, July 29 - "Mr. Mogk, do self-help programs and dividing up the city mean that you would have community people pick up garbage if the sanitation workers went out on strike?"

The questioner was a black youth in the audience at the debate here today between Gerry Rose, U.S. Labor Party candidate for mayor of Detro in 1973, and one of his opponents, John Mogk, a liberal who has a reputation for support of "local community control.

control." 'If city workers refuse to work,' Mogk bleated in reply to the youth, 'and the quality of life is threatened,' he con-tinued outrageously, 'it's up to the elected officials to do something about it.' Trans-lation: If Mogk were mayor he would call on Detroiters to scab would call on Detroiters to scab on striking sanitation workers.

Rose immediately strode to the podium. "When there is a strike, we organize the working class and the unemployed to join that strike and support it. Mogk says that he believes in collective bargaining, but the city is bankrupt. Collective bargaining under bankruptcy is a joke. Mogk talks as if there isn't any slave labor going on. We should be angry and go from this meeting and organize! The audience of 45, including Labor Party supporters, Mogk

staffers and half a dozen auto workers, loudly applauded this challenge.

During the debate Rose proved ruthlessly that Mogk's do-for-self, community-control schemes for schools, sanitation services, jobs and housing fall right in line with capitalist pla get workers to kowtow in the depression. The two-party system is gone and the capitalists are left with the problem, "How can we police the working class?" Cool on the surface but obviously itchy when confronted with his role as dupe of the employers, Mogk found it necessary to deny over and over that he "subscribed" to New Detroit, the large counterinsurgency operation here run by Chrysler, Ford and General Motors. "I resigned from the New Detroit Law Committee because it wasn't effective." he asserted.

Mogk is proud that he sat on the commission which proposed the new city charter to divide the city into eight or more warring camps competing for dwindling funds. This charter would give the perfect set-up for him to implement his local control ideology. "What would this city charter

mean for Detroit's workers?" Rose asked. "Look at what happened when the school system was broken up. New Detroit didn't want a united movement to improve the schools so school decentral-

ization was instituted in 1970 so that parents would fight teachers over wage increases when the schools are faced with diminishing funds. Mogk also sat on the committee that drew up the warring boundaries for the school districts.

Mogk was on the defensive. The decentralization of the schools was supposed to in-crease the quality of education which it hasn't done. All the region board members should come together and demand funding. That would be a more effective force than the seven people on the central board." After New Detroit spent millions of dollars and years of effort in decentralizing the schools, aided by Mogk, among others - gee, why don't folks all get back together and demand funding? Do For Self

This ex-member of the New Detroit Law Committee who resigned because it wasn't effective is one of the best do-for-self proponents New Detroit could wish for. He administered the Jefferson-Chalmers Citizens District Council, which has been highly acclaimed in the press as a model local-control neighborhood.

What they mean by "model" is that it has the largest volunteer scab operation in the city. Those residents busy cleaning streets, playgrounds, and vacant lots don't bother to

question why the city isn't doing the job. And they can be relied upon to scab on striking sanitation workers. Young volsanitation workers. Young voi-unteers are now being herded for park maintenance. With this do-for-self spirit, who needs all those municipal workers? "One needs little imagination

to see that an army of volunteers can break a city strike," Rose pointed out. "Mogk has even organized potential vigilante squads now known in the area as volunteer police - which could be available to enforce such strikebreaking." Slave Labor

Mogk claimed to be in favor of jobs for everyone "at a union wage." However, he proposed in the same breath that Detroit workers must "compete" with workers in other areas for jobs. How? "...by giving businesses incentives to relocate here.

Mogk has the gall to suggest mogx nas the gall to suggest that workers subsidize capi-talists while fighting other workers for jobs. This swinish, self-defeating idea is in direct contrast to the Labor Party campaign for modulity in incampaign for productive jobs

r everyone. When Rose asked Mogk flat out if he opposed slave labor, Mogk felt compelled to say welfare victims should have jobs at union wages. But he sheepishly evaded the next question - "Would you join question - "Would you join with the National Unemployed and Welfare Rights Organization in demonstrating against slave labor?"

'I'm very busy," he said, hurrying out the door after the debate.

"Busy trying to hide the knot that ties him to New De-troit," a Labor Party organizer commented.

Continued from page 1 view between Chaitkin and Philip Haire. an aide of the Select Committee, this "impartial" body, as well as the Armed Services Committee and the Cox Commission, refused to accept the NCLC's thoroughly documented proof of CIA plots against the workers and unem-ployed in the United States.

According to Lieutenant Lugene Branner of the Washington Police, the eight arrested Labor Committee members were to be charged with disrupting Congress and unlawful entry. When asked for the basis for an unlawful entry charge at a public hearing, Branner stated that "It's unlawful entry

if you come with the intention of disrupting Congress: we will prove that intention." Branner's statement revealed tentamajor 'conspiracy' type charges against the Labor Com-mittees.

At the arraignment that afternoon, however, court offic-ials announced that charges against all eight had been dropped on orders from Senators Baker and Ervin. Rather than risk the massive public exposure of the CIA that would accompany any conspiracy frame-up of the Labor Committees, Ervin and company had quickly moved to hush up the entire affair. The wavering

They drew reporters from the United Press International, the Associated Press, the New York Times, Reuters, CBS Radio, Time Magazine, The Philadelphia Bulletin, Philadelphia Inquirer, and numerous local newspapers and radio and TV stations.

Today's New York Post and Washington Star carried stories on the NCLC's Watergate expose and numerous other newspapers, including the Seattle Times and the Buffalo Evening News printed the Associated Press's dispatch on the Senate intervention.

In Newark eight media repre-sentatives, including the New York Daily News, UPI, WNJR Radio, and the Newark Star Ledger, were on hand for the noon conference at the Robert Treat Hotel. One hour before the conference three young Baraka hoodlums entered the hotel conference room and be-gan tearing down anti-Baraka posters from the walls. They were driven out by a Labor Committee defense squad and led the hotel to a waiting car, leaving a trail of blood in the

Later that afternoon, following the press conference, two

carloads of Baraka suppo staking out the Newark Labor Committee's office were taught a harsh lesson for their coward ly attack on the Labor Committee office the day before. Cornered by Labor Committee de-fense groups after an automobile chase through the city streets, three Baraka thugs were left beaten and bleeding. their car partially destroye

Throughout the day in New-ark a clear pattern of harassment had been discernible. Baraka's goons continually cruised the area around the downtown hotel. Suspicious phone calls and visits from hony reporters were received at the conference.

With today's national expos-ure of Baraka and the CIA's growing national network, Baraka has no more room to hide. As mayoral candidate Jim Ro-tonda said, "We will immediately saturate Newark with our posters advertising this new pamphlet. The ghetto will begin to realize that we are the revolutionary organization that can drive Baraka and his white fascist twin Anthony Imperiale out of town
