Online Privacy Policy

This privacy policy discloses the privacy practices for <u>isna.net</u>. This privacy policy applies solely to information collected by this web site or any other web sites controlled by the Islamic Society of North America (ISNA). It will notify you of the following:

- 1. What personally identifiable information is collected from you through the web site, how it is used and with whom it may be shared.
- 2. What choices are available to you regarding the use of your data.
- 3. The security procedures in place to protect the misuse of your information.
- 4. How you can correct any inaccuracies in the information.

Information Collection, Use, and Sharing

We are the sole owners of the information collected on these sites. We only have access to/collect information that you voluntarily give us via email or other direct contact from you. We will not sell or rent this information to anyone.

We will use your information to respond to you, regarding the reason you contacted us. We will not share your information with any third party outside of our organization, other than as necessary to fulfill your request or if that third party has been contracted by ISNA to provide a service, e.g. to ship an order.

Individuals attending ISNA events may be audiotaped, videotaped, or photographed during the course of the event. By registering you grant permission to ISNA to broadcast, webcast, publish, or otherwise report these materials for use by ISNA. Your email will be included in the ISNA e-listserve. You will have the option to opt out from this list.

Unless you ask us not to, we may contact you via email in the future to tell you about specials, new products or services, or changes to this privacy policy.

Surveys and Contests

From time-to-time our site requests information via surveys. Participation in these surveys is completely voluntary and you may choose whether or not to participate and therefore disclose this information. Information requested may include contact information (such as name and address), and demographic information (such as zip code, age level). Contact information will be used to notify the participants. Survey information will be used for purposes of monitoring or improving the use and satisfaction of the program/service.

Your Access to and Control Over Information

You may opt out of any future contacts from us at any time. You can do the following at any

Security

We take precautions to protect your information. When you submit sensitive information via the website, your information is protected both online and offline.

Wherever we collect sensitive information (such as credit card data), that information is encrypted and transmitted to us in a secure way. You can verify this by looking for a closed lock icon at the bottom of your web browser, or looking for "https" at the beginning of the address of the web page.

While we use encryption to protect sensitive information transmitted online, we also protect your information offline. Only employees who need the information to perform a specific job (for example, billing or customer service) are granted access to personally identifiable information. The computers/servers in which we store personally identifiable information are kept in a secure environment.
