The West Lancashire (Parish) Order 2007

Coming into force in accordance with article 1(2)

The Secretary of State, in exercise of the powers conferred by sections 14 and 23 of the Local Government and Rating Act 1997(a), makes the following Order:

Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the West Lancashire (Parish) Order 2007.
 - (2) It shall come into force
 - (a) for the purposes of this article and proceedings preliminary or relating to elections of parish councillors to be held on the ordinary day of election in 2007, on the day after that on which it is made;
 - (b) for all other purposes, on 1st April 2007.
 - (3) In this Order—

"the new parish" means the parish constituted by article 2; and

"the map" means the map prepared by the Department for Communities and Local Government, marked "Map referred to in the West Lancashire (Parish) Order 2007" and deposited in accordance with regulation 6(1) of the Local Government (Parishes and Parish Councils) Regulations 1999(b).

Constitution of a new parish

- 2.—(1) A new parish, comprising the area outlined in blue on the map, shall be constituted within the district of West Lancashire
 - (2) The name of the new parish shall be Lathom South

Directions to establish a parish council

3. The West Lancashire District Council is hereby directed to establish a parish council for the new parish

Transitional Provision

4. Until the councillors elected to the council of the new parish of Lathom South at the elections to be held on the ordinary day of election in 2007 come into office, the new parish shall be represented by those persons who immediately before 1st April 2007 are the elected councillors for the district wards of Newburgh, Bickerstaffe and Derby

Order Date

5. 1st April 2007 is the order date for the purposes of the Local Government (Parishes and Parish Councils) Regulations 1999

This Order gives effect (with modifications relating to minor changes to the boundary of the new parish) to a petition sent to the Secretary of State for the creation as a parish of an area within the district of West Lancashire and for the establishment of a parish council for that area A map forming part of this note gives a general guide to the area concerned


Article 2 creates a new parish to be called Lathom South

Article 3 directs the West Lancashire District Council to establish a parish council for the new parish

Article 4 provides for the parish of Lathom South to be represented by the district councillors elected for the districts wards of Newburgh, Bickerstaffe and Derby until councillors for the new parish, to be elected on the ordinary day of election in 2007, come into office

Article 5 specifies 1st April 2007 as the Order date for the purposes of the Local Government (Parishes and Parish Councils) Regulations 1999, which make provision of general application in relation to orders such as this Order
