## 政綱 Election Platform:

- 町 要求機場管理局自行向乘客收取機場建設費,否則當局必須向旅行社支付 行政費。
- 要求機管局調低泊位停泊費,減輕航空公司成本。
- 成功促使落實興建機場第三條跑道,爭取在過渡期盡量增加班次,令航空 公司和乘客同樣受惠。
- 4) 曾舉辦旅遊業論壇,向標時委員會主席表明反對旅遊業實行標準工時。當 選後會繼續跟淮工作。
- 5) 協助酒店業減低經營成本,我會爭取在 2017-2018 財政年度免收酒店差餉。
- 6 善用旅遊業賠償基金龐大結餘,支援旅行社提升競爭力。
- 可 爭取旅遊業成立獨立政策局,把旅行社和酒店規管、推廣、旅遊基建及人力發展,集中統籌。
- 要求政府責成旅遊業議會,檢討商會與成員之間的溝通問題及其管治制度。
- 9 再次要求港府在適當時間恢復一簽多行,並且延長旅行留港時間,振興旅遊業零售業。
- 10) 要求投放充足資源,加強培訓本地導遊,提升本港旅遊業形象。
- I will request the Airport Authority to collect the Airport Construction Fund levy from travelers themselves, or alternatively request that the Airport Authority pay Travel Agents an administrative fee to cover our increased incidental costs.
- 2) I will request the Airport Authority to scrap the berthing fees, which will help to alleviate some costs for airlines.
- 3) I will urge the Government to finalize their plans for the construction of the 3<sup>rd</sup> runway, and in this transition period will push for an increase in the number of flights, benefiting both airlines and travelers.
- 4) During previously held discussion forums, I have expressed to the president of the Standard Working Hours Working Group that I object to the implementation of standard working hours for the Tourism Industry. After I am successfully elected, I will continue to pursue this task.
- In order to help the hotel industry reduce its operating costs, I will fight for the removal of Government Rates for hotels in the financial year of 2017-2018
- 6) I will ensure that the Tourism Compensation Sinking Fund is put to better use, and provide support for Travel Agents to increase their competitiveness.
- 1 will push for the Tourism Industry to establish an independent policy making body. This body will centrally govern travel agents and hotels, as well as promote the development of infrastructure and the workforce in the tourism sector.
- 8) I will request the Government to conduct a review on the Travel Industry Council, examining the inadequacy of the current levels of communication between the Council and its members, as well as the problems with its current governing system.
- 9) I will once again request the Government to reinstate the issuance of multiple entry permits for visitors from the mainland in the appropriate time. Furthermore, I will request that the permitted duration of their stay be prolonged, which will help to revive the currently dwindling retail and tourism sectors.
- I will request that sufficient funding and resources be injected into training programs for local tour guides, helping
  to lift the image of tourism sector.
