Pursuant to the Provisions of the Constitution and the laws of the State of Maine, the Senators-elect of the One Hundred and Twenty-Fifth Legislature convened in the Senate Chamber and were called to order by JUDITH DELFRANCO, Assistant Secretary of the Senate of the One Hundred and Twenty-Fourth Legislature.

Prayer by Rev. Dr. Patricia MacHugh of Bangor, District Superintendent for Northern Maine United Methodist Church.

They are really the unsung heroes in each one of our efforts and they are there, back at the home front, tending those fires while you are down here doing this work. As I remember when I was elected to the State Senate so many years ago and my family joined with me, this day should be about celebrations and enjoyment with them. I honor your families today.

Congratulations to all of them and all the sacrifices and hard work that they put up and will continue to put up with so we can do the work that we do for the people of Maine. Congratulations to them today.

I didn't notice, is the Chief Justice here today? I didn't want to leave out any dignitaries that are here today. I'd like to ask the Senate-elect if they would please rise to take the oath of office.

ELECTION OF SENATE OFFICERS

THE ASSISTANT SECRETARY: Nominations are now in order for the Office of President of the Senate of the 125th Legislature.

Senator **COURTNEY** of York **NOMINATED** Senator **KEVIN L. RAYE** of Washington for the Office of President of the Senate of the 125th Legislature.

THE ASSISTANT SECRETARY: The Chair recognizes the Senator from York, Senator Courtney.

Senator **COURTNEY:** Thank you Madame Secretary. Men and women of the Senate, it is my distinct honor to place in nomination for Senate President Kevin Raye. From Washington County to Washington D.C., Kevin Raye has repeatedly shown his leadership skills, not by the offices he has held but by the actions of a dedicated public servant. From a young volunteer for State Representative Olympia Snowe to the Chief of Staff for U.S. Senator Olympia Snowe, Kevin has worked tirelessly to improve the lives of Maine people. As a small business person, along with his wife, Karen, Kevin knows the challenges facing many Mainers today. He also knows that the only way to save our economy is through job creation and that we must remove the impediments to help create jobs. He knows state government needs to be a partner in job creation and not an impediment.

Kevin has been tested. His grace was tested when he lost a close Congressional race to Mike Michaud. Rather than be discouraged, Kevin Raye looked forward and arrived in the Maine Senate two years later, determined to change the way they do business in Augusta, not through bravado but through compassion and thoughtful deliberation. Not by fighting, but finding out where commonality exists and searching for ways to enhance it. Not by saying no, but by offering commonsense solutions for the people of Maine.

It was always expected that Kevin would rise to a leadership position in this caucus, but he did not seek leadership. He was called by the members of the caucus after what many felt was time for a new direction. With this charge from the caucus we set a new direction for dealing with the Majority. We made a commitment that we would work together to govern and, rather

than throw bombs across the hall, we would settle our differences quietly and respectfully.

The last two years have been the most financially challenging of our lifetime. The times have been too precarious for politics as usual. When differences did arise we did it respectfully and we honored the decorum of the Senate. We knew there would be ample differences to campaign on during the election cycle, but we were determined not to govern based on the next election.

I can tell you, serving along with Kevin Raye the last two years as Assistant Minority Leader, I have seen a leader that is compassionate, thoughtful, pragmatic, and inclusive. He listens respectfully even when he does not share that person's perspective. He is patient and respects all points of view. He has an ability not to react to a challenge but look at the entire picture. Kevin has proven again, over and over, that these traits are not a sign of weakness but a sign of inner strength. Kevin is a leader that can see beyond our immediate circumstances. Probably one of the most telling traits about Kevin Raye, and many of you have been there, is when he is sitting in a meeting and the phone rings. He sees that it's a call from Washington County and he always answers the phone. We all can sit and wait. We're very glad to do that because he really knows what is important in life. He's grounded and he's never forgotten where he came from.

Kevin has shown us he has the temperament to be Senate President. No better example of this is his respectful dealings with the transition process. His compassion for the previous staff during this difficult time is an example of how he treats people, regardless of party. It is my sincere hope that this example will become the standard for those who come after us. Madame Secretary, it is truly my honor to place in nomination the name of Kevin Raye for Senate President. Thank you.

THE ASSISTANT SECRETARY: The name of Kevin Raye has been placed in nomination for the Office of President of the Senate. Is there a second?

Nomination seconded by Senator **HOBBS** of York.

THE ASSISTANT SECRETARY: The Chair recognizes the Senator from York, Senator Hobbins.

Senator **HOBBS:** Thank you Madame Secretary. Men and women of the Senate, I rise today to second the nomination of my friend and colleague from Washington County to be the next President of the Maine Senate. A lot of things have changed since the Senate adjourned just a few months ago. One thing is the view from where I sit now. It is not nearly as good as where I sat before. One thing has not changed and that is the awesome responsibility entrusted by the voters to the 35 men and women who make up the Maine Senate. In just a few minutes we are going to elect an intelligent, passionate, and committed man to serve as the leader of this Body. Kevin has dedicated his life to public service. He has fought hard for the things he believes in and he has always remained committed to inclusion and bipartisanship. Those attributes, coupled with his skills as a policymaker, make him the right leader for this Body during these difficult times. We gather today under difficult circumstances. The budget forecast, while improving, remains grim. Unemployment is too high and too many people have lost the economic security that they have worked for all their lives. Let there be no doubt that the two parties will come at these problems from vastly different places, but it is also true that every person in

this chamber, regardless of party, wants these problems solved. In Senator Kevin Raye you will have a Senate President who will conduct the chamber's business in a manner that keeps us on track regardless of how hot the debate or how divisive the issue. Senator Raye's experience and temperament makes him uniquely suited for a position whose greatest responsibility is to bring people together to solve the very difficult problems that face our state. I'm honored to second the nomination of Kevin Raye for the position of President of the Senate.

Senator **KEVIN L. RAYE** of Washington took and subscribed to the oaths of office required by the Constitution to qualify him to discharge his duties as President of the Senate, pursuant to the Rules of the Senate.

The Governor withdrew from the Senate Chamber. (Amid applause, the Members rising.)

THE PRESIDENT: Allow me to express my heartfelt thank you, colleagues, for the confidence you have placed in me to serve as the 114th President of the Maine Senate. I am deeply touched. It is both a tremendous honor and so very humbling to be entrusted to lead this Body as we prepare for the work that lays ahead over the next two years. Thank you especially to my friend, the Senator from York, the Majority Leader, for his gracious and generous words in nominating me. It has been a pleasure to work closely with the Senator from York, Senator Courtney, since we both arrived in the Senate six years ago, and particularly these last two years in leadership together. I have been impressed with the thoughtful approach that Senator Courtney employs. He brings to bear a passionate commitment to his principles combined with a respectful ability to listen and to seek common ground, traits that will make him an excellent Majority Leader. Likewise, I thank the Senator from York, the Minority Leader, for the spirit of bipartisanship embodied in his kind and generous seconding of my nomination. Senator Hobbins has a long history in the Legislature and has shown an ability to forge consensus in his work on the Judiciary and Utilities and Energy Committees. I know that he will bring that spirit to his work in his new post and with so much important and difficult work ahead the positive and constructive working relationship that we have forged over the years will serve this Body and this state well. With my longtime friend, the Senator from Penobscot, Senator Plowman, and the good Senator from Cumberland, Senator Alford, rounding out the new leadership teams we have strong and talented people in place to help guide the work of the Senate.

I want to extend a warm welcome to all of our family and friends who are gathered here with us on this very special day and in all of our lives. Your presence makes this day even more special for all of us. I know that this is a day of great pride for each of you as you see your loved ones assume office as Senators. For me, personally, it is wonderful to have members of my family here. My wife, Karen, without whose love and support I would not be here today. My mother, Francis Raye, a teacher whose 38 years of devotion to her students inspired my passion for education. My in-laws, Barbara and Stan Howard, who are like another mother and father to me. Two of my brothers and their wives. My sister-in-law and her husband. Many nieces and nephews and cousins and friends. Thanks to each of you for being here. I want to thank also my friend, former Senate President Rick Bennett, for being here and for gracing this Chamber with his stirring rendition of the National Anthem. Thank you, Mr. President, for your service in this Body and helping to make this day so memorable for all of us. I'd like to especially acknowledge my good friend, former Governor John R. McKernan Jr. Jock is here not only as our former Governor who provided strong and courageous leadership during difficult times but he is also representing his roommate, our Senior United States Senator, my dear friend, former boss, and long time mentor, Olympia Snowe who is unable to be here due to votes in the United States Senate. Governor, thank you so much for being here. We are all honored by your presence.

Welcome to all of our Senators, both those who are returning for another term and those, more than one-third of this Chamber, who are beginning your first term today. For those of you who are just beginning your service in Augusta, you will find that while the headlines may shout about our disagreements most of what is done here in Augusta is done in bipartisan harmony. Where principle differences divide us, it need not be characterized by bitter recriminations and verbal bombs because, despite our different views, you will come to understand that each person who services here is motivated to do so by a love of this state and a sincere desire to make it a better place. Together, working with the other Body and with the new Chief Executive, we will face many challenges over the next two years. While recent projections suggest that the shortfall over the 2012-2013 biennium will be \$365 million less than previously estimated, the fact is we still face a very significant budget shortfall that will require hard decisions. We face a business climate weakened by a burdensome and confusing array of regulations as well as taxes, energy costs, and healthcare premiums significantly higher than our neighbors in New Hampshire. We face an embarrassing \$400 million debt to our hospitals that must be paid to preserve jobs and secure access to quality health care across the state. We face a precipitous drop in funding for education, exacerbated by a one-time infusion of federal funding that led many school districts to avoid more gradual spending reductions that could have provided a softer landing this year. We face unfunded liabilities, including the need for reform of the Maine State Retirement System. We face transportation needs that will require innovated new thinking and new approaches to squeeze more money out of existing resources because we cannot raise taxes on the hard working families of Maine. We possess important tools that will allow us to meet these challenges head on; determination, focus, thoughtfulness, mutual respect, and Downeast common sense. You know, Winston Churchill once said, 'A pessimist sees the difficulty in every opportunity. An optimist sees the opportunity in every difficulty.' We must face today's difficulties with optimism because we do have an opportunity to make the responsible decisions that will make Maine a stronger state in the long run. As we move forward together, I am looking forward to working with each of you as we craft a budget that establishes thoughtful priorities, maintains a commitment to education and to the most vulnerable among us, including our frail elderly and the severely disabled. We must work to put Maine on a stronger foundation for the future by improving our business climate. We must help make it possible for Maine's young people and working families to carve out a bright future and successful careers without pulling up stakes. That is why one of our first acts will be the creation of the Joint Select Committee on Regulatory Reform to consider L.D. 1, a measure to ease the regulatory burdens on Maine's job creators and signal that Maine is open for business. Soon after his inauguration our new Governor will be unveiling a proposal to provide a more detailed framework for the committee's work. In the wake of this historic election, we need to challenge the status quo, so the Joint Select Committee on Rules will be taking a careful look at how this Legislature does business and how we can work smarter and better. We must also share in the sacrifice that is required to secure a balanced budget without raising taxes. That is why I have already taken steps to ensure that the budget in the President's Office and in the Senate's partisan offices will be reduced from previous levels. The people of Maine will be watching us and we will lead by example. That also includes

taking steps to heal the divisions between the two Maines by demonstrating sensitivity to the concerns of parts of this state that have felt left behind by policies pursued here in Augusta. We must recognize that as long as any region of this great state does not share fully in prosperity and opportunity we are all diminished. We will strive for thoughtful balance, balance between preserving vital services and achieving a smaller and more efficient government, balance between rural and urban, balance between preserving our cherished environment and preserving jobs, and balance between the needs of our workforce and ability of employers to continue to provide jobs. Together we can help change the culture of state government. Together we can help create a Maine State Government that is caring and responsible, efficient and affordable, and transparent and effective. Thank you and God bless you. Enjoy this day with your families and friends.

Senator **COURTNEY** of York was granted unanimous consent to address the Senate on the Record.

Senator **COURTNEY**: Thank you Mr. President. Men and women of the Senate, I'd like to start out by congratulating my good friend from York, Senator Hobbins, and my good friend from Cumberland, Senator Alford, on their leadership positions. I've thoroughly enjoyed working with them in the past two years, and the past six years with the Senator from York, Senator Hobbins. I am looking forward to continuing that.

It's with great humility and a sense of duty that I stand before you today. Two years ago Senate Republicans committed to work together with a Democrat majority to solve some of the most difficult challenges of our lifetime. We knew that we could not simply look to the next election for if we did we would be doing a disservice to the people who sent us here. We choose a new direction. Together, with our caucus, we transformed our party from the party of no to one that offered common sense solutions. Instead of walking away from the table when times got tough we persevered and forced ourselves to find common ground. We did this not by compromising our principles but by working respectfully, even when we disagreed.

We've had a lot of time in the Minority to learn some very important lessons. We learned that even though you may have the votes it's better to work together because the other side might come up with an idea that's a better solution than either side thought possible and one should never dismiss an idea just because it comes from a Minority member. Under Senator Raye's leadership the bar for the loyal opposition has set very high. We have all been sent to govern and govern we shall. We will always endeavor to work together to put people before politics.

When I was in the other Body as a Freshman I got bumped from my seat. The Senator from York, Senator Collins, wanted his seat back, so I got bumped to the end of the line in the next to the last row. I was the last Republican actually. I got to sit next to an experienced Democratic legislator, someone who is in this Body today, the Senator from Cumberland, Senator Gerzofsky. He shared a lesson with me that I've tried to live by. Although the first lesson he taught me was how to vote. I knew if I voted opposite of him I would always vote right. Probably the lesson that has lasted with me to this day is that he told me to fight for my beliefs but not to take the debate personal. In some strange twist of faith, the Senator from Cumberland, Senator Gerzofsky,

may be one of the reasons why I am standing here today. Don't be too tough on him in the caucus, he really is a good guy. In all seriousness, I think that just sets the tone and it's a tone that, especially for the incoming members, you can't just turn on and off. You've come off a campaign. We've all come off campaigns. Now is the time to govern. If we try to live by that creed I think we will do the people of Maine a good service.

We're also grateful for the cooperation and grace that has been shown during this transition. We understand that you are not accustomed to being in the Minority. We are not accustomed to being in the Majority. We will both make mistakes on our new journey, but let us resolve together to work through the mistakes and put the people of Maine first. Thank you Mr. President.

Senator **HOBBS** of York was granted unanimous consent to address the Senate on the Record.

Senator **HOBBS**: Thank you Mr. President. Men and women of the Senate, that is going to be a very tough act to follow. My best wishes to you, the gentleman from York, Senator Courtney, and the Senator from Penobscot, Senator Plowman. We look forward to working with you.

As Democrats sitting on this side of the aisle we find ourselves playing a new role. We have heard the voters and we respect what they had to say. Our new status means that we no longer have the votes to pass our preferred legislation, but being in the Minority does not give us carte blanche to be a bone in the throat of the Majority Party. Rather it means that we will offer constructive criticism, an alternative vision, and collective knowledge to help forge important public policy. It is important that both parties operate with a spirit of bipartisan cooperation. We must work together in good faith to solve the State's financial problems, to make government smarter and more efficient, and to create an environment more conducive to job creation. Bipartisanship and good faith cooperation does not mean we will agree on everything or that every vote will be unanimous. There will be issues that cut fundamentally at who we are as people and on those issues the Democratic caucus will stand strong as the loyal opposition. We will fight to protect against austere cuts to services to the elderly, the disabled, and the very young. We will stand up when legislation threatens the civil rights of any Maine person and we will never fail to give a voice to every person who goes to work every day in an effort to provide for their families. Like the people of Maine, we know that we can move Maine forward but only by working together. Divisiveness and petty politics may serve short term political gain, but they do not provide a service. They provide a disservice to the people of this state. As I said earlier, the voters have placed with us a tremendous amount of trust. Only by extending that trust to one another will we be able to meet the extraordinary challenges that face us at this time. I look forward to working with all of you in the Maine Senate. I join with my able members of the caucus, the Democratic caucus, and my able Assistant Leader. We look forward to forging a better Maine. Thank you very much.

At this point, the President noted the presence in the Senate Chamber of Senator-elect **SAVIELLO** of Franklin. In accordance with a long-standing and unique tradition of the Maine Senate, the

Senator-elect from Franklin was absent to attend to and stoke the furnace. The President requested the Senator from Lincoln, Senator **TRAHAN**, along with four former Senators from Franklin, Senator **WEBSTER**, Senator **BENOIT**, Senator **WOODCOCK**, and Senator **GOOLEY**, to escort the Senator-elect from Franklin, Senator-elect **SAVIELLO**, to the Governor's Office for the purpose of taking and subscribing to the oaths of office required by the Constitution.

The Senators and Senator-elect were escorted to the Governor's Office.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Collins.

Senator **COLLINS**: Thank you Mr. President. Ladies and gentlemen of the Senate, I've known Joe Carleton for well over 20 years. Joe has a law practice in the town of Wells. During his tenure there he has also been the moderator of our town meetings. Joe was my predecessor in the House. He did his four terms in the House. I'm not sure for what reason, he took a fancy to Mason's Rules of Order and those are the rules of order we follow here in the Maine Legislature along with many other state legislatures. He made a study out of it. It is very important to us to have a Secretary who is very well versed in Mason's Rules of Order. Like I said previously, I've known Joe for well over 20 years and we are both members of our local Rotary Club. I know Joe is probably going to be missing some meetings since he'll be

up here. I also will be missing a few meetings. Nevertheless, we need Joe's input. He is considered by many to be an expert on Mason's Rules of Order and we need his knowledge. I look forward to working with Joe. I thank you very much for your kind attention and hope you agree with me that Joe will make a great Secretary of the Senate. Thank you.

THE PRESIDENT: The name of Joseph G. Carleton Jr. of Wells has been placed in nomination for the Office of Secretary of the Senate. Is there a second?

Nomination seconded by Senator **HILL** of York

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Hill.

Senator **HILL:** Thank you Mr. President. Ladies and gentlemen of the Senate, I want to share with you that I was delighted to be asked to do this nomination because I met Mr. Carleton 30 years ago, after graduating law school and having moved to Maine. While I was preparing for the Bar he offered me a part-time job, which worked out beautifully. WHEREAS, Maine was recently ranked by Forbes magazine as the worst state in the nation in terms of its business climate; and

WHEREAS, it is essential to improving the business climate in Maine that legislation providing real and meaningful regulatory fairness and reform be enacted prior to the adjournment of the First Regular Session of the 125th Legislature; and

WHEREAS, meaningful regulatory fairness and reform must, by definition, cut across the traditional jurisdictional boundaries of the different joint standing committees of the Legislature; and

WHEREAS, meaningful regulatory reforms must be developed in a coordinated manner, with full transparency and fairness and in the shortest possible time frame; now, therefore, be it

ORDERED, the House concurring, that the Joint Select Committee on Regulatory Fairness and Reform is established as follows.

1. Establishment. The Joint Select Committee on Regulatory Fairness and Reform, referred to in this order as "the committee," is established.

2. Membership. The committee consists of 15 members of the Legislature: 5 members of the Senate appointed by the President of the Senate and 10 members of the House of Representatives appointed by the Speaker of the House of Representatives. The President of the Senate shall appoint no more than 3 Senators from the party holding the largest number of seats in the Senate and no more than 2 Senators from the party holding the 2nd-largest number of seats in the Senate. The Speaker of the House of Representatives shall appoint no more than 6 Representatives from the party holding the largest number of seats in the House of Representatives and no more than 4 Representatives from the party holding the 2nd-largest number of seats in the House of Representatives. Nothing in this section

precludes the appointment of a member who is not a member of the party holding the largest number of seats or the 2nd-largest number of seats in the chamber. The first-named Senate and House members shall serve as cochairs of the committee.

3. Duties. The committee shall make recommendations on improving the business climate in the State and facilitating private-sector job creation by reforming the regulatory structure to ensure that the regulatory process is more efficient and less costly to the regulated community, eliminating duplicate or unnecessary regulatory procedures, streamlining and reducing the time required to obtain necessary business permits, ensuring that balanced, transparent and more predictable decision-making processes exist within the regulatory agencies and making any other necessary changes.

4. Authority. The committee shall hold public hearings and work sessions on any legislation referred to it and shall vote on and report out such legislation to the appropriate chamber in the manner prescribed in Joint Rule 310.

5. Meetings; staff assistance. The committee and any authorized subcommittees may meet on days and at locations, including locations across the State, jointly authorized by the President of the Senate and the Speaker of the House of Representatives. The Legislative Council shall provide staffing to the committee. The cochairs of the committee may request technical assistance from appropriate sources whenever necessary. The committee shall report out all legislation referred to it in accordance with deadlines established by the President of the Senate and the Speaker of the House of Representatives.

6. Termination. The committee terminates on June 15, 2011.
