HISTORICAL AND/OR ARCHITECTURAL SIGNIFICANCE

The Reverend C.S. Soule, pastor of the H.P. Presbyterian Church from 1880 until 1886 lived in this home. He died in Ravenswood in 1893. The date of actual construction is unknown, but the residency of Rev. Soule gives a clue as to date. Rev. Soule was a professor of Latin at Highland Hall, the "female school" located at the northeast corner of St. Johns and Ravine Drive.
