### VERIFIED NOTICE OF EXEMPTION

Pursuant to 49 C.F.R. §1150.41, et. seq., Elkhart & Western Railroad Co. ("EWR"), a Class III rail carrier, hereby files this Verified Notice of Exemption to acquire and operate a line of railroad owned by CSX Transportation, Inc. ("CSXT") between Monon, Indiana (Milepost 0QA-88.42) and Monticello, Indiana (Milepost 0QA-98.00), as shown on Exhibit A, attached hereto, in White County, Indiana (the "Line"). Based on projected revenues for the Line, EWR expects to remain a Class III rail carrier after consummation of the transaction proposed herein.

CSXT previously sought to abandon the Line, which was denied in *CSX Transportation, Inc.-Abandonment Exemption-White County, IN*, Docket No. AB-55 (Sub-No. 712X) (served September 19, 2014). CSXT embargoed the Line on March 10, 2017 due to the condition of the Line. EWR intends to repair the Line upon acquisition and to provide service to any shippers on the Line, including Monticello Farm Service, Inc.

In accordance with the requirements of 49 C.F.R. §1150.43, EWR submits the following information:

### Statement Concerning Agreement: 49 C.F.R. §11500.43(c)

EWR has reached agreement in principle with CSX Transportation, Inc. ("CSXT"), the current owner/operator of the Line, providing for EWR to acquire CSXT's interest in the Line, and for EWR to operate the Line between Monon, Indiana (Milepost 0QA-88.425) and Monticello,

Indiana (Milepost 0QA-98.00), a distance of 9.58 miles

### Operation of the Property: 49 C.F.R. §1149.43(d)

EWR will operate, maintain and provide all rail common carrier services on the Line.

### **Brief Summary of the Transaction:** 49 C.F.R. §1150.43(e):

Pursuant to the Agreement with CSXT, EWR proposes to acquire, operate, maintain, and perform all common carrier service on the Line. EWR will interchange with CSX at Monon, Indiana. There are no restrictions on interchange.

The Line is currently owned and operated by CSXT.

EWR is controlled by Pioneer Railcorp, See Finance Docket No. FD-35323, Served

December 2, 2009, <u>Pioneer Railcorp – Continuance in Control Exemption – Georgia Southern</u> <u>Railway Co</u>. EWR currently operates three lines of railroad: (1) between Elkhart, IN and Mishiwaka, IN. <u>See</u> Finance Docket No. 33941, Served October 10, 2000, <u>Pioneer Railcorp and Michigan</u> <u>Southern Railroad Company – Corporate Family Transaction Exemption</u>; (2) between Argos, IN and Walkerton, IN. <u>See</u> Finance Docket No. 35347, Served October 14, 2016, <u>Elkhart & Western</u> <u>Railroad Co. – Amended Lease and Operation Exemption – Norfolk Southern Railway Company</u>; and (3) between Argos, IN and Rochester, IN. <u>See</u> Finance Docket No. 35453, Served February 9, 2011, <u>Elkhart & Western Railroad Co. – Trackage Rights Exemption – Fulton County, LLC, d/b/a</u> <u>Fulton County Railroad</u>. None of these lines physically connect with the Line, nor are there any plans to connect them (Rochester, IN is approximately 47 miles from Monon). EWR will operate the Line as a separate line.

(1) The name and address of the railroad transferring the subject property to the Class III rail carrier applicant:

CSX Transportation, Inc. 500 Water Street Jacksonville, Florida 32202

(2) The proposed time schedule for consummation of the transaction:

Under the Agreement, consummation of this transaction will occur on or about January 30, 2018, and operations under this exemption will begin thereafter.

(3) The mileposts of the subject property:

The Line extends from the connection with CSXT at/near Monon, IN ((Milepost 0QA-88.42), to a point in Monticello, IN (Milepost 0QA-98.00), in White County, Indiana.

(4) The total route miles being acquired:

The length of the mainline trackage is approximately 9.58 miles.

### Map: 49 C.F.R. §1150.43(f):

A map showing the Line and the surrounding trackage is attached as Exhibit A of this Notice.

# Certificate of Compliance: 49 C.F.R. §1150.43(g):

A Certificate of Compliance with the provisions of 49 C.F.R. §1150.33(g) is attached as Exhibit B to this Notice.

### Transactions Imposing Interchange Commitment: 49 C.F.R. §1105.43(h):

The proposed acquisition and operation of the Line does not involve a provision or agreement that would limit future interchange with a third-party connecting carrier.

### Environmental and Historic Preservation Data: 49 C.F.R. §1105:

Under 49 C.F.R. §1105(c)(2), EWR's proposed acquisition and operation of the Line is exempt from environmental reporting requirements. The proposed transaction will not result in significant changes in carrier operations, <u>i.e.</u>, changes that exceed the thresholds established in 49 C.F.R. §1105.7(e)(4) or (5).

Under 49 C.F.R. §1105.8(b)(1), EWR's acquisition and operation of the Line is also exempt from historic preservation reporting requirements. The proposed lease is for the purpose of continued rail operations. Further Surface Transportation Board approval is required to discontinue or abandon service, and there are no plans to dispose of or alter properties subject to Board jurisdiction that are fifty years old or older.


