Prof. Thomashausen grew up in Portugal, studied in France, Germany and the UK and then graduated in law in Germany where he is fully admitted as an attorney. He is a senior legal academic of 35 years standing in South Africa with an established international profile and publications in Europe, China and Africa. His work covers a wide range of legal studies. He is considered a specialist and expert in his main focus areas of constitutional law, transitional constitutional law, constitutionalism, and peacekeeping. He is also internationally acclaimed for his contributions in international law, contemporary law in Africa, natural resources law, law of international commercial transactions, transnational corporate and private international law and anti-corruption law. He has published widely in all these fields, in English, German, French, Portuguese, Turkish and Mandarin.

Professor Thomashausen combined his academic life with many managerial responsibilities:

- From 1974 to 1981 he built up and managed in Northern Germany the adult education and political engagement work of *Fortbildungswerk für Studenten und Schüler FWS*, administering over one million Deutsche Mark in project and donor funding.
- From 1983 to 1986 he acted as negotiator and drafter for the Lesotho Highlands Water Treaty on behalf of the South African Department of Water Affairs (1983 to 1986).
- 1984 to 1991 he acted as international law consultant to the then largest firm of attorneys in South Africa, Webber Wentzel; whilst serving as Director of Bischoff International chaired by the late Paul H. Bischoff, then President of the Southern African German Chamber of Commerce and Industry.
- From 1986 to 1991 he was the regional representative for Southern Africa of Herbert Quandt Foundation, a Foundation of BMW AG, responsible for a program known as "Development Law Strategies", organizing and financially administering 26 strategic workshops and conferences over 5 years, in anticipation of the political change in South Africa in 1992.
- From 1990 until 1994 he assisted the negotiation of and drafted most of the General Peace Accord for Mozambique, and then served as Special Advisor to the Special Representative of the Secretary General of the United Nations Operation in Mozambique – UNOMOZ.
- Based on his UNOMOZ experience, he consulted for the Angolan Presidents Office from 1998 until 2004 on conflict resolution in that country.
- From 1997 to 1998 he incorporated and developed the ID-SOFT group of companies, a software development group dedicated to data compression, data encryption and application software for high-density barcodes in support of the South African card drivers licence project.
- In 2006 he advised the Angolan government on its naval rehabilitation program and conducted research on the legal framework for an integrated Southern Atlantic Maritime Security system.
- Since 2004 he acts as a member of the Senior Council of the Southern African German Chamber of Commerce and Industry.

• Since 2016 he has been acting as Subject Matter Expert (SME) in Government Performance Assessment to the Federal Entities in the United Arab Emirates as well as to the State of Ajman Excellence Award Programme (AJEP) and the State of Abu Dhabi Award for Excellence in Government Performance (ADAEP).

Professor Thomashausen's academic career culminated in his nomination and admission as a member for Academia Europaea in 2012. He is currently ranked by one the World leading academic publishing websites, ACADEMIA.EDU as amongst the top 2% globally cited academic authors (see https://unisouthafr.academia.edu/AndreThomashausen). From January 2008 until August 2014 he combined his position of chair of Unisa's Centre of Foreign and Comparative Law (which he holds since 1984) with that of chair of the Department of Public, Constitutional and International Law — PCI-Law. He transformed PCI-Law into a flagship department at Unisa with a fully racially integrated and representative lecturing staff of 36, including 4 full professors and 2 Associate Professors, comprising 64% staff from designated and formerly disadvantaged population groups, serving over 20.000 undergraduate plus just over 300 post graduate (dissertation) student enrolments (masters and PhD levels). Professor Thomashausen is also responsible since 1984 for South Africa's most widely read law journal internationally, the Comparative and International Law Journal of Southern Africa - CILSA (which is an international accredited IBSS journal).

The 26 Development Law Strategies workshops, seminars and conferences, during the period from 1987 to 1991, brought together a total of 172 academic speakers and 1 373 participants. Of these, 76 speakers (44%) and 570 participants (41,5%) were Black.

The Conference on Constitutional Issues in 1990 saw the return to South Africa for the first time after decades in

exile, on invitation of Professor Thomashausen, of three senior ANC members: Advocate N. Masimola (from London), Dr T. Pekane (from Brussels), and Professor K. Asmal (from Dublin), who addressed the Conference on the topics "Managing the Constitutional Transition", "Chieftainship in a Period of Transition in South Africa", and "Decentralisation in a Unitary State", respectively.

The Conference on "Conflicts and Negotiations" in 1991 presented five renowned foreign speakers, and was addressed by Professor Kadar Asmal and Mr Jacob Zuma on behalf of the ANC. This was at a time when neither negotiations, nor indemnities for ANC members were yet a certainty.

The Development Law Strategies Project was the result of a co-operation agreement negotiated and concluded in 1986 by Professor Thomashausen with the Herbert Quandt Foundation of BMW Germany. It created a continuous series of forums for free debate on the inevitable transformation of South Africa. The Development Law Strategies debates and proceedings brought many personalities who were to become key players in subsequent years, together for the first time. It also identified many of the major reform issues of the new South Africa.
