Friends of the Boardwalk



When you think of a classic, popular shore scene in New York, what location comes to mind? For many, it is Coney Island. The Friends of the Boardwalk is a nonprofit, volunteer-based organization that works to ensure a safe and clean boardwalk at Conev Island for all to enjoy. Since 1998 the volunteer-based organization has worked to improve the boardwalk for the residents and visitors each year.

Currently, the main focus of the group is the severe state of disrepair of the boardwalk and the lack of City support to make repairs. Friends of the Boardwalk works to find solutions and to provide a safe location for "shore" fun. Also, the Friends donated a gazebo on the boardwalk.

In addition, Friends of the Boardwalk monitors for pollution. Volunteers collect information about litter or "floatables" on Coney Island beaches and send the reports to the Parks Department. Recently, the group joined other organizations in opposing the Southwest Brooklyn Waste Transfer Station proposed for Bensonhurst, which is nearby Coney Island, that threatens environmental quality and marine life. The group participated in a flotilla protest against the proposed station.

"We want to make sure that the boardwalk at Coney Island is a safe and clean place to go," said Todd Dobrin, President of Friends of the Boardwalk.

The organization supports plans for a bike path and beach access ramps to the high water mark for the elderly or health-impaired. The Friends also organizes a program called "Classroom on the Pier"

NJ Assemblymen Launch State Effort to Support the COZ

A bi-partisan New Jersey Assembly resolution will be introduced when session resumes in November to urge the US Congress and President to pass The NJ/NY Clean Ocean Zone Act (H.R. 2854). The measure will be introduced by prime sponsor NJ Assemblyman Sean Kean (R-11) and co-prime sponsor Asm. Reed Gusciora (D-15). The announcement was



made at an August 20th press conference at which US Representative Chris Smith (R-4), a current federal co-sponsor of the bill, participated. This measure marks the start of the process to gain state support for the COZ in New Jersey.

NJDEP Jeopardizes Future Protection of Waterways



The New Jersey Department of Environmental Protection (NJDEP) is proposing changes to the definition of "Category One waters." Category One (C1) waters receive the second highest protection against degradation in New Jersey. Waterways designated as C1 are protected from measurable changes in water

quality. Designating waterways as C1 is extremely important for the health of our rivers and the downstream ocean.

The change will extremely narrow the definition and will drastically limit the NJDEP's ability to upgrade waters to C1. The change excludes from consideration a significant amount of saline and brackish waters, found at and near the coast. This means the proposed rule will keep many of these waters in the bottom tier of protection. COA strongly opposes this proposed change.

At the same time, these rules propose adding 910 river miles to C1 status under the new definition. COA supports upgrading these waters, as they do merit protection. However, COA does not accept coupling these upgrades with the proposed definition.

COA's comments submitted on August 20th were also signed by nine other organizations: Bayshore Regional Watershed Council, Fishermen's Conservation Association, Garden Club of Long Beach Island, Monmouth County Audubon Society, Natural Resources Protective Association, PaddleOut.Org, Raritan Riverkeeper, Sisters of St. Dominic, and WATERSPIRIT. WASTING OUR WATERS AWAY

Beneficial Reuse of Wastewater

The NJDEP proposed changes to the Water Quality Management Planning rules. COA commented specifically on some proposals regarding reclaimed water (effluent from wastewater treatment plants) for beneficial reuse (RWBR). According to NJDEP, RWBR is water that is to be re-used for non-potable uses instead of using potable water or diverted surface or ground waters. Different uses of RWBR require different levels of treatment.

COA generally commends the Program Objective of preserving quality water and reducing the export of freshwater out of basins. However, COA requested that NJDEP adopt a Vision Statement to add clarification to these goals and staff to manage this program. COA believes NJDEP should explicitly state that RWBR programs will not allow for development into regions traditionally limited by inadequate water supplies. Also, COA recommended NJDEP address treatment for endocrine disrupting chemicals, which alter reproductive systems of humans and aquatic life, and emerging contaminants.

Companies Invest in a Clean Ocean with Sweat Equity

What do 6,128 bottle caps, 4,364 cigarette filters, and a pair of dentures have in common? They were all collected this summer during COA's Corporate Beach Sweeps program. Through the dog days of summer, corporations in New Jersey and New York invested in a cleaner ocean by sending their employees to Sandy Hook to become part of the solution to ocean pollution. Over 600 employees from **Goldman, Sachs & Co.** and **iCIMS** cleaned over ten miles of Sandy Hook bay and ocean beaches.

"The Beach Sweeps program is a great opportunity for our employees to get out and see the results of their efforts," said **Colin Day, iCIMS President and CEO**. Employees of iCIMS are granted two days per year for "green" volunteerism, contributing to environmental progression through non-financial means.

Goldman Sachs Community TeamWorks (CTW), is an annual, global volunteering initiative that gives the people of Goldman Sachs one day away from the office, May through August, to volunteer in a team-based project organized with a local nonprofit organization. In 2007, they mobilized over 20,900 volunteers globally to make an impact in their local communities.

2007 Corporate Beach Sweeps Top Five Items:

6,128 plastic bottle caps and lids
4,416 plastic food and candy wrappers
4,364 cigarette filters
3,436 plastic straws and stirrers
2,422 pieces of plastic and foam

The Corporate Beach Sweeps program is an activity that provides awareness, knowledge, and hands-on experience. Participants learn about nonpoint source or "people" pollution and its ill effects on the ocean and marine life. During the Sweeps, employee teams collect harmful and unsightly litter from beaches and record information about the debris using datacards. The top five items found during the corporate cleanups (see box) come from people, which can be reduced through public awareness and education.

The program provides worthy "take-home" lessons, including how people can be good environmental stewards. Many participants learn ways to reduce the amount of trash they produce, and proper ways to dispose waste, including recycling. Further, they are reminded that litter and other pollutants in streets and parking lots miles away from the beach make their way to the ocean with every rainfall.
