# DND BIDS AND AWARDS COMMITTEE 1 RESOLUTION NO. DND/PA-TGS-R3-19-04

"A Resolution Declaring the Joint Venture of Wolfberry Asia Pte Ltd and PT Indocertes as the Single Calculated and Responsive Bidder for the Acquisition of Tank Gunnery Simulator Project of the Philippine Army and the Issuance of Notice of Award in its favor"

WHEREAS, on 6 December 2018, the Secretary of National Defense (SND) issued Acquisition Decision Memorandum (ADM) No. 2018-047 directing the acquisition of one (1) unit Tank Gunnery Simulator Project of the Philippine Army with an Approved Budget for the Contract (ABC) in the amount of PhP36,200,000.00, which shall be procured through Negotiated Procurement, "Government-to-Government" pursuant to Section 4 of the 2016 RIRR of RA 9184, without precluding other modes as may be allowed and determined to be more advantageous to the government;

**WHEREAS,** on 23 August 2019, SND noted the recommendation of the DND Bids and Awards Committee 1 ("Committee," for brevity) for the change in the Mode of Procurement from Negotiated Mode of Procurement to Public Bidding;

**WHEREAS**, the Committee conducted the Pre-bid Conference for the project on 29 November 2019 which was participated by three (3) prospective bidders, namely: (1) JV of Bohemia Interactive Simulations Inc and Precision Munitions Inc., (2) JV of Wolfberry Asia Pte Ltd and PT Indocertes and (3) SSEI.

**WHEREAS**, on 11 December 2019, the Committee conducted the Submission and Opening of Bid Evaluation (SOBE) for the project and was participated by two (2) prospective bidders, namely: (1) JV of Bohemia Interactive Simulations Inc and Precision Munitions Inc and (2) JV of Wolfberry Asia Pte Ltd and PT Indocertes.

**WHEREAS,** in the same conference, during the evaluation of the eligibility and technical requirements, the Joint Ventire of Wolfberry Asia Pte Ltd and PT Indocertes was declared as the Single Calculated Bidder (SCB) through Resolution No. DND/PN-SRLL-19-R-01.

**WHEREAS,** on 19 December 2019, the Committee issued Resolution No. DND/PA-TGS-19-R3-03 directing the conduct of post-qualification on the

Joint Venture of Wolfberry Asia Pte Ltd and PT Indocertes, as well as the approval of the Composition of the Post-Qualification Team and Alternates scheduled within 21-28 December 2019 and the corresponding Post-Qualification Plan;

WHEREAS, USDP, OIC USND issued Travel Authority No. 1939 dated 20 December 2019 approving the travel of MGEN REYNALDO M AQUINO O-9632 AFP and three (3) others to conduct the post-qualification on the Joint Venture of Wolfberry Asia Pte Ltd and PT Indocertes for a period of seven (7) days, inclusive of travel time, anytime from 21 to 28 December 2019;

**WHEREAS,** the PQ Team conducted post-qualification on the Joint Venture of Wolfberry Asia Pte Ltd and PT Indocertes in Singapore and Indonesia from 21-24 December 2019 to verify, validate and ascertain all the submitted eligibility documents of the bidder during the SOBE;

WHEREAS, on 23 December 2019, the PQ Team presented its PQ report and found that the Joint Venture of Wolfberry Asia Pte Ltd and PT Indocertes is compliant and responsive to all the requirements set forth in the bidding documents and recommended to the Committee that it be declared as Post-Qualified and the Single Calculated and Responsive Bidder (SCRB) for the Acquisition of Tank Gunnery Simulator Project of the Philippine Army, as well as the issuance of Notice of Award (NOA) in favor of the said bidder;

**NOW,** THEREFORE, we, the members of the DND Bids and Awards Committee 1, upon the recommendation of the TWG, resolve, as it is hereby **RESOLVED**, to approve the following:

- a) to declare the Joint Venture of Wolfberry Asia Pte Ltd and PT Indocertes as post-qualified;
- b) to declare Joint Venture of Wolfberry Asia Pte Ltd and PT Indocertes as the Single Calculated and Responsive Bidder (SCRB) for the Acquisition of Tank Gunnery Simulator Project of the Philippine Army with a bid price in the amount of **PhP36,100,000.00**.
- c) to recommend to the Secretary of National Defense (SND) the issuance of a Notice of Award (NOA) in its favor.
