Subordinate to him is the Municipal Commissioner who is supported by one Additional Commissioner and one Deputy Commissioner. The Secretary is the elected head who presides over Corporators. Kakinada Municipal Corporation is divided into 50 wards.
	The Municipal Corporation collects taxes (water, land, property etc.), manages city solid waste, provides building permission and its evaluation, municipal schools and health care system etc. It also builds roads, drains; provide water connection to the households lying under its jurisdiction.
