SIGNIFICANCE

Understated, but one of Evanston's loveliest courtyard buildings, the Oak Ridge Apartments were featured in A.J. PARDRIDGE and HAROLD BRADLEY'S Directory to Apartments of the Better Class Along the North Side of Chicago as "a high grade artistic building containing four- five- seven-and eightroom apartments, with a comfortable private sun parlor, enclosed and heated." The windows are large, providing ample light, ventilation and views of the "artistically landscaped", electrically lit courtyard. Inside, most apartments have maids rooms and butlers pantries. Each apartment has a living room or dining room with an attractive wood-burning fireplace, some of glazed brick Many apartments have French doors separating the rooms. The architect, Andrew Sandegren, was known for having designed a number of upper class apartments on Chicago's near north side (305 Fullerton, 325 Fullerton, 1235-45 Asto 3122 Sheridan Road), yet he chose as his own home, 1625 Ridge. The Oak Ridge was published in the Architectural Record in January 1922 in one article in a series by Frank Chouteau Brown on "Tendancies in Apartment House Design.
