SPEED

Having a fast transaction confirmation time is important. Users want to see their coins travel across the globe instantly. Since Masternodes scale in a linear way, our network has the potential to support many thousands of transactions per second. Instead of performing useless computations to mine the next block, Masternodes use transaction locking and consensus[5] to maximize the use of every watt of electricity to enhance the speed and security of the network. The result is a nearly instantaneous transaction system that does not rely on a centralized authority.

"Virtual Currencies may hold long-term promise, particularly if the innovations promote a faster, more secure and more efficient payment system." - Ben Bernanke[6], Congress address. Elunium will challenge the status quo of big payment processors in the competitive market of online and offline transactions.

LOW FEES

We believe in the original vision: a cryptocurrency should perform well for all use cases. We want it to be fast, user-friendly, practical, and above all, carry a low transaction cost. We need to be able to do micro-payments of a cent and big payments all the same. A study from 2011[7] asserts that the cost and inconveniences associated with a payment method discourage its use in online transactions.


