From 1974 (when WYP formed) – to 31st December 2018 there are 114 undetected murders.

This list also includes the 1974 M62 Terrorist Attack where 12 victims lost their life.

West Yorkshire Police is currently undertaking a review to understand the outcomes of investigations into all previous homicides. This includes a review of all cases where suspects were charged but were subsequently acquitted at court. This may have been for numerous reasons and understanding this is crucial. Equally cases with no suspect charged may not necessarily be 'unsolved' dependent on the circumstances.

Cases classed as 'undetected' encompass any case where no suspect has been charged or where no conviction has been secured against a suspect. However, within these will be cases that West Yorkshire class as 'resolved'. These can include cases whereby the evidence clearly indicates an individual suspect, however a conviction cannot be obtained.

They will also include cases where suspicious deaths have been crimed as homicide in order to comply with Home office counting rules and whilst subsequent investigations establish no evidence of any criminal intent, the additional verifiable evidence required to cancel the crime is not currently attainable.

All undetected cases are subject to review and these figures are subject to further investigation, reclassification and cancellation, and may therefore change over time
