#### The Kingdom of Netherlands

# 1. Bilateral relations

#### **Brief information**

On the 31<sup>st</sup> of December, 1991 the Kingdom of Netherlands has recognized the independence of the Republic of Azerbaijan and on the 1<sup>st</sup> of April, 1992 the diplomatic relations have been established between two countries.

The embassy of the Republic of Azerbaijan to the Kingdom of Netherlands was opened in 2007.

#### Chronology of the main official relations

03-05<sup>th</sup> of May 1994, 1995 and 22-23<sup>th</sup> of April 1996 the President of Azerbaijan H.Aliyev paid working visits to Belgium. The main goals of the visits were to discuss the issues related to the cooperation of Azerbaijan with NATO and the EU.

13-15<sup>th</sup> of April 1998 the |Prime Minister of Belgium Jean-Luc Deheane paid an official visit to Azerbaijan.

17-19<sup>th</sup> of May 2004 the Prezident of Azerbaijan I.Aliyev paid a working visit to Belgium to participate in the session of the Council on Common issues and foreign affairs of the EU and to meet with the representatives of NATO.

21-24<sup>th</sup> of November 2004, the commander of the Armed Forces of Belgium, the general O.Vandel paid a visit to Azerbaijan.

In 1998 a delegation headed by A.Bogue, the Minister of Economy of Netherland, paid a visit to Azerbaijan and met with the deputy PM A.Sharifov to discuss the issues related to the development of bilateral relations.

29 November-17 December 1999, the deputy Minister of Agriculture of Azerbaijan visited to the Netherlands.

4-6<sup>th</sup> of February 2002, the Minister of Justice of Azerbaijan F.Mammadov made a visit to Netherlands. During the visit a Memorandum of Understanding between the Minisitries of Justice of the two countries was signed.

The 15-19th May 2002, the Minister of Education of Azerbaijan paid a visit to Netherlands.

The 23rd of October 2002, the deputy Minister of Foreign Affairs of Azerbaijan X.Xalafov made a visit to Netherlands for political consultations. During the visit he met Arden van der Hoefen, the State secretary on Development and cooperation of the Ministry of Foreign Affairs and F.Mayoot, the State secretary and other officials.

The 14<sup>th</sup> of April 2003, the chief of the Eastern Europe and Central Asia Department of the MFA of Netherlands Antony M. Van der Toght visited Azerbaijan and met with A.Azimov, the deputy foreign minister of Azerbaijan.

26<sup>th</sup> of April 2004, the Minister of Foreign Affairs of Azerbaijan E.Mammadyarov sent a letter to the Minister of Foreign Affairs B.Bot about the opening of Honorary Consulate of Netherlands in Azerbaijan.

20<sup>th</sup> of September 2005, the President of Azerbaijan signed a decree on the opening of Azerbaijani Embassy to Netherlands.

24<sup>th</sup> of April 2007, the newly appointed ambassador of Azerbaijan to Netherlands, F.Isgandarov, presented his credentials to the Princess of the Kingdom of Netherlands Vilhemina Beatrix.

14-17<sup>th</sup> of April 2008, a delegation of the Ministry of Foreign Affairs of Netherlands headed by acting General director of European Cooperation Directorate, Marianne de Kvaasteniet visited Azerbaijan and was received in the Ministries of Foreign Affairs, Energy and Industry Ministry and in SOCAR.

13-15 May 2008, the Princess of Netherland Laurentyen paid a visit to Azerbaijan to participate in the regional conference of UNESCO named "The struggle against the illiteracy".

## **Political relations:**

Azerbaijan stands for the broadening of bilateral relations with Netherlands. Both countries are interested in the strengthening of political dialogue, in cooperation between the legislative and executive branches of the political systems and taking serious steps toward this direction. After opening of the Embassy of Azerbaijan to Netherlands, the relations between the two countries are expanding in all spheres of economic, cultural and political life.

## International cooperation:

Azerbaijan and Netherland are interested in continuation of cooperation in the framework of international organisations such as the UN, OSCE, CoE. Both countries are willing to cooperate in struggle against international crimes, including international terrorism, aggressive separatism, trafficking, organised transnational crime, the illegal arms and human trafficking.

The 13 September, 2006 during the 61st session of General Assembly of the UN, the Kingdom of Netherlands abstained from the voting on the agenda about "The protracting conflicts in GUAM states and its influence to the international peace, security and development".

On 14 March, 2008 the Kingdom of Netherlands abstained from the voting in the General Assembly of the UN on the resolution "About the situation in the occupied territories of Azerbaijan".

#### **Inter-parliamentary relations**

In the National Assembly of Azerbaijan, a working group on Interparliamentary relations between Azerbaijan and Netherlands was created. The group comprises of 5 deputies and the head of the group is Adil Aliyev.

#### Cultural and humanitarian issues

Cultural and humanitarian issues are developing between Azerbaijan and Netherlands.

26 January 2007, the Ambassador of Azerbaijan in Belgium met with the head of the State Library in Hague and presented a number of books to the Library.

24 March 2007, in the eve of "The 31st March- the day of genocide of Azerbaijanis", with the assistance of the Embassy of Azerbaijan in Belgium a film about Azerbaijan in Dutch language presented to the Dutch public in the official TV channel of "Netherlands-2".

24 February 2008, there was an opening ceremony of a monument commemorating the victims of Khodjali genocide in Hague.

26 February 2008, the presentation the books on Khodjali tragedy was organised in Hague's Peace Palace Library. During the ceremony 16 Azerbaijani students in Netherlands presented 16 volumes of book named "The genocide of Khodjali: 1 million signatures-one demand" to the Library high-officials.
