Media Bulletin on COVID-19, Dated- 03/06/2020, Evening

World Health Organization (WHO) has declared the Novel Corona virus, COVID-19 as Pandemic. Till now it has affected 217 countries/areas/territories, infected 61,94,533 people and caused 3,76,320 deaths. Most severely affected countries are the U.S.A, Spain, Italy, France, Germany, U.K. Turkey, Iran, China etc. Till date in India, it has infected 2,07,615 people including 5,815 deaths.

In order to contain the spread of the virus, Haryana Government has strengthened the surveillance and control measures against the disease.

Major Activities undertaken by the State of Haryana to control the spread of COVID-19

- **Special campaign has been launched in Haryana for random COVID sampling of vegetable vendors, Health workers, Police personnel, Media personnel, Pharmacists, Depot Holders, Sanitation workers etc.**
- **Special campaign for screening the Urban slums in districts namely Faridabad, Gurugram, Sonipat etc. and intensive sampling of COVID also being done in these areas.**

- Control Room –cum- Helpline of 30 lines has been made operational at Panchkula. Services of tele-medicines are being provided through helpline. The helpline nos. are 8558893911, 1075 and 108 (Ambulance Services) available for 24 X 7.
- The State Government notified 'The Haryana Government Epidemic, COVID-19 Regulations, 2020' under the Epidemic Disease Act 1897 on 11th March 2020.
- MHA GoI has issued orders vide no.: 40-3/2020-DM-I(A) dated: 24.03.2020, order No. 40.3/2020-DM-I(A) dated 14th April, 2020, order no. 40-3/2020-DM-I(A) dated 01.05.2020, order no. 40-3/2020-DM-I(A) dated 17.05.2020 and order no. 40-3/2020-DM-I(A) dated 30.05.2020 to take lockdown measures to prevent the spread of COVID 19 in the country.
- Nine labs, one each at PGIMS, Rohtak (capacity 1500 sample per day) and BPS Khanpur Kalan (700 sample per day), ESIC Medical College Faridabad (500 sample per day), Kalpna Chawla Medical College Karnal (500 sample per day), NRCE Hisar (200 sample per day), PGIMER, Chandigarh (50 sample per day), CSIR, Mohali (200 sample per day), Civil Hospital, Panchkula (100 sample per day) and SHKMGMGC, Nalhar (400 samples per day) are for doing test for COVID-19 and five private labs at Gurugram (SRL (400 sample per day), CORE Diagnostics (800 sample per day), Dr. Lal Pathlabs (400 sample per day), Modern Diagnostic & Research Centre Lab, Gurugram (300 sample per day), Path Kind Lab, Gurugram (250 sample per day) are doing test for COVID-19.
- **More than 53.98 lac persons have already downloaded Aarogya Setu App in Haryana.**
- **More than 190 Mobile Health Teams have already been formed to check health status regarding SARI, ILI etc.**
- **Micro plan/ containment plan prepared for districts namely Nuh, Palwal, Sonapat, Karnal, Faridabad, Bhiwani, Charkhi Dadri, Gurugram, Jind, Fatehabad, Panipat, Kaithal, Jhajjar, Panchkula, Sirsa, Hisar, Ambala, Yamunanagar, Kurukshetra, Rewari, Mahendergarh and Rohtak,**
- **Containment orders have been issued by concerned District Magistrate/ Deputy Commissioner. No. of active containment zones in districts namely Ambala (13 containment zones), Bhiwani (02), Charkhi Dadri (05), Faridabad (59), Fatehabad (10), Gurugram (75), Hisar (39), Jhajjar (27), Jind (17), Kaithal (08), Karnal (23), Kurukshetra (26), Mahendragarh (02), Nuh (01), Palwal (11), Panchkula (08), Panipat (31), Rewari (1), Rohtak (35), Sirsa (23), Sonapat (80) and Yamuna Nagar (06).**
- All Commissioners of Municipal Corporations, all Executive Officers of Municipal Councils and Secretary of Municipal Committees are authorized to dispose of the dead bodies of COVID and detailed SOP issued regarding dead body management.
- **Haryana has 26, 787 bedded quarantine facilities in Dedicated COVID Care Centers and 11,015 Beds are available in Dedicated COVID Hospitals and in Dedicated COVID Health Centers.**
- Order issued under Food and Safety Act, 2006 regarding ban on consumption/ sale of Pan Masala, Gutka, Chewing-Bubble gum etc..
- Instructions issued regarding ban on smoking in public places and ban on consumption of Khaini etc. at public place.
- **312 regular doctors by Health Department and 206 Ayush Medical Officers by Ayush Department recruited across Haryana state to tackle the crisis of COVID effectively.**
- **Department of Ayush has distributed immunity boosting medicines to more than 1.5 lac persons (sanitation workers, health workers, police personnel, senior citizens, PRIs etc.).**
- **Fixed OPD Services have been started in all the health institutions including District Hospitals. In District Hospitals, Casualty Services, Medicine OPD and MCH Services are already going on and other OPD Services have been made operational in a phased manner.**
- A total no. of 100 FIRs have been registered against 125 accused persons and 55 arrests have been for spreading fake news/rumors on WhatsApp and social media and a total no. of 21 FIRs have been registered against 92 known accused persons/ various unknown persons and 28 arrests have been for attacking on religious minorities.
- Drive against Boot-leggers: - A total no. of 2697 cases under Excise Act have been registered and 2772 persons have been arrested. Recovery of 196829 btl English, 12265 btl & 4014 Canes Beer, 131207 Btl. & 226.75 Ltrs Desi, 226 Btl & 02 ltr & 16 pouch Raw Wine, 63 Working still, 67753 btl & 5.25 Ltr Licit, 9865.25 btl and 567.35 ltr Illicit, 25202 KG and 41983 ltr. Lahan has been made.
- Total 11859 no. of violations of lockdown/Curfew have taken place. 7149 no. of FIRs have been registered against such violators, 10176 people have been arrested, 16170 vehicles have been seized and a fine of Rs. 35.97 Cr. has been imposed upon them under the M.V. Act.
- All BPL families are being provided their monthly rations.
- Financial packages have been given to MMPSY beneficiaries, BPL families, construction workers etc.
- In view of MHA order no. 40-3/2020-DM-I(A) dated 29.03.2020. Adequate arrangements of temporary shelters and provision of foods etc. for the poor and needy people are made. Free food packets are being served.
