In view of the Resolution dated 22.06.2019 adopted by the Selection Committee for the purpose of recruitment of Para Legal Volunteers for the Alipurduar Sub-Division, Alipurduar, it is hereby notified that 84 out of 95 candidates had appeared for the interview/viva-voice and they had been examined accordingly.



Office to comply accordingly.


