- Photocopies of the Blue Book, Driving License, latest Insurance Premium receipt, valid Road
 Tax clearance and Pollution Certificate will have to be submitted along with the tender and
 the originals of these documents have to be produced during opening of tender, if required.
- An experienced and well-behaved driver must be provided. In case of any misbehavior on the part of the owner or his driver, if reported by any Govt. official, the contract will summarily be terminated.
- 3. The contract for hiring of vehicle will be initially for a period of 1 year only.
- 4. No over-time will be given to the owner or his driver.
- 5. The vehicle to be provided should be maintained in proper physical and mechanical condition. Any repairing, renovation, colouring as advised by the office has to be carried out by the owner on his own cost.
- 6. The fuel will be provided from this office initially till exhaustion of the stock for this purpose.
