**DECLARATION OF JEN SHIN**

I, Jen Shin, upon my personal knowledge, and in accordance with 28 U.S.C. § 1746, declare as follows:

1. I am an architecture professional and joint-degree Master's Candidate in Architecture and Environmental Management at the Yale School of Architecture and Yale School of Forestry & Environmental Studies.
2. I worked for three years as an Architectural Designer and Project Manager at Leroy Street Studio, an award-winning architecture studio in New York City. I am the Co-Founder of the Raymond Farm Center for Living Arts & Design, a nonprofit cultural arts center and artist residency in Bucks County, Pennsylvania. I have been selected for several awards in recognition of her architectural work, including the Paul and Daisy Soros Fellowship for New Americans and Drexel University's Michael Pearson Architecture Prize. My CV is attached hereto as Exhibit A.
3. I have drafted architectural diagrams of the four units of the Bristol County Immigration Facilities to-scale, based on information provided in Defendant's filings and productions.
4. Attached hereto as Exhibit B is a diagram of the C. Carlos Carreiro Immigration Detention Center Unit A and Unit B drafted to-scale.
5. I generated these diagrams using a 3D architectural drafting software called Vectorworks.
6. In order to make these diagrams, I carefully reviewed the descriptions of the dimensions, layouts, furniture, fixtures, orientation, and placement of individuals within Unit A and Unit B provided in the Declaration of BCHOC Superintendent Steven Souza dated April 14, 2020. ECF 83-1 (hereafter "Souza Declaration").

7. I prepared the dimensions of the diagrams of Unit A and Unit B based on the measurements provided in the Souza Declaration. ECF 83-1 at 5-7.
8. The number of individuals and their placement in specified rows of bunks as marked in the diagrams of Units A and B reflect the numbers and placements that were provided in the Souza Declaration: 19 in Unit A and 30 in Unit B. *Id.*
9. I corroborated the layout and orientation of the furniture, fixtures and room features in Unit A by viewing the videos produced by Defendant and shared with the Court and Plaintiffs' counsel on April 9, 2020.
10. The Souza Declaration notes that Unit B mirrors Unit A in layout and dimensions. ECF 83-1 at 6. The diagrams reflect this symmetry.
11. Attached hereto as Exhibit C is a diagram of the 2 East Unit, drafted to-scale.
12. I generated these diagrams using the method described above: I carefully reviewed the descriptions provided in the Souza Declaration and prepared a diagram of the 2 East Unit accordingly, to-scale using Vectorworks.
13. The number of individuals (54) and their placement in specified cells as marked in the diagram the 2 East Unit reflect the numbers and placements that were provided in the Souza Declaration. ECF 83-1 at 2-3.
14. Because Defendant did not provide a video of the 2 East Unit, I was not able to corroborate the layout of the cells within the Unit. However, all of the dimensions and measurements of the diagram accurately reflect the information provided in the Souza Declaration.
15. Attached hereto as Exhibit D is a diagram of the EB Unit, drafted to-scale.
16. I generated these diagrams using the method described above: I carefully reviewed the descriptions provided in the Souza Declaration and prepared a diagram of the EB Unit accordingly, to-scale using Vectorworks.
17. The number of individuals (11) and their placement in specified cells as marked in the diagram the EB Unit reflect the numbers and placements that were provided in the Souza Declaration. ECF 83-1 at 2.
18. Because Defendant did not provide a video of the EB Unit, I was not able to corroborate the layout of the cells within the Unit. However, all of the dimensions and measurements of the diagram accurately reflect the information provided in the Souza Declaration.
19. Exhibits B, C and D include diagrams of the space that an individual would require in all directions in order to maintain 6-feet of social distancing. These social-distance zones are

marked by blue circles surrounding the symbols of individuals. These social-distance zones are drafted to-scale.


20. I prepared Exhibits B, C and D to accurately depict the dimensions, measurements and information provided by Defendant in the Souza Declaration to the best of my ability and to-scale.
21. These diagrams have been reviewed and their accuracy confirmed by Deborah Berke, Dean of the Yale School of Architecture.
22. Dean Berke is an architect and educator. She is the founder of the New York-based architecture firm Deborah Berke Partners. Among firm's most significant works are the Marianne Boesky Gallery building in New York, the Irwin Union Bank in Columbus, Indiana, the Yale School of Art in New Haven, Connecticut, the 21c Museum Hotels across the South and Midwest, the Cummins Distribution Headquarters in Indianapolis, Indiana, and the Rockefeller Arts Center at SUNY Fredonia.
23. In 2012, Dean Berke was the inaugural recipient of the Berkeley-Rupp Prize at the University of California at Berkeley, which is given to an architect who has advanced the position of women in the profession and whose work emphasizes a commitment to sustainability and the community. She is a board member of the James Howell Foundation, a member of the board of directors of Yaddo, and advisor to the Norman Foster Foundation. She was a founder and vice president of DesignNYC, a founding trustee of the Design Trust for Public Space, a trustee of the National Building Museum, chair of the board of advisors of the Buell Center for the Study of American Architecture at Columbia University, trustee of the Brearley School, vice president of the AIA New York Chapter, and a member of the Pritzker Architecture Prize jury. Here CV is attached hereto as Exhibit E.
24. In her roles as Dean of the Yale School of Architecture and Partner at her architecture firm, Dean Berke regularly reviews the work of architecture professionals to assess the work's quality and accuracy.
25. Dean Berke has reviewed Exhibits B, C and D as well as the Souza Declaration, ECF 83-1, and videos of ICE Unit A in which Defendant provided the data underling the diagrams.
26. Dean Berke's review has confirmed that the diagrams accurately represent the information provided by Defendant. Her signature below attests to her review and finding that the diagrams are accurate representations of information provided by Defendant

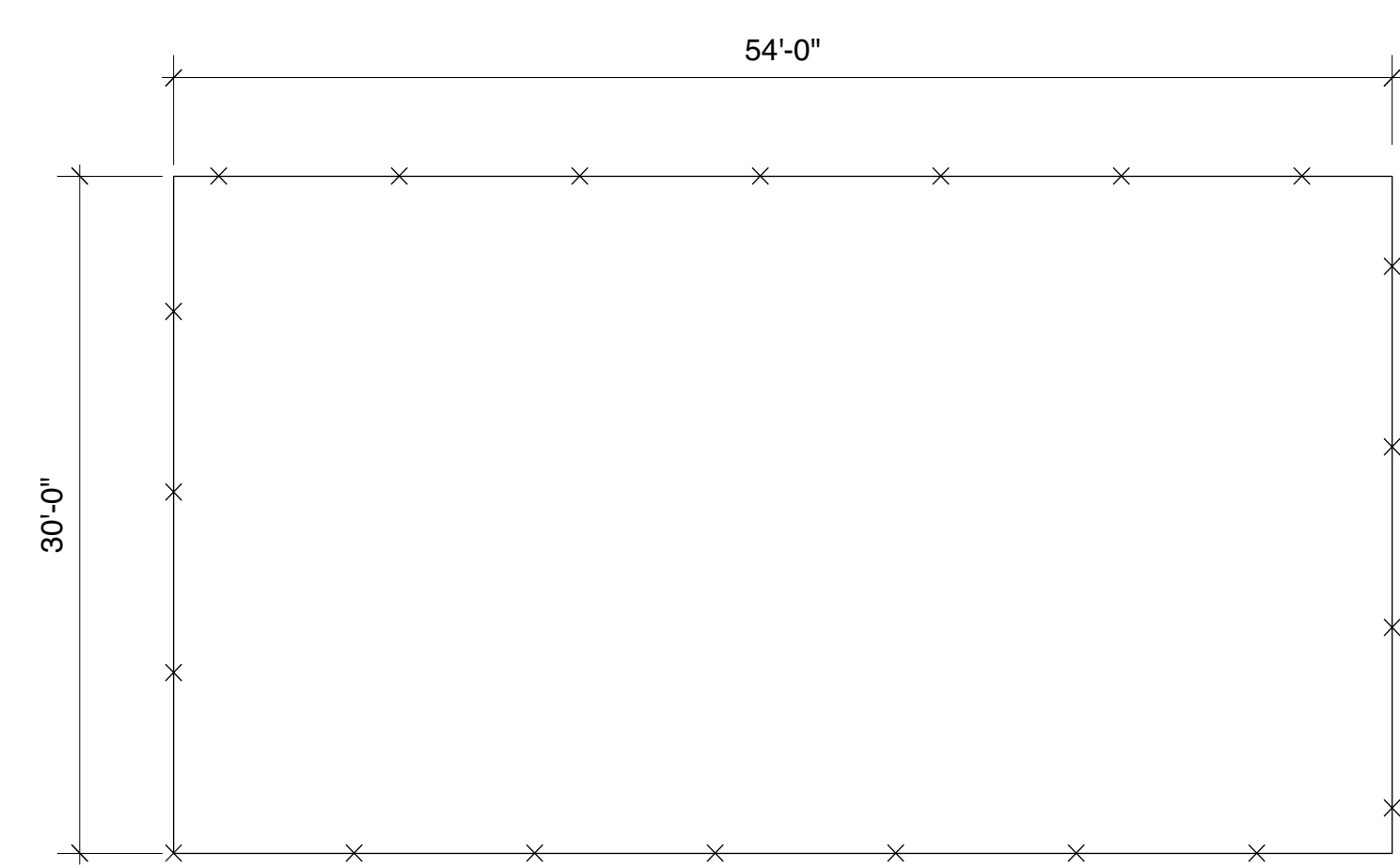
REQUIRED RADIUS FOR SOCIAL DISTANCING



SINGLE OCCUPANT BUNK

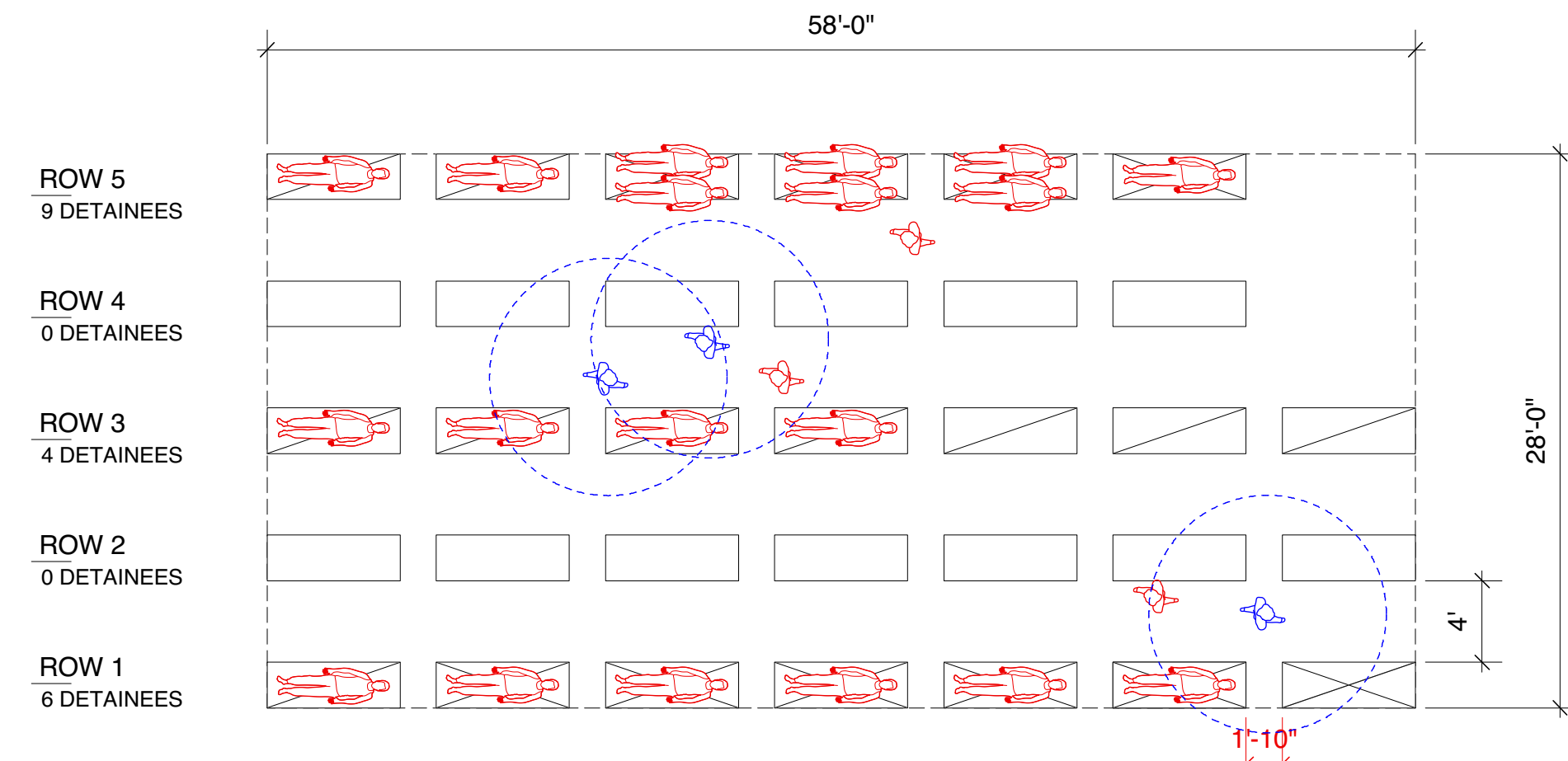

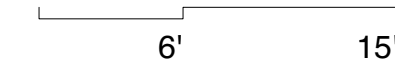
GROUND LEVEL PLAN



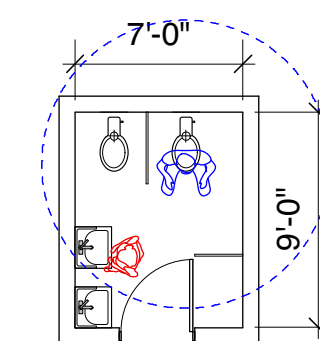
