# BERNSTEIN - VON MISES THEOREMS FOR STATISTICAL INVERSE PROBLEMS II: COMPOUND POISSON PROCESSES

#### Abstract

We study nonparametric Bayesian statistical inference for the parameters governing a pure jump process of the form $$
Y_{t}=\sum_{k=1}^{N(t)} Z_{k}, t \geqslant 0
$$ where $N(t)$ is a standard Poisson process of intensity $\lambda$, and $Z_{k}$ are drawn i.i.d. from jump measure $\mu$. A high-dimensional wavelet series prior for the Lévy measure $\nu=\lambda \mu$ is devised and the posterior distribution arises from observing discrete samples $Y_{\Delta}, Y_{2 \Delta}, \ldots, Y_{n \Delta}$ at fixed observation distance $\Delta$, giving rise to a nonlinear inverse inference problem. We derive contraction rates in uniform norm for the posterior distribution around the true Lévy density that are optimal up to logarithmic factors over Hölder classes, as sample size $n$ increases. We prove a functional Bernstein-von Mises theorem for the distribution functions of both $\mu$ and $\nu$, as well as for the intensity $\lambda$, establishing the fact that the posterior distribution is approximated by an infinite-dimensional Gaussian measure whose covariance structure is shown to attain the Cramér-Rao lower bound for this inverse problem. As a consequence posterior based inferences, such as nonparametric credible sets, are asymptotically valid and optimal from a frequentist point of view.

## 1. Introduction

While the Bayesian approach to inverse problems is widely used in scientific and statistical practice, very little theory is available that explains why Bayesian algorithms should be trusted to provide objective solutions of inverse problems in the presence of statistical noise, particularly in infinite-dimensional, non-linear cases which naturally arise in applications, see [11, 29]. In the recent contributions [20, 23, 26] a general proof strategy was developed that can be used to derive theoretical guarantees for posterior-based inference, based on suitably chosen priors, in various settings, including inverse problems arising with diffusion processes, $X$-ray tomography or elliptic partial differential equations. A main idea of [20, 23] is that a careful analysis of the 'Fisher information operator' inducing the statistical observation scheme combined with tools from Bayesian nonparametrics [6, 7] can be used to derive sharp results about the frequentist behaviour of posterior distributions in general inverse problems.

The analysis of the 'information operator' depends highly on the particular problem at hand, and in the present article we continue this line of investigation in a statistical inverse problem very different from the ones considered in [20, 23, 26], namely in the problem of recovering parameters of a stochastic jump process from discrete observations. Statistically speaking, the inverse problem is a 'missing observations' problem that arises from the fact that we do not observe all the jumps and need to 'decompound' the effect of possibly seeing an accumulation of jumps without knowing how many have occurred. This has been studied from a non-Bayesian perspective for certain classes of Lévy processes by several authors, we mention here the seminal papers [2, 3, 21, 34] - see also [1] for various further references - and [24], [10, 25, 30] relevant for the results obtained in the present paper. A typical estimation method used in several of these articles is based on spectral regularisation techniques built around the fact that the Lévy measure identifying all parameters of the jump process can be expressed in the Fourier domain by the Lévy-Khintchine formula (see (3) below).

Given the sophistication of the non-linear estimators proposed so far in the 'decompounding problem' just described, one may wonder if a 'principled' Bayesian approach that just places a standard high-dimensional random series prior on the unknown Lévy measure can at all return valid posterior inferences, for example in the sense of frequentist's coverage of credible sets, in such a measurement scheme. In the present article we provide some answers to this question in the prototypical setting where one observes discrete increments of a compound Poisson processes at fixed observation distance $\Delta>0$. To lift some of the technicalities occurring in the proofs we restrict ourselves to periodic and hence compactly
supported processes, and - to avoid identifiability problems arising in the periodic case - to small enough $\Delta$. We show that the posterior distribution optimally recovers all parameters of the jump process, both in terms of convergence rates for the Lévy density $\nu$ and in terms of efficient inference for the intensity of the Poisson process and the distribution function of the jump measure $\mu$. For the latter we obtain functional Bernstein-von Mises theorems which are the Bayesian analogues of the 'Donsker-type' central limit theorems obtained in [24], [10] for frequentist regularisation estimators. Just as in [23], our proofs are inspired by techniques put forward in [4 8] in 'direct' problems. However, due to the different structure of the jump process model, our proofs need to depart from those in [23] in various ways, perhaps most notably since we have to consider a prior with a larger support ellipsoid, and hence need to prove initial contraction rates for our posterior distribution by quite different methods than is commonly done, see Section 4 . The inversion of the information operator in the jump process setting also poses some surprising subtleties that nicely reveal finer properties of the inference problem at hand - our explicit construction of the inverse information operator in Section 2.4 also gives new, more direct proofs of the semi-parametric lower bounds obtained in [30] (whose lower bounds admittedly hold in a more general setting than ours). Finally we should mention that substantial work - using tools from empirical process theory - is required in our setting when linearising the likelihood function to obtain quantitative LANexpansions since, in contrast to [23], our observation scheme is far from Gaussian. In this sense the techniques we develop here are relevant also beyond compound Poisson processes, although, as argued above, the theory for non-linear inverse problems is largely constrained by any specific case one is studying.

## 2. Main Results

2.1. Basic definitions. Let $(N(t): t \geqslant 0)$ be a standard Poisson process of intensity $\lambda>0$. Let $\mu$ be a probability measure on $(-1 / 2,1 / 2]$ such that $\mu(\{0\})=0$, and let $Z_{1}, Z_{2}, \ldots$ be an i.i.d. sequence of random variables drawn from $\mu$. In what follows we view $I=(-1 / 2,1 / 2]$ as a compact group under addition modulo 1. Then the (periodic) compound Poisson process taking values in $(-1 / 2,1 / 2]$ is defined as

\begin{equation*}
Y_{t}=\sum_{k=1}^{N(t)} Z_{k}, t \geqslant 0 \tag{1}
\end{equation*}
$$

where $Y_{0}=0$ almost surely, by convention. The process $\left(Y_{t}: t \geqslant 0\right)$ is a pure jump Lévy process on $I=(-1 / 2,1 / 2]$ with Lévy measure $d \nu=\lambda d \mu$. We observe this process at fixed observation distance $\Delta$, namely $Y_{\Delta}, Y_{2 \Delta}, \ldots, Y_{n \Delta}$, and define the increments of the process

\begin{equation*}
X_{1}=Y_{\Delta}, X_{2}=Y_{2 \Delta}-Y_{\Delta}, \ldots, X_{n}=Y_{n \Delta}-Y_{(n-1) \Delta} \tag{2}
\end{equation*}
$$

The $X_{k}$ 's are i.i.d. random variables drawn from the infinitely divisible distribution $\mathbb{P}_{\nu}=\mathbb{P}_{\nu, \Delta}$ which has characteristic function (Fourier transform)

$$
\begin{equation*}
\varphi_{\nu}(k)=\mathcal{F} \mathbb{P}_{\nu}(k)=\exp \left(\Delta \int_{I}\left(e^{2 \pi i k x}-1\right) d \nu\right), k \in \mathbb{Z} \tag{3}
\end{equation*}
$$

by the Lévy-Khintchine formula for Lévy processes in compact groups (Chapter IV. 4 in [27]). Obviously $\left(\varphi_{\nu}(k): k \in \mathbb{Z}\right)$ identifies $\mathbb{P}_{\nu}$ but under the hypotheses we will employ below it will also identify $\nu$ and thus the law of the jump process $\left(Y_{t}: t \geqslant 0\right)$. The inverse problem is to recover $\nu$ from i.i.d. samples drawn from the probability measure $\mathbb{P}_{\nu}$.

We denote by $C(I)$ the space of bounded continuous functions on $I$ equipped with the uniform norm $\|\cdot\|_{\infty}$, and let $M(I)=C(I)^{*}$ denote the (dual) space of finite signed (Borel) measures on $I$. For $\kappa_{1}, \kappa_{2} \in M(I)$ their convolution is defined by

$$
\kappa_{1} * \kappa_{2}(g)=\int_{I} \int_{I} g(x+y) d \kappa_{1}(x) d \kappa_{2}(y), g \in C(I),
$$

and the last identity holds in fact for arbitrary $g \in L^{\infty}(I)$ by approximation, see Proposition 8.48 in [14]. This coincides with the usual definition of convolution of functions when the measures involved have densities with respect to the Lebesgue measure. We shall freely use standard properties of convolution integrals, see, e.g., Section 8.2 in [14].

An equivalent representation of $\mathbb{P}_{\nu}$ is by the infinite convolution series

\begin{equation*}
\mathbb{P}_{\nu}=e^{-\Delta \nu(I)} \sum_{k=0}^{\infty} \frac{\Delta^{k} \nu^{* k}}{k!} \tag{4}
\end{equation*}

where $\nu^{0}=\delta_{0}, \nu^{* 1}=\nu, \nu^{* 2}=\nu * \nu$ and $\nu^{* k}$ is the $k-1$-fold convolution of $\nu$ with itself. [To see this just check the obvious fact that the Fourier transform of the last representation coincides with $\varphi_{\nu}$ in (3), and use injectivity of the Fourier transform.]

We will denote by $\mathbb{P}_{\nu}^{\mathbb{N}}$ the infinite product measures describing the laws of infinite sequences of i.i.d. samples (21) arising from a compound Poisson process with Lévy measure $\nu$, and $\mathbb{E}_{\nu}$ will denote the corresponding expectation operator. We denote by $L^{p}=L^{p}(I), 1 \leqslant p<\infty$, the standard spaces of functions $f$ for which $|f|^{p}$ is Lebesgue-integrable on $I$, whereas, in slight abuse of notation, for a finite measure $\kappa$ we will denote by $L^{p}(\kappa), 1 \leqslant p \leqslant \infty$, the corresponding spaces of $\kappa$-integrable functions on $I$, predominantly for the choices $\kappa=\nu, \kappa=\mathbb{P}_{\nu}$. The spaces $L^{2}(I), L^{2}(\kappa)$ are Hilbert spaces equipped with natural inner products $\langle\cdot, \cdot\rangle,\langle\cdot, \cdot\rangle_{L^{2}(\kappa)}$, respectively. The symbol $L^{\infty}(I)$ denotes the usual space of bounded measurable functions on $I$ normed by $\|\cdot\|_{\infty}$. We also write $\lesssim, \approx$ for (in-)equalities that hold up to fixed multiplicative constants, and employ the usual $o_{P}, O_{P}$-notation to indicate stochastic orders of magnitude of sequences of random variables.
2.2. Likelihood, prior and posterior. We study here the problem of conducting nonparametric Bayesian inference on the parameters $\nu, \mu, \lambda$, assuming a regularity constraint $\nu \in C^{s}(I), s>0$, where $C^{s}$ is the usual Hölder space over $I$ normed by $\|\cdot\|_{C^{s}}$ (when $s \in \mathbb{N}$ these are the ordinary spaces of $s$-times continuously differentiable functions, e.g., Section 2.2.2 in [31]). To define the likelihood function we need a common dominating measure for the statistical model $\left(\mathbb{P}_{\nu}: \nu \in \mathcal{V}\right)$ where $\mathcal{V}$ is some family of Lévy measures possessing densities with respect to Lebesgue measure $\Lambda$ with density $\Lambda=1_{(-1 / 2,1 / 2]}$. Since $\Lambda$ is idempotent $-\Lambda * \Lambda=\int_{I} \Lambda(\cdot-y) \Lambda(y) d y=\Lambda$ - we can consider the resulting compound Poisson measure $\mathbb{P}_{\Lambda}=e^{-\Delta} \delta_{0}+\left(1-e^{-\Delta}\right) \Lambda$ as a fixed reference measure on $I$. Then for any absolutely continuous $\nu$ on $I$ the densities $p_{\nu}$ of $\mathbb{P}_{\nu}$ with respect to $\mathbb{P}_{\Lambda}$ exist. The likelihood function of the observations $X_{1}, \ldots, X_{n}$ is defined as

L_{n}(\nu)=\prod_{i=1}^{n} p_{\nu}\left(X_{i}\right), \nu \in \mathcal{V} \tag{5}
\end{equation*}

We also write $\ell_{n}(\nu)=\log L_{n}(\nu)$ for the $\log$-likelihood function. Next, if $\Pi$ is a prior distribution on a $\sigma$-field $\mathcal{S}_{\mathcal{V}}$ of $\mathcal{V}$ such that the map $(\nu, x) \mapsto p_{\nu}(x)$ is jointly measurable,
then standard arguments imply that the resulting posterior distribution given observations $X_{1}, \ldots, X_{n}$ is

\Pi\left(B \mid X_{1}, \ldots, X_{n}\right)=\frac{\int_{B} L_{n}(\nu) d \Pi(\nu)}{\int_{\mathcal{V}} L_{n}(\nu) d \Pi(\nu)} \tag{6}
\end{equation*}

We shall model an $s$-regular function by a high-dimensional product prior expressed through a wavelet basis: Let

$$
\begin{equation*}
\left\{\psi_{l k}: k=0, \ldots,\left(2^{l} \vee 1\right)-1, l=-1, \ldots, J-1\right\}, J \in \mathbb{N} \tag{7}
\end{equation*}
$$

form a periodised Daubechies' type wavelet basis of $L^{2}=L^{2}(I)$, orthogonal for the usual $L^{2}$ inner product $\langle\cdot, \cdot\rangle$ (described in Section 4.3.4 in [18]; where the constant 'scaling function' is written as the first element $\psi_{-1,0} \equiv 1$, in slight abuse of notation). Basic localisation and approximation properties of this basis are, for any $g \in C^{s}(I)$ and $j \in \mathbb{N}$,

& \sup _{x \in I} \sum_{k}\left|\psi_{j k}(x)\right| \lesssim 2^{j / 2},\left|\left\langle g, \psi_{j k}\right\rangle\right| \lesssim\|g\|_{C^{s}} 2^{-j(s+1 / 2)}, \\
& \left\|P_{V_{j}}(g)-g\right\|_{L^{2}(I)} \lesssim\|g\|_{C^{s}} 2^{-j s} \tag{8}
\end{align*}

where $P_{V_{j}}$ is the usual $L^{2}$-projector onto the linear span $V_{j}$ of the $\psi_{l k}$ 's with $l \leqslant j-1$.
Now consider the random function

$$
\begin{equation*}
v=\sum_{l \leqslant J-1} \sum_{k} a_{l} u_{l k} \psi_{l k}(\cdot), a_{l}=2^{-l}\left(l^{2}+1\right)^{-1}, J \in \mathbb{N}, \tag{9}
\end{equation*}
$$

where $u_{l k}$ are i.i.d. uniform $U(-B, B)$ random variables, and $B$ is a fixed constant. The support of this prior is isomorphic to the hyper-ellipsoid

$$
V_{B, J}:=\prod_{l=-1}^{J-1}\left(-B a_{l}, B a_{l}\right)^{2^{l} \vee 1} \subseteq \mathbb{R}^{2^{J}}
$$

of wavelet coefficients. To model an s-regular Lévy measure $\nu$ we define the random function

$$
\begin{equation*}
\nu=e^{v}, \Pi=\Pi_{J}=\text { the law } \mathcal{L}(\nu) \text { of } \nu \text { in } V_{J} \tag{10}
\end{equation*}
$$

and shall choose $J=J_{n}$ such that $2^{J}$ grows as a function of $n$ approximately as

$$
\begin{equation*}
2^{J} \approx n^{\frac{1}{2 s+1}} \tag{11}
\end{equation*}
$$

We note that the weights $a_{l}=2^{-l}\left(l^{2}+1\right)^{-1}$ ensure that the random function $v$ has some minimal regularity, in particular is contained in a bounded subset of $C(I)$.

Throughout we shall work under the following assumption on the Lévy measure and on the prior identifying the law of the compound Poisson process generating the data.

Assumption 1. Assume the true Lévy measure $\nu_{0}$ has a Lebesgue density, still denoted by $\nu_{0}$, which is contained in $C^{s}(I)$ for some $s>5 / 2$, that $\nu_{0}$ is bounded away from zero on $I$, and that for $v_{0}=\log \nu_{0}$ and some $\gamma>0$,

\left|\left\langle v_{0}, \psi_{l k}\right\rangle\right| \leqslant(B-\gamma) a_{l} \forall l, k, \tag{12}
\end{equation*}

where $a_{l}$ was defined in (9). Assume moreover that $B, \Delta$ are such that $\lambda=\int_{I} \nu<\pi / \Delta$ for all $\nu$ in the support of the prior.

The assumption $s>5 / 2$ (in place of, say, $s>1 / 2$ ) may be an artefact of our proof methods (which localise the likelihood function by an initially suboptimal contraction rate) but, in absence of a general 'Hellinger-distance' testing theory (cf. Appendix D in [16] or Section 7.1 in [18]) for the inverse problem considered here, appears unavoidable.

The assumption (12) with $\gamma>0$ guarantees that the true Lévy density is an 'interior' point of the parameter space $V_{B, J}$ for all $J$ - a standard requirement if one wishes to obtain Gaussian asymptotics for posterior distributions.

Finally, the bound on $\lambda$ ensures identifiability of $\nu$, and thus of the law of the compound Poisson process, from the measure $\mathbb{P}_{\nu}$ generating the observations. That such an upper bound is necessary is a consequence of the fact that we are considering the periodic setting, see the discussion after Assumption 19 below. For the present parameter space $V_{B, J}$, Assumption 1 enforces a fixed upper bound on $\Delta$ - alternatively for a given value of $\Delta$ we could also renormalise $\nu$ by a large enough constant to make the intensities $\lambda$ small enough, but we avoid this for conciseness of exposition.
2.3. Supremum norm contraction rates. Even though the standard 'Hellinger-distance' testing theory to obtain contraction rates is not directly viable in our setting, following ideas in [4] we can use the Bernstein-von Mises techniques underlying the main theorems of this paper to obtain (near-) optimal contraction rates for the Lévy density $\nu_{0}$ in supremum norm loss. The idea is basically to represent the norm by a maximum over suitable collections of linear functionals, and to then treat each functional individually by semi-parametric methods. It can be shown that the minimax rate of estimation for Lévy densities in $C^{s}(I)$ with respect to the supremum loss is $(\log n / n)^{s /(2 s+1)}$, see [9] for a discussion. The following theorem achieves this rate up to the power of the log-factor.

Theorem 2. Suppose the $X_{1}, \ldots, X_{n}$ are generated from (2) and grant Assumption 1. Let $\Pi\left(\cdot \mid X_{1}, \ldots, X_{n}\right)$ be the posterior distribution arising from prior $\Pi=\Pi_{J}$ in (10) with $J$ as in (11). Then for every $\kappa>3$ we have as $n \rightarrow \infty$ that

\Pi\left(\nu:\left\|\nu-\nu_{0}\right\|_{\infty}>n^{-s /(2 s+1)} \log ^{\kappa} n \mid X_{1}, \ldots, X_{n}\right) \rightarrow^{\mathbb{P}_{\nu_{0}}^{N}} 0 .
$$

The only comparable posterior contraction rate result of this kind we are aware of in the literature can be found in [19], who obtain contraction rates for the Hellinger distance $h\left(\mathbb{P}_{\nu}, \mathbb{P}_{\nu_{0}}\right)$ between the infinitely divisible distributions $\mathbb{P}_{\nu}, \mathbb{P}_{\nu_{0}}$ induced by the Lévy measures $\nu, \nu_{0}$. Without any sharp 'stability estimates' that would allow to derive optimal bounds on the distance $\left\|\nu-\nu_{0}\right\|_{\infty}$, or even just on $\left\|\nu-\nu_{0}\right\|_{L^{2}}$, in terms of $h\left(\mathbb{P}_{\nu}, \mathbb{P}_{\nu_{0}}\right)$, the results in [19] do a fortiori not imply any guarantees for Bayesian inference on the statistically relevant parameters $\nu, \mu, \lambda$.

The above contraction rate result shows that the Bayesian method works in principle and that estimators that converge with the minimax optimal rate up to log-factors can be derived from the posterior distribution, see [15].
2.4. The LAN expansion and semi-parametric Cramér-Rao lower bounds. In order to formulate, and prove, Bernstein-von Mises type theorems, and to derive a notion of semi-parametric optimality of the limit distributions that will occur, we now obtain, for $L_{n}$ the likelihood function defined in (5), the LAN-expansion of the log-likelihood ratio process

\ell_{n}\left(\nu_{h, n}\right)-\ell_{n}(\nu)=\log \frac{L_{n}\left(\nu_{h, n}\right)}{L_{n}(\nu)}, n \in \mathbb{N},
$$

of the observation scheme considered here, in perturbation directions $\nu_{h, n}$ that are additive on the log-scale. This will induce the score operator for the model and allow us to derive the inverse Fisher information (Cramér-Rao lower bound) for a large class of semi-parametric subproblems. Some ideas of what follows are implicit in the work by Trabs (2015), although we need a finer analysis for our results, including inversion of the score operator itself.
Proposition 3 (LAN expansion). Let $\nu=e^{v}$ be a Lévy density that is bounded and bounded away from zero, and for $h \in L^{\infty}(I)$ consider a perturbation $\nu_{h, n}=e^{v+h / \sqrt{n}}$. Then if $X_{i} \sim^{i . i . d}$. $\mathbb{P}_{\nu}$ we have

\ell_{n}\left(\nu_{h, n}\right)-\ell_{n}(\nu)=\frac{1}{\sqrt{n}} \sum_{i=1}^{n} A_{\nu}(h)\left(X_{i}\right)-\frac{1}{2}\left\|A_{\nu}(h)\right\|_{L^{2}\left(\mathbb{P}_{\nu}\right)}^{2}+o_{\mathbb{P}_{\nu}^{\mathbb{N}}}(1) \tag{13}
\end{equation*}
$$

where the score operator is given by the Radon-Nikodym density

$$
\begin{equation*}
A_{\nu}(h) \equiv \Delta \frac{d\left(h \nu-\int_{I} h d \nu \cdot \delta_{0}\right) * \mathbb{P}_{\nu}}{d \mathbb{P}_{\nu}} \tag{14}
\end{equation*}
$$

The operator $A_{\nu}$ defines a continuous linear map from $L^{2}(\nu)$ into $L_{0}^{2}\left(\mathbb{P}_{\nu}\right):=\left\{g \in L^{2}\left(\mathbb{P}_{\nu}\right)\right.$ : $\left.\int_{I} g d \mathbb{P}_{\nu}=0\right\}$.

The proposition is proved in Section 6. In what follows we study properties of $A_{\nu}$ and of its adjoint $A_{\nu}^{*}$, in particular we need to construct certain inverse mappings. Due to the presence of the Dirac measure in (14) some care has to be exercised when identifying the natural domain of the inverse ('Fisher') information operator $A_{\nu}^{*} A_{\nu}$. In particular we can invert $A_{\nu}^{*} A_{\nu}$ only along directions $\psi$ for which $\psi(0)=0$. An intuitive explanation is that the axiomatic property $\nu(\{0\})=0$ is required for $\nu$ to identify the law of the compound Poisson process (otherwise 'no jumps' and 'jumps of size zero' are indistinguishable), and as a consequence when making inference on the functional $\int_{I} \psi d \nu$ one should a priori restrict to $\int_{I} \psi 1_{\{0\}^{c}} d \nu$, a fact that features in the Cramér-Rao information lower bound (25) to be established below.

To proceed we will set $\Delta=1$ without loss of generality for the moment. If $\kappa \in M(I)$ is a finite signed measure on $I$ and $g: I \rightarrow \mathbb{R}$ a function such that $\int_{I}|g| d|\kappa|<\infty$, we use the notation $g \kappa$ for the element of $M(I)$ given by $(g \kappa)(A)=\int_{A} g d \kappa, A$ a Borel subset of $I$. Then, for a fixed Lévy density $\nu \in L^{\infty}(I)$, consider the operator

$$
\begin{equation*}
h \mapsto A_{\nu}(h):=\frac{d\left[(\nu h) * \mathbb{P}_{\nu}\right]}{d \mathbb{P}_{\nu}}(x)-\left[\int_{I} d(\nu h)\right], x \in I, \tag{15}
\end{equation*}
$$

defined on the subset of $M(I)$ given by

$$
\mathcal{D} \equiv\left\{\kappa=\kappa_{a}+c \delta_{0}, \kappa_{a} \in M(I) \text { has Lebesgue-density } h_{a} \in L^{2}(\nu) ; c \in \mathbb{R}\right\}
$$

This operator serves as an extension of $A_{\nu}$ from (14) to the larger domain $\mathcal{D}$. It still takes values in $L_{0}^{2}\left(\mathbb{P}_{\nu}\right)$; in fact $\delta_{0}$ is in the kernel of $A_{\nu}$ since

$$
\begin{equation*}
A_{\nu}\left(\delta_{0}\right)=\frac{\nu(0) d \mathbb{P}_{\nu}}{d \mathbb{P}_{\nu}}-\int_{I} \nu(x) d \delta_{0}(x)=\nu(0)-\nu(0)=0 \tag{16}
\end{equation*}
$$

but extending $A_{\nu}$ formally to $\mathcal{D}$ is convenient since the inverse of $A_{\nu}$ to be constructed next will take values in $\mathcal{D}$. Define

$$
\begin{equation*}
\pi_{\nu}=e^{\nu(I)} \sum_{m=0}^{\infty} \frac{(-1)^{m} \nu^{* m}}{m!} \tag{17}
\end{equation*}
$$

a finite signed measure for which $\mathbb{P}_{\nu} * \pi_{\nu}=\delta_{0}$ (by checking Fourier transforms). Formally, up to a constant, $\pi_{\nu}$ equals the inverse Fourier transform $\mathcal{F}^{-1}\left(1 / \varphi_{\nu}\right)$ of $1 / \varphi_{\nu}$, and convolution with $\pi_{\nu}$ can be thought of as a 'deconvolution operation'.

Lemma 4. Assume the Lévy density $\nu \in L^{\infty}(I)$ is bounded away from zero on $I$. The operator $A_{\nu}: \mathcal{D} \rightarrow L_{0}^{2}\left(\mathbb{P}_{\nu}\right)$ from (15) has inverse

$$
\begin{equation*}
\widetilde{A}_{\nu}: L_{0}^{2}\left(\mathbb{P}_{\nu}\right) \rightarrow \mathcal{D}, \quad \widetilde{A}_{\nu}(g):=\frac{1}{\nu(\cdot)} \pi_{\nu} *\left(g \mathbb{P}_{\nu}\right)(\cdot) \tag{18}
\end{equation*}
$$

in the sense that $A_{\nu} \widetilde{A}_{\nu}=I d$ on $L_{0}^{2}\left(\mathbb{P}_{\nu}\right)$.
Proof. For any $g \in L_{0}^{2}\left(\mathbb{P}_{\nu}\right)$, by the Cauchy-Schwarz inequality, $g \mathbb{P}_{\nu}$ defines a finite signed measure, so that $\widetilde{A}_{\nu}$ is well-defined and takes values in $M(I)$. Since $\mathbb{P}_{\nu} * \pi_{\nu}=\delta_{0}$ the RadonNikodym theorem (Theorem 5.5.4 in [12]) implies

$$
\frac{d\left[\mathbb{P}_{\nu} * \pi_{\nu} *\left(g \mathbb{P}_{\nu}\right)\right]}{d \mathbb{P}_{\nu}}=\frac{d\left(g \mathbb{P}_{\nu}\right)}{d \mathbb{P}_{\nu}}=g, \quad \mathbb{P}_{\nu} \text { a.s.. }
$$

We then have

$$
\begin{equation*}
A_{\nu}\left(\widetilde{A}_{\nu}(g)\right)=\frac{d\left[\mathbb{P}_{\nu} * \pi_{\nu} *\left(g \mathbb{P}_{\nu}\right)\right]}{d \mathbb{P}_{\nu}}-\int_{I} d\left[\pi_{\nu} *\left(g \mathbb{P}_{\nu}\right)\right]=g \tag{19}
\end{equation*}
$$

where the second term vanishes since for such $g$, by the definition of convolution,

$$
\int_{I} d\left[\pi_{\nu} *\left(g \mathbb{P}_{\nu}\right)\right]=\int_{I} g d \mathbb{P}_{\nu} \int_{I} d \pi_{\nu}=0 .
$$

That $\widetilde{A}_{\nu}$ takes values in $\mathcal{D}$ is immediate from the definition of $\pi_{\nu}$ and (4).
We now calculate the adjoint operator of $A_{\nu}$.
Lemma 5. Assume the Lévy density $\nu \in L^{\infty}(I)$ is bounded away from zero on I. If we regard $A_{\nu}$ from (14) as an operator mapping the Hilbert spaces $L^{2}(\nu)$ into $L_{0}^{2}\left(\mathbb{P}_{\nu}\right)$ then its adjoint $A_{\nu}^{*}: L_{0}^{2}\left(\mathbb{P}_{\nu}\right) \rightarrow L^{2}(\nu)$ is given by $A_{\nu}^{*}(w)=\Delta \mathbb{P}_{\nu}(-\cdot) * w$.

Proof. We set w.l.o.g. $\Delta=1$. Let $h \in L^{2}(\nu)$ and $w \in C(I) \subseteq L^{2}\left(\mathbb{P}_{\nu}\right)$ s.t. $\int w d \mathbb{P}_{\nu}=0$. Then by Fubini's theorem

$$
\begin{aligned}
& \left\langle A_{\nu}(h), w\right\rangle_{L^{2}\left(\mathbb{P}_{\nu}\right)}=\int_{I} A_{\nu}(h) w d \mathbb{P}_{\nu}=\int_{I} w d\left(\mathbb{P}_{\nu} *(h \nu)\right)-\int h \nu \int w d \mathbb{P}_{\nu} \\
& \quad=\int_{I} \int_{I} w(x+y) h(x) \nu(x) d x d \mathbb{P}_{\nu}(y)=\int_{I} h\left(\mathbb{P}_{\nu}(-\cdot) * w\right) d \nu=\left\langle h, A_{\nu}^{*}(w)\right\rangle_{L^{2}(\nu)}
\end{aligned}
$$

so that the formula for the adjoint holds on the dense subspace $C(I)$ of $L_{0}^{2}\left(\mathbb{P}_{\nu}\right)$. The CauchySchwarz inequality implies that $\mathbb{P}_{\nu}(-\cdot) * w \in L^{2}(\nu)$ so that the case of general $w \in L_{0}^{2}\left(\mathbb{P}_{\nu}\right)$ follows from standard approximation arguments.

Inspecting the formula for $A_{\nu}^{*}$ we can formally define the 'inverse' map

$$
\left(A_{\nu}^{*}\right)^{-1}(g)=\pi_{\nu}(-\cdot) * g \text { with }\left(\pi_{\nu}(-\cdot) * g\right)(x)=\int_{I} g(x+y) d \pi_{\nu}(y), g \in L^{2}\left(\mathbb{P}_{\Lambda}\right),
$$

for $\nu \in L^{\infty}(I)$ and scaled by $1 / \Delta$ if $\Delta \neq 1$. If $g(0)=0$, then using $\mathbb{P}_{\nu} * \pi_{\nu}=\delta_{0}$ (cf. after (17)) we have for $g \in L^{\infty}(I)$

$$
\begin{equation*}
\int_{I}\left(A_{\nu}^{*}\right)^{-1}(g) d \mathbb{P}_{\nu}=\int_{I} \pi_{\nu}(-\cdot) * g d \mathbb{P}_{\nu}=\int_{I} g d\left(\mathbb{P}_{\nu} * \pi_{\nu}\right)=g(0)=0 \tag{20}
\end{equation*}
$$

Now let $\psi \in L^{\infty}(I)$ be arbitrary but such that $\psi(0)=0$, for instance we can take $\psi 1_{\{0\}}{ }^{c}$ for any $\psi \in C(I)$. If $\nu \in L^{\infty}(I)$ is bounded away from zero then $\psi / \nu \in L^{2}\left(\mathbb{P}_{\Lambda}\right)$ and by what precedes $\left(A_{\nu}^{*}\right)^{-1}(\psi / \nu) \in L_{0}^{2}\left(\mathbb{P}_{\nu}\right)$ and hence in view of Lemma 4 we can define, for any such $\psi$, the new function

$$
\begin{equation*}
\widetilde{\psi}_{d}=-\widetilde{A}_{\nu}\left[\left(A_{\nu}^{*}\right)^{-1}\left(\frac{\psi}{\nu}\right)\right] \tag{21}
\end{equation*}
$$

as an element of $\mathcal{D}$. Concretely, in view of (4), (17), (when $\Delta=1$, otherwise divide the right hand side in the following expression by $\Delta^{2}$ )

$$
\begin{equation*}
\widetilde{\psi}_{d}=-\widetilde{A}_{\nu}\left[\pi_{\nu}(-\cdot) * \frac{\psi}{\nu}\right]=-\frac{1}{\nu} \pi_{\nu} *\left(\left(\pi_{\nu}(-\cdot) * \frac{\psi}{\nu}\right) \mathbb{P}_{\nu}\right)(\cdot) . \tag{22}
\end{equation*}
$$

We can then write $\widetilde{\psi}_{d}=\widetilde{\psi}+c \delta_{0}$ where

$$
\begin{equation*}
\tilde{\psi}=\widetilde{\psi}_{d}-c \delta_{0} \tag{23}
\end{equation*}
$$

is the part of $\widetilde{\psi}_{d}$ that is absolutely continuous with respect to Lebesgue measure $\Lambda$, and $c \delta_{0}$ is the discrete part (for some constant $c$ ).

The content of the next lemma is that $\widetilde{\psi}$ allows to represent the LAN inner product

$$
\begin{equation*}
\langle f, g\rangle_{L A N} \equiv\left\langle A_{\nu}(f), A_{\nu}(g)\right\rangle_{L^{2}\left(\mathbb{P}_{\nu}\right)}, f, g \in L^{2}(\nu) \tag{24}
\end{equation*}
$$

in the standard $L^{2}$-inner product $\langle\cdot, \cdot\rangle$ of $L^{2}(I)$.
Lemma 6. Assume the Lévy density $\nu \in L^{\infty}(I)$ is bounded away from zero on I. If $\psi \in$ $L^{\infty}(I)$ satisfies $\psi(0)=0$ then for all $h \in L^{2}(\nu)$ and $\widetilde{\psi}_{d}, \widetilde{\psi}$ given as in (22), (23),

$$
\int_{I} A_{\nu}(h) A_{\nu}(\widetilde{\psi}) d \mathbb{P}_{\nu}=\int_{I} A_{\nu}(h) A_{\nu}\left(\widetilde{\psi}_{d}\right) d \mathbb{P}_{\nu}=-\langle h, \psi\rangle
$$

Proof. From (16) and (23) we have $A_{\nu}\left(\widetilde{\psi}_{d}-\widetilde{\psi}\right)=0$, so the first identity is immediate. By Lemma 4 and the definition of $\widetilde{\psi}_{d}$ we see $A_{\nu}\left(\widetilde{\psi}_{d}\right)=-\pi_{\nu}(-\cdot) *(\psi / \nu)$ in $L_{0}^{2}\left(\mathbb{P}_{\nu}\right)$ and from Lemma 5 we hence deduce

$$
\int_{I} A_{\nu}(h) A_{\nu}\left(\widetilde{\psi}_{d}\right) d \mathbb{P}_{\nu}=-\int_{I} h\left[\mathbb{P}_{\nu}(-\cdot) * \pi_{\nu}(-\cdot) *(\psi / \nu)\right] \nu=-\int_{I} h \psi
$$

using also that $\mathbb{P}_{\nu}(-\cdot) * \pi_{\nu}(-\cdot)=\delta_{0}$ (cf. after (17)).
Using the LAN expansion and the previous lemma we derive the Cramér-Rao lower bound for $1 / \sqrt{n}$-consistently estimable functional parameters of the Lévy measure of a compound Poisson process, following the theory laid out in Chapter 25 in [32]. We recall some standard facts from efficient estimation in Banach spaces: assume for all $h$ in some linear subspace $H$ of a Hilbert space with Hilbert norm $\|\cdot\|_{L A N}$, that the LAN expansion

$$
\log \frac{d \mathbb{P}_{v+h / \sqrt{n}}^{n}}{d \mathbb{P}_{v}^{n}}=\Delta_{n}(h)-\frac{1}{2}\|h\|_{L A N}^{2}, v \in H
$$

holds, where $\mathbb{P}_{v}^{n}$ are laws on some measurable space $\mathcal{X}_{n}$ and where $\Delta_{n}(h) \rightarrow^{d} \Delta(h)$ as $n \rightarrow \infty$ with $\Delta(h) \sim N\left(0,\|h\|_{L A N}^{2}\right), h \in H$. Consider a map

$$
K:\left(H,\|\cdot\|_{L A N}\right) \rightarrow \mathbb{R}
$$

that is suitably differentiable with continuous linear derivative map $\kappa: H \rightarrow \mathbb{R}$. By Theorem 3.11 .5 in [33] the Cramér-Rao information lower bound for estimating the parameter $K(\nu)$ is given by $\left\|\kappa^{*}\right\|_{L A N}^{2}$ where $\kappa^{*}$ is the Riesz-representer of the map $\kappa:\left(H,\|\cdot\|_{L A N}\right) \rightarrow \mathbb{R}$.

We now apply this in the setting of the LAN expansion obtained from Proposition 3, with laws $\mathbb{P}_{v}^{n}$ parametrised by $v=\log \nu$, tangent space $H=L^{\infty}$ and LAN-norm $\|h\|_{L A N}=$ $\left\|A_{\nu_{0}} h\right\|_{L^{2}\left(\mathbb{P}_{\nu}\right)}$, where $A_{\nu_{0}}:\left(H,\|\cdot\|_{L^{2}\left(\nu_{0}\right)}\right) \rightarrow L_{0}^{2}\left(\mathbb{P}_{\nu_{0}}\right)$ is the score operator studied above corresponding to the true absolutely continuous Lévy density $\nu_{0}$ generating the data (note that the central limit theorem ensures $\Delta_{n}(h) \rightarrow^{d} \Delta(h)$ for these choices). For $\psi \in L^{\infty}(I)$ we consider the map

$$
K: v \mapsto \int_{I} \psi \nu=\int_{I} \psi e^{v},
$$

which can be linearised at $\nu_{0}$ with derivative

$$
\kappa: h \mapsto \int_{I} \psi h \nu_{0}=\left\langle\psi_{(0)}, h\right\rangle_{L^{2}\left(\nu_{0}\right)}=\int_{I} \psi 1_{\{0\}^{c} \nu_{0}} h
$$

where by definition $\psi_{(0)}=\psi 1_{\{0\}^{c}}$. Using Lemma 6 we have

$$
\kappa(h)=\left\langle\psi_{(0)} \nu_{0}, h\right\rangle=-\left\langle\left(\widetilde{\left.\psi_{(0)} \nu_{0}\right)_{d}}, h\right\rangle_{L A N} \equiv\left\langle\kappa^{*}, h\right\rangle_{L A N} .\right.
$$

We conclude that the Cramér-Rao information lower bound for estimating $\int_{I} \psi \nu_{0}$ from discretely observed increments of the compound Poisson process equals

$$
\begin{align*}
\left\|\kappa^{*}\right\|_{L A N}^{2} & =\left\|A_{\nu_{0}}\left(\widetilde{\left(\psi_{(0)} \nu_{0}\right)_{d}}\right)\right\|_{L^{2}\left(\mathbb{P}_{\nu_{0}}\right)}^{2}=\left\|\left(A_{\nu_{0}}^{*}\right)^{-1}\left[\psi_{(0)}\right)\right\|_{L^{2}\left(\mathbb{P}_{\nu_{0}}\right)}^{2} \\
& =\left\|\pi_{\nu}(-\cdot) *\left(\psi 1_{\{0\}^{c}}\right)\right\|_{L^{2}\left(\mathbb{P}_{\nu_{0}}\right)}, \tag{25}
\end{align*}
$$

where we used Lemma 4 in the second equality. Note that the last identity holds under the notational assumption $\Delta=1$ employed in the preceding arguments and the far right hand side needs to be scaled by $1 / \Delta^{2}$ when $\Delta \neq 1$.
2.5. A multi-scale Bernstein-von Mises theorem. We now formulate a Bernstein-von Mises theorem that entails a Gaussian approximation of the posterior distribution arising from prior (10) in an infinite-dimensional multi-scale space. We will show in the next subsection how one can deduce from it various Bernstein-von Mises theorems for statistically relevant aspects of $\nu, \mu, \lambda$. Following [7] (see also p.596f. in [18]) the idea is to study the asymptotics of the measure induced in sequence space by the action $\left(\left\langle\nu, \psi_{l k}\right\rangle\right)$ of draws $\nu \sim \Pi\left(\cdot \mid X_{1}, \ldots, X_{n}\right)$ of the conditional posterior distribution on the wavelet basis $\left\{\psi_{l k}\right\}$ from (7). In sequence space we introduce weighted supremum norms

$$
\begin{equation*}
\|x\|_{\mathcal{M}(w)}=\sup _{l} \frac{\max _{k}\left|x_{l k}\right|}{w_{l}}, \mathcal{M}(w)=\left\{\left(x_{l k}\right):\|x\|_{\mathcal{M}(w)}<\infty\right\} \tag{26}
\end{equation*}
$$

with monotone increasing weighting sequence $\left(w_{l}\right)$ to be chosen. Define further the closed separable subspace $\mathcal{M}_{0}(w)$ of $\mathcal{M}(w)$ consisting of sequences for which $w_{l}^{-1} \max _{k}\left|x_{l k}\right|$ converges to zero as $l \rightarrow \infty$, equipped with the same norm.

The Bernstein-von Mises theorem will be derived for the case where the posterior distribution is centred at the random element $\widehat{\nu}(J)=\left(\widehat{\nu}(J)_{l, k}\right)$ of $\mathcal{M}_{0}(w)$ defined as follows

$$
\begin{equation*}
\widehat{\nu}(J)_{l, k} \equiv \int_{I} \psi_{l k} \nu_{0}+\frac{1}{n} \sum_{i=1}^{n}\left(A_{\nu_{0}}^{*}\right)^{-1}\left[\psi_{l k} 1_{\{0\}^{c}}\right]\left(X_{i}\right), \quad l \leqslant J-1, k, \tag{27}
\end{equation*}
$$

with the convention that $\widehat{\nu}(J)_{l, k}=0$ whenever $l \geqslant J$ (the operator $\left(A_{\nu_{0}}^{*}\right)^{-1}$ was defined just after Lemma 5 above). A standard application of the central limit theorem and of (20) implies as $n \rightarrow \infty$ and under $\mathbb{P}_{\nu_{0}}^{\mathbb{N}}$ that, for every fixed $k, l$,

$$
\sqrt{n}\left(\widehat{\nu}(J)_{l, k}-\int_{I} \psi_{l k} \nu_{0}\right) \rightarrow^{d} N\left(0,\left\|\left(A_{\nu_{0}}^{*}\right)^{-1}\left[\psi_{l k} 1_{\{0\}^{c}}\right]\right\|_{L^{2}\left(\mathbb{P}_{\nu_{0}}\right)}^{2}\right),
$$

and hence in view of (25) the random variable $\widehat{\nu}(J)$ is a natural centring for a Bernstein-von Mises theorem. Since $\nu \in L^{\infty}(I)$ the law of $\sqrt{n}(\nu-\widehat{\nu}(J))$ defines a probability measure in the space $\mathcal{M}_{0}(\omega)$ for $\omega$ as in the next theorem. Next, denote by $\mathcal{N}_{\nu_{0}}$ the law $\mathcal{L}(\mathbb{X})$ of the centred Gaussian random variable $\mathbb{X}$ on $\mathcal{M}(w)$ whose coordinate process has covariances

$$
E \mathbb{X}_{l, k} \mathbb{X}_{l^{\prime}, k^{\prime}}=\left\langle\left(A_{\nu_{0}}^{*}\right)^{-1}\left(\psi_{l k} 1_{\{0\}^{c}}\right),\left(A_{\nu_{0}}^{*}\right)^{-1}\left(\psi_{l^{\prime} k^{\prime}} 1_{\{0\}^{c}}\right)\right\rangle_{L^{2}\left(\mathbb{P}_{\nu_{0}}\right)}
$$

The proof of the following theorem implies in particular that $\mathcal{N}_{\nu_{0}}$ is a tight Gaussian probability measure concentrated on the space $\mathcal{M}_{0}(w)$ where weak convergence occurs. Recall (Theorem 11.3.3 in [12]) that weak convergence of a sequence of probability measures on a separable metric space $(S, d)$ can be metrised by the bounded Lipschitz (BL) metric

$$
\begin{aligned}
\beta_{S}\left(\kappa, \kappa^{\prime}\right) & =\sup _{F: S \rightarrow \mathbb{R},\|F\|_{L i p} \leqslant 1}\left|\int_{S} F(s) d\left(\kappa-\kappa^{\prime}\right)(s)\right|, \\
\|F\|_{\text {Lip }} & =\sup _{s \in S}|F(s)|+\sup _{s \neq t, s, t \in S} \frac{|F(s)-F(t)|}{d(s, t)} .
\end{aligned}
$$

Theorem 7. Suppose the $X_{1}, \ldots, X_{n}$ are generated from (2) and grant Assumption 11. Let $\Pi\left(\cdot \mid X_{1}, \ldots, X_{n}\right)$ be the posterior distribution arising from prior $\Pi=\Pi_{J}$ in (10) with $J$ as in (11). Let $\beta_{\mathcal{M}_{0}(\omega)}$ be the BL metric for weak convergence of laws in $\mathcal{M}_{0}(\omega)$, with $\omega=\left(\omega_{l}\right)$ satisfying $\omega_{l} / l^{4} \uparrow \infty$ as $l \rightarrow \infty$. Let $\widehat{\nu}_{J}$ be the random variable in $\mathcal{M}_{0}(\omega)$ given by (27). Then for $\nu \sim \Pi\left(\cdot \mid X_{1}, \ldots, X_{n}\right)$ and $\mathcal{N}_{\nu_{0}}$ as above we have in $\mathbb{P}_{\nu_{0}}^{\mathbb{N}}$-probability, as $n \rightarrow \infty$,

$$
\beta_{\mathcal{M}_{0}(\omega)}\left(\mathcal{L}\left(\sqrt{n}(\nu-\widehat{\nu}(J)) \mid X_{1}, \ldots, X_{n}\right), \mathcal{N}_{\nu_{0}}\right) \rightarrow 0
$$

Theorem 7 is proved in Section 3.4 and has various implications for posterior-based inference on the parameter $\nu$. Arguing as in [7], Section 4.2, we could construct credible bands for the unknown Lévy density $\nu$ with $L^{\infty}$-diameter shrinking at the rate from Theorem 2 from Bayesian multi-scale credible bands. We will leave this application to the reader and instead focus on inference on functionals of the Lévy measure $\nu$ that are continuous, or differentiable, for $\|\cdot\|_{\mathcal{M}(\omega)}$ (see Section 4.1 in [7], [5]).
2.6. Bernstein-von Mises theorem for functionals of the Lévy measure. We now deduce from Theorem 7 Bernstein-von Mises theorems for the functionals

$$
V(t)=\int_{-1 / 2}^{t} \nu(x) d x, t \in I
$$

which for $t=1 / 2$ also includes the intensity $\lambda=\int_{I} d \nu=V(1 / 2)$ of the underlying Poisson process. From the usual 'Delta method' we can then also deduce a Bernstein-von Mises
theorem for the distribution function $M(t)=\int_{I} 1_{(-1 / 2, t]} d \mu$ of the jump measure $\mu=\nu / \lambda=$ $\nu / \int_{I} \nu$. The key to this is the following lemma, proved in (the proof of) Theorem 4 of [7].

Lemma 8. Suppose the weights $\left(\omega_{l}\right)$ satisfy $\sum_{l} 2^{-l / 2} \omega_{l}<\infty$. Then the mapping

L:\left(\nu_{l k}\right) \mapsto V=\int_{0} \sum_{l, k} \nu_{l k} \psi_{l k}
$$

is linear and continuous from $\mathcal{M}_{0}(\omega)$ to $L^{\infty}(I)$ for the respective norm topologies.
The measures $\mathcal{N}_{V_{0}}, \mathcal{N}_{M_{0}}^{\prime}$ in the next theorem have separable range in the image in $L^{\infty}(I)$ of $\mathcal{M}_{0}(\omega)$ under a continuous map. The metrisation of weak convergence of laws towards $\mathcal{N}_{V_{0}}, \mathcal{N}_{M_{0}}^{\prime}$ in the non-separable space $L^{\infty}$ by $\beta_{L^{\infty}(I)}$ thus remains valid (Theorem 3.28 in [13]).

Theorem 9. Suppose the $X_{1}, \ldots, X_{n}$ are generated from (2) and grant Assumption (1) Let $\nu \sim \Pi\left(\cdot \mid X_{1}, \ldots, X_{n}\right)$ be a draw from the posterior distribution arising from prior $\Pi=\Pi_{J}$ in (10) with $J$ as in (11) and let $L$ be the linear mapping from Lemma 8. Conditional on $X_{1}, \ldots, X_{n}$ define $V=L(\nu)$ and $\widehat{V}=L\left(\widehat{\nu}_{J}\right)$ where $\widehat{\nu}_{J}$ is given in (27).

Then we have as $n \rightarrow \infty$ and in $\mathbb{P}_{\nu_{0}}^{\mathbb{N}}$-probability that

\beta_{L^{\infty}(I)}\left(\mathcal{L}\left(\sqrt{n}(V-\widehat{V}) \mid X_{1}, \ldots, X_{n}\right), \mathcal{N}_{V_{0}}\right) \rightarrow 0
$$

where $\mathcal{N}_{V_{0}}$ is the law of the tight Gaussian random variable in $L^{\infty}(I)$ given by $L(Z), Z \sim \mathcal{N}_{\nu_{0}}$. In particular if $N_{\lambda_{0}}$ is the law on $\mathbb{R}$ of $L(Z)\left(\frac{1}{2}\right)$ then as $n \rightarrow \infty$,

\beta_{\mathbb{R}}\left(\mathcal{L}\left(\left.\sqrt{n}\left(V\left(\frac{1}{2}\right)-\widehat{V}\left(\frac{1}{2}\right)\right) \right\rvert\, X_{1}, \ldots, X_{n}\right), N_{\lambda_{0}}\right) \rightarrow^{\mathbb{P}_{\nu_{0}}^{\mathbb{N}}} 0
$$

Moreover, if $M=V / V\left(\frac{1}{2}\right)$ and $\widehat{M}=\widehat{V} / \widehat{V}\left(\frac{1}{2}\right)$, then as $n \rightarrow \infty$,

\beta_{L^{\infty}(I)}\left(\mathcal{L}\left(\sqrt{n}(M-\widehat{M}) \mid X_{1}, \ldots, X_{n}\right), \mathcal{N}_{M_{0}}^{\prime}\right) \rightarrow^{\mathbb{P}_{\nu_{0}}^{\mathbb{N}}} 0
$$

where $\mathcal{N}_{M_{0}}^{\prime}$ is the law of the tight Gaussian random variable in $L^{\infty}(I)$ given by $l_{\nu_{0}}[L(Z)]$ with $l_{\nu_{0}}$ the linear mapping $L^{\infty}(I) \mapsto L^{\infty}(I)$ given by $l_{\nu_{0}}[h]=\left(h V_{0}\left(\frac{1}{2}\right)-V_{0} h\left(\frac{1}{2}\right)\right) / V_{0}^{2}\left(\frac{1}{2}\right)$.

Proof. The first two limits are immediate consequences of Theorem 7, Lemma 8 and the continuous mapping theorem. For the last limit we apply the Delta method for weak convergence ([32], Theorem 20.8) to the map $V \mapsto V / V\left(\frac{1}{2}\right)$, which is Fréchet differentiable from $L^{\infty}(I) \rightarrow L^{\infty}(I)$ at any $\nu \in L^{\infty}(I)$ that is bounded away from zero, with derivative $l_{\nu}$.

Arguing just as before (25) one shows that the above Gaussian limit distributions all attain the semi-parametric Cramér-Rao lower bounds for the problems of estimating $V, M, \lambda=V\left(\frac{1}{2}\right)$, respectively. In particular they imply that 'Bayesian credible sets' are optimal asymptotic frequentist confidence sets for these parameters - the arguments are the same as in [7], Section 4.1, and hence omitted. These results are the 'Bayesian' versions of the Donsker type limit theorems obtained for frequentist estimators in [10, 24], where the same limit distributions were obtained.

## 3. Proofs of the main results

3.1. Asymptotics for the localised posterior distribution. The first step will be to localise the posterior distribution near the 'true' $\nu_{0} \in C^{s}$ by obtaining a preliminary (in itself sub-optimal) contraction rate for the prior $\Pi$ from (10). Recall the notation $v=\log \nu$ and define

with $M$ a constant and

\varepsilon_{n}^{L^{2}}=n^{-\frac{s-1 / 2}{2 s+1}}(\log n)^{1 / 2+\delta}, \quad \varepsilon_{n}^{L^{\infty}}=n^{-\frac{s-1}{2 s+1}}(\log n)^{1 / 2+\delta}
$$

for any $\delta>1 / 2$. We have the following
Proposition 10. For $D_{n, M}$ as in (28), prior $\Pi$ arising from (10) with $J$ chosen as in (11) and under Assumption 1, we have for any $s>5 / 2, \delta>1 / 2$ and every $M$ large enough

\Pi\left(D_{n, M}^{c} \mid X_{1}, \ldots, X_{n}\right) \rightarrow^{\mathbb{P}_{\nu_{0}}^{\mathbb{N}}} 0 \tag{29}
\end{equation*}

as $n \rightarrow \infty$. In particular we can choose $M$ in (28) large enough so that the last convergence to zero occurs also for $D_{n, M / 2}$ replacing $D_{n, M}$. Moreover, on the set $D_{n, M}$ we also have the same contraction rates for $\nu-\nu_{0}$ in place of $v-v_{0}$ with a possibly larger constant $M$.

Proof. This is proved in Section 4 below.
As a consequence of the previous proposition, if $\Pi^{D_{n, M}}:=\Pi^{D_{n, M}}\left(\cdot \mid X_{1}, \ldots, X_{n}\right)$ equals the posterior measure arising from the prior $\Pi\left(\cdot \cap D_{n, M}\right) / \Pi\left(D_{n, M}\right)$ instead of from $\Pi$, we can deduce the basic inequality

$$

& \sup _{B \in \mathcal{S}_{V}}\left|\Pi\left(B \mid X_{1}, \ldots, X_{n}\right)-\Pi^{D_{n, M}}\left(B \mid X_{1}, \ldots, X_{n}\right)\right| \\
& \leqslant 2 \Pi\left(D_{n, M}^{c} \mid X_{1}, \ldots, X_{n}\right) \rightarrow^{\mathbb{P}_{\nu_{0}}^{\mathbb{N}}} 0 \tag{30}
\end{align*}
$$

as $n \rightarrow \infty$. We now study certain Laplace-transform functionals of the localised posterior measure $\Pi^{D_{n, M}}$. We use the shorthand notation $g_{J}=P_{V_{J}}(g)$ for the wavelet projection of $g \in L^{2}(I)$ onto $V_{J}$, and for a fixed function $\eta: I \rightarrow \mathbb{R}$, consider a perturbation of $\nu$ given by

& v_{t}=v+\delta_{n}\left(\frac{t}{\delta_{n} \sqrt{n}} \eta+v_{0, J}-v\right)=\left(1-\delta_{n}\right) v+\delta_{n}\left(\frac{t}{\delta_{n} \sqrt{n}} \eta+v_{0, J}\right),
\end{align*}
$$

where $0<t<\infty$ and $\delta_{n} \rightarrow 0$ such that $\delta_{n} \sqrt{n} \rightarrow \infty$ is a sequence to be chosen. That the perturbation $\nu_{t}$ equals a convex combination of points will be useful to deal with the fact that our parameter space has a boundary (see also [22, 23]).

We have the following key proposition, giving general conditions under which a (sub-) Gaussian approximation for the Laplace transform of general functionals $F(\nu)$ of the posterior distribution holds. Its proof is given in Section 5 .

Proposition 11. Under the hypotheses of Proposition 10, suppose $\delta_{n}$ is chosen such that (61) is satisfied and let $\mathcal{H}_{n} \subseteq L^{\infty}(I)$ be such that (62), (63) hold uniformly for all $\eta \in \mathcal{H}_{n}$. If
$T>0$ and if $F: \mathcal{V} \rightarrow \mathbb{R}$ is any fixed measurable function then

& \quad=\exp \left\{\frac{t^{2}}{2}\left\|A_{\nu_{0}}(\eta)\right\|_{L^{2}\left(\mathbb{P}_{\nu_{0}}\right)}^{2}-\frac{t}{\sqrt{n}} \sum_{i=1}^{n} A_{\nu_{0}}(\eta)\left(X_{i}\right)+r_{n}\right\} \times Z_{n}
\end{aligned}
$$

where $r_{n}=O_{\mathbb{P}_{\nu_{0}}}\left(a_{n}\right)$ as $n \rightarrow \infty$ with a nonstochastic null sequence $a_{n} \rightarrow 0$ that is uniform in $|t| \leqslant T, \eta \in \mathcal{H}_{n}$; and where

$$
\begin{gathered}
Z_{n}=\frac{\int_{D_{n, M}} e^{S_{n}(\nu)+\ell_{n}\left(\nu_{t}\right)} d \Pi(\nu)}{\int_{D_{n, M}} e^{\ell_{n}(\nu)} d \Pi(\nu)}, \quad \nu_{t} \text { as in (31) }, \\
S_{n}(\nu)=t \sqrt{n}\left(F(\nu)+\int A_{\nu_{0}}\left(v-v_{0}\right) A_{\nu_{0}}(\eta) d \mathbb{P}_{\nu_{0}}\right), v=\log \nu, \quad v_{0}=\log \nu_{0},
\end{gathered}
$$

and $A_{\nu}: L^{2}(\nu) \rightarrow L_{0}^{2}\left(\mathbb{P}_{\nu}\right)$ was defined in Proposition 3 .
Given a functional $F$ of interest, Proposition 11 can be used to prove Bernstein-von Mises theorems by selecting appropriate $\eta$ so that $S(\nu)$ vanishes (or converges to zero). When this is the case it remains to deal with $Z_{n}$ by a change of measure argument for $\nu \mapsto \nu_{t}$.
3.2. Change of measure in the posterior. We now study the ratio $Z_{n}$ for $\eta, \delta_{n}$ satisfying certain conditions, and under the assumption that $\sup _{\nu \in D_{n, M}}\left|S_{n}(\nu)\right|$ is either $O(1)$ or $o(1)$. Note that by Assumption 1, $v_{0}=\log \nu_{0}$ is an 'interior' point of the support

of the prior $\Pi$. We shall require that $\left(t / \delta_{n} \sqrt{n}\right) \eta+v_{0, J}$ is also contained in $V_{B, J}$, implied by

Note that under (321) the function $v_{t}$ from (31) is a convex combination of elements $v,\left(t / \delta_{n} \sqrt{n}\right) \eta+v_{0, J}$ of $V_{J, B}$ and hence itself contained in the support $V_{J, B}$ of $\Pi$. We can thus write

where $\Pi^{t}$ is the law of $\nu_{t}$, absolutely continuous with respect to $\Pi$, and where

D_{n, M}^{t}=\left\{\nu_{t}: \nu \in D_{n, M}\right\} .
$$

The measure $\Pi^{t}$ corresponds to transforming each coordinate $v_{l k}$ of the $2^{J}$-dimensional product integral defining the prior $\Pi$ into the convex combination $v_{t, l k}=\left(1-\delta_{n}\right) v_{l k}+\delta_{n} i_{t, l k}$ where $i_{t, l k}=\left\langle\frac{t}{\delta_{n} \sqrt{n}} \eta+v_{0, J}, \psi_{l k}\right\rangle$ is a deterministic (under $\Pi$ ) point in $\left(-B a_{l}, B a_{l}\right)=I_{l, B}$ for every $k, l \leqslant J$. The density of the law of $v_{t, l k}$ with respect to $v_{l k}$ is constant on a subinterval of $I_{l, B}$ of length $2 B\left(1-\delta_{n}\right)$ and thus has constant density $\left(1-\delta_{n}\right)^{-1}$. The density of the product integrals is then also constant in $v$ and equal to

independently of $\nu$. We conclude that if (32), (33) hold then

& =(1+o(1)) \times \frac{\Pi\left(D_{n, M}^{t} \mid X_{1}, \ldots, X_{n}\right)}{\Pi\left(D_{n, M} \mid X_{1}, \ldots, X_{n}\right)},
\end{align*}
$$

where the last identity follows from renormalising both numerator and denominator by $\int_{\mathcal{V}} e^{\ell_{n}(\nu)} d \Pi(\nu)$. The numerator in the last expression is always less than or equal to one and by Proposition 10 the denominator converges to one in probability, so that we have

Lemma 12. Suppose $\sup _{\nu \in D_{n, M}}\left|S_{n}(\nu)\right|=O(1)$ holds as $n \rightarrow \infty$ and assume $\eta, \delta_{n}, t$ are such that (32), (33) hold. Then the random variable $Z_{n}$ in Proposition 11 is $O_{\mathbb{P}_{\nu_{0}}}(1)$, uniformly in $\eta$, as $n \rightarrow \infty$.

To prove the exact asymptotics in the Bernstein-von Mises theorem we need:
Lemma 13. Suppose $\eta, \delta_{n}$ are such that (32), (331) hold and assume in addition that $\|\eta\|_{\infty} \leqslant$ $d$ for some fixed constant $d$.
A) Let $D_{n, M}$ be as in (28) and define the set $D_{n, M}^{t}=\left\{\nu_{t}: \nu \in D_{n, M}\right\}$. Then for all $n \geqslant n_{0}(t)$ and $M$ large enough we have $D_{n, M / 2} \subseteq D_{n, M}^{t}$ and thus by Proposition 10 also $\Pi\left(D_{n, M}^{t} \mid X_{1}, \ldots, X_{n}\right) \rightarrow 1$ in $\mathbb{P}_{\nu_{0}}^{\mathbb{N}}$-probability.
B) Assume also that $\sup _{\nu \in D_{n, M}}\left|S_{n}(\nu)\right|=o(1)$ then $Z_{n}$ from Proposition 11 satisfies $Z_{n}=$ $1+o_{\mathbb{P}_{\nu_{0}}}(1)$ as $n \rightarrow \infty$.

Proof. A) Let $\nu \in D_{n, M / 2}$ be arbitrary. We need to show that there exists $\zeta=\zeta(\nu) \in D_{n, M}$ such that $\zeta_{t}=\nu$. For $v=\log \nu$ notice that by definition of $D_{n, M / 2}$ we have $\left\|v-v_{0, J}\right\|_{L^{2}} \leqslant$ $\left\|v-v_{0}\right\|_{L^{2}} \leqslant(M / 2) \varepsilon_{n}^{L^{2}}$ and similarly $\left\|v-v_{0, J}\right\|_{\infty} \leqslant(M / 2) \varepsilon_{n}^{L^{\infty}}$. Now define $\zeta=e^{z}$ where

z=z(\nu):=v_{0, J}+\frac{\left(v-v_{0, J}\right)-\frac{t}{\sqrt{n}} \eta}{1-\delta_{n}}, \nu \in D_{n, M / 2} .
$$

Then by definition

\end{aligned}
$$

so $\zeta_{t}(\nu)=\nu$ follows. It remains to verify that also $\zeta(\nu) \in D_{n, M}$ for every $\nu \in D_{n, M / 2}$. To see this we let $n$ large enough such that in particular $\delta_{n}<1 / 4$ and then

using $\left\|v_{0}-v_{0, J}\right\|_{L^{2}} \lesssim 2^{-J s}=o\left(\varepsilon_{n}^{L^{2}}\right)$ from (8) and also $1 / \sqrt{n}=o\left(\varepsilon_{n}^{L^{2}}\right)$. The same arguments imply

Finally we need to check that $z(\nu) \in V_{J, B}$ holds true. We notice that for all $l \leqslant J$

\varepsilon_{n}^{L^{2}} \approx n^{-\frac{s-1 / 2}{2 s+1}}(\log n)^{1 / 2+\delta}=o\left(2^{-J}\left(J^{2}+1\right)^{-1}\right), s>5 / 2
$$

for $n$ large enough, so that from Assumption 1 and (35) we deduce

\left|\left\langle z(\nu), \psi_{l k}\right\rangle\right| \leqslant\left|\left\langle v_{0}, \psi_{l k}\right\rangle\right|+\left|\left\langle z(\nu)-v_{0}, \psi_{l k}\right\rangle\right| \leqslant(B-\gamma) a_{l}+\gamma a_{l}, l \leqslant J-1
$$

for $n$ large enough, hence $\zeta \in V_{J, B}$. The last claim in Part A) now follows directly from Proposition 10, and Part B) also follows, from (34).
3.3. Proof of Theorem 2. Given the results from Sections 3.1, 3.2, the proof follows ideas in [4]. By (30) it suffices to prove the theorem with the posterior $\Pi\left(\cdot \mid X_{1}, \ldots, X_{n}\right)$ replaced by $\Pi^{D_{n, M}}\left(\cdot \mid X_{1}, \ldots, X_{n}\right)$. Using that $\nu=e^{v}$ are uniformly bounded and that $v_{J}=P_{V_{J}} v=v$ for $v \sim \Pi^{D_{n, M}}\left(\cdot \mid X_{1}, \ldots, X_{n}\right)$, we can write

The second term is of deterministic order $2^{-J_{n} s}=O\left(n^{-s /(2 s+1)}\right)$ by (8) and since $v_{0}=\log \nu_{0} \in$ $C^{s}$, so it remains to deal with the first. We can write, using (8) again,

& \lesssim \sum_{\ell<J} \frac{2^{\ell / 2}}{\sqrt{n}}(\log n)^{1 / 2+\delta} \max _{m=0, \ldots, 2^{\ell}-1} \frac{\sqrt{n}}{(\log n)^{1 / 2+\delta}}\left|\left\langle v-v_{0}, \psi_{\ell m}\right\rangle\right| \\
& \lesssim \frac{2^{J / 2}(J+1)}{\sqrt{n}}(\log n)^{1 / 2+\delta} \max _{\ell<J, m=0, \ldots, 2^{\ell-1}} \sqrt{n}\left|\left\langle v-v_{0}, c_{\ell J} \psi_{\ell m}\right\rangle\right| \tag{36}
\end{align*}
$$

where we have set $c_{\ell J}=\frac{2^{\ell / 2}}{2^{J / 2}}(\log n)^{-1 / 2-\delta}$, bounded by 1 since $\ell \leqslant J$.
Fix $\ell<J, m$ for the moment and let $\widetilde{\psi} \equiv(\widetilde{\psi})_{\ell m}$ be the absolutely continuous part (23) of $\widetilde{\psi}_{d}$ from (21) where we choose $\psi=c_{\ell J} \psi_{\ell m} 1_{I \backslash\{0\}}$. We will apply Proposition 11 to the functional $F(\nu)=\left\langle v-v_{0}, c_{\ell J} \psi_{\ell m}\right\rangle$ and for the choices

\eta=\widetilde{\psi}_{J} \quad \text { and } \quad \delta_{n}=\frac{K 2^{J}\left(J^{2}+1\right)}{\sqrt{n}} \tag{37}
\end{equation*}
$$

where $K>0$ is a constant. To bound the term $S_{n}(\nu)$ in Proposition 11 we need the following approximation lemma.
Lemma 14. For any $\psi=c_{\ell J} \psi_{\ell m} 1_{I \backslash\{0\}}$ with fixed $\ell<J, m$, let $\widetilde{\psi}_{d}$ be the corresponding finite measure defined in (21), let $\widetilde{\psi}$ be its absolutely continuous part from (23), and let $\widetilde{\psi}_{J}=P_{V_{J}}(\widetilde{\psi})$ be its wavelet projection onto $V_{J}$. Then we have, for some constant $c_{0}$ independent of $\ell, m, J$, that

& =\sum_{l>J} \sum_{k}\left\langle h\left(\nu, \nu_{0}\right), \psi_{l k}\right\rangle\left\langle\widetilde{\psi}, \psi_{l k}\right\rangle
\end{aligned}
$$

where we have used Parseval's identity, and the shorthand notation $h\left(\nu, \nu_{0}\right):=\nu_{0} A_{\nu_{0}}^{*}\left[A_{\nu_{0}}(v-\right.$ $\left.\left.v_{0}\right)\right]$. Now $\widetilde{\psi}$ is the absolutely continuous part of $\widetilde{\psi}_{d}$ which according to (22) (with $\Delta=1$ w.l.o.g.) is given by

& =-\frac{e^{2 \nu_{0}(I)}}{\nu_{0}}\left(\sum_{\iota=0}^{\infty} \sum_{\kappa=0}^{\infty} \frac{(-1)^{\iota+\kappa}}{\iota!\kappa!}\left(\nu_{0}^{* \iota} * \nu_{0}(-\cdot)^{* \kappa} * \frac{\psi}{\nu_{0}}\right) \mathbb{P}_{\nu_{0}}\right) .
\end{aligned}
$$

By standard properties of convolutions, using (4) and since $\psi / \nu_{0}$ is absolutely continuous, removing the discrete part of $\widetilde{\psi}_{d}$ means removing Dirac measure from the series expansion of $\mathbb{P}_{\nu_{0}}$ - denote the resulting absolutely continuous measure by $P_{\nu_{0}}$. First we consider the part $\bar{\psi}$ of $\widetilde{\psi}$ corresponding to the terms in the last series where either $\iota>0$ or $\kappa>0$, so that not all of the convolution factors in

are Dirac measures $\delta_{0}$. Since $C^{s}(I), s>5 / 2$, is imbedded into the standard periodic Sobolev space $H^{\alpha}(I), \alpha \leqslant 2$, we can use the basic convolution inequality $\|f * g\|_{C^{\alpha}(I)} \leqslant$ $\|f\|_{H^{\alpha}(I)}\|g\|_{L^{2}}, \alpha=0,2$, (proved, e.g., just as Lemma 4.3.18 in [18]), the fact that $\psi / \nu_{0}=$ $c_{\ell J} \psi_{\ell m} / \nu_{0}$ is bounded in $L^{2}=H^{0}$, and the multiplier property $\|f g\|_{H^{2}} \lesssim\|f\|_{C^{2}}\|g\|_{H^{2}}$ combined with the fact that the density of $P_{\nu_{0}}$ is contained in $C^{s}(I) \subseteq C^{2}(I)$, to deduce that $\bar{\psi}$ is contained in $C^{2}(I)$ and thus, by (8)

which is of the desired order.
Setting $\iota=\kappa=0$ in the preceding representation of $\widetilde{\psi}$ and using the convolution series representation of $P_{\nu_{0}}$ (without discrete part) yields the 'critical' term which is given by $-\psi g$ where

& \quad \lesssim \sum_{l>J} 2^{-l / 2}\left\|h\left(\nu, \nu_{0}\right)\right\|_{L^{2}}\left\|\psi_{\ell m}\right\|_{L^{1}} \lesssim 2^{-J / 2} 2^{-\ell / 2}\left\|\nu-\nu_{0}\right\|_{L^{2}}
\end{aligned}
$$

Scaling the last estimate by a multiple of $c_{\ell J}=2^{\ell / 2-J / 2}(\log n)^{-1 / 2-\delta}$ leads to the result.
Conclude from Proposition 10 and our choice of $J$ that

Simple calculations (using that (22) implies that $\widetilde{\psi}_{J}, 2^{-J / 2} \widetilde{\psi}_{J}$ are uniformly bounded in $L^{2}, L^{\infty}$, respectively, proved by arguments similar to those used in Lemma 14) show that for $s>5 / 2$ the three conditions (61), (62), (63) and the two conditions (32), (33) are all satisfied for such $\eta, \delta_{n}$ chosen as in (37) and $K$ large enough. We thus deduce from Proposition 11 and Lemma 12 that for some sequence $C_{n}=O_{\mathbb{P}_{\nu_{0}}}(1)$ and $|t| \leqslant T$,

\end{aligned}
$$

If we define $\widetilde{\nu}_{\ell m}=-\frac{1}{n} \sum_{k=1}^{n} A_{\nu_{0}}\left(\widetilde{\psi}_{J}\right)\left(X_{k}\right)+c_{\ell J} \int v_{0} \psi_{\ell m}$ then for $|t| \leqslant T$ this becomes the sub-Gaussian estimate

\end{equation*}

for the stochastic process $Z_{\ell, m}=\left(c_{\ell J} \int v \psi_{\ell m}-\widetilde{\nu}_{\ell m}\right) \mid X_{1}, \ldots, X_{n}$ conditional on $X_{1}, \ldots, X_{n}$, with constants $\eta, t$ uniform. We can then decompose

and the maximum over $2^{J}$ many variables in (36) can now be estimated by the sum of the maxima of each of the preceding processes. For the first process we observe that the sub-Gaussian constants are uniformly bounded through

\end{equation*}

using Lemma [26, that $\nu_{0} \in L^{\infty}$ is bounded away from zero, that $P_{V_{J}}$ is a $L^{2}$-projector, combined with standard convolution inequalities. Using the sub-Gaussian estimate for $|t| \leqslant$ $T$, the display in the proof of Lemma 2.3.4 in [18] yields that this maximum has expectation of order at most $O(J)$ with $\mathbb{P}_{\nu_{0}}^{\mathbb{N}}$-probability as close to one as desired. To the maximum of the second (empirical) process we apply Lemma 3.5.12 in [18] (and again Lemma [26] combined with the inequality in the previous display and also that $\|g\|_{\infty} \lesssim 2^{J / 2}\|g\|_{L^{2}}$ for any $g \in V_{J}$ ) to see that its $\mathbb{P}_{\nu_{0}}^{\mathbb{N}}$-expectation is of order $O\left(\sqrt{J}+J 2^{J / 2} / \sqrt{n}\right)=O(\sqrt{J})$ uniformly in $\ell \leqslant J, m$. Feeding these bounds into (36) we see that on an event of $\mathbb{P}_{\nu_{0}}^{\mathbb{N}}$-probability as close to one as desired,

Since $\delta>1 / 2$ was arbitrary an application of Markov's inequality completes the proof.
3.4. Proof of Theorem 7. Given results from Sections 3.1, 3.2, the proof follows ideas in [7]. Let $\widehat{\nu}(J)$ be the random element of $\mathcal{M}_{0}(w)$ from (27) with $J$ chosen as in (11). For $D_{n, M}$ as in (28) let $\Pi^{D_{n, M}}\left(\cdot \mid X_{n}, \ldots, X_{n}\right)$ be as before (30), and suppose $\nu \sim \Pi^{D_{n, M}}\left(\cdot \mid X_{1}, \ldots, X_{n}\right)$. In view of (30), and since the total variation distance dominates the metric $\beta_{\mathcal{M}_{0}(\omega)}$, it suffices to prove the result for $\Pi^{D_{n, M}}\left(\cdot \mid X_{1}, \ldots, X_{n}\right)$ replacing $\Pi\left(\cdot \mid X_{1}, \ldots, X_{n}\right)$. Let $\widetilde{\Pi}_{n}$ denote the laws of $\sqrt{n}(\nu-\widehat{\nu}(J))$ conditionally on $X_{1}, \ldots, X_{n}$ and let $\mathcal{N}_{\nu_{0}}$ be the Gaussian probability measure on $\mathcal{M}_{0}(w)$ defined (cylindrically) before Theorem $\mathbb{Z}$, arising from the law of $\mathbb{X}=\left(\mathbb{X}_{l, k}\right)$. The following norm estimate is the main step to establish tightness of the process $Z$ in $\mathcal{M}_{0}(\omega)$.

Lemma 15. For any monotone increasing sequence $\bar{w}=\left(\bar{w}_{l}\right), \bar{w}_{l} / l^{4} \geqslant 1$, if $Z$ equals either $\mathbb{X}$ or the process $\sqrt{n}(\nu-\widehat{\nu}(J)) \mid X_{1}, \ldots, X_{n}$, then for some fixed constant $C>0$ we have

Proof. We first consider the more difficult case where $Z$ is the centred and scaled posterior process. We decompose, with $\nu_{J}=P_{V_{J}}(\nu)$,

The second term on the right hand side has multi-scale norm $\left\|\nu_{0}-\nu_{0, J}\right\|_{\mathcal{M}(w)}$ bounded by $2^{-J(s+1 / 2)} w_{J}^{-1}=o(1 / \sqrt{n})$ in view of (8),$\left\|\psi_{l k}\right\|_{L^{1}} \lesssim 2^{-l / 2}$. Similarly the expectation of the
multi-scale norm of the third term is bounded by

& \leqslant w_{J}^{-1} \sup _{l>J} \max _{k}\left\|\psi_{l k}\right\|_{L^{1}} \int\left\|\nu-\nu_{0}\right\|_{\infty} d \Pi^{D_{n, M}}\left(\nu \mid X_{1}, \ldots, X_{n}\right) \\
& \lesssim \frac{2^{-J / 2} 2^{J / 2}}{J^{4} \sqrt{n}} \log ^{5 / 2+\delta} n=o_{\mathbb{P}_{\nu_{0}}}(1 / \sqrt{n}),
\end{aligned}
$$

using (40). We turn to bounding the multi-scale norm of the first term, corresponding to

equals

\begin{equation*}
\int_{I}\left(\nu-\nu_{0}\right) \psi_{l k}=\int_{I}\left(e^{v}-e^{v_{0}}\right) \psi_{l k}=\int_{I}\left(v-v_{0}\right) \nu_{0} \psi_{l k}+O\left(\left\|\nu-\nu_{0}\right\|_{\infty}^{2}\right) \tag{43}
\end{equation*}
$$

and the quadratic remainder is of order $o(1 / \sqrt{n})$ uniformly in $k, l$ by definition of $D_{n, M}$ and since $s>5 / 2$.
Lemma 16. Let $\psi=\nu_{0} \psi_{l k} 1_{I \backslash\{0\}}$ for some $l<J, k$ with corresponding $\widetilde{\psi}=(\widetilde{\psi})_{l k}$ from (21), (23) and wavelet approximation $\widetilde{\psi}_{J} \in V_{J}$. We have

\left|\int_{I} A_{\nu_{0}}\left(v-v_{0}\right) A_{\nu_{0}}\left(\widetilde{\psi}_{J}\right) d \mathbb{P}_{\nu_{0}}+\int_{I}\left(v-v_{0}\right) \nu_{0} \psi_{l k}\right| \lesssim\left\|\nu-\nu_{0}\right\|_{\infty} 2^{-J} .

Proof. The proof requires only notational adaptation of the proof of Lemma 14, except for the last display, where now we use Lemma 26 (and its variant for $A_{\nu}^{*}$ ) in the estimate $\left|\left\langle h\left(\nu, \nu_{0}\right), \psi_{l k}\right\rangle\right| \leq\left\|h\left(\nu, \nu_{0}\right)\right\|_{\infty}\left\|\psi_{l k}\right\|_{L^{1}} \lesssim 2^{-l / 2}\left\|\nu-\nu_{0}\right\|_{\infty}$ so that scaling by $c_{\ell J}$ is not necessary.

The upper bound in the display of Lemma 16 has $E^{D_{n, M}}\left[\cdot \mid X_{1}, \ldots, X_{n}\right]$-expectation of order $o(1 / \sqrt{n})$ in view of (40). We now apply Proposition 11 to the functional

Conclude from Proposition 11 and Lemma 12 that

for $|t| \leqslant T$, or equivalently, if $V_{l k}=\frac{1}{n} \sum_{k=1}^{n} A_{\nu_{0}}\left(\widetilde{\psi}_{J}\right)\left(X_{k}\right)$, then for some $C_{n}^{\prime}=O_{\mathbb{P}_{\nu_{0}}}(1)$,

Arguing just as in (39) the sub-Gaussian constants $\left\|\widetilde{\psi}_{J}\right\|_{L A N}^{2}$ are bounded by a fixed constant. We then have, for $M$ a fixed constant and using $w_{l} \geqslant l$,

Moreover, one proves $E_{\nu_{0}} \sup _{l<J} w_{l}^{-1} \max _{k}\left|V_{l k}\right| \lesssim 1 / \sqrt{n}$ and also $E_{\nu_{0}} \sup _{l<J} w_{l}^{-1} \max _{k}\left|W_{l k}\right| \lesssim 1 / \sqrt{n}$ just as in the proof of Theorem 1 in [7] (or Theorem 5.2.16 in [18]), using Bernstein's inequality combined with the previous bound on the sub-Gaussian constants and a uniform bound of order $2^{J / 2}$ (proved just as after (39)) on the envelopes $\left\|A_{\nu_{0}}\left(\widetilde{\psi}_{J}\right)\right\|_{\infty},\left\|\left(A_{\nu_{0}}^{*}\right)^{-1}\left(\psi_{l k} 1_{\{0\}^{c}}\right)\right\|_{\infty}, l \leqslant J$, of the empirical processes involved. Combining what precedes with Lemma 16 (and the remark after it), (42), (431) proves (41) for the 'posterior' process. The Gaussian process $\mathbb{X}$ admits by definition the same (sub-) Gaussian bound as in (45) so that the result follows from the same arguments just given.

The inequality (41) implies in particular that for any weighting sequence $\omega$ as in Theorem7, the processes $Z$ concentrate in the separable subspace $\mathcal{M}_{0}(\omega)$ of $\mathcal{M}(\omega)$, and their laws define tight (in the case of $\mathcal{N}_{\nu_{0}}$, Gaussian) Borel probability measures in it (by Ulam's theorem, see p. 225 in [12]). Then, using the estimate (411) and arguing as in the proof of Proposition 6 in [7] (or in Theorem 7.3.20 in [18]), Theorem 7 will follow if we can establish convergence of the finite-dimensional distributions $\widetilde{\Pi}_{n} \circ P_{V_{L}}^{-1}$ towards those of $\mathcal{N}_{\nu_{0}} \circ P_{V_{L}}^{-1}, L \in \mathbb{N}$ fixed, as $n \rightarrow \infty$, where $P_{V_{L}}$ is the projection operator onto the finite-dimensional subspace $V_{L}$ of $\mathcal{M}_{0}(w)$ corresponding to the first $2^{L}$ coordinates $\left(x_{l k}: l \leqslant L, k\right)$. For this we proceed as in the previous lemma, combining (42), (43) with Lemma 16 and the definition of $W_{l k}$, to reduce the problem to showing for $\nu \sim \Pi^{D_{n, M}}\left(\cdot \mid X_{1}, \ldots, X_{n}\right)$ weak convergence in probability of the conditional laws of

and convergence in distribution now follows from standard arguments (see, e.g., Proposition 29 in [23]). This argument extends directly to all linear combinations $\sum_{l \leqslant L, k} a_{l, k} \psi_{l k}$, so that we can apply the Cramer-Wold device to obtain joint convergence in $V_{L}$ for any $L \in \mathbb{N}$. The proof is complete.

## 4. Proof of Proposition 10

We first derive a general contraction theorem from which we will deduce Proposition 10 (after Proposition [23). We follow the usual 'testing and small ball probability approach' (as in Theorem 7.3.1 in [18], see also [16]), which in our setting gives the following starting point to prove contraction rates, where $K\left(\mathbb{P}_{\nu}, \mathbb{P}_{\nu^{\prime}}\right)$ denotes the usual Kullback-Leibler (KL-) divergence between two probability measures $\mathbb{P}_{\nu}, \mathbb{P}_{\nu^{\prime}}$.

Proposition 17. Consider a prior $\Pi$ on a $\sigma$-field $\mathcal{S}_{V}$ of some set $\mathcal{V}$ of Lévy measures for which the map $(\nu, x) \mapsto p_{\nu}(x)$, defined before (5) is jointly measurable. Let d be some metric on $\mathcal{V}$ such that $\nu \mapsto d\left(\nu, \nu^{\prime}\right)$ is measurable for all $\nu^{\prime} \in \mathcal{V}$. Suppose for some sequence $\varepsilon_{n} \rightarrow 0$ such that $\sqrt{n} \varepsilon_{n} \rightarrow \infty$, constant $C>0$ and $n$ large enough we have

As in previously studied 'inverse problems' settings [23, 26, 28], to apply this proposition with a metric $d$ different from the Hellinger distance $h\left(\mathbb{P}_{\nu}, \mathbb{P}_{\nu_{0}}\right)$ requires new approaches to the construction of frequentist tests, and as in these references we use tools from 'concentration of measure' theory put forward in [17], where we initially choose for $d$ the weak (or 'robust') metric induced by the norm $\|\cdot\|_{\mathbb{H}(\delta)}$ of

a negative order Sobolev space. Contraction rates in stronger norms will then be deduced from interpolation arguments. Before doing so, however, we need to calculate KL-divergences for the observation scheme relevant in our context, and show that they can be bounded in terms of the distance of their Lévy measures.

By the upper and lower bounds on the Lévy densities the differentiation may be performed under the integral and we obtain

Assumption 19. The intensity $\lambda$ of $\nu$ satisfies $\lambda<\pi / \Delta$.
For Lévy processes on $\mathbb{R}$ the Lévy measure can be identified by taking the complex logarithm of the characteristic function of $\mathbb{P}_{\nu}$ in such a way that the resulting function is continuous. (This is known as the distinguished logarithm.) For Lévy processes on a circle the characteristic function is defined only on the integer lattice and a continuous version of the logarithm cannot be defined. However, this problem can be resolved by assuming $\lambda<\pi / \Delta$ since then the exponent in the Lévy-Khintchine representation always coincides with the principle branch of the logarithm of the characteristic function, ensuring identifiability. This condition is sharp as the following examples show.

Examples. By the Lévy-Khintchine representation (3) we see that $\mathbb{P}_{\nu_{1}}$ and $\mathbb{P}_{\nu_{2}}$ coincide if $\mathcal{F} \nu_{1}(k)$ equals $\mathcal{F} \nu_{2}(k)$ modulo multiples of $2 \pi i / \Delta$ for all $k \in \mathbb{Z}$.
(i) For $\nu_{1}=(\pi / \Delta) \delta_{1 / 4}$ and $\nu_{2}=(\pi / \Delta) \delta_{-1 / 4}$ we have $\mathcal{F} \nu_{1}(k)=\mathcal{F} \nu_{2}(k)$ for all even $k$ and $\mathcal{F} \nu_{1}(k)=\mathcal{F} \nu_{2}(k)+(2 \pi / \Delta) i$ or $\mathcal{F} \nu_{1}(k)=\mathcal{F} \nu_{2}(k)-(2 \pi / \Delta) i$ for all odd $k$. This shows that the intensity bound in Assumption (19) is sharp.
(ii) For $\nu_{1}(x)=(4 \pi / \Delta)(\sin (2 \pi x))_{+}$and $\nu_{2}(x)=(4 \pi / \Delta)(\sin (2 \pi x))_{-}$we have $\mathcal{F} \nu_{1}(1)=$ $\mathcal{F} \nu_{2}(1)+(2 \pi / \Delta) i$ and $\mathcal{F} \nu_{1}(-1)=\mathcal{F} \nu_{2}(-1)-(2 \pi / \Delta) i$. For all other $k$ it can be shown that $\mathcal{F} \nu_{1}(k)=\mathcal{F} \nu_{2}(k)$. This demonstrates that there exist nonidentifiable Lévy measures which are absolutely continuous with respect to Lebesgue measure.

\leq e^{-D x^{2}}+\frac{e^{-\frac{n R_{2}}{\log K}}}{R_{2}} . \tag{47}
\end{array}
$$

Proof. We first show the above concentration inequality with $\|\widehat{\nu}-\nu\|_{\mathbb{H}(\delta)}$ replaced by $\mid \widehat{\lambda}-$ $\lambda \mid$, where $\lambda=\int_{I} \nu=(\mathcal{F} \nu)(0)$ is the intensity and $\widehat{\lambda}$ is an estimator defined as follows: Let $\varphi_{n}(k)=(1 / n) \sum_{j=1}^{n} \exp \left\{2 \pi i k X_{j}\right\}$ be the empirical characteristic function, set $\Phi_{n}(k)=$ $\Delta^{-1} \log \varphi_{n}(k)$ for $\varphi_{n}(k) \neq 0$ and $\Phi_{n}(k)=0$ otherwise, where we take the principal branch of the complex logarithm. For $K \geqslant 2$ consider the estimator $\widehat{\lambda}=-(1 / K) \sum_{k=1}^{K} \operatorname{Re} \Phi_{n}(k)$. The Lévy-Khintchine representation (3) yields $\Phi_{\nu}(k):=\Delta^{-1} \log \varphi_{\nu}(k)=\mathcal{F} \nu(k)-\lambda$, where thanks to the restriction $\|\nu\|_{L^{1}}<\pi / \Delta$ the imaginary part on the r.h.s. lies in $(-\pi / \Delta, \pi / \Delta)$ and hence $\log$ is the logarithm in the principle branch. We obtain

& =-\frac{1}{K} \sum_{k=1}^{K} \operatorname{Re}\left(\Phi_{n}(k)-\Phi_{\nu}(k)\right)-\frac{1}{K} \sum_{k=1}^{K} \operatorname{Re} \mathcal{F} \nu(k) \tag{48}
\end{align*}

In order to linearise the first term in previous equation we define the event

It holds $|\log (1+z)-z| \leqslant 2|z|^{2}$ for $|z| \leqslant 1 / 2$. Thus we have on the event $A_{n}$ for $|k| \leqslant K$

& =\frac{1}{\Delta}\left\{\frac{\varphi_{n}(k)-\varphi_{\nu}(k)}{\varphi_{\nu}(k)}+O\left(\left|\frac{\varphi_{n}(k)-\varphi_{\nu}(k)}{\varphi_{\nu}(k)}\right|^{2}\right)\right\} .
\end{aligned}

The first term in (48), up to linearisation, is purely stochastic and bounded by a term of the form

Since $\|\nu\|_{1}<\pi / \Delta$ we know that $\sup _{k}\left|1 / \varphi_{\nu}(k)\right| \leqslant c^{\prime}$ for some constant $c^{\prime}=c^{\prime}(\Delta)$. For the numerator we consider the $4 K+4$ random variables

and denote them by $Z_{j}$ with $j=1, \ldots, 4 K+4$. These have bounded differences with constant $c^{2}=4 / n$ which follows from using example b) before Theorem 3.3.14 in [18] and observing
that $e^{2 \pi i k(\cdot)}$ are uniformly bounded by 1. Applying this theorem we have $E e^{\lambda Z_{j}} \leqslant e^{\lambda^{2} c^{2} / 8}=$ $e^{\lambda^{2} /(2 n)}$. By Lemma 2.3.4 in [18] we further obtain that

For the concentration around the mean we observe that $Z$ itself also has bounded differences with $c^{2}=4 / n$ and applying Theorem 3.3.14 in [18] yields

This shows that the linearisation of the first term in (48) is bounded by a multiple of $(\sqrt{\log K}+x) / \sqrt{n}$. On $A_{n}$ we can bound the remainder in the linearisation by a multiple of the same quantity. For $n / \log K$ large enough $E Z$ is smaller than $1 /\left(4 c^{\prime}\right)$ and we can bound $\mathbb{P}\left(A_{n}^{c}\right)$ by $\exp \left(-R_{2} n\right) \leqslant \exp \left(-R_{2} n / \log K\right)$ using the concentration of $Z$. The bound $\mathbb{P}\left(A_{n}^{c}\right) \leqslant\left(1 / R_{2}\right) \exp \left(-R_{2} n / \log K\right)$ for all $n$ and $K$ is obtained by choosing a possibly smaller constant $R_{2}$.

For the bias we bound, using the Cauchy-Schwarz inequality,

which explains the second regime in the inequality in Lemma 20
Now to estimate $\nu$ we first estimate $\mathcal{F} \nu(k), k \neq 0$, by $\mathcal{F} \widehat{\nu}(k)=\left(\Phi_{n}(k)+\widehat{\lambda}\right) 1_{[-K, K]}(k)$, where $K$ is a spectral cut-off parameter. By standard theory of Sobolev spaces on the unit circle, an equivalent norm on $\mathbb{H}(\delta)$ is given by

= & \sum_{|k| \leqslant K} k^{-1}(\log (e+k))^{-2 \delta}\left|\Phi_{n}(k)-\Phi_{\nu}(k)+\widehat{\lambda}-\lambda\right|^{2} \\
& +\sum_{|k|>K} k^{-1}(\log k)^{-2 \delta}|\mathcal{F} \nu(k)|^{2}
\end{aligned}
$$

$$
\begin{aligned}
& \lesssim(\widehat{\lambda}-\lambda)^{2}+ \sum_{|k| \leqslant K} k^{-1}(\log (e+k))^{-2 \delta}\left|\Phi_{n}(k)-\Phi_{\nu}(k)\right|^{2} \\
&+\sum_{|k|>K} k^{-1}(\log (e+k))^{-2 \delta}|\mathcal{F} \nu(k)|^{2} \\
& \lesssim(\widehat{\lambda}-\lambda)^{2}+\max _{|k| \leqslant K}\left|\Phi_{n}(k)-\Phi_{\nu}(k)\right|^{2}+\|\nu\|_{L^{2}}^{2} / K
\end{aligned}
$$

which，repeating the above，gives the same bounds as those obtained for error of the intensity $\widehat{\lambda}-\lambda$ ．

The proof of the following proposition is contained in Section 7
Proposition 21．Denote $\overline{\mathcal{V}}=\left\{\nu \in \mathcal{V}:\|\nu\|_{L^{1}}<\pi / \Delta\right.$ and $\left.\|\nu\|_{L^{2}} \leqslant c\right\}$ for some $c, \Delta>0$ ． Let $\varepsilon_{n}$ be such that $\sqrt{(\log n) / n} \lesssim \varepsilon_{n}$ and $\varepsilon_{n}=o(1 / \sqrt{\log n})$ ．Then for $\nu_{0} \in \overline{\mathcal{V}}$ there exists a sequence of tests（indicator functions）$\Psi_{n} \equiv \Psi\left(X_{1}, \ldots, X_{n}\right)$ such that for every $C>0$ ，there exist $M=M(C, c, \Delta)>0$ such that for all $n$ large enough

Proposition 22．Suppose we have for some constants $c, C, D>0$ ，for a sequence $\varepsilon_{n}$ such that $\sqrt{(\log n) / n} \lesssim \varepsilon_{n}$ and $\varepsilon_{n}=o(1 / \sqrt{\log n})$ ，for $\nu_{0}$ such that $e^{-D} \leqslant d \nu_{0} / d \Lambda \leqslant e^{D}$ ，for some prior $\Pi$ on a set $\left\{\nu \in \mathcal{V}: e^{-D} \leqslant d \nu / d \Lambda \leqslant e^{D}\right\}$ of Lévy measures bounded from above and away from zero，for $n$ large enough and with $K_{D}$ from Lemma 18 that

If $\Pi\left(\cdot \mid X_{1}, \ldots, X_{n}\right)$ is the posterior distribution from（6）），then there exists $M_{0}$ such that for every $M \geqslant M_{0}$ ，as $n \rightarrow \infty$ and in $\mathbb{P}_{\nu_{0}}^{\mathbb{N}}$－probability，

Proof．Starting with Proposition 17 we replace the condition on the Kullback－Leibler neigh－ bourhood by a condition on a $L^{2}$ neighbourhood using Lemma 18．Further we choose $\mathcal{V}_{n}=\left\{\nu \in \mathcal{V}:\|\nu\|_{L^{1}}<\pi / \Delta,\|\nu\|_{L^{2}} \leqslant c\right\}, d\left(\nu, \nu_{0}\right)=\left\|\nu-\nu_{0}\right\|_{\mathbb{H}(\delta)}$ and $\delta_{n}=\varepsilon_{n}$ ．The existence of tests follows by Proposition 21．

Proposition 23．Grant Assumption 1 for some $s>5 / 2, B>0$ ，and set

For the choice $J=J_{n}$ with $2^{J_{n}} \approx n^{1 /(2 s+1)}$ the prior（10）satisfies for $n$ large enough the small ball probability condition（49）．

The above proposition is proved in Section 8．We now turn to the proof of Proposition 10. When modelling an $s$－regular function $\nu$ ，and when $\nu_{0} \in C^{s}$ as well，Proposition 23 shows （49）for the choice $\varepsilon_{n} \approx n^{-s /(2 s+1)}(\log n)^{1 / 2}$ ，and so we obtain the lower bound on the small ball probabilities．By Assumption $⿴ 囗 十$ we have $\|\nu\|_{L^{1}}<\pi / \Delta$ and we also see that the prior
concentrates almost surely on a fixed $L^{\infty}$ - (and then also $L^{2}$-) ball since $\|v\|_{\infty}^{2} \lesssim \sum_{l} 2^{-l / 2}$, thus (50) holds for $\Pi$ too. As a consequence we obtain

& \leqslant 2^{J} J^{2 \delta}\left\|v-v_{0}\right\|_{\mathbb{H}(\delta)}^{2}+O\left(2^{-2 J s}\right) \lesssim 2^{J} J^{2 \delta}\left\|\nu-\nu_{0}\right\|_{\mathbb{H}(\delta)}^{2}+O\left(2^{-2 J s}\right) \lesssim 2^{J} J^{2 \delta} \varepsilon_{n}^{2}
\end{aligned}

so that, as $n \rightarrow \infty$,

& \lesssim 2^{J / 2}\left\|v-v_{0}\right\|_{L^{2}}+O\left(2^{-J s}\right) \lesssim 2^{J} J^{\delta} \varepsilon_{n}
\end{aligned}
$$

which also implies that

For $\delta>1 / 2$ we have posterior contraction with rates $\varepsilon_{n}^{L^{2}}$ and $\varepsilon_{n}^{L^{\infty}}$ in $L^{2}$ and $L^{\infty}$, respectively, where

Estimating $\left\|v-v_{0}\right\|_{L^{p}} \lesssim\left\|\nu-\nu_{0}\right\|_{p}$ for $p=2, \infty$ implies Proposition 10. Moreover, using $\left(\varepsilon_{n}^{L^{p}}\right)^{p} \leqslant\left(\varepsilon_{n}^{L^{\infty}}\right)^{p-2}\left(\varepsilon_{n}^{L^{2}}\right)^{2}$ we obtain for contraction in $L^{p}$ the rate

It remains to prove Lemma 24. Let us introduce the spaces

which are equal to the (logarithmically refined) Sobolev spaces $H^{1 / 2, \delta}(I)$. As in Proposition 4.3.12 in [18] one shows that $\mathbb{H}(\delta)$ is the topological dual space of $\mathbb{B}(\delta)$. We further see directly from the definition of the prior that $v=\log \nu$ satisfies

and one further shows that also $\|\nu\|_{\mathbb{B}\left(\delta^{\prime}\right)}=\left\|e^{v}\right\|_{\mathbb{B}\left(\delta^{\prime}\right)}$ is bounded by a fixed constant $\Pi$-almost surely (e.g., using the modulus of continuity characterisation of the $\mathbb{B}(\delta)$-norm, proved as in Section 4.3.5 in [18]). This justifies the application of the following lemma with $1 / 2<\delta<$ $\delta^{\prime}<3 / 2$ in the above estimate. The lemma is proved in Section 9 ,

Lemma 24. a) For any $\nu, \nu_{0} \in \mathbb{B}(\delta), \delta>1 / 2$, such that $\nu, \nu_{0}$ are bounded away from zero on I and such that $\left\|\nu-\nu_{0}\right\|_{\mathbb{B}(\delta)} \rightarrow 0$, we have $\left\|\log \nu-\log \nu_{0}\right\|_{\mathbb{H}(\delta)} \lesssim\left\|\nu-\nu_{0}\right\|_{\mathbb{H}(\delta)}$.
b) If $\left\|\nu-\nu_{0}\right\|_{\mathbb{H}(\delta)} \rightarrow 0$ and $\nu, \nu_{0}$ are uniformly bounded in $\mathbb{B}\left(\delta^{\prime}\right)$, then for any $\delta<\delta^{\prime}$ we have $\left\|\nu-\nu_{0}\right\|_{\mathbb{B}(\delta)} \rightarrow 0$.

&=\frac{\int_{D_{n, M}} e^{S_{n}(\nu)-t \sqrt{n} \int A_{\nu_{0}}\left(v-v_{0}\right) A_{\nu_{0}}(\eta) d \mathbb{P}_{\nu_{0}}+\ell_{n}(\nu)} d \Pi(\nu)}{\int_{D_{n, M}} e^{\ell_{n}(\nu)} d \Pi(\nu)} .
\end{align*}

By Assumption 1 we have $s>5 / 2$ so that by Remark 28 condition (63) implies condition (64) and we conclude that the entire Assumption 27 is satisfied. By Lemma [29, the choice of $J$ as in (11), Assumption 27 and the $L^{p}$-contraction rates (53) derived from Proposition 10 we have that Assumption 25 is satisfied. In Section 5.2 we prove that under Assumption 25

where $\sup _{\nu \in D_{n, M}}\left|r_{n}^{\prime}(\nu)\right|=o_{\mathbb{P}_{\nu_{0}}}(1)$ with the nonstochastic null sequence implicit in the $o_{\mathbb{P}_{\nu_{0}}}$ notation uniform in $\eta \in \mathcal{H}_{n}$. Since the first two terms on the right hand side do not depend on $\nu$ they can be taken outside the posterior integral in (54) so that

By the mean value theorem for integrals $r_{n}^{\prime}(\nu)$ can be replaced by $r_{n}$ not depending on $\nu$ with $\left|r_{n}\right| \leqslant \sup _{\nu \in D_{n, M}}\left|r_{n}^{\prime}(\nu)\right|=o_{\mathbb{P}_{\nu_{0}}}(1)$ in the above display finishing the proof of the proposition.

In order to prove the crucial perturbation approximation (55), we first need to obtain formulas for the directional derivatives of the likelihood function, which is done in the next section.
5.1. Directional derivatives of the likelihood function. We fix a positive and absolutely continuous Lévy measure $\nu_{0}=\lambda_{0} \mu_{0}$ with corresponding infinitely divisible distribution $\mathbb{P}_{\nu_{0}}$. We set $v_{0}=\log \nu_{0}$ so that $\nu_{0}=\exp v_{0}$ and parametrise a path away from $\nu_{0}$ as

Both $\mathbb{P}_{\nu^{(s)}}$ and $\mathbb{P}_{\nu^{(s+h)}}$ are absolutely continuous with respect to $\mathbb{P}_{\Lambda}$. We will now determine the first five derivatives of $d \mathbb{P}_{\nu^{(s)}} / d \mathbb{P}_{\Lambda}$. To this end we expand (56) in terms of $h$. We start with the factor in front of the sum and expand

& \lesssim\left\|w_{1}\right\|_{L^{p}(\nu)} \cdots\left\|w_{k}\right\|_{L^{p}(\nu)}
\end{aligned}

and the lemma follows by treating all $2^{k}$ terms in this way.
We define $v(u)=\sum_{l \leqslant J-1} \sum_{k} a_{l} u_{l k} \psi_{l k}$ with $a_{l}=2^{-l}\left(l^{2}+1\right)^{-1}$. For $u, u^{\prime} \in \mathbb{R}^{2^{J}}$ we denote $v=v(u), v^{\prime}=v\left(u^{\prime}\right)$. Applying Lemma 26 with $w_{1}=v-v^{\prime}$ yields $\left\|f_{v}-f_{v^{\prime}}\right\|_{\infty} \lesssim\left\|v-v^{\prime}\right\|_{\infty} \lesssim$ $\left\|u-u^{\prime}\right\|_{\infty}$, where the constant only depends on $D$ and $\Delta$. & \sqrt{n}\left(\varepsilon_{n}^{L^{\infty}}+\omega_{n}^{L^{\infty}}\right)^{2}\left(\varepsilon_{n}^{L^{2}}+\omega_{n}^{L^{2}}\right) 2^{J / 2}\left(\log \frac{c}{\varepsilon_{n}^{L^{2}}+\omega_{n}^{L^{2}}}\right)^{1 / 2} \\
& \lesssim \sqrt{n}\left(\varepsilon_{n}^{L^{\infty}}+\frac{t}{\sqrt{n}}\|\eta\|_{\infty}\right)^{2}\left(\varepsilon_{n}^{L^{2}}+\frac{t}{\sqrt{n}}\|\eta\|_{L^{2}}\right) 2^{J / 2}(\log n)^{1 / 2} \\
& \lesssim \sqrt{n}\left(\left(\varepsilon_{n}^{L^{\infty}}\right)^{2}+\frac{\|\eta\|_{\infty}^{2}}{n}\right)\left(\varepsilon_{n}^{L^{2}}+n^{-1 / 2}\right) n^{(1 / 2) /(2 s+1)}(\log n)^{1 / 2} \\
& \lesssim\left(\left(\varepsilon_{n}^{L^{\infty}}\right)^{2} \varepsilon_{n}^{L^{2}}+\left(\varepsilon_{n}^{L^{\infty}}\right)^{2} n^{-1 / 2}+\frac{\|\eta\|_{\infty}^{2}}{n} \varepsilon_{n}^{L^{2}}+\frac{\|\eta\|_{\infty}^{2}}{n^{3 / 2}}\right) n^{(s+1) /(2 s+1)}(\log n)^{1 / 2} \\
& \lesssim n^{(-2 s+7 / 2) /(2 s+1)}(\log n)^{2+3 \delta}+n^{(-2 s+5 / 2) /(2 s+1)}(\log n)^{3 / 2+2 \delta} \\
& \quad+\|\eta\|_{\infty}^{2} n^{(-2 s+1 / 2) /(2 s+1)}(\log n)^{1+\delta}+\|\eta\|_{\infty}^{2} n^{(-2 s-1 / 2) /(2 s+1)}(\log n)^{1 / 2}=o(1)
\end{aligned}
$$

using that $s>11 / 6$ for the first and the second term and (63) for the third and the fourth term. Finally for the condition that the first term dominates in $R_{n}$ we verify

$$
\begin{aligned}
\frac{1}{\sqrt{n}} 2^{J / 2} \frac{1}{\varepsilon_{n}^{L^{2}}+\omega_{n}^{L^{2}}} \sqrt{\log \frac{c}{\varepsilon_{n}^{L^{2}}+\omega_{n}^{L^{2}}}} & \lesssim n^{(-s-1 / 2) /(2 s+1)} n^{(1 / 2) /(2 s+1)} \frac{1}{\varepsilon_{n}^{L^{2}}} \sqrt{\log \frac{c}{\varepsilon_{n}^{L^{2}}}} \\
& \lesssim n^{(-1 / 2) /(2 s+1)}(\log n)^{-\delta}=O(1)
\end{aligned}
$$

## 6. Proof of Proposition 3

The Radon-Nikodym density in (14) is well defined in view of the convolution series representation of $\mathbb{P}_{\nu}$ in (4). That $A_{\nu}$ maps $L^{2}(\nu)$ into $L^{2}\left(\mathbb{P}_{\nu}\right)$ is proved in Lemma 26, and an application of Fubini's theorem gives $\int_{I} A_{\nu}(h) d \mathbb{P}_{\nu}=0$ for all $h \in L^{2}(\nu)$. The expansion (13) follows by the same arguments used for the proof in Section 5.2 but is in fact easier and no empirical process tools are needed here. In the case $v \in V_{J}$ for some $J$ the expansion follows directly from setting $v_{0}=v$ and $\eta=h$ in (58). For the general case we consider the path $s \mapsto \exp (v+s h / \sqrt{n})=\nu^{(s)}$ and obtain by a Taylor expansion for some $s \in[0,1]$

\begin{aligned}
& \ell_{n}\left(\nu_{h, n}\right)-\ell_{n}(\nu) \\
&= D \ell_{n}\left(\nu_{0}\right)\left[\frac{h}{\sqrt{n}}\right]+\frac{1}{2} D^{2} \ell_{n}\left(\nu_{0}\right)\left[\frac{h}{\sqrt{n}}, \frac{h}{\sqrt{n}}\right]+\frac{1}{6} D^{3} \ell_{n}\left(\nu^{(s)}\right)\left[\frac{h}{\sqrt{n}}, \frac{h}{\sqrt{n}}, \frac{h}{\sqrt{n}}\right] \\
&= \frac{1}{\sqrt{n}} \sum_{i=1}^{n} A_{\nu}(h)\left(X_{i}\right)-\frac{1}{2}\left\|A_{\nu}(h)\right\|_{L^{2}\left(\mathbb{P}_{\nu)}\right.}^{2}+\left.\sum_{j=1}^{n} \frac{d \frac{d^{2}}{d s^{2}} \mathbb{P}_{\nu^{(s)}}}{d \mathbb{P}_{\nu^{(s)}}}\right|_{s=0}[h, h]\left(X_{j}\right) \\
&+\left(-\left.\sum_{j=1}^{n}\left(\frac{d \frac{d}{d s} \mathbb{P}_{\nu^{(s)}}}{d \mathbb{P}_{\nu^{(s)}}}[h]\left(X_{j}\right)\right)^{2}\right|_{s=0}+\frac{1}{2}\left\|A_{\nu}(h)\right\|_{L^{2}\left(\mathbb{P}_{\nu)}\right)}^{2}\right) \\
&+\frac{1}{6 n^{3 / 2}} D^{3} \ell_{n}\left(\nu^{(s)}\right)[h, h, h] \\
&= \frac{1}{\sqrt{n}} \sum_{i=1}^{n} A_{\nu}(h)\left(X_{i}\right)-\frac{1}{2}\left\|A_{\nu}(h)\right\|_{L^{2}\left(\mathbb{P}_{\nu}\right)}^{2}+I+I I+I I I .
\end{aligned}
$$

The terms $I$ and $I I$ are both centred and are treated exactly as the term $I V(i)(a)$ and the centred version of $I V(i)(b)$ in Section 5.2. This yields $I+I I=O_{\mathbb{P}_{\nu}^{N}}\left(n^{-1 / 2}\|h\|_{L^{4}}^{2}\right)$. The centring of term III is shown to be $O_{\mathbb{P}_{\nu}^{N}}\left(n^{-3 / 2}\|h\|_{L^{3}}^{3}\right)$, which is proved along the same lines as the centring of the third derivatives of the term $R_{n}$ in Section 5.2 combined with the measure change there applied to the fifth derivatives. After centring the term $I I I$ is shown to be of order $O_{\mathbb{P}_{V}^{\mathbb{N}}}\left(n^{-1}\|h\|_{L^{6}}^{3}\right)$ with the same bounds as used for bounding $\sigma$ when treating the empirical process part of $R_{n}$ except that here $h$ is fixed and so a simple variance bound suffices instead of the empirical process inequality used for $R_{n}$. We conclude $I+I I+I I I=o_{\mathbb{P}_{\nu}^{N}}(1)$.

## 7. Proof of Proposition 21

We define, for $L^{\prime}>0$ to be chosen

$$
\Psi_{n}= \begin{cases}0 & \text { if }\left\|\widehat{\nu}-\nu_{0}\right\|_{\mathbb{H}(\delta)}<L^{\prime} \varepsilon_{n} \\ 1 & \text { if }\left\|\widehat{\nu}-\nu_{0}\right\|_{\mathbb{H}(\delta)} \geqslant L^{\prime} \varepsilon_{n} .\end{cases}
$$

Applying Lemma 20 with $K=n$ and $x=\sqrt{n} \varepsilon_{n}$ yields, for $L^{\prime}$ large enough, $E_{\nu_{0}}\left[\Psi_{n}\right] \rightarrow 0$ as $n \rightarrow \infty$. For the error of second type we obtain, for $M$ large enough depending on $L^{\prime}, C$
that, again by Lemma 20,

$$
\begin{aligned}
& \sup _{\nu \in \overline{\mathcal{V}}:\left\|\nu-\nu_{0}\right\|_{\mathbb{H}(\delta)} \geqslant M \varepsilon_{n}} E_{\nu}\left[1-\Psi_{n}\right] \\
& =\sup _{\nu \in \overline{\mathcal{V}}:\left\|\nu-\nu_{0}\right\|_{\mathbb{H}(\delta)} \geqslant M \varepsilon_{n}} \mathbb{P}_{\nu}^{\mathbb{N}}\left(\left\|\widehat{\nu}-\nu_{0}\right\|_{\mathbb{H}(\delta)}<L^{\prime} \varepsilon_{n}\right) \\
& \leqslant \sup _{\nu \in \overline{\mathcal{V}}:\left\|\nu-\nu_{0}\right\|_{\mathbb{H}(\delta)} \geqslant M \varepsilon_{n}}^{\mathbb{P}_{\nu}^{\mathbb{N}}\left(\left\|\nu_{0}-\nu\right\|_{\mathbb{H}(\delta)}-\|\nu-\widehat{\nu}\|_{\mathbb{H}(\delta)}<L^{\prime} \varepsilon_{n}\right)} \\
& \leqslant \sup _{\nu \in \overline{\mathcal{V}}} \mathbb{P}_{\nu}^{\mathbb{N}}\left(\|\nu-\widehat{\nu}\|_{\mathbb{H}(\delta)}>(M / 2) \varepsilon_{n}\right) \\
& \leqslant e^{-(C+4) n \varepsilon_{n}^{2}}+\frac{1}{R_{2}} e^{-n R_{2} / \log n} \leqslant 2 e^{-(C+4) n \varepsilon_{n}^{2}},
\end{aligned}
$$

where we used $\varepsilon_{n}=o(1 / \sqrt{\log n})$ and $n$ large enough in the last inequality.

## 8. Proof of Proposition 23

Since $v, v_{0}$ are bounded and thus exp is Lipschitz on the range of $v, v_{0}$ we have

$$
\begin{aligned}
& \mathbb{P}\left(\left\|\nu-\nu_{0}\right\|_{L^{2}} \leqslant \frac{\varepsilon_{n}}{\sqrt{K_{D}}}\right) \geqslant \mathbb{P}\left(\left\|v-v_{0}\right\|_{\infty} \leqslant c \varepsilon_{n}\right) \\
& \geqslant \mathbb{P}\left(\sum_{l} 2^{l / 2} \max _{k}\left|\beta_{l k}-2^{-l}\left(l^{2}+1\right)^{-1} u_{l k}\right|<c^{\prime} \varepsilon_{n}\right),
\end{aligned}
$$

where $u_{l k}=0$ for $l \geqslant J$ and $\beta_{l k}=\left\langle v_{0}, \psi_{l k}\right\rangle$. We define $b_{l k}=2^{l}\left(l^{2}+1\right) \beta_{l k}$ such that $\left|b_{l k}\right| \leqslant B$, and $M(J)=\sum_{l=-1}^{J-1} \sum_{k=0}^{\left(2^{l}-1\right) \vee 0} 1=2^{J}$. We can bound the last probability from below by

$$
\begin{aligned}
& \mathbb{P}\left(\sum_{l \leqslant J-1} 2^{-l / 2}\left(l^{2}+1\right)^{-1} \max _{k}\left|b_{l k}-u_{l k}\right|<c^{\prime} \varepsilon_{n}-\bar{c} 2^{-J_{n} s} /\left(J_{n}^{2}+1\right)\right) \\
& \geqslant \mathbb{P}\left(\max _{l \leqslant J-1} \max _{k}\left|b_{l k}-u_{l k}\right|<c^{\prime \prime} \varepsilon_{n}\right)=\prod_{l \leqslant J-1} \prod_{k} \mathbb{P}\left(\left|b_{l k}-u_{l k}\right|<c^{\prime \prime} \varepsilon_{n}\right) \\
& \geqslant\left(\frac{c^{\prime \prime} \varepsilon_{n}}{2 B}\right)^{M(J)} \geqslant e^{-C n \varepsilon_{n}^{2}}
\end{aligned}
$$

for $n$ large enough and for some constant $C>0$.

## 9. Proof of Lemma 24

a) Write $B$ for the unit ball of the space $\mathbb{B}=\mathbb{B}(\delta)$ which can be shown to be closed under pointwise multiplication in the sense that $\|f g\|_{\mathbb{B}} \leqslant c_{0}\|f\|_{\mathbb{B}}\|g\|_{\mathbb{B}}$. Since $\nu_{0}^{-1} \in \mathbb{B},\left\|\nu-\nu_{0}\right\|_{\mathbb{B}} \rightarrow 0$ we also have $\left\|\left(\nu-\nu_{0}\right) / \nu_{0}\right\|_{\infty} \lesssim\left\|\left(\nu-\nu_{0}\right) / \nu_{0}\right\|_{\mathbb{B}} \rightarrow 0$ and thus $\left\|\left[\left(\nu-\nu_{0}\right) / \nu_{0}\right]^{k}\right\|_{\mathbb{B}} \leqslant c_{0}^{k} \|(\nu-$ $\left.\nu_{0}\right) / \nu_{0} \|_{\mathbb{B}}^{k}$. Since eventually $\left\|\left(\nu-\nu_{0}\right) / \nu_{0}\right\|_{\mathbb{B}}<1 /\left(2 c_{0}\right)$ we deduce that the series

$$
g=\sum_{k} \frac{(-1)^{k}}{k}\left(\frac{\nu-\nu_{0}}{\nu_{0}}\right)^{k-1}
$$

converges absolutely uniformly and in $\mathbb{B}$ and has $\|\cdot\|_{\mathbb{B}}$-norm less than a constant multiple of $\left\|\nu-\nu_{0}\right\|_{\mathbb{B}}$. Thus, using again the multiplication property of the norm

$$
\begin{aligned}
& \left\|\log \nu-\log \nu_{0}\right\|_{\mathbb{H}(\delta)}=\sup _{f \in B}\left|\int f \log \left(1+\frac{\nu-\nu_{0}}{\nu_{0}}\right)\right| \\
& \quad=\sup _{f \in B}\left|\int\left(\nu-\nu_{0}\right) \sum_{k=1}^{\infty} \frac{(-1)^{k}}{k} \frac{\left(\nu-\nu_{0}\right)^{k-1}}{\nu_{0}^{k-1}} \frac{f}{\nu_{0}}\right| \\
& \quad=\sup _{f \in B}\left|\int\left(\nu-\nu_{0}\right) g \frac{f}{\nu_{0}}\right| \leqslant \sup _{h \in c_{1} B}\left|\int h\left(\nu-\nu_{0}\right)\right|=c_{1}\left\|\nu-\nu_{0}\right\|_{\mathbb{H}(\delta)} .
\end{aligned}
$$

b) For any $j$ we have, using the Cauchy-Schwarz inequality,

$$
\begin{aligned}
\left\|\nu-\nu_{0}\right\|_{\mathbb{B}(\delta)}^{2} & \lesssim \sum_{l \leqslant j} 2^{l} l^{2 \delta} \sum_{k}\left|\left\langle\nu-\nu_{0}, \psi_{l k}\right\rangle\right|^{2}+j^{2 \delta-2 \delta^{\prime}} \sum_{l>j} 2^{l} l^{2 \delta^{\prime}} \sum_{k}\left|\left\langle\nu-\nu_{0}, \psi_{l k}\right\rangle\right|^{2} \\
& \leq 2^{2 j} j^{4 \delta} \sum_{l \leqslant j} 2^{-l} l^{-2 \delta} \sum_{k}\left|\left\langle\nu-\nu_{0}, \psi_{l k}\right\rangle\right|^{2}+j^{2 \delta-2 \delta^{\prime}}\left\|\nu-\nu_{0}\right\|_{B_{22}^{1 / 2, \delta^{\prime}}} \\
& \lesssim 2^{2 j} j^{4 \delta}\left\|\nu-\nu_{0}\right\|_{\mathbb{H}(\delta)}+j^{-2\left(\delta^{\prime}-\delta\right)} .
\end{aligned}
$$

Using $\left\|\nu-\nu_{0}\right\|_{\mathbb{H}(\delta)}=o(1)$ and letting $j \rightarrow \infty$ slowly enough we deduce $\left\|\nu-\nu_{0}\right\|_{\mathbb{B}(\delta)} \rightarrow 0$.
