To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a matches.

Photography is not permitted within the playing arena at any time, and the Championships reserves the right to remove any items of equipment breaching this policy.

Video recording within the playing arena is only permitted by players and Team Officials of competing Member Associations from clearly defined points using video accreditation passes. There are a limited number of these positions and passes available, and prior authorization must be obtained in advance from the Information Office, and accreditation must be clearly displayed on the cameras. The Championships reserves the right to remove any non-accredited items of equipment. PLEASE NOTE: Video footage captured must be used solely for training purposes by the Member Association and its coaching staff. Member Associations may be liable for any costs incurred by BWF if their video footage is used for any other purpose.
