# CLASSIFICATION OF L-FUNCTIONS OF DEGREE 2 AND CONDUCTOR 1

#### Abstract

We give a full description of the functions $F$ of degree 2 and conductor 1 in the general framework of the extended Selberg class $\mathcal{S}^{\sharp}$. This is performed by means of a new numerical invariant $\chi_{F}$, which is easily computed from the data of the functional equation. We show that the value of $\chi_{F}$ gives a precise description of the nature of $F$, thus providing a sharp form of the classical converse theorems of Hecke and Maass. In particular, our result confirms, in the special case under consideration, the conjecture that the functions in the Selberg class $\mathcal{S}$ are automorphic $L$-functions.

## 1. Introduction

It is generally expected that the Selberg class $\mathcal{S}$ of $L$-functions coincides with the class of automorphic $L$-functions. This is known for functions of degrees $0<d<2$, see ConreyGhosh [2] and the authors' papers [9] and [13], but already the important case of degree $d=2$ appears at present to be out of reach in its full generality. In that case, it is conjectured that the primitive functions in $\mathcal{S}$ coincide, roughly, with the $L$-functions of holomorphic and non-holomorphic eigenforms of any level. Since the Ramanujan conjecture is not known in the non-holomorphic case, while it is assumed in the definition of $\mathcal{S}$, here we consider the weaker conjecture that the functions of degree 2 in $\mathcal{S}$ are contained, roughly, in the family of the $L$-functions of the above eigenforms. We refer to Section 2 for the definitions and notions introduced in this section.

The latter conjecture is actually known, thanks to the classical converse theorems of Hecke [4], Maass [20], Weil [30], Jacquet-Langlands [5] and the theory of Hecke operators, provided the functions $F \in \mathcal{S}$ satisfy a functional equation with very special $\Gamma$-factors and, if the conductor $q$ is greater than 4 , certain twists of $F$ by Dirichlet characters also satisfy suitable functional equations. Concerning general $\Gamma$-factors, the only known case of such a conjecture is, as far as we know, when the conductor $q$ equals 1 and $F$ has a pole at $s=1$, in which case it turns out that necessarily $F=\zeta^{2}$; see [14]. Although the existence of an Euler product expansion for $F$ is not necessary in the converse theorems of Hecke, Maass and Weil, both the Euler product and the pole at $s=1$ play a crucial role in the arguments in [14].

In this paper we describe the nature of the functions of degree $d=2$ and conductor $q=1$ in the full generality of the extended Selberg class $\mathcal{S}^{\sharp}$ and, as a consequence, we confirm the above conjecture in the case of conductor 1. Our description of such functions is performed by means of a new numerical invariant, denoted $\chi_{F}$ and called the eigenweight of $F \in \mathcal{S}^{\sharp}$, which is easy to compute from the data of the functional equation. The name of $\chi_{F}$ comes from the fact that it determines the eigenvalue and the weight of the modular form corresponding to $F$; see Theorem 1.1. To give a glimpse on our main result, let $F \in \mathcal{S}^{\sharp}$ with $d=2$ and $q=1$ be normalized in the sense described below; then, for example,

\chi_{F}=0 \Longrightarrow F(s)=\zeta(s)^{2} \quad \text { and } \quad \chi_{F}=\frac{121}{2} \Longrightarrow F(s)=L\left(s+\frac{11}{2}, \Delta\right)
$$

where $L(s, \Delta)$ is the Ramanujan $L$-function.
In order to state our results we have to introduce a normalization. This is due to the fact that the functional equation in $\mathcal{S}^{\sharp}$ reflects $F$ into its conjugate $\bar{F}$, while the $L$-functions of modular forms of level 1 are reflected into themselves. We say that $F \in \mathcal{S}^{\sharp}$ is normalized if its internal shift $\theta_{F}$ vanishes and the first nonvanishing Dirichlet coefficient is 1 . Normalized functions have a twofold advantage, making them the right objects for our purpose. Indeed, on one side every $F \in \mathcal{S}^{\sharp}$ with $d=2$ and $q=1$ can be normalized by means of a simple procedure, see Lemma 4.1, so we may consider only such functions without loosing generality. On the other side, normalized functions have real coefficients, see again Lemma 4.1, and hence the above mentioned discrepancy disappears.

The new invariant $\chi_{F}$ is defined as

$$
\begin{equation*}
\chi_{F}=\xi_{F}+H_{F}(2)+2 / 3 \tag{1.1}
\end{equation*}
$$

where $\xi_{F}$ and $H_{F}(2)$ are the $H$-invariants defined in (2.3)-(2.5) below. Hence $\chi_{F}$ can easily be computed plugging the data of the functional equation of $F$ into the first and second Bernoulli polynomials. For example, if $f$ is a holomorphic cusp form of level 1 and weight $k$, with first nonvanishing Fourier coefficient equal 1 , and we denote by $L(s, f)$ its $L$-function, then $F(s)=L\left(s+\frac{k-1}{2}, f\right)$ is a normalized function of $\mathcal{S}^{\sharp}$ with $d=2$ and $q=1$, and

$$
\chi_{F}=\frac{(k-1)^{2}}{2} .
$$

Similarly, one easily checks that if $u$ is a Maass form of level 1 and weight 0 , with eigenvalue $1 / 4+\kappa^{2}$ and first Fourier-Bessel coefficient equal 1, and $L(s, u)$ is its $L$-function, then $F(s)=$ $L(s, u)$ is a normalized member of $\mathcal{S}^{\sharp}$ with $d=2$ and $q=1$, and

$$
\chi_{F}=-2 \kappa^{2}
$$

Our main result shows, conversely, that the value of $\chi_{F}$ is sufficient to detect the nature of any normalized $F \in \mathcal{S}^{\sharp}$ of degree 2 and conductor 1 . Thus it may be regarded as a sharp form of the Hecke and Maass converse theorems; note that these theorems are used in the very last step of our proof.

Theorem 1.1. Let $F \in \mathcal{S}^{\sharp}$ of degree 2 and conductor 1 be normalized. Then $\chi_{F} \in \mathbb{R}$ and
(i) if $\chi_{F}>0$ then there exists a holomorphic cusp form $f$ of level 1 and even integral weight $k=1+\sqrt{2 \chi_{F}}$ such that $F(s)=L\left(s+\frac{k-1}{2}, f\right)$;
(ii) if $\chi_{F}=0$ then $F(s)=\zeta(s)^{2}$;
(iii) if $\chi_{F}<0$ then there exists a Maass form $u$ of level 1, weight 0 and with eigenvalue $1 / 4+\kappa^{2}=\left(1-2 \chi_{F}\right) / 4$ such that $F(s)=L(s, u)$.

In case (iii) we can specify the parity $\varepsilon$ of $u$ by means of the root number $\omega_{F}$ of $F$, namely

$$
\begin{equation*}
\varepsilon=\frac{1-\omega_{F}}{2} \tag{1.2}
\end{equation*}
$$

Clearly, if $F \in \mathcal{S}^{\sharp}$ with $d=2$ and $q=1$ is not normalized, we may first normalize it and then use Theorem 1.1 to detect its nature. Therefore every such $F$ is closely related to one of the three types of $L$-functions in Theorem 1.1.

Corollary 1.1. Every $F \in \mathcal{S}^{\sharp}$ of degree 2 and conductor 1 belongs, modulo normalization, to one of the three families of $L$-functions in Theorem 1.1.

Concerning the functions in $\mathcal{S}$, from the theory of Hecke operators and the linear independence of Euler products in Kaczorowski-Molteni-Perelli [7],[8] we have the following corollary.

Corollary 1.2. Every $F \in \mathcal{S}$ of degree 2 and conductor 1 is an automorphic L-function.
Remark 1.1. Since it is well known that exceptional eigenvalues do not exist in level 1 , see Selberg [26], we use this fact in the proof. However, if exceptional eigenvalues would actually exist, then our proof would still work, and the resulting theorem would list a second possibility for the functions $F$ with $\chi_{F}<0$, namely $F(s)=L(s, u)$ for some Maass form $u$ associated with an exceptional eigenvalue.

Remark 1.2. Long ago we conjectured that the functional equation of any $F \in \mathcal{S}^{\sharp}$ of degree $d$ is completely described by conductor, root number and the $H$-invariants $H_{F}(n)$ with $n \leq d$, see [11, p.103]. This is confirmed by Theorem 1.1 and (1.2) in the present special case where $d=2$ and $q=1$, since $\chi_{F}$ is defined in terms of $H_{F}(1)$ and $H_{F}(2)$; see (1.1) and (2.5).

We refer to Section 3 for an outline of the proof, where we describe the ideas leading to Theorem 1.1; here we only add a final remark.

Remark 1.3. A new and crucial ingredient in the proof of Theorem 1.1 is the fact that, in the present special case, the structural invariants $d_{\ell}(F)$ of $F$, defined by (2.11) and closely related to the functional equation of $F$, lie on a certain universal family of algebraic varieties; see Proposition 4.1. We suspect that something similar should hold in general for the functions $F \in \mathcal{S}^{\sharp}$, i.e. the $d_{\ell}(F)$ should lie on certain algebraic varieties to a large extent independent of $F$. In turn, this could explain why $L$-functions satisfy only functional equations with very special $\Gamma$-factors, and in particular could shed some light on the general structure of the Selberg class.

## 2. Definitions, notation and basic REQUisites

2.1. Definitions and notation. Throughout the paper we write $s=\sigma+i t$ and $\bar{f}(s)$ for $\overline{f(\bar{s})}, f(s) \equiv 0$ means that $f(s)$ vanishes identically and $\mathbb{H}$ denotes the upper half-plane $\{z=x+i y \in \mathbb{C}: y>0\}$. The extended Selberg class $\mathcal{S}^{\sharp}$ consists of non identically vanishing Dirichlet series

$$
F(s)=\sum_{n=1}^{\infty} \frac{a(n)}{n^{s}}
$$

absolutely convergent for $\sigma>1$, such that $(s-1)^{m} F(s)$ is entire of finite order for some integer $m \geq 0$, and satisfying a functional equation of type

$$
\begin{equation*}
F(s) \gamma(s)=\omega \bar{\gamma}(1-s) \bar{F}(1-s) \tag{2.1}
\end{equation*}
$$

where $|\omega|=1$ and the $\gamma$-factor

$$
\begin{equation*}
\gamma(s)=Q^{s} \prod_{j=1}^{r} \Gamma\left(\lambda_{j} s+\mu_{j}\right) \tag{2.2}
\end{equation*}
$$

has $Q>0, \underline{r \geq 0}, \lambda_{j}>0$ and $\Re\left(\mu_{j}\right) \geq 0$. Note that the conjugate function $\bar{F}$ has conjugated coefficients $\overline{a(n)}$. The Selberg class $\mathcal{S}$ is, roughly speaking, the subclass of $\mathcal{S}^{\sharp}$ of the functions with Euler product and satisfying the Ramanujan conjecture $a(n) \ll n^{\varepsilon}$. We refer to Selberg [27], Conrey-Ghosh [2] and to our survey papers [6],[10],,[21],[22],[23],[24] for further definitions, examples and the basic theory of the Selberg class.

Degree $d$, conductor $q$, root number $\omega_{F}$ and $\xi$-invariant $\xi_{F}$ of $F \in \mathcal{S}^{\sharp}$ are defined by

$$
\begin{array}{r}
d=d_{F}:=2 \sum_{j=1}^{r} \lambda_{j}, \quad q=q_{F}:=(2 \pi)^{d} Q^{2} \prod_{j=1}^{r} \lambda_{j}^{2 \lambda_{j}},  \tag{2.3}\\
\omega_{F}=\omega \prod_{j=1}^{r} \lambda_{j}^{-2 i \Im\left(\mu_{j}\right)}, \quad \xi_{F}=2 \sum_{j=1}^{r}\left(\mu_{j}-1 / 2\right):=\eta_{F}+i d \theta_{F}
\end{array}
$$

with $\eta_{F}, \theta_{F} \in \mathbb{R} ; \theta_{F}$ is called the internal shift, and the classical $L$-functions have $\theta_{F}=0$. In this paper we deal only with $F \in \mathcal{S}^{\sharp}$ of positive degree, hence with $r \geq 1$. The $H$-invariants, introduced in [11], are defined for every $n \geq 0$ as

$$
\begin{equation*}
H_{F}(n)=2 \sum_{j=1}^{r} \frac{B_{n}\left(\mu_{j}\right)}{\lambda_{j}^{n-1}} \tag{2.4}
\end{equation*}
$$

where $B_{n}(z)$ is the $n$th Bernoulli polynomial. Clearly

$$
\begin{equation*}
H_{F}(0)=d, \quad H_{F}(1)=\xi_{F}, \quad H_{F}(2)=2 \sum_{j=1}^{r} \frac{\mu_{j}^{2}-\mu_{j}+1 / 6}{\lambda_{j}} \tag{2.5}
\end{equation*}
$$

Remark 2.1. Since $H$-invariants depend only on the data $Q, r, \lambda_{j}, \mu_{j}$ of $\gamma$-factors (2.2), we may define such invariants for any $\gamma$-factor, without referring to functions $F \in \mathcal{S}^{\sharp}$. More generally, the same remark holds for any invariant depending only on the data of $\gamma$-factors. Clearly, the invariants of a $\gamma$-factor coincide with the corresponding invariants of any $F \in \mathcal{S}^{\sharp}$ having such a $\gamma$-factor. The invariants of $\gamma$-factors are usually denoted replacing the suffix $F$ by $\gamma$.

For $\alpha>0$ the standard twist of $F \in \mathcal{S}^{\sharp}$ is

$$
F(s, \alpha)=\sum_{n=1}^{\infty} \frac{a(n)}{n^{s}} e\left(-\alpha n^{1 / d}\right), \quad e(x)=e^{2 \pi i x}
$$

the spectrum of $F$ is defined as

$$
\operatorname{Spec}(F)=\left\{\alpha>0: a\left(n_{\alpha}\right) \neq 0\right\}=\left\{d\left(\frac{m}{q}\right)^{1 / d}: m \in \mathbb{N} \text { with } a(m) \neq 0\right\}
$$

where

$$
n_{\alpha}=q d^{-d} \alpha^{d} \quad \text { and } \quad a\left(n_{\alpha}\right)=0 \text { if } n_{\alpha} \notin \mathbb{N} .
$$

Moreover, for $\ell=0,1, \ldots$ we write

$$
\begin{equation*}
s_{\ell}=\frac{d+1}{2 d}-\frac{\ell}{d} \quad \text { and } \quad s_{\ell}^{*}=s_{\ell}-i \theta_{F} \tag{2.6}
\end{equation*}
$$

Finally we consider the $S$-function

$$
\begin{equation*}
S_{F}(s):=2^{r} \prod_{j=1}^{r} \sin \left(\pi\left(\lambda_{j} s+\mu_{j}\right)\right)=\sum_{j=-N}^{N} a_{j} e^{i \pi d_{F} \omega_{j} s} \tag{2.7}
\end{equation*}
$$

with certain $N \in \mathbb{N}, a_{j} \in \mathbb{C}$ and $-1 / 2=\omega_{-N}<\cdots<\omega_{N}=1 / 2$, and the $h$-function

$$
h_{F}(s)=\frac{\omega}{(2 \pi)^{r}} Q^{1-2 s} \prod_{j=1}^{r}\left(\Gamma\left(\lambda_{j}(1-s)+\bar{\mu}_{j}\right) \Gamma\left(1-\lambda_{j} s-\mu_{j}\right)\right) .
$$

Here we keep the notation for $S_{F}(s)$ used in [18] since we heavily refer to that paper in Section 4 , but in Section 5 we make a slight change of notation in (2.7), see (5.18). Since the function $h_{F}(s)$ depends also on the $\omega$-datum, not present in $\gamma$-factors, we define the analog of $h_{F}(s)$ for $\gamma$-factors as

$$
\begin{equation*}
h_{\gamma}(s)=\prod_{j=1}^{r} \lambda_{j}^{2 i \Im\left(\mu_{j}\right)} \frac{1}{(2 \pi)^{r}} Q^{1-2 s} \prod_{j=1}^{r}\left(\Gamma\left(\lambda_{j}(1-s)+\bar{\mu}_{j}\right) \Gamma\left(1-\lambda_{j} s-\mu_{j}\right)\right) . \tag{2.8}
\end{equation*}
$$

Instead, the analog $S_{\gamma}(s)$ of $S_{F}(s)$ is defined exactly in the same way. Clearly, in view of (2.3), for any $\gamma$-factor of $F$ we have that

$$
\begin{equation*}
h_{F}(s)=\omega_{F} h_{\gamma}(s) \tag{2.9}
\end{equation*}
$$

2.2. Basic requisites. We recall that every $F \in \mathcal{S}^{\sharp}$ has polynomial growth on vertical strips. Moreover, the standard twist $F(s, \alpha)$ is entire if $\alpha \notin \operatorname{Spec}(F)$, while for $\alpha \in \operatorname{Spec}(F)$ it is meromorphic on $\mathbb{C}$ with at most simple poles at the points $s=s_{\ell}^{*}$, with residue denoted by $\rho_{\ell}(\alpha)$. It is known that $\rho_{0}(\alpha) \neq 0$ for every $\alpha \in \operatorname{Spec}(F)$. Further, $F(s, \alpha)$ has polynomial growth on every vertical strip. We refer to [12] and [15] for these and other results on $F(s, \alpha)$.

The functions $S_{F}(s), S_{\gamma}(s), h_{F}(s)$ and $h_{\gamma}(s)$ are invariants, and functional equation (2.1) can be written in the invariant form

$$
\begin{equation*}
F(s)=h_{F}(s) S_{F}(s) \bar{F}(1-s) \tag{2.10}
\end{equation*}
$$

see Section 1.2 of [18]. Moreover, for large $|s|$ outside an arbitrarily small angular region containing the positive real axis we have the asymptotic expansion

$$
\begin{equation*}
h_{F}(s) \approx \frac{\omega_{F}}{\sqrt{2 \pi}}\left(\frac{q^{1 / d}}{2 \pi d}\right)^{d\left(\frac{1}{2}-s\right)} \sum_{\ell=0}^{\infty} d_{\ell}(F) \Gamma\left(d\left(s_{\ell}^{*}-s\right)\right), \quad d_{0}(F)=d^{i d \theta_{F}} \tag{2.11}
\end{equation*}
$$

where $\approx$ means that cutting the sum at $\ell=M$ one gets a meromorphic remainder which is $\ll$ than the modulus of the $M$-th term times $1 /|s|$; see Section 1.3 of [18]. Since (2.11) is proved by means of Stirling's formula without using the properties of $F \in \mathcal{S}^{\sharp}$, see Section 3.2 of [18], a completely analogous expansion holds for $h_{\gamma}(s)$ as well. Clearly, such an expansion holds without the factor $\omega_{F}$ and with $d_{\ell}(F)$ replaced by $d_{\ell}(\gamma)$. The coefficients $d_{\ell}(F)$ and $d_{\ell}(\gamma)$ are called the structural invariants and play an important role in the Selberg class theory. When $\alpha \in \operatorname{Spec}(F)$, Theorem 3 of [18] shows that the residue $\rho_{\ell}(\alpha)$ of $F(s, \alpha)$ at $s=s_{\ell}^{*}$ is given by

\rho_{\ell}(\alpha)=\frac{d_{\ell}(F)}{d} \frac{\omega_{F}}{\sqrt{2 \pi}} e^{-i \frac{\pi}{2}\left(\xi_{F}+d s_{\ell}^{*}\right)}\left(\frac{q^{1 / d}}{2 \pi d}\right)^{\frac{d}{2}-d s_{\ell}^{*}} \frac{\overline{a\left(n_{\alpha}\right)}}{n_{\alpha}^{1-s_{\ell}^{*}}} .
$$

If $F \in \mathcal{S}^{\sharp}$ has $d=2, q=1$ and is normalized, the above quantities simplify as follows:

$$
\begin{gather*}
\theta_{F}=0, \quad \operatorname{Spec}(F)=\{2 \sqrt{m}: m \in \mathbb{N} \text { with } a(m) \neq 0\}, \quad n_{\alpha}=\alpha^{2} / 4, \quad s_{\ell}^{*}=s_{\ell}=\frac{3}{4}-\frac{\ell}{2} \\
h_{F}(s) \approx \frac{\omega_{F}}{\sqrt{2 \pi}}(4 \pi)^{2 s-1} \sum_{\ell=0}^{\infty} d_{\ell}(F) \Gamma(3 / 2-2 s-\ell), \quad d_{0}(F)=1  \tag{2.12}\\
\rho_{\ell}(\alpha)=\frac{e^{i \pi / 4} \frac{a\left(\alpha^{2} / 4\right)}{\sqrt{\alpha}}}{d} d_{\ell}(F)(-2 \pi i)^{-\ell} \alpha^{-\ell} \text { for } \alpha \in \operatorname{Spec}(F)
\end{gather*}
$$

Note that we used Lemma 4.1 in Section 4 to get the above simplified expression of $\rho_{\ell}(\alpha)$. Note also that $\operatorname{Spec}(F)$ is an infinite set. Indeed, $F$ cannot be a Dirichlet polynomial since, by the functional equation, its Lindelöf function $\mu_{F}(\sigma)$ is positive for negative values of $\sigma$.

## 3. Outline of the proof

In Section 4 we start the proof with a finer investigation of the properties of the structural invariants $d_{\ell}(F)$ with $\ell \geq 0$, introduced in [18], in the case of normalized functions $F \in \mathcal{S}^{\sharp}$ of degree 2 and conductor 1 . These invariants do not characterize completely the functional equation of $F$, but contain a good amount of information on it. In particular, the $d_{\ell}(F)$ essentially determine the $h$-function $h_{F}(s)$ appearing in the invariant form (2.10) of the functional equation; see (2.12). The main tool in such investigation is a fully explicit version of a special case of the transformation formula for nonlinear twists studied in [13],[14],[16],[17]; see Lemma 4.2. From this formula we derive an interesting result in itself, namely: for every integer $N \geq 2$ the invariants $d_{\ell}(F)$ with $\ell \leq N$ lie on the algebraic variety defined by $Q_{N}\left(X_{0}, \ldots, X_{N}\right)=0$, where $Q_{N}$ are certain universal quadratic forms, i.e. independent of $F$; see Proposition 4.1. Since $d_{0}(F)=1$, an inductive argument immediately shows that all $d_{\ell}(F)$ with $\ell \geq 2$ are determined by $d_{1}(F)$ by means of a procedure not depending on $F$. Then we derive the value of $d_{1}(F)$ in terms of H -invariants, which are easy to compute from the data of the functional equation of $F$. Actually, recalling (1.1) and (2.5), it turns out that

$$
\begin{equation*}
d_{1}(F)=\chi_{F}-\frac{1}{8} \tag{3.1}
\end{equation*}
$$

see Lemma 4.3. Moreover, $d_{1}(F)$ is real-valued in the present case.
Next, in Section 5 we introduce the virtual $\gamma$-factors

$$
\gamma(s)= \begin{cases}(2 \pi)^{-s} \Gamma(s+\mu) & \text { with } \mu>0  \tag{3.2}\\ \pi^{-s} \Gamma\left(\frac{s+\varepsilon+i \kappa}{2}\right) \Gamma\left(\frac{s+\varepsilon-i \kappa}{2}\right) & \text { with } \varepsilon \in\{0,1\} \text { and } \kappa \geq 0\end{cases}
$$

respectively of Hecke and Maass type, and consider the analogues $h_{\gamma}(s)$ of the $h$-function, $S_{\gamma}(s)$ of the $S$-function in (5.18) and $d_{\ell}(\gamma)$ of the structural invariants, see (5.8). Although not every virtual $\gamma$-factor corresponds to an existing $L$-function, the invariants $d_{\ell}(\gamma)$ satisfy the same properties of the $d_{\ell}(F)$; see Lemma 5.2. Moreover, since

$$
\chi_{\gamma}:=\xi_{\gamma}+H_{\gamma}(2)+\frac{2}{3}=\left\{\begin{array}{l}
2 \mu^{2}  \tag{3.3}\\
-2 \kappa^{2}
\end{array}\right.
$$

with $\mu$ and $\kappa$ as in (3.2), thanks to the analog of (3.1) the set $\left\{d_{1}(\gamma): \gamma\right.$ virtual $\gamma$-factor $\}$ coincides with $\mathbb{R}$. Hence to any $F$ we associate a unique virtual $\gamma$-factor such that

$$
\begin{equation*}
d_{1}(F)=d_{1}(\gamma) \tag{3.4}
\end{equation*}
$$

Thus $d_{\ell}(F)=d_{\ell}(\gamma)$ for every $\ell \geq 0$ by the above reported properties of the structural invariants, and hence $h_{F}(s)=\omega_{F} h_{\gamma}(s)$; see Proposition 5.1. As a consequence, $F$ satisfies the functional equation

$$
\begin{equation*}
\gamma(s) F(s)=\omega_{F} R(s) \gamma(1-s) F(1-s), \quad R(s)=\frac{S_{F}(s)}{S_{\gamma}(s)} \tag{3.5}
\end{equation*}
$$

where $\gamma$ is the virtual $\gamma$-factor associated with $F$; see Corollary 5.1. Now we observe that if $R(s)=1$, then (3.5) becomes a functional equation of Hecke or Maass type, thus Theorem 1.1 follows at once from classical converse theorems, see Lemma 5.1, thanks to (3.1),(3.3) and (3.4).

In order to prove that $R(s)=1$ we first show, under a certain assumption if $\chi_{F}>0$, that $R(s)$ is almost constant, namely as $|t| \rightarrow \infty$

\begin{equation*}
R(s)=\eta+O\left(e^{-\delta|t|}\right) \quad \text { with some } \delta>0 \text { and a certain constant } \eta \neq 0 \tag{3.6}
\end{equation*}
$$

see Lemma 5.3. Moreover, if $R(s) \neq \eta$ then the function $S_{F}(s)$ in (5.18), namely

$$
\begin{equation*}
S_{F}(s)=\sum_{j=0}^{N} a_{j} e^{i \pi \omega_{j} s} \quad \text { with } a_{j} \neq 0 \text { and } \omega_{j} \text { strictly increasing, } \tag{3.7}
\end{equation*}
$$

has $N \geq 3$ and hence contains the term

$$
\begin{equation*}
a_{N-1} e^{i \pi \omega_{N-1} s} \quad \text { with } \omega_{N-1}>0 \tag{3.8}
\end{equation*}
$$

see Lemma 5.4.
The last step, i.e. proving that actually $R(s)=\eta$ (and hence $\eta=1$ ), requires deeper arguments and involves a non-standard use of certain period functions, in the sense of LewisZagier [19]. Indeed, given $F$ and its virtual $\gamma$-factor, in Section 6 we consider the Fourier series

f(z)=\sum_{n=1}^{\infty} a(n) n^{\lambda} e(n z), \quad z \in \mathbb{H}
$$

where $\lambda=\mu$ or $\lambda=i \kappa$ according to (3.2), and the period function

$$
\psi(z)=f(z)-z^{-2 \lambda-1} f(-1 / z)
$$

Then we proceed to the analysis of the function $f(z)$, involving the use of (3.6), of the properties of certain Mittag-Leffler functions and of the three-term functional equation (6.22) satisfied by $\psi(z)$. This leads to Propositions 6.1 and 6.2 , where we show that the assumption in Lemma 5.3 holds true and

\psi(z)=\omega_{F} Q_{\eta}(z)+H_{1}(z)
$$

say, where for some $c_{1}=c_{1}(\lambda)>0$

$$
\begin{equation*}
Q_{\eta}(z)=\frac{1}{2 \pi i} \int_{\left(c_{1}\right)}(R(s-\lambda)-\eta) \Gamma(s) \frac{\gamma(1-s+\lambda)}{\gamma(s-\lambda)} F(1-s+\lambda)(-2 \pi i z)^{-s} \mathrm{~d} s \tag{3.9}
\end{equation*}
$$

and both $H_{1}(z)$ and $Q_{\eta}(z)$ are holomorphic for $|\arg (z)|<\pi$.
Finally, in Section 7 we analyse the integral $Q_{\eta}(z)$, plugging into the function $R(s-\lambda)$ in (3.9) the expression (3.7) of $S_{F}(s-\lambda)$ as linear combination of exponentials. It turns out that the sum of all resulting terms, but the one coming from (3.8), gives raise to a function $H_{2}(z)$, say, holomorphic in the sector

-\pi \min \left(1-\omega_{N-2}, 1\right)<\arg (z)<\pi
$$

see (7.3)-(7.5). Instead, the term involving (3.8) can be transformed to

$$
c f\left(e^{i \pi\left(1-\omega_{N-1}\right)} z\right)+H_{3}(z)
$$

with a certain function $H_{3}(z)$ and $c \neq 0$, and we obtain that $f\left(e^{i \pi\left(1-\omega_{N-1}\right)} z\right)$ is holomorphic in the sector

$$
-\pi \min \left(1-\omega_{N-2}, 1-\omega_{N-1}+\delta, 1\right)<\arg (z)<\pi \omega_{N-1}
$$

$\delta$ being as in (3.6); see (7.6)-(7.10). After a change of variable we therefore get that $f(z)$ is holomorphic for $-\delta_{0}<\arg (z)<\pi$ with some $\delta_{0}>0$. But $f(z)$ is 1-periodic, hence it is an entire function; this leads immediately to a contradiction. Thus $R(s)=\eta$ and Theorem 1.1 follows.

## 4. Invariants

We refer to Sections 1 and 2 for definitions and notation used in what follows. We start recalling the basic properties of normalized functions in $\mathcal{S}^{\sharp}$ with degree 2 and conductor 1 .

Lemma 4.1. Let $F \in \mathcal{S}^{\sharp}$ be of degree 2 and conductor 1 . Then $F$ can be normalized. If $F$ is normalized then its Dirichlet coefficients are real, $\xi_{F}$ is an even integer and $\omega_{F}=-e^{i \frac{\pi}{2} \xi_{F}}$. Moreover, all its $H$-invariants are real and its $\gamma$-factor satisfies $\bar{\gamma}(s)=\gamma(s)$.

Proof. If $F$ has a pole at $s=1$ then $\theta_{F}=0$, see Lemma 4.1 of [14], while an entire $F$ can always be shifted by a purely imaginary quantity to get $\theta_{F}=0$. Clearly, such a shift does not change degree and conductor. Hence, if necessary, every $F \in \mathcal{S}^{\sharp}$ with $d=2$ and $q=1$ can be normalized by a suitable shift and multiplication by a constant. The second statement follows from equation (5) and the theorem in [17], observing that $\omega_{F}^{*}$ there is denoted here by $\omega_{F}$ and $H_{F}(1)=\xi_{F}$, see (2.5). The assertion about $H$-invariants follows since the $\mu$-data of the conjugate function $\bar{F}$ are $\bar{\mu}_{j}, j=1, \ldots, r$, thus $H_{\bar{F}}(n)=\overline{H_{F}(n)}$ for every $n \geq 0$ and hence $H_{F}(n) \in \mathbb{R}$ in our case. This also explains why $\bar{\gamma}(s)=\gamma(s)$.

Since every $F \in \mathcal{S}^{\sharp}$ with $d=2$ and $q=1$ can be normalized, from now on we always consider normalized functions, as in Theorem 1.1.

A major source of information about invariants comes from the transformation formula for nonlinear twists, which we studied in $[13],[14],[16],[17]$. Indeed, roughly speaking, the transformation formula gives different outputs if the same nonlinear twist of a function $F \in \mathcal{S}^{\sharp}$ is written in formally different ways; this phenomenon imposes several constraints on the invariants. Actually, some of the results in Lemma 4.1 were obtained along these lines, and to proceed further we need a closer analysis of the transformation formula. This is done, in a special case relevant for our purposes, in the next lemma. For $\alpha>0$ we rewrite the standard twist $F(s, \alpha)$ in the form

F(s ; f)=\sum_{n=1}^{\infty} \frac{a(n)}{n^{s}} e(-f(n, \alpha)), \quad f(n, \alpha)=n+\alpha \sqrt{n}
$$

For any integer $m \geq 0$ we define the polynomials in the $(s, \alpha)$-variables

$$
\left.\begin{array}{rl}
W_{m}(s, \alpha) & =\sum_{\nu=0}^{\infty} \sum_{\mu=0}^{\infty} \sum_{k=3 \nu}^{\infty} \sum_{\ell=0}^{\infty} \sum_{h=0}^{\infty} A(\nu+k) \\
-2 \nu+\mu+k+2 \ell+h=m
\end{array}\right)
$$

where $d_{\ell}(F)$ are the structural invariants of $F$,

$$
\begin{equation*}
A(\nu, \mu, k, \ell, h)=\frac{1}{\sqrt{\pi} \nu!}\left(-\frac{2 i}{\pi}\right)^{\frac{\mu+k}{2}}\left(-\frac{1}{2}\right)^{h}(4 \pi)^{\nu-\ell} a_{k, \nu} \Gamma\left(\frac{\mu+k+1}{2}\right) i^{\nu+\ell} \tag{4.2}
\end{equation*}
$$

and the coefficients $a_{k, \nu}$ are defined by the expansion

$$
\begin{equation*}
\left(\sum_{k=3}^{\infty}\binom{1 / 2}{k} \xi^{k}\right)^{\nu}=\sum_{k=3 \nu}^{\infty} a_{k, \nu} \xi^{k} . \tag{4.3}
\end{equation*}
$$

Note that $W_{m}(s, \alpha)$ is a polynomial since $k \geq 3 \nu$ and hence equation $-2 \nu+\mu+k+2 \ell+h=m$ in (4.1) has only finitely many solutions for every $m$.

Lemma 4.2. Let $F$ be as in Theorem 1.1 and $\alpha \in \operatorname{Spec}(F)$. Then, with the above notation, for every integer $M \geq 0$ we have

$$
F(s ; f)=\sum_{m=0}^{M} W_{m}(s, \alpha) F\left(s+\frac{m}{2}, \alpha\right)+H_{M}(s, \alpha),
$$

where $W_{0}(s, \alpha) \equiv 1$ and the function $H_{M}(s, \alpha)$ is holomorphic for $\sigma>-(M-1) / 2$.
Proof. We follow closely the arguments in [13] and [16], see also [17], giving details only at the places which are important for this paper. Moreover, since our goal here is to compute explicitly the quantities appearing in the main term of the transformation formula, we proceed in an essentially formal way, largely disregarding the problems about convergence, regularity and error terms. Indeed, for these issues a detailed treatment already appears in the above mentioned papers. Therefore, in order to simplify the presentation we denote generically by $\mathcal{E}$ any quantity not contributing to our explicit computations, and replace equality by $\sim$ whenever a finite sum plus error term is replaced by the full expansion. We also correct some minor inaccuracies in our previous computations. Such inaccuracies were unimportant for the results in [13] and [16], while precise computations of the involved quantities are essential here. Moreover, we simply write $d_{\ell}$ for the structural invariants $d_{\ell}(F)$.
(a) Set up. Let $\alpha>0$, not necessarily in $\operatorname{Spec}(F)$. Since in our case

f(n, \alpha)=n+\alpha \sqrt{n}=n^{\kappa_{0}}+\alpha n^{\kappa_{1}},
$$

say, as in Section 2 of [16] for $X>1$ and $s \in \mathbb{C}$ we write

$$
F_{X}(s ; f)=\sum_{n=1}^{\infty} \frac{a(n)}{n^{s}} e(-f(n, \alpha)) e^{-(n+\sqrt{n}) / X}
$$

Moreover, as in Section 2.1 of [16], let $R \geq 1$ be such that $3 / 2+2 R \notin \mathbb{N},-R<\sigma<-R+\delta$ with a small $\delta>0, \rho>2(R+1) / 3, \emptyset \neq \mathcal{A} \subset\{0,1\}$ with cardinality $|\mathcal{A}|$,

$$
\begin{gathered}
\boldsymbol{w}=w_{0}+\frac{1}{2} w_{1}, \quad \mathrm{~d} \boldsymbol{w}=\mathrm{d} w_{0} \mathrm{~d} w_{1}, \quad z_{0}=\frac{1}{X}+2 \pi i, \quad z_{1}=\frac{1}{X}+2 \pi i \alpha \\
G(\boldsymbol{w})=\Gamma\left(w_{0}\right) \Gamma\left(w_{1}\right) z_{0}^{-w_{0}} z_{1}^{-w_{1}}
\end{gathered}
$$

and let $\boldsymbol{w}_{\mid \mathcal{A}}, \mathrm{d} \boldsymbol{w}_{\mid \mathcal{A}}$ and $G\left(\boldsymbol{w}_{\mid \mathcal{A}}\right)$ be the restriction of $\boldsymbol{w}, \mathrm{d} \boldsymbol{w}$ and $G(\boldsymbol{w})$ to the indices appearing in $\mathcal{A}$, respectively. For $\sigma>-R$ and $\Re\left(w_{\nu}\right)=\rho$ for $\nu=0,1$ we have $\Re(s+\boldsymbol{w})>1$, hence by Mellin's transform we get, as in (2.1) of [16], that

F_{X}(s ; f)=\frac{1}{(2 \pi i)^{2}} \int_{(\rho)} \int_{(\rho)} F(s+\boldsymbol{w}) G(\boldsymbol{w}) \mathrm{d} \boldsymbol{w}
$$

Next we shift the lines of integration to $-\eta$ with some $1 / 2<\eta<3 / 4$. Writing

$$
\int_{\mathcal{L}} \mathrm{d} \boldsymbol{w}=\int_{(-\eta)} \int_{(-\eta)} \mathrm{d} \boldsymbol{w} \quad \text { and analogously for } \quad \int_{\mathcal{L}_{\mid \mathcal{A}}} \mathrm{d} \boldsymbol{w}_{\mid \mathcal{A}}
$$

and

$$
I_{X}(s, \mathcal{A})=\frac{1}{(2 \pi i)^{|\mathcal{A}|}} \int_{\mathcal{L}_{\mid \mathcal{A}}} F\left(s+\boldsymbol{w}_{\mid \mathcal{A}}\right) G\left(\boldsymbol{w}_{\mid \mathcal{A}}\right) \mathrm{d} \boldsymbol{w}_{\mid \mathcal{A}}
$$

as in Lemma 2.1 of [16] we have that

$$
\begin{equation*}
F_{X}(s ; f)=\sum_{\emptyset \neq \mathcal{A} \subset\{0,1\}} I_{X}(s, \mathcal{A})+\mathcal{E} \tag{4.4}
\end{equation*}
$$

Now, recalling that the coefficients of $F$ are real by Lemma 4.1, since $\sigma-\eta<0$ we apply inside each integral $I_{X}(s, \mathcal{A})$ the functional equation of $F$ in the invariant form

$$
\begin{equation*}
F\left(s+\boldsymbol{w}_{\mid \mathcal{A}}\right)=h_{F}\left(s+\boldsymbol{w}_{\mid \mathcal{A}}\right) S_{F}\left(s+\boldsymbol{w}_{\mid \mathcal{A}}\right) F\left(1-s-\boldsymbol{w}_{\mid \mathcal{A}}\right), \tag{4.5}
\end{equation*}
$$

see (2.10), and expand $F\left(1-s-\boldsymbol{w}_{\mid \mathcal{A}}\right)$. This way, writing $\boldsymbol{x}_{\mid \mathcal{A}}=s+\boldsymbol{w}_{\mid \mathcal{A}}$ as on p. 7656 of [16], we obtain that

$$
\begin{equation*}
I_{X}(s, \mathcal{A})=\sum_{n=1}^{\infty} \frac{a(n)}{n^{1-s}} \frac{1}{(2 \pi i)^{|\mathcal{A}|}} \int_{\mathcal{L}_{\mid \mathcal{A}}} h_{F}\left(\boldsymbol{x}_{\mid \mathcal{A}}\right) S_{F}\left(\boldsymbol{x}_{\mid \mathcal{A}}\right) G\left(\boldsymbol{w}_{\mid \mathcal{A}}\right) n^{\boldsymbol{w}_{\mid \mathcal{A}}} \mathrm{d} \boldsymbol{w}_{\mid \mathcal{A}} \tag{4.6}
\end{equation*}
$$

Note that the right hand side of (4.6) is formally slightly different from (2.10) of [16], as here we use the invariant form (4.5) of the functional equation. Precisely, comparing with the notation in (2.10) of [16] we have

$$
S_{F}\left(\boldsymbol{x}_{\mid \mathcal{A}}\right)=2^{r} S\left(\boldsymbol{x}_{\mid \mathcal{A}}\right) \quad \text { and } \quad h_{F}\left(\boldsymbol{x}_{\mid \mathcal{A}}\right)=\frac{\omega}{(2 \pi)^{r}} Q^{1-2 \boldsymbol{x}_{\mid \mathcal{A}}} \widetilde{G}\left(\boldsymbol{x}_{\mid \mathcal{A}}\right) .
$$

However, this slight difference does not affect the subsequent arguments in [13],[16],[17]. Actually, our present approach simplifies the treatment since we can appeal directly to the asymptotic expansion in (2.12) of the function $h_{F}(s)$, involving the structural invariants $d_{\ell}$. The presence of the invariants $d_{\ell}$ provides also a conceptual advantage, which turns out to be important later on in the paper.
(b) Expansions. From (2.12) of [16] we have that

$$
S_{F}\left(\boldsymbol{x}_{\mid \mathcal{A}}\right)=a_{-N} e^{-i \pi \boldsymbol{x}_{\mid \mathcal{A}}}+a_{N} e^{i \pi \boldsymbol{x}_{\mid \mathcal{A}}}+\mathcal{E}
$$

From the treatment on pages 7657-7659 of [16] of the $J_{X}$-integrals, stemming from the term $a_{N} e^{\pi i x_{\mid \mathcal{A}}}$, we have that in the end their contribution is absorbed by the function $H_{M}(s, \alpha)$ in the statement of the lemma; see also Lemma 2.2 of [16]. Thus the term $a_{N} e^{\pi i \boldsymbol{x}_{\mid \mathcal{A}}}$ does not contribute to the main terms, hence we rewrite the above expression for $S_{F}\left(\boldsymbol{x}_{\mid \mathcal{A}}\right)$ as

$$
S_{F}\left(\boldsymbol{x}_{\mid \mathcal{A}}\right)=a_{-N} e^{-i \pi \boldsymbol{x}_{\mid \mathcal{A}}}+\mathcal{E}
$$

Next we recall that $a_{-N}=e^{-i \frac{\pi}{2} \xi_{F}}$, see Section 3.7 of [18], hence $\omega_{F} a_{-N}=-1$ by Lemma 4.1. Therefore, in view of the expansion of $h_{F}(s)$ in (2.12) we have that equation (2.13) of [16] is now replaced by

$$
\begin{equation*}
h_{F}\left(\boldsymbol{x}_{\mid \mathcal{A}}\right) S_{F}\left(\boldsymbol{x}_{\mid \mathcal{A}}\right) \sim \frac{-(4 \pi)^{2 \boldsymbol{x}_{\mid \mathcal{A}}}}{2(2 \pi)^{3 / 2}} e^{-i \pi \boldsymbol{x}_{\mid \mathcal{A}}} \sum_{\ell=0}^{\infty} d_{\ell} \Gamma\left(3 / 2-2 \boldsymbol{x}_{\mid \mathcal{A}}-\ell\right)+\mathcal{E} \tag{4.7}
\end{equation*}
$$

Thus, by (4.6) and (4.7), equation (2.15) of [16] finally becomes

$$
\begin{equation*}
I_{X}(s, \mathcal{A}) \sim \frac{-(4 \pi)^{2 s}}{2(2 \pi)^{3 / 2}} \sum_{\ell=0}^{\infty} d_{\ell} \sum_{n=1}^{\infty} \frac{a(n)}{n^{1-s}} I_{X}(s, \mathcal{A}, n, \ell)+\mathcal{E} \tag{4.8}
\end{equation*}
$$

with

$$
I_{X}(s, \mathcal{A}, n, \ell)=\frac{1}{(2 \pi i)^{|\mathcal{A}|}} \int_{\mathcal{L}_{\mid \mathcal{A}}} \Gamma\left(3 / 2-2 \boldsymbol{x}_{\mid \mathcal{A}}-\ell\right) e^{-i \pi \boldsymbol{x}_{\mid \mathcal{A}}} G\left(\boldsymbol{w}_{\mid \mathcal{A}}\right)\left((4 \pi)^{2} n\right)^{\boldsymbol{w}_{\mid \mathcal{A}}} \mathrm{d} \boldsymbol{w}_{\mid \mathcal{A}}
$$

Note that $I_{X}(s, \mathcal{A}, n, \ell)$ coincides with the definition of $I_{X}(s, \mathcal{A}, n, \ell)$ in (2.16) of [16] with $d=2$, $q=1 /(4 \pi)^{2}$ and $\theta_{F}=0$, but not with the definition of $I_{X}(s, \mathcal{A}, n, \ell)$ on p. 1409 of [13]. Indeed, recalling the data of the functional equation of $F$ in Section 2, the latter coincides with

$$
\begin{equation*}
\left(\frac{4}{\beta}\right)^{s} I_{X}(s, \mathcal{A}, n, \ell), \quad \text { where } \quad \beta=\prod_{j=1}^{r} \lambda_{j}^{2 \lambda_{j}} \tag{4.9}
\end{equation*}
$$

since $Q^{2} \beta / d^{d}=(4 \pi)^{-2}$ in the present case, where degree is 2 and conductor is 1 .
Now we use the Mellin transform argument leading to equation (2.18) of [16], but in order to compute the coefficients $f_{\ell}$ in such equation we have to follow the arguments on p. 1410 of [13]. Recalling the difference in notation pointed out in (4.9), by (2.13) of [13] we have that the inverse Mellin transform $\widetilde{I}_{X}(y)$ of $\left(\frac{4}{\beta}\right)^{s} I_{X}(s, \mathcal{A}, n, \ell)$ is in our case

$$
\widetilde{I}_{X}(y)=\frac{1}{2} e^{2 i / \sqrt{y \beta}}\left(\frac{2 e^{-i \pi / 2}}{\sqrt{y \beta}}\right)^{\frac{3}{2}-\ell} \prod_{\nu \in \mathcal{A}}\left(e^{-\frac{z_{\nu} Q^{2 \kappa_{\nu}}}{n^{\kappa \nu} y^{\kappa \nu}}}-1\right)
$$

Hence, after a computation needed since the constants $c_{\ell}$ in (2.13) and (2.14) of [13] are not the same, equation (2.14) of [13] in the present case becomes

$$
\left(\frac{4}{\beta}\right)^{s} I_{X}(s, \mathcal{A}, n, \ell)=\left(\frac{4}{\beta}\right)^{s} c_{\ell} \int_{0}^{\infty} e^{i \sqrt{x}} \prod_{\nu \in \mathcal{A}}\left(e^{-z_{\nu}\left(\frac{x}{(4 \pi)^{2} n}\right)^{\kappa_{\nu}}}-1\right) x^{-s-\frac{\ell}{2}-\frac{1}{4}} \mathrm{~d} x
$$

where

$$
\begin{equation*}
c_{\ell}=\frac{1}{2} e^{-\frac{3}{4} \pi i} i^{\ell} \tag{4.10}
\end{equation*}
$$

As a consequence, using identity (2.16) of [13], equation (2.19) of [16] now takes the form

$$
\begin{align*}
I_{X}(s, n, \ell) & :=\sum_{\emptyset \neq \mathcal{A} \subset\{0,1\}} I_{X}(s, \mathcal{A}, n, \ell)  \tag{4.11}\\
& =c_{\ell} \int_{0}^{\infty} e^{i \sqrt{x}}\left(e^{-\Psi_{X}(x, n)} e\left(-f\left(\frac{x}{(4 \pi)^{2} n}, \alpha\right)\right)-1\right) x^{-s-\frac{\ell}{2}-\frac{1}{4}} \mathrm{~d} x
\end{align*}
$$

with

$$
\Psi_{X}(x, n)=\frac{1}{X}\left(\frac{x}{(4 \pi)^{2} n}+\sqrt{\frac{x}{(4 \pi)^{2} n}}\right) .
$$

(c) Saddle point and limit as $X \rightarrow \infty$. The next step is to apply the saddle point technique developed in Section 2.3 of [13] and [16] to the right hand side of (4.11). Recalling that $\theta_{F}=0$ and that the integral on the right hand side of (4.11) is multiplied by $c_{\ell}$, from Lemma 2.3 of [16] we deduce that for $n \geq n_{0}$ and $n_{0}$ sufficiently large

\end{equation*}
$$

where $K_{X}(s, \xi)$ is as in (2.21) of [16]. Hence from (4.4),(4.8),(4.10) and (4.12) we have that (2.22) of [16] becomes

$$

Then we pass to the limit as $X \rightarrow \infty$ as in Section 2.4 of [16], thus getting that

F(s ; f) \sim \frac{e^{i \pi / 4}}{4(2 \pi)^{3 / 2}}(4 \pi)^{2 s} \sum_{\ell=0}^{\infty} i^{\ell} d_{\ell} \sum_{n \geq n_{0}} \frac{a(n)}{n^{1-s}} K\left(s+\frac{\ell}{2}, n\right)+\mathcal{E} \tag{4.13}
\end{equation*}
$$

where

K(s, n)=\gamma x_{0}^{\frac{3}{4}-s} \int_{-r}^{r} e^{i \Phi(z, n)}(1+\gamma \lambda)^{-s-\frac{1}{4}} \mathrm{~d} \lambda
$$

and $x_{0}=x_{0}(n)$ is the critical point of $\Phi(z, n)$, see Lemma 2.3 of [13],

$$
\begin{gathered}
\Phi(z, n)=z^{\frac{1}{2}}-2 \pi f\left(\frac{z}{(4 \pi)^{2} n}, \alpha\right), \quad z=x_{0}(1+\gamma \lambda) \\
\gamma=1-i, \quad r=\frac{\log n}{\sqrt{R}}, \quad R=x_{0}^{2} \Phi^{\prime \prime}\left(x_{0}, n\right)
\end{gathered}
$$

We finally note that the critical point $x_{0}$ is real and

see Lemma 2.3 and (2.30) of [13], respectively. Note also that, with respect to [13] and [16], we slightly simplified the notation of the various terms in $K(s, \xi)$.
(d) Computation of $K(s, n)$. Now we proceed to the novel part of the proof of the lemma, namely a detailed computation of the function $K(s, n)$. From now on we assume that $\alpha \in$ $\operatorname{Spec}(F)$, thus $\alpha^{2} / 4 \in \mathbb{N}$. Clearly, the critical point $x_{0}$, solution of the equation $\frac{\partial}{\partial z} \Phi(z, n)=0$, in our case satisfies

& =\gamma e(-\alpha \sqrt{n})\left(4 \pi n \Delta_{n}\right)^{\frac{3}{2}-2 s} I(s, n),
\end{align*}
$$

where

I(s, n)=\int_{-r}^{r} e^{i\left(\Phi(z, n)-\Phi\left(x_{0}, n\right)\right)}(1+\gamma \lambda)^{-s-\frac{1}{4}} \mathrm{~d} \lambda .
$$

But

$$
\begin{aligned}
\Phi(z, n)-\Phi\left(x_{0}, n\right) & =\sqrt{z} \Delta_{n}-\frac{z}{8 \pi n}-\sqrt{x_{0}} \Delta_{n}+\frac{x_{0}}{8 \pi n} \\
& =4 \pi n \Delta_{n}^{2}\left((1+\gamma \lambda)^{1 / 2}-1-\frac{\gamma \lambda}{2}\right)
\end{aligned}
$$

hence writing

\phi(x)=(1+x)^{1 / 2}-1-\frac{1}{2} x+\frac{1}{8} x^{2}=\sum_{k=3}^{\infty}\binom{1 / 2}{k} x^{k} \tag{4.17}

and recalling that $\gamma^{2}=-2 i$ we have that

& =\int_{-r}^{r} e^{-\pi n \Delta_{n}^{2} \lambda^{2}} e\left(2 n \Delta_{n}^{2} \phi(\gamma \lambda)\right)(1+\gamma \lambda)^{-s-\frac{1}{4}} \mathrm{~d} \lambda \tag{4.18}
\end{align*}

Since $r=o(1)$ as $n \rightarrow \infty$ by (4.14), for $n \geq n_{0}$ we expand the complex exponential and the function $(1+\gamma \lambda)^{-s-\frac{1}{4}}$ in the above integral, and then we replace $\phi(\gamma \lambda)$ by its power series. Hence we have

\end{equation*}

But, first by the change of variable $\sqrt{n} \Delta_{n} \lambda=u$, then completing the integral to $(0, \infty)$ and finally by the change of variable $\pi u^{2}=\xi$, in view of (4.14) we have

& =\frac{1}{2\left(\sqrt{\pi n} \Delta_{n}\right)^{\mu+k+1}} \int_{0}^{\infty} e^{-\xi} \xi^{\frac{\mu+k-1}{2}} \mathrm{~d} \xi+\mathcal{E} \\
& =\frac{\Gamma\left(\frac{\mu+k+1}{2}\right)}{2\left(\sqrt{\pi n} \Delta_{n}\right)^{\mu+k+1}}+\mathcal{E}
\end{aligned}
$$

Hence (4.19) becomes

I(s, n)=\sum_{\nu=0}^{\infty} \sum_{\substack{\mu=0 \\ 2 \mid(\mu+k)}}^{\infty} \sum_{k=3 \nu}^{\infty} \frac{(4 \pi i)^{\nu}}{\nu!} a_{k, \nu} \gamma^{\mu+k} \frac{\Gamma\left(\frac{\mu+k+1}{2}\right)}{\pi^{\frac{\mu+k+1}{2}}}\binom{-s-\frac{1}{4}}{\mu} \frac{\Delta_{n}^{2 \nu-\mu-k-1}}{n^{-\frac{2 \nu-\mu-k-1}{2}}}+\mathcal{E}, \tag{4.20}
\end{equation*}
$$

and from (4.16) and (4.20) we obtain that

K(s, n) & =\gamma e(-\alpha \sqrt{n})(4 \pi)^{\frac{3}{2}-2 s}\left(n \Delta_{n}\right)^{\frac{3}{2}-2 s} \\
\times \sum_{\nu=0}^{\infty} \sum_{\mu=0}^{2 \mid(\mu+k)} & \sum_{k=3 \nu}^{\infty} \frac{(4 \pi i)^{\nu}}{\nu!} a_{k, \nu} \gamma^{\mu+k} \frac{\Gamma\left(\frac{\mu+k+1}{2}\right)}{\pi^{\frac{\mu+k+1}{2}}}\binom{-s-\frac{1}{4}}{\mu} \frac{\Delta_{n}^{2 \nu-\mu-k-1}}{n^{-\frac{2 \nu-\mu-k-1}{2}}}+\mathcal{E}  \tag{4.21}\\
& =\sum_{\substack{\nu=0 \\
2 \mid(\mu+k)}}^{\infty} \sum_{\substack{ }}^{\infty} \sum_{k=3 \nu}^{\infty} b_{\nu, \mu, k}(s) \frac{\Delta_{n}^{2 \nu-\mu-k+\frac{1}{2}-2 s}}{n^{2 s-1-\frac{2 \nu-\mu-k}{2}}} e(-\alpha \sqrt{n})+\mathcal{E}
\end{align*}
$$

where

$$
b_{\nu, \mu, k}(s)=(4 \pi)^{\frac{3}{2}-2 s} \frac{(4 \pi i)^{\nu}}{\nu!} a_{k, \nu} \gamma^{\mu+k+1} \frac{\Gamma\left(\frac{\mu+k+1}{2}\right)}{\pi^{\frac{\mu+k+1}{2}}}\binom{-s-\frac{1}{4}}{\mu} .
$$

Note that $b_{\nu, \mu, k}(s)$ is independent of $\alpha, n$ and the data of the functional equation of $F$.
Recalling the definition of $\Delta_{n}$ in (4.15) we have the following expansion

F(s ; f) \sim \sum_{\nu=0}^{\infty} \sum_{\substack{\mu=0 \\ 2 \mid(\mu+k)}}^{\infty} \sum_{\substack{ \\2 \mid(\mu)}}^{\infty} \sum_{h=0}^{\infty} c_{\nu, \mu, k, \ell, h}(s) d_{\ell} \alpha^{h} \sum_{n \geq n_{0}} \frac{a(n)}{n^{s+\ell-\frac{2 \nu-\mu-k-h}{2}}} e(-\alpha \sqrt{n})+\mathcal{E} \tag{4.22}
\end{equation*}
$$

with

$$
\begin{equation*}
c_{\nu, \mu, k, \ell, h}(s)=\frac{e^{i \pi / 4}}{4(2 \pi)^{3 / 2}}(4 \pi)^{2 s} i^{\ell}\binom{2 \nu-\mu-k+\frac{1}{2}-2 s-\ell}{h} \frac{(-1)^{h}}{2^{h}} b_{\nu, \mu, k}\left(s+\frac{\ell}{2}\right) . \tag{4.23}
\end{equation*}

Note that, again, the coefficients $c_{\nu, \mu, k, \ell, h}(s)$ are independent of $\alpha, n$ and the data of the functional equation of $F$. Hence, recalling that $\gamma=1-i$ and rearranging terms, a comparison of (4.22) and (4.23) with (4.1) and (4.2) shows that (4.22) can be rewritten as

Given $M$, if $K(M)<(M-1) / 2$ we choose $M^{*}>M$ such that $K\left(M^{*}\right) \geq(M-1) / 2$, thus getting that (4.26) holds with $M^{*}$ in place of $M$ and $-(M-1) / 2$ in place of $-K$. But for $M<m \leq M^{*}$ and $\sigma>-(M-1) / 2$ we have that $\Re(s+m / 2)>(1-M) / 2+(M+1) / 2=1$, hence

The previous lemma is the first step in the proof of the main result of this section.

Before normalization of coefficients, such a quadratic form is given by (4.34) and (4.29) below.

Proof. Again we write $d_{\ell}$ for $d_{\ell}(F)$. Thanks to the periodicity of the complex exponential we have that the nonlinear twist $F(s ; f)$ defined before Lemma 4.2 coincides with the standard twist $F(s, \alpha)$, hence Lemma 4.2 implies that for $\alpha \in \operatorname{Spec}(F)$ and $M \geq 1$

We set $k=3 \nu+b$ with $b \geq 0$ in (4.1) and observe that the range of variation of $2 \ell+h$ is

& \times\binom{-\frac{1}{4}-s-\frac{\ell}{2}}{\mu}\binom{\frac{1}{2}-2 s-\nu-\mu-b-\ell}{h} d_{\ell}(F) \alpha^{h} \\
= & \sum_{\substack{\ell=0 \\
2 \ell+h \leq m}}^{\infty} \sum_{h=0}^{\infty} B_{m}(s, \ell, h) d_{\ell}(F) \alpha^{h}, \tag{4.28}
\end{align*}
$$

where

$$
\begin{align*}
B_{m}(s, \ell, h) & =\sum_{\substack{\nu=0 \\
2 \mid(\nu+\mu+0)}}^{\infty} \sum_{b=0}^{\infty} \sum_{\substack{ \\
\nu+\mu+b=m-(2 \ell+h)}}^{\infty} A(\nu, \mu, 3 \nu+b, \ell, h) \\
& \times\binom{-\frac{1}{4}-s-\frac{\ell}{2}}{\mu}\binom{\frac{1}{2}-2 s-\nu-\mu-b-\ell}{h} . \tag{4.29}
\end{align*}
$$

Thus from (4.27) and (4.28) we have, still for every $\alpha \in \operatorname{Spec}(F)$ and $M \geq 1$, that

Next we set $p=m+h$, hence (4.30) becomes

& =\sum_{1 \leq m \leq M}(-2 \pi i)^{m} \sum_{m \leq p \leq 2 m} \sum_{0 \leq \ell \leq m-p / 2} B_{m}\left(s_{M}, \ell, p-m\right) d_{\ell} d_{M-m} \alpha^{p}  \tag{4.31}\\
& =\sum_{1 \leq p \leq 2 M}\left(\sum_{p / 2 \leq m \leq \min (p, M)} \cdot \sum_{0 \leq \ell \leq m-p / 2}(-2 \pi i)^{m} B_{m}\left(s_{M}, \ell, p-m\right) d_{\ell} d_{M-m}\right) \alpha^{p}
\end{align*}
$$

for every $\alpha \in \operatorname{Spec}(F)$ and $M \geq 1$.
But we know that $\operatorname{Spec}(F)$ is an infinite set, see at the end of Section 2, thus (4.31) implies that for every $M \geq 1$ and $1 \leq p \leq 2 M$

Setting further $h=M-m$, and hence $m=M-h$, we see that condition $p / 2 \leq m \leq \min (p, M)$ in (4.32) is equivalent to $M-\min (p, M) \leq h \leq M-p / 2$ and hence to $\max (M-p, 0) \leq h \leq$ $M-p / 2$. Therefore we rewrite (4.32) as

This is, before normalization, the quadratic form announced in the proposition.
Hence it remains to check our assertions about the quadratic form $\widetilde{Q}_{N}\left(X_{0}, \ldots, X_{N}\right)$, namely that its coefficients are independent of $F$ and real after normalization, and for $N \geq 2$

The first assertion is immediate since the coefficients $A(\nu, \mu, k, \ell, h)$ in (4.2), and hence the polynomials $B_{m}(s, \ell, h)$ in (4.29), are independent of $F$, and so is also $s_{2 N}$ by (2.6). Moreover, in view of (4.2) and (4.29), the coefficients $(-2 \pi i)^{-h} B_{2 N-h}\left(s_{2 N}, \ell, h\right)$ are sums of type

$$

with $c_{N}(\nu, \mu, b, \ell, h) \in \mathbb{R}$, so the second assertion follows. Finally, again from (4.2) and (4.29) we have that

B_{2 N}\left(s_{2 N}, N, 0\right)=A(0,0,0, N, 0)=\frac{1}{\sqrt{\pi}}(4 \pi)^{-N} \Gamma(1 / 2) i^{N}=(-4 \pi i)^{-N}
$$

thus

$$
(-2 \pi i)^{-N} B_{N}\left(s_{2 N}, 0, N\right)+B_{2 N}\left(s_{2 N}, N, 0\right)=(-4 \pi i)^{-N}\left(1+(-1)^{N}\binom{2 N-1}{N}\right) \neq 0
$$

for $N \geq 2$, as required. The proposition now follows dividing $\widetilde{Q}_{N}$ by the right hand side of the last equation.

As an immediate consequence of Proposition 4.1 we explicitly record the following corollary, obtained by a trivial induction since $d_{0}(F)=1$, see (2.12).

Corollary 4.1. Let $F$ be as in Theorem 1.1. Then the value of any $d_{\ell}(F)$ with $\ell \geq 2$ is determined by the value of $d_{1}(F)$ by a recursive algorithm independent of $F$.

Finally we express the structural invariant $d_{1}(F)$ in terms of the $H$-invariants, which are easy to compute by means of definition (2.4).

Lemma 4.3. Let $F$ be as in Theorem 1.1. Then, recalling (1.1), we have that

$$
d_{1}(F)=\chi_{F}-\frac{1}{8}
$$

Proof. We briefly sketch the formal computations leading to the result; actually, these computations lead to an expression of any $d_{\ell}(F)$ in terms of $H$-invariants, see (4.39), which can be used to calculate explicitly any given $d_{\ell}(F)$.

Using (2.3) and Stirling's formula, see Corollary 6.2 of [29], adopting the notation $\sim$ in the proof of Lemma 4.2 we get

$$
\begin{aligned}
& \log h_{F}(s)-\log \Gamma(3 / 2-2 s) \sim \log \omega_{F}-\log \sqrt{2 \pi}+(2 s-1) \log (4 \pi) \\
&+\sum_{\nu=1}^{\infty} \frac{(-1)^{\nu+1}}{\nu(\nu+1)}\left\{\sum_{j=1}^{r}\left(\frac{B_{\nu+1}\left(\lambda_{j}+\bar{\mu}_{j}\right)}{\left(-\lambda_{j} s\right)^{\nu}}+\frac{B_{\nu+1}\left(1-\mu_{j}\right)}{\left(-\lambda_{j} s\right)^{\nu}}\right)-\frac{B_{\nu+1}(3 / 2)}{(-2 s)^{\nu}}\right\} \\
& \sim \log \left(\frac{\omega_{F}}{\sqrt{2 \pi}}\left(\frac{1}{4 \pi}\right)^{1-2 s}\right)+\sum_{\nu=1}^{\infty} \frac{r_{\nu}(F)}{\nu(\nu+1)} \frac{1}{s^{\nu}},
\end{aligned}
$$

say, since $d=2, q=1$ and $\theta_{F}=0$. Moreover, thanks to (2.4) and to the formulae

$$
B_{\nu+1}\left(\lambda_{j}+\bar{\mu}_{j}\right)=\sum_{k=0}^{\nu+1}\binom{\nu+1}{k} B_{k}\left(\bar{\mu}_{j}\right) \lambda_{j}^{\nu+1-k} \quad \text { and } \quad B_{\nu+1}\left(1-\mu_{j}\right)=(-1)^{\nu+1} B_{\nu+1}\left(\mu_{j}\right)
$$

see (4.23) and (4.27) of [29], we have that

$$
\begin{equation*}
r_{\nu}(F)=\frac{B_{\nu+1}(3 / 2)}{2^{\nu}}-\frac{1}{2}\left\{\sum_{k=0}^{\nu+1}\binom{\nu+1}{k} \overline{H_{F}(k)}+(-1)^{\nu+1} H_{F}(\nu+1)\right\} . \tag{4.35}
\end{equation*}
$$

Thus

$$
\begin{equation*}
h_{F}(s) \sim \frac{\omega_{F}}{\sqrt{2 \pi}}\left(\frac{1}{4 \pi}\right)^{1-2 s} \Gamma(3 / 2-2 s) \exp \left(\sum_{\nu=1}^{\infty} \frac{r_{\nu}(F)}{\nu(\nu+1)} \frac{1}{s^{\nu}}\right) . \tag{4.36}
\end{equation*}
$$

Next, expanding the exponential we obtain

$$
\exp \left(\sum_{\nu=1}^{\infty} \frac{r_{\nu}(F)}{\nu(\nu+1)} \frac{1}{s^{\nu}}\right) \sim 1+\sum_{m=1}^{\infty} \frac{1}{m!}\left(\sum_{\nu=1}^{\infty} \frac{r_{\nu}(F)}{\nu(\nu+1)} \frac{1}{s^{\nu}}\right)^{m} \sim 1+\sum_{h=1}^{\infty} \frac{V_{h}(F)}{s^{h}}
$$

with

$$
\begin{equation*}
V_{h}(F)=\sum_{m=1}^{h} \frac{1}{m!} \sum_{\substack{\nu_{1} \geq 1 \\ \nu_{1}+\cdots+\nu_{m}=h}} \cdots \sum_{\substack{\nu_{m} \geq 1}} \prod_{j=1}^{m} \frac{r_{\nu_{j}}(F)}{\nu_{j}\left(\nu_{j}+1\right)} \quad \text { for } h \geq 1 \tag{4.37}
\end{equation*}
$$

Moreover, letting $z=1 / 2-2 s$, for $h \geq 1$ we write

$$
\begin{equation*}
\frac{1}{s^{h}}=\sum_{\ell \geq h} \frac{A_{h, \ell}}{z(z-1) \cdots(z-\ell+1)} \tag{4.38}
\end{equation*}
$$

with certain coefficients $A_{h, \ell} \in \mathbb{R}$. But, by the factorial formula for the $\Gamma$ function, for $\ell \geq 1$

$$
\frac{\Gamma(3 / 2-2 s)}{z(z-1) \cdots(z-\ell+1)}=\Gamma(z-\ell+1)=\Gamma(3 / 2-2 s-\ell)
$$

hence substituting into (4.36) and comparing with (2.12) we finally obtain that for $\ell \geq 1$

$$
\begin{equation*}
d_{\ell}(F)=\sum_{h=1}^{\ell} A_{h, \ell} V_{h}(F) \tag{4.39}
\end{equation*}
$$

In particular, (4.37) and (4.38) imply that for $\ell=1$ we have $A_{1,1}=-2$ and $V_{1}(F)=r_{1}(F) / 2$, hence by (4.39), (4.35) and Lemma 4.1

$$
d_{1}(F)=-r_{1}(F)=-\frac{1}{2} B_{2}(3 / 2)+\frac{1}{2}\left(H_{F}(0)+2 H_{F}(1)+2 H_{F}(2)\right)=\frac{13}{24}+\xi_{F}+H_{F}(2)
$$

and the result follows in view of (1.1).

## 5. Virtual $\gamma$-FActors

With the cases of holomorphic and non-holomorphic modular forms of level 1 in mind, we define the virtual $\gamma$-factors as

$$
\gamma(s)= \begin{cases}(2 \pi)^{-s} \Gamma(s+\mu) & \text { with } \mu>0  \tag{5.1}\\ \pi^{-s} \Gamma\left(\frac{s+\varepsilon+i \kappa}{2}\right) \Gamma\left(\frac{s+\varepsilon-i \kappa}{2}\right) & \text { with } \varepsilon \in\{0,1\} \text { and } \kappa \geq 0\end{cases}
$$

Obviously, we say that the first $\gamma$-factor in (5.1) is of Hecke type and the second is of Maass type. In view of Remark 2.1, the virtual $\gamma$-factors have degree 2 and conductor 1 . Moreover, by (2.5) we also have

$$
\xi_{\gamma}=\left\{\begin{array}{l}
2 \mu-1  \tag{5.2}\\
2(\varepsilon-1)
\end{array} \quad \text { and } \quad \chi_{\gamma}:=\xi_{\gamma}+H_{\gamma}(2)+\frac{2}{3}=\left\{\begin{array}{l}
2 \mu^{2} \\
-2 \kappa^{2}
\end{array}\right.\right.
$$

and clearly, with obvious notation,

$$
\begin{equation*}
\prod_{j=1}^{r} \lambda_{j}^{2 i \Im \mu_{j}}=1 \tag{5.3}
\end{equation*}
$$

for all virtual $\gamma$-factors.
As suggested by the name, not every virtual $\gamma$-factor corresponds to an existing $L$-function. The list of all normalized $F \in \mathcal{S}^{\sharp}$ whose $\gamma$-factor is a virtual $\gamma$-factor is provided by the classical converse theorems of Hecke [4] and Maass [20]. In the next lemma, "eigenvalue of the Laplacian" means eigenvalue of the hyperbolic Laplacian on the real analytic, $L^{2}$ and $\Gamma_{0}(1)$ invariant functions on the upper half-plane $\mathbb{H}$.

Lemma 5.1. If the $\gamma$-factor of $F \in \mathcal{S}^{\sharp}$ is a virtual $\gamma$-factor and $F$ is normalized, then one of the following cases holds true:
(i) $\mu=\frac{k-1}{2}$ with an even integer $k \geq 12$, in which case $\omega_{F}=(-1)^{k / 2}$ and $F(s)=L(s+\mu, f)$ with some holomorphic cusp form $f$ of level 1 and weight $k$;
(ii) $\rho=1 / 4+\kappa^{2}$ is an eigenvalue of the Laplacian, in which case $\omega_{F}=(-1)^{\varepsilon}$ and $F(s)=$ $L(s, u)$ with some Maass form $u$ of level 1 , weight 0 , parity $\varepsilon$ and with eigenvalue $\rho$.

Proof. We deal first with virtual $\gamma$-factors of Hecke type. Suppose that a normalized $F \in \mathcal{S}^{\sharp}$ satisfies

$$
\begin{equation*}
\gamma(s) F(s)=\omega \gamma(1-s) F(1-s) \tag{5.4}
\end{equation*}
$$

Then $a(n) \ll n^{c}$ for some $c>0$ and, by the change of variable $s \mapsto s-\mu$, (5.4) becomes

$$
(2 \pi)^{-s} \Gamma(s) G(s)=\omega(2 \pi)^{-(k-s)} \Gamma(k-s) G(k-s),
$$

where

$$
k=2 \mu+1>1 \quad \text { and } \quad G(s)=F(s-\mu) .
$$

This is Hecke's functional equation with signature $(1, k, \omega)$, see Definition 2.1 of Berndt-Knopp [1]. Moreover, by (5.3) we have

$$
\begin{equation*}
\omega_{F}=\omega \tag{5.5}
\end{equation*}
$$

But, by Lemma 4.1 and (5.2), $\xi_{F}=2 \mu-1$ is an even integer, thus $k$ is also an even integer and $\omega=(-1)^{k / 2}$ by (5.5). Hence $G(s)$ has signature

$$
\left(1, k,(-1)^{k / 2}\right) \quad \text { with an even integer } k \geq 2
$$

therefore by Hecke's converse theorem, see Theorem 2.1 of $[1], G(s)=L(s, f)$, the $L$-function associated with a modular form $f$ of level 1 and weight $k$. According to Theorem 4 of Chapter VII of Serre [28] (where the weight of $f$ is denoted by $2 k$ ) the space of modular forms of weight $k \in 2 \mathbb{Z}$ is trivial for $k<0$ and $k=2$, while it has dimension 1 for $k=0,4,6,8,10$ and is generated, respectively, by 1 and the Eisenstein series $G_{4}, G_{6}, G_{8}, G_{10}$. Moreover, for $k \geq 12$ the subspace of cusp forms has always dimension $\geq 1$. But $L\left(s, G_{k}\right)$ has a pole at $s=k$, thus $F$ should have a pole at $s=(k+1) / 2 \neq 1$, impossible for $k \geq 4$. On the other hand, if $f$ is a Hecke eigenform of weight $k \geq 12$ then $F(s)=L\left(s+\frac{k-1}{2}, f\right)$ is normalized, and our first assertion follows.

Next we deal with virtual $\gamma$-factors of Maass type. The argument is similar, this time based on the version allowing poles of Maass' converse theorem given by Theorem 2.1 of Raghunathan [25], with $\nu=1 / 2+i \kappa$. Suppose that a normalized $F$ satisfies (5.4) with such a $\gamma$-factor. Then by (5.5), Lemma 4.1 and (5.2) we have $\omega=(-1)^{\varepsilon}$. Hence our assertion follows from the above quoted version of Maass' converse theorem, since $\nu(1-\nu)=1 / 4+\kappa^{2}=\rho$ must be an eigenvalue of the Laplacian, thus its eigenspace is nontrivial and therefore we may choose a Maass form $u$ associated with $\rho$ and with parity $\varepsilon$ such that $F(s)=L(s, u)$ is normalized.

Remark 5.1. The limitations $\mu>0$ and $\kappa \geq 0$ imposed on the virtual $\gamma$-factors in (5.1) are actually natural. Indeed, we may restrict to $\kappa \geq 0$ since there are no exceptional eigenvalues of the Laplacian in the case of $\Gamma_{0}(1)$, see Selberg [26]. Moreover, if $\mu \leq 0$ then the weight $k$ in the above proof is an even integer $\leq 0$, thus by the above quoted Theorem 4 of [28] the space of modular forms is either trivial (if $k<0$ ) or generated by 1 (if $k=0$ ), in which case $L(s, 1$ ) is identically vanishing and hence $F(s) \equiv 0$, impossible.

By (2.8), given any virtual $\gamma$-factor in (5.1) we define the virtual $h$-function as

$$
h_{\gamma}(s)=\left\{\begin{array}{l}
(2 \pi)^{2(s-1)} \Gamma(1-s+\mu) \Gamma(1-s-\mu)  \tag{5.6}\\
\frac{1}{4} \pi^{2 s-3} \Gamma\left(\frac{1-s+\varepsilon-i \kappa}{2}\right) \Gamma\left(\frac{2-s-\varepsilon+i \kappa}{2}\right) \Gamma\left(\frac{1-s+\varepsilon+i \kappa}{2}\right) \Gamma\left(\frac{2-s-\varepsilon-i \kappa}{2}\right)
\end{array}\right.
$$

Hence by the reflection formula for the $\Gamma$ function we have that

$$
\begin{equation*}
h_{\gamma}(s) S_{\gamma}(s)=\frac{\gamma(1-s)}{\gamma(s)} \tag{5.7}
\end{equation*}
$$

and by (2.12) and (2.9)

$$
\begin{equation*}
h_{\gamma}(s) \approx \frac{(4 \pi)^{2 s-1}}{\sqrt{2 \pi}} \sum_{\ell=0}^{\infty} d_{\ell}(\gamma) \Gamma(3 / 2-2 s-\ell), \quad d_{0}(\gamma)=1 \tag{5.8}
\end{equation*}
$$

Remark 5.2. Since $\varepsilon \in\{0,1\}$, the virtual $h$-functions do not depend on $\varepsilon$ thanks to the symmetry of the $\Gamma$-factors in (5.6). In particular, this shows that the $h$-functions do not determine uniquely the $\gamma$-factors.

Although virtual $\gamma$-factors do not correspond, in general, to some $F \in \mathcal{S}^{\sharp}$, their structural invariants $d_{\ell}(\gamma)$ satisfy the same properties of the invariants $d_{\ell}(F)$ of the normalized functions $F \in \mathcal{S}^{\sharp}$ of degree 2 and conductor 1 .

Lemma 5.2. The structural invariants $d_{\ell}(\gamma)$ of virtual $\gamma$-factors satisfy the same properties of the invariants $d_{\ell}(F)$ in Proposition 4.1, Corollary 4.1 and Lemma 4.3.

Proof. We first show that there exist polynomials $P_{\ell}, Q_{\ell} \in \mathbb{R}[x]$ such that

$$
d_{\ell}(\gamma)=\left\{\begin{array}{l}
P_{\ell}(\mu)  \tag{5.9}\\
Q_{\ell}(\kappa)
\end{array}\right.
$$

for every virtual $\gamma$-factor in (5.1). Note, in view of Remark 5.2, that the polynomials $Q_{\ell}$, if they exist, do not depend on $\varepsilon$. Now we observe that Lemma 4.3 is proved by Stirling's formula, without using the properties of $F \in \mathcal{S}^{\sharp}$. Hence in the present case (4.39) becomes

$$
\begin{equation*}
d_{\ell}(\gamma)=\sum_{h=1}^{\ell} A_{h, \ell} V_{h}(\gamma) \tag{5.10}
\end{equation*}
$$

where $A_{h, \ell}$ is defined by (4.38) and $V_{h}(\gamma)$ by (4.37) and (4.35), clearly with $\gamma$ in place of $F$. But the $H$-invariants in (4.35) are defined in terms of Bernoulli polynomials involving $\mu$ and $\kappa$, hence the dependence of $d_{\ell}(\gamma)$ on $\mu$ and $\kappa$ is polynomial as well. Moreover, $A_{h, \ell} \in \mathbb{R}$ so $P_{\ell} \in \mathbb{R}[x]$, and $Q_{\ell}(\kappa)$ involves Bernoulli polynomials at $i \kappa$ and $-i \kappa$, thus its coefficients are also real. Hence (5.9) is proved.

Next we observe that if a virtual $\gamma$-factor is actually a $\gamma$-factor of a function $F \in \mathcal{S}^{\sharp}$ as in Theorem 1.1, then by Proposition 4.1 we have

$$
\begin{equation*}
Q_{N}\left(d_{0}(\gamma), \ldots, d_{N}(\gamma)\right)=0 \tag{5.11}
\end{equation*}
$$

But $Q_{N}\left(d_{0}(\gamma), \ldots, d_{N}(\gamma)\right)$ is a polynomial in $\mu$ or $\kappa$ by (5.9), and by Lemma 5.1 there exist infinitely many $\mu$ and $\kappa$ for which (5.11) holds (remember that the spectrum of the Laplacian is infinite). Thus (5.11) holds identically in $\mu$ and $\kappa$, i.e. Proposition 4.1 holds for all virtual $\gamma$-factors. Hence the analog of Corollary 4.1 holds as well, and the analog of Lemma 4.3 follows from (5.10).

Now we are ready to prove the main result of this section.
Proposition 5.1. Let $F \in \mathcal{S}^{\sharp}$ be as in Theorem 1.1. Then there exists a virtual $\gamma$-factor such that

$$
\chi_{F}=\chi_{\gamma} \quad \text { and } \quad h_{F}(s)=\omega_{F} h_{\gamma}(s)
$$

Moreover, such a $\gamma$-factor is uniquely determined if we choose $\varepsilon$ in (5.1) satisfying $\omega_{F}=(-1)^{\varepsilon}$, and it is of Hecke or Maass type depending on $\chi_{F}>0$ or $\chi_{F} \leq 0$, respectively.

Proof. Thanks to Lemmas 4.3 and 5.2 we have

$$
\begin{equation*}
d_{1}(F)=d_{1}(\gamma) \Longleftrightarrow \chi_{F}=\chi_{\gamma} \tag{5.12}
\end{equation*}
$$

Moreover, by Lemmas 4.1 and 4.3 we have $d_{1}(F) \in \mathbb{R}$ (recall that $\xi_{F}=H_{F}(1)$ ), and by (5.2) the set of values of $\chi_{\gamma}$ coincides with $\mathbb{R}$. Thus there exists a virtual $\gamma$-factor such that $d_{1}(F)=d_{1}(\gamma)$. But then, thanks to Corollary 4.1 and Lemma 5.2, we have that

$$
d_{\ell}(F)=d_{\ell}(\gamma) \quad \text { for every } \ell \geq 0
$$

and the first assertion of the proposition follows in view of (2.12) and (5.8).

In view of (5.2) and the equality in the right hand side of (5.12), if $\chi_{F}>0$ there is only one choice for the virtual $\gamma$-factor of Hecke type. Instead, if $\chi_{F} \leq 0$ there are two possible choices of virtual $\gamma$-factors of Maass type, depending on the value of $\varepsilon$. Thus, since $\omega_{F}= \pm 1$ by Lemma 4.1, we choose $\varepsilon \in\{0,1\}$ in (5.1) in such a way that $\omega_{F}=(-1)^{\varepsilon}$, and the second assertion follows as well.

Recalling the definition of the functions $S_{F}(s)$ and $S_{\gamma}(s)$ in Section 2.1 and writing

$$
\begin{equation*}
R(s)=R_{F, \gamma}(s):=\frac{S_{F}(s)}{S_{\gamma}(s)} \tag{5.13}
\end{equation*}
$$

we have the following important consequence of Proposition 5.1.
Corollary 5.1. Let $F \in \mathcal{S}^{\sharp}$ be as in Theorem 1.1 and $R(s)$ be as in (5.13). Then there exists a unique virtual $\gamma$-factor, in the sense of Proposition 5.1, such that $F$ satisfies the functional equation

$$
\gamma(s) F(s)=\omega_{F} R(s) \gamma(1-s) F(1-s)
$$

Proof. We start with the functional equation of $F$ written as in (2.10) and then use Lemma 4.1, Proposition 5.1 and (5.7) to get

$$
F(s)=\omega_{F} h_{\gamma}(s) S_{F}(s) F(1-s)=\omega_{F} \frac{\gamma(1-s)}{\gamma(s)} \frac{S_{F}(s)}{S_{\gamma}(s)} F(1-s) ;
$$

thus the result follows.
We conclude the section with a study of the function $R(s)$ in (5.13). We shall always assume that $\gamma$ in (5.13) is the virtual $\gamma$-factor associated with $F$ in the sense of Proposition 5.1.

Lemma 5.3. Let $F$ be as in Theorem 1.1, $R(s)$ be as in (5.13) and assume that $\mu+1 / 2$ is a positive integer, $\mu$ being as in (5.1). Then as $|t| \rightarrow \infty$

$$
R(s)=\eta+O\left(e^{-\delta|t|}\right)
$$

with some $\delta>0$, where

$$
\eta= \begin{cases}\omega_{F} e^{-i \frac{\pi}{2}(2 \mu+1)} \in\{-1,1\} & \text { if } \gamma \text { is of Hecke type } \\ 1 & \text { if } \gamma \text { is of Maass type. }\end{cases}
$$

Proof. A computation based on (2.7) shows that as $|t| \rightarrow \infty$

$$
S_{F}(s)=e^{-\operatorname{sgn}(t) \pi i\left(s+\xi_{F} / 2\right)}\left(1+O\left(e^{-c_{1}|t|}\right)\right)
$$

with some $c_{1}>0$. Hence by Lemma 4.1 this becomes

$$
\begin{equation*}
S_{F}(s)=-\omega_{F} e^{-\operatorname{sgn}(t) \pi i s}\left(1+O\left(e^{-c_{1}|t|}\right)\right) \tag{5.14}
\end{equation*}
$$

since $\omega_{F}= \pm 1$. Similarly, for virtual $\gamma$-factors of Hecke type we have, thanks to our assumption on $\mu$, that

$$
\begin{equation*}
S_{\gamma}(s)=-i e^{\pi i \mu} e^{\pi i s}+i e^{-\pi i \mu} e^{-\pi i s}=-\eta_{0} e^{-\operatorname{sgn}(t) \pi i s}\left(1+O\left(e^{-c_{2}|t|}\right)\right) \tag{5.15}
\end{equation*}
$$

with some $c_{2}>0$ and

$$
\begin{equation*}
\eta_{0}=i e^{\pi i \mu} \in\{-1,1\} \tag{5.16}
\end{equation*}
$$

The result follows in this case from (5.14),(5.15) and (5.16) with $\eta=\omega_{F} / \eta_{0} \in\{-1,1\}$.
For virtual $\gamma$-factors of Maass type we have

$$
\begin{equation*}
S_{\gamma}(s)=-(-1)^{\varepsilon} e^{-\operatorname{sgn}(t) \pi i s}\left(1+O\left(e^{-c_{3}|t|}\right)\right) \tag{5.17}
\end{equation*}
$$

with some $c_{3}>0$. Since in this case $\omega_{F}=(-1)^{\varepsilon}$ by Proposition 5.1, the result follows with $\eta=1$ from (5.14) and (5.17).

Finally, with a convenient abuse of notation, we rewrite (2.7) as

$$
\begin{equation*}
S_{F}(s)=\sum_{j=0}^{N} a_{j} e^{i \pi \omega_{j} s} \tag{5.18}
\end{equation*}
$$

with

$$
\begin{equation*}
N \geq 1, \quad-1=\omega_{0}<\omega_{1}<\cdots<\omega_{N}=1, \quad \omega_{j}=-\omega_{N-j}, \quad a_{j} \neq 0 \tag{5.19}
\end{equation*}
$$

and, by (5.14),

$$
\begin{equation*}
a_{0}=a_{N}=-\omega_{F} . \tag{5.20}
\end{equation*}
$$

Lemma 5.4. Under the same hypotheses of Lemma 5.3, and with the notation in (5.18) and in Lemma 5.3, we have that if $R(s) \neq \eta$ then $N \geq 3$ and $\omega_{N-1}>0$.

Proof. We start with the case of Hecke type virtual $\gamma$-factors. From (5.15) and (5.16) we have

$$
\begin{equation*}
S_{\gamma}(s)=-\eta_{0}\left(e^{\pi i s}+e^{-\pi i s}\right)=-2 \eta_{0} \cos (\pi s) \tag{5.21}
\end{equation*}
$$

If $N=1$, from (5.20) we get

$$
\begin{equation*}
S_{F}(s)=-\omega_{F}\left(e^{\pi i s}+e^{-\pi i s}\right)=-2 \omega_{F} \cos (\pi s) \tag{5.22}
\end{equation*}
$$

hence $R(s)=\eta$ thanks to Lemma 5.3, (5.16) and (5.21). If $N=2$ we have

$$
S_{F}(s)=-\omega_{F} e^{-\pi i s}+a_{1} e^{\pi i \omega_{1} s}-\omega_{F} e^{\pi i s}
$$

and $\omega_{1}=-\omega_{1}$ by (5.19), so $\omega_{1}=0$. Thus, again by (5.19),

$$
\begin{equation*}
S_{F}(s)=-2 \omega_{F} \cos (\pi s)+a_{1}, \quad a_{1} \neq 0 \tag{5.23}
\end{equation*}
$$

Applying twice the functional equation in Proposition 5.1 we get

$$
\begin{equation*}
R(s) R(1-s)=1 \tag{5.24}
\end{equation*}
$$

Thus, from (5.24), (5.16) and (5.21) we deduce that

$$
S_{F}(s) S_{F}(1-s)=S_{\gamma}(s) S_{\gamma}(1-s)=4 \cos (\pi s) \cos (\pi(1-s))=-4 \cos ^{2}(\pi s)
$$

Hence if $S_{F}\left(x_{0}\right)=0$ then $\cos \left(\pi x_{0}\right)=0$, which contradicts (5.23). Thus we cannot have $N=2$, and the result follows in this case.

For virtual $\gamma$-factors of Maass type we have

$$
\begin{equation*}
S_{\gamma}(s)=4 \sin \left(\pi\left(\frac{s+\varepsilon+i \kappa}{2}\right)\right) \sin \left(\pi\left(\frac{s+\varepsilon-i \kappa}{2}\right)\right)=-2(-1)^{\varepsilon} \cos (\pi s)+a_{1}(\gamma) \tag{5.25}
\end{equation*}
$$

with a certain $a_{1}(\gamma)$. If $N=1$, from (5.24),(5.22) and the first equation in (5.25) we get

$$
\begin{aligned}
16 \sin \left(\pi\left(\frac{s+\varepsilon+i \kappa}{2}\right)\right) \sin \left(\pi\left(\frac{s+\varepsilon-i \kappa}{2}\right)\right) & \sin \left(\pi\left(\frac{1-s+\varepsilon+i \kappa}{2}\right)\right) \sin \left(\pi\left(\frac{1-s+\varepsilon-i \kappa}{2}\right)\right) \\
& =4 \cos ^{2}(\pi s)
\end{aligned}
$$

impossible since zeros on the two sides do not match. Thus we cannot have $N=1$. If $N=2$, then by $(5.24),(5.23)$ and the second expression for $S_{\gamma}(s)$ in (5.25) we have

$$
\begin{aligned}
\left(-2 \omega_{F} \cos (\pi s)+a_{1}\right) & \left(-2 \omega_{F} \cos (\pi(1-s))+a_{1}\right) \\
& =\left(-2(-1)^{\varepsilon} \cos (\pi s)+a_{1}(\gamma)\right)\left(-2(-1)^{\varepsilon} \cos (\pi(1-s))+a_{1}(\gamma)\right)
\end{aligned}
$$

which gives $a_{1}^{2}=a_{1}(\gamma)^{2}$ and hence $a_{1}= \pm a_{1}(\gamma)$. Recalling that $\omega_{F}=(-1)^{\varepsilon}$ and $\eta=1$, see Proposition 5.1 and Lemma 5.3 (in this case we have $\chi_{F} \leq 0$ since the virtual $\gamma$-factor is of Maass type), if $a_{1}=a_{1}(\gamma)$ we have $S_{F}(s)=\eta S_{\gamma}(s)$ by (5.23) and (5.25). If $a_{1}=-a_{1}(\gamma)$, then from (5.23) and (5.25) we have $S_{\gamma}(s)=-S_{F}(1-s)$ and hence Corollary 5.1 yelds

$$
S_{F}(1-s) \gamma(s) F(s)=-\omega_{F} S_{F}(s) \gamma(1-s) F(1-s)
$$

Dividing this by the functional equation (2.1) of $F$, denoting by $\gamma_{F}(s)$ the $\gamma$-factor of $F$ and recalling Lemma 4.1 we obtain

$$
\frac{S_{F}(1-s) \gamma(s)}{\gamma_{F}(s)}=-\frac{S_{F}(s) \gamma(1-s)}{\gamma_{F}(1-s)} .
$$

Thus the function $f(s)=S_{F}(1-s) \gamma(s) \gamma_{F}(1-s)$ satisfies $f(s)=-f(1-s)$, and in particular $f(1 / 2)=0$. Therefore

$$
S_{F}(1 / 2) \gamma(1 / 2) \gamma_{F}(1 / 2)=0
$$

and since $\gamma$-factors do not vanish this implies $0=S_{F}(1 / 2)=a_{1}$, which contradicts (5.23). Hence for $N=2$ we have $R(s)=\eta$ and the result follows.

## 6. Period functions

For a function $F$ as in Theorem 1.1 and $z$ in the upper half-plane $\mathbb{H}$ we define

$$
f(z)=\sum_{n=1}^{\infty} a(n) n^{\lambda} e(n z), \quad \text { where } \quad \lambda= \begin{cases}\mu & \text { if } \chi_{F}>0  \tag{6.1}\\ i \kappa & \text { if } \chi_{F} \leq 0\end{cases}
$$

$\mu, \kappa$ are as in (5.1) and $\chi_{F}$ is defined by (1.1). Clearly, $f(z)$ is holomorphic on $\mathbb{H}$. We shall repeatedly use the following simple, and essentially well known, lemma.

Lemma 6.1. For every $F \in \mathcal{S}^{\sharp}$ with positive degree and $\lambda \in \mathbb{C}$ the function $f(z)$ cannot be continued to an entire function.

Proof. From the convergence properties of the Dirichlet series of $F$ we have that $a(n) \ll n^{1+\varepsilon}$, hence the power series $g(z)=\sum_{n=1}^{\infty} a(n) n^{\lambda} z^{n}$ is convergent for $|z|<1$. If $f(z)$ is entire, then $g(z)$ is also entire since clearly it is bounded around $z=0$. Therefore $g(z)$ is convergent for some $\left|z_{0}\right|>1$, thus $a(n) n^{\lambda} \ll\left|z_{0}\right|^{-n}$ and hence $a(n) \ll n^{-A}$ for every $A>0$. As a consequence the Dirichlet series of $F$ is everywhere convergent, a contradiction since its Lindelöf function $\mu_{F}(\sigma)$ is positive for $\sigma<0$.

In the next two propositions we study the function $f(z)$ distinguishing the cases $\chi_{F}>0$ and $\chi_{F} \leq 0$, corresponding to associated virtual $\gamma$-factors of Hecke and Maass type, since the arguments are somewhat different. In the first case we also use the properties of $f(z)$ to show that the hypothesis on the parameter $\mu$ in Lemmas 5.3 and 5.4 holds true. However, for ease of reference we adopt the following uniform notation.

Let $R(s)$ and $\eta$ be as in Lemma 5.3, $\gamma$ being the virtual $\gamma$-factor associated with $F$. Writing

$$
\begin{equation*}
0<c_{1}<1 \text { if } \Re(\lambda)=0 \text { and } 0<c_{1}<\Re(\lambda) \text { if } \Re(\lambda)>0, \quad \text { and } \quad c_{2}=1+2 \Re(\lambda)-c_{1} \tag{6.2}
\end{equation*}
$$

we define the following functions.
(a) $P(z) \equiv 0$ if $\lambda=\mu$, i.e. $\gamma$ is of Hecke type, while

$$
\begin{equation*}
P(z)=\frac{i^{\varepsilon+1} \cos (\pi \lambda)}{2 \pi^{\lambda+3 / 2}} \frac{1}{2 \pi i} \int_{\left(c_{2}\right)} \Gamma\left(\frac{1-\varepsilon+s}{2}\right) \Gamma\left(\frac{2-\varepsilon-s+2 \lambda}{2}\right) \gamma(s-\lambda) F(s-\lambda) z^{s-1-2 \lambda} \mathrm{~d} s \tag{6.3}
\end{equation*}
$$

if $\lambda=i \kappa$, i.e. $\gamma$ is of Maass type; clearly, the integral is absolutely convergent for $|\arg (z)|<\pi$ and $P(z)$ is holomorphic there.
(b) For every $\lambda$ as above

$$
\begin{equation*}
Q_{\eta}(z)=\frac{1}{2 \pi i} \int_{\left(c_{1}\right)}(R(s-\lambda)-\eta) \Gamma(s) \frac{\gamma(1-s+\lambda)}{\gamma(s-\lambda)} F(1-s+\lambda)(-2 \pi i z)^{-s} \mathrm{~d} s \tag{6.4}
\end{equation*}
$$

by Lemma 5.3 the integral is certainly absolutely convergent for $z \in \mathbb{H}$ and $Q_{\eta}(z)$ is holomorphic there.
(c) For every $\lambda$ as above

$$
\begin{equation*}
L(z)=\operatorname{res}_{s=1+\lambda} \Gamma(s) F(s-\lambda)(-2 \pi i z)^{-s} ; \tag{6.5}
\end{equation*}
$$

clearly, $L(z) \equiv 0$ if $F$ is entire and otherwise is holomorphic for $|\arg (z)|<\pi$, since it is a linear combinations of terms of type $z^{a}$ and $z^{a} \log ^{k} z$ with $a \in \mathbb{C}$ and $k \in \mathbb{N}$. Finally, for $z \in \mathbb{H}$ we write

$$
\begin{equation*}
\psi(z)=f(z)-z^{-2 \lambda-1} f(-1 / z) \tag{6.6}
\end{equation*}
$$

Proposition 6.1. Let $F$ be as in Theorem 1.1 with $\chi_{F}>0$. Then $\mu+1 / 2$ is a positive integer and

$$
\psi(z)=\eta P(z)+L(z)+\omega_{F} Q_{\eta}(z)
$$

where $P(z), L(z)$ and $Q_{\eta}(z)$ are holomorphic for $|\arg (z)|<\pi$.
Proof. For future reference we take the first steps of the proof keeping $\chi_{F}$ general and using the above uniform notation. Let $z=x+i y \in \mathbb{H}$. Since $F(s-\lambda)$ is absolutely convergent for $\sigma>1+\Re(\lambda)$, by Mellin's transform we have

$$
\begin{equation*}
f(i y)=\sum_{n=1}^{\infty} a(n) n^{\lambda} e^{-2 \pi n y}=\frac{1}{2 \pi i} \int_{(c)}(2 \pi)^{-s} \Gamma(s) F(s-\lambda) y^{-s} \mathrm{~d} s \tag{6.7}
\end{equation*}
$$

where $c>\Re(\lambda)+1$. Recalling (6.5) and that $F$ has at most a pole at $s=1$, we shift the integration line to $\sigma=c_{1}$ as in (6.2), thus getting

$$
f(i y)=\frac{1}{2 \pi i} \int_{\left(c_{1}\right)}(2 \pi)^{-s} \Gamma(s) F(s-\lambda) y^{-s} \mathrm{~d} s+L(i y)
$$

Hence by Corollary 5.1 we obtain

$$
\begin{equation*}
f(i y)=\frac{\omega_{F}}{2 \pi i} \int_{\left(c_{1}\right)}(2 \pi)^{-s} \Gamma(s) R(s-\lambda) \frac{\gamma(1-s+\lambda)}{\gamma(s-\lambda)} F(1-s+\lambda) y^{-s} \mathrm{~d} s+L(i y) \tag{6.8}
\end{equation*}
$$

Now we recall that if $\chi_{F}>0$ then $\lambda=\mu>0$ and the associated virtual $\gamma$-factor is $\gamma(s)=$ $(2 \pi)^{-s} \Gamma(s+\mu)$; in what follows we restrict ourselves to this case. Thus, for $\chi_{F}>0$, by the change of variable $s \mapsto 1-s+\mu$ we see that (6.8) becomes

$$
\begin{equation*}
f(i y)=\omega_{F}(2 \pi)^{-\mu} y^{-\mu-1} \frac{1}{2 \pi i} \int_{\left(1-c_{1}+\mu\right)} R(1-s) \gamma(s) F(s) y^{s} \mathrm{~d} s+L(i y) \tag{6.9}
\end{equation*}
$$

But $1-c_{1}+\mu>1$ by ( 6.2 ), so we write $1-c_{1}+\mu=1+\delta$ with some $\delta>0$; for later use, we may assume that $\delta$ is sufficiently small. Moreover, thanks to (5.24) we rewrite (6.9) as

$$
f(i y)=\omega_{F}(2 \pi)^{-\mu} y^{-\mu-1} \frac{1}{2 \pi i} \int_{(1+\delta)} \frac{S_{\gamma}(s)}{S_{F}(s)} \gamma(s) F(s) y^{s} \mathrm{~d} s+L(i y)
$$

Hence, expanding $F(s)$, recalling that $S_{\gamma}(s)=2 \sin (\pi(s+\mu))$ by definition and applying the reflection formula to $\gamma(s)$, we finally obtain that

$$
\begin{equation*}
f(i y)=\omega_{F}(2 \pi)^{1-\mu} y^{-\mu-1} \sum_{n=1}^{\infty} a(n) \frac{1}{2 \pi i} \int_{(1+\delta)} \frac{1}{S_{F}(s) \Gamma(1-s-\mu)}\left(\frac{2 \pi n}{y}\right)^{-s} \mathrm{~d} s+L(i y) \tag{6.10}
\end{equation*}
$$

From (5.18)-(5.20) we have that

$$
S_{F}(s)=-2 \omega_{F} \cos (\pi s)+\sum_{j=1}^{N-1} a_{j} e^{i \pi \omega_{j} s}
$$

with $\left|\omega_{j}\right|<1$ for $1 \leq j \leq N-1$. Thus, as $|t| \rightarrow \infty$

$$
\begin{equation*}
\frac{1}{S_{F}(s)}+\frac{1}{2 \omega_{F} \cos (\pi s)} \ll e^{-\pi(1+\rho)|t|} \tag{6.11}
\end{equation*}
$$

for some $0<\rho<1 / 2$. Hence we rewrite (6.10) as

$$
\begin{equation*}
f(i y)=-\frac{1}{2}(2 \pi)^{1-\mu} y^{-\mu-1} \sum_{n=1}^{\infty} a(n) J\left(\frac{2 \pi n}{y}\right)+H(y)+L(i y) \tag{6.12}
\end{equation*}
$$

where, introducing a new variable $w$ for later use,

$$
J(w)=\frac{1}{2 \pi i} \int_{(1+\delta)} \frac{1}{\cos (\pi s) \Gamma(1-s-\mu)} w^{-s} \mathrm{~d} s
$$

and

$$
H(y)=\omega_{F}(2 \pi)^{1-\mu} y^{-\mu-1} \sum_{n=1}^{\infty} a(n) \frac{1}{2 \pi i} \int_{(1+\delta)}\left\{\frac{1}{S_{F}(s)}+\frac{1}{2 \omega_{F} \cos (\pi s)}\right\} \frac{1}{\Gamma(1-s-\mu)}\left(\frac{2 \pi n}{y}\right)^{-s} \mathrm{~d} s
$$

Now we consider $y$ as a complex variable. From (6.11) and Stirling's formula we see that the sum of integrals defining $H(y)$ is holomorphic for $|\arg (y)|<\pi / 2+\pi \rho$. Moreover, by Stirling's formula the integral defining $J(2 \pi n / y)$ is holomorphic for $|\arg (y)|<\pi / 2$, and clearly

$$
J(2 \pi n / y)<_{y} n^{-1-\delta} .
$$

Thus the series on the right hand side of (6.12) is also holomorphic for $|\arg (y)|<\pi / 2$.
The next step is a closer study of $J(w)$. To this end we shift the line of integration to $-\infty$ and, recalling that $\delta>0$ is sufficiently small, we collect the residues of the simple poles at the points $s=-\ell+1 / 2$ with $\ell \geq 0$. Thus we obtain that

$$
\begin{equation*}
J(w)=-\frac{w^{-1 / 2}}{\pi} \sum_{\ell=0}^{\infty} \frac{(-w)^{\ell}}{\Gamma(\ell+1 / 2-\mu)}=-\frac{w^{-1 / 2}}{\pi} E_{1 / 2-\mu}(w) \tag{6.13}
\end{equation*}
$$

say. Formula (6.13) holds since by Stirling's formula the integral tends to 0 as the integration line is shifted to $-\infty$, and the series in (6.13) is everywhere convergent; in particular, $E_{1 / 2-\mu}(w)$ is an entire function. Actually, $E_{1 / 2-\mu}(w)$ is a special case of a two-parametric Mittag-Leffler function, see Chapter 4 of Gorenflo-Kilbas-Mainardi-Rogosin [3]. More precisely we have that

$$
E_{\beta}(w)=E_{1, \beta}(-w),
$$

where $\beta=1 / 2-\mu$ and $E_{1, \beta}(w)$ is the function defined by (4.1.1) of [3]. One easily checks (see also (4.3.2) of [3] with $m=n=1$ ) that $E_{\beta}(w)$ satisfies the first order linear differential equation

$$
E_{\beta}^{\prime}(w)=-\left(1+\frac{\beta-1}{w}\right) E_{\beta}(w)+\frac{1}{w \Gamma(\beta-1)} .
$$

Writing $w=u+i v$, we solve such a differential equation by the standard method, choosing an initial point $w_{0} \neq 0$ of the form $u_{0}+i v$ and then letting $u_{0} \rightarrow-\infty$. Thus we obtain for $w \in \mathbb{C} \backslash[0,+\infty)$ that

$$
\begin{equation*}
E_{\beta}(w)=\kappa_{0} e^{-w} w^{1-\beta}+\frac{e^{-w} w^{1-\beta}}{\Gamma(\beta-1)} \int_{-\infty}^{w} e^{\xi} \xi^{\beta-2} \mathrm{~d} \xi \tag{6.14}
\end{equation*}
$$

with some constant $\kappa_{0}$, where the integration is along the horizontal half-line $\xi=\beta+i v$, $-\infty<\beta \leq u$, and the integral is absolutely convergent. Formula (6.14) follows also from (4.3.6) of [3] with $z=-w, z_{0}=-w_{0}$ and $n=1$, after the change of variable $\tau=-\xi$ inside the integral. Indeed, the constant term in (4.3.6) is convergent as $u_{0} \rightarrow-\infty$ thanks to (4.4.16) in Theorem 4.3 of [3].

In view of (6.1), from (6.12)-(6.14) with $w=2 \pi n / y$ we get

$$
\begin{equation*}
f(i y)=\kappa_{1}(i y)^{-2 \mu-1} f(i / y)+\frac{y^{-2 \mu-1}}{\Gamma(-1 / 2-\mu)} \widetilde{f}(y)+H(y)+L(i y) \tag{6.15}
\end{equation*}
$$

where

$$
\begin{equation*}
\kappa_{1}=\kappa_{0} i^{2 \mu+1} \tag{6.16}
\end{equation*}
$$

and

$$
\begin{equation*}
\widetilde{f}(y)=\sum_{n=1}^{\infty} a(n) n^{\mu} e^{-2 \pi n / y} \int_{-\infty}^{2 \pi n / y} e^{\xi} \xi^{-\mu-3 / 2} \mathrm{~d} \xi \tag{6.17}
\end{equation*}
$$

Note that the integral in (6.17) is

$$
\ll e^{2 \pi n \Re(y) /|y|^{2}} n^{-\mu-3 / 2}
$$

uniformly for $2 \pi n / y$ in any compact subset of $\mathbb{C} \backslash[0,+\infty)$, therefore the series in (6.17) is absolutely convergent for the same values of $y$ and hence $\widetilde{f}(y)$ is holomorphic for $y \in \mathbb{C} \backslash[0,+\infty)$. But, since $\arg (i y)=\pi / 2+\arg (y)$, every other term in (6.15) is holomorphic at least for $|\arg (y)|<\pi / 2$, and $H(y)+L(i y)$ is holomorphic for $|\arg (y)|<\pi / 2+\pi \rho$. Hence, coming back to the variable $z=x+i y$, we rewrite (6.15) as

$$
\begin{equation*}
f(z)=\kappa_{1} z^{-2 \mu-1} f(-1 / z)+\widetilde{\psi}(z) \tag{6.18}
\end{equation*}
$$

where $\widetilde{\psi}(z)$ is holomorphic for $-\pi \rho<\arg (z)<\pi+\pi \rho$.
Now we are ready to conclude the proof. Applying again (6.18) to $f(-1 / z)$ we obtain that

$$
f(z)=\kappa_{0}^{2} f(z)+\widetilde{H}(z)
$$

with a certain function $\widetilde{H}(z)$ holomorphic for $-\pi \rho<\arg (z)<\pi+\pi \rho$. If $\kappa_{0} \neq \pm 1$, then $f(z)$ is also holomorphic for $-\pi \rho<\arg (z)<\pi+\pi \rho$. But $f(z)$ is periodic of period 1 hence it is entire, a contradiction by Lemma 6.1; thus

$$
\begin{equation*}
\kappa_{0}= \pm 1 \tag{6.19}
\end{equation*}
$$

Applying (6.18) with $z+1$ in place of $z$ and recalling the periodicity of $f(z)$ we get

$$
\begin{equation*}
\frac{1}{\kappa_{1}} \widetilde{\psi}(z+1)=\frac{1}{\kappa_{1}} f(z)-(z+1)^{-2 \mu-1} f\left(-\frac{1}{z+1}\right) . \tag{6.20}
\end{equation*}
$$

Subtracting (6.20) from (6.18), using the 1-periodicity in the resulting terms $f(-1 /(z+1))$ and $f(-1 / z)$, and then applying again (6.18) with $z /(z+1)$ in place of $z$ we finally obtain that

$$
\begin{align*}
\widetilde{\psi}(z)-\frac{1}{\kappa_{1}} \widetilde{\psi}(z+1) & =\left(1-\frac{1}{\kappa_{1}}\right) f(z)-\kappa_{1} z^{-2 \mu-1} f(-1 / z)+(z+1)^{-2 \mu-1} f\left(-\frac{1}{z+1}\right)  \tag{6.21}\\
& =\left(1-\frac{1}{\kappa_{1}}\right) f(z)+(z+1)^{-2 \mu-1} \widetilde{\psi}\left(\frac{z}{z+1}\right)
\end{align*}
$$

Suppose now that $\kappa_{1} \neq 1$. Then (6.21) gives an expression of $f(z)$ in terms of $\widetilde{\psi}(z), \widetilde{\psi}(z+1)$ and $\widetilde{\psi}(z /(z+1))$. But, in particular, $\widetilde{\psi}(z)$ is holomorphic for $|\arg (z)|<\pi \rho$, and clearly $|\arg (z+1)|,|\arg (z /(z+1))|<\pi \rho$ for $z$ in that region. Therefore, such an expression shows that $f(z)$ is holomorphic for $|\arg (z)|<\pi \rho$, thus it is entire by 1-periodicity, a contradiction by Lemma 6.1. Consequently by (6.16) and (6.19) we have

$$
1=\kappa_{1}=\kappa_{0} i^{2 \mu+1}= \pm i^{2 \mu+1}
$$

and hence $\mu+1 / 2$ is a positive integer; the first statement of the proposition is now proved. For future reference we note here that $\widetilde{\psi}(z)=\psi(z)$ in view of (6.6), thus $\psi(z)$ is holomorphic for $-\pi \rho<\arg (z)<\pi+\pi \rho$, and (6.21) becomes the three-term functional equation

$$
\begin{equation*}
\psi(z)=\psi(z+1)+(z+1)^{-2 \mu-1} \psi\left(\frac{z}{z+1}\right) \tag{6.22}
\end{equation*}
$$

To prove the second assertion we first recall that $\gamma(s)=(2 \pi)^{-s} \Gamma(s+\mu), c_{2}=1-c_{1}+2 \mu>1$ and $\eta$ is as in Lemma 5.3. Starting with (6.8), adding and subtracting $\eta$ to $R(s-\mu)$, separating the two integrals involving $\eta$ and $R(s-\mu)-\eta$ and finally making the substitution $s \mapsto 1-s+2 \mu$ into the first one, in view of (6.7) we have

$$
\begin{aligned}
f(i y) & =\eta \omega_{F}(2 \pi)^{-\mu} y^{-\mu-1} \frac{1}{2 \pi i} \int_{\left(c_{2}\right)} \Gamma(s) F(s-\mu)\left(\frac{2 \pi}{y}\right)^{-s+\mu} \mathrm{d} s+L(i y)+\omega_{F} Q_{\eta}(i y) \\
& =(i y)^{-2 \mu-1} f(i / y)+L(i y)+\omega_{F} Q_{\eta}(i y) .
\end{aligned}
$$

Thus, recalling (6.6) and the regularity properties of $\psi(z)$ and $L(z)$, by analytic continuation we obtain

$$
\begin{equation*}
\psi(z)=L(z)+\omega_{F} Q_{\eta}(z) \tag{6.23}
\end{equation*}
$$

for $-\pi \rho<\arg (z)<\pi+\pi \rho$. In order to extend the range of holomorphy in (6.23) we exploit (6.22). Indeed, by elementary geometry, we have

$$
\left|\arg \left(\frac{z}{z+1}\right)\right|,|\arg (z+1)|<|\arg (z)|
$$

for $|\arg (z)|<\pi$. More precisely, given $R, \varepsilon>0$, if $z \in \mathcal{C}(R, \varepsilon)=\{|z| \leq R:|\arg (z)| \leq \pi-\varepsilon\}$ then

$$
\left|\arg \left(\frac{z}{z+1}\right)\right|,|\arg (z+1)| \leq|\arg (z)|-\delta(R, \varepsilon)
$$

for some $\delta(R, \varepsilon)>0$. Thus (6.22) gives step-by-step analytic continuation of $\psi(z)$ to $\mathcal{C}(R, \varepsilon)$, and hence to $|\arg (z)|<\pi$ since $R$ and $\varepsilon$ are arbitrary. The result follows now from (6.23) since $P \equiv 0$ in our case and $L(z)$ is holomorphic for $|\arg (z)|<\pi$.

Proposition 6.2. Let $F$ be as in Theorem 1.1 with $\chi_{F} \leq 0$. Then $\psi(z)$ satisfies the same properties as in Proposition 6.1.

Proof. For simplicity we keep the uniform notation described at the beginning of this section, but later on in the proof we use the fact that the virtual $\gamma$-factor $\gamma(s)$ is of Maass type. We follow the steps in the proof of Proposition 6.1 till equation (6.8); then, by Lemma 5.3, in view of (6.4) we have

$$
\begin{align*}
f(i y)= & \eta \frac{\omega_{F}}{2 \pi i} \int_{\left(c_{1}\right)}(2 \pi)^{-s} \Gamma(s) \frac{\gamma(1-s+\lambda)}{\gamma(s-\lambda)} F(1-s+\lambda) y^{-s} \mathrm{~d} s+L(i y) \\
& \quad+\frac{\omega_{F}}{2 \pi i} \int_{\left(c_{1}\right)}(2 \pi)^{-s} \Gamma(s)(R(s-\lambda)-\eta) \frac{\gamma(1-s+\lambda)}{\gamma(s-\lambda)} F(1-s+\lambda) y^{-s} \mathrm{~d} s  \tag{6.24}\\
= & \eta P_{0}(i y)+L(i y)+\omega_{F} Q_{\eta}(i y),
\end{align*}
$$

say. In $P_{0}(i y)$ we make the substitution $1-s+\lambda \mapsto s-\lambda$. Thus, recalling (6.2) and writing

$$
\begin{equation*}
T(s)=(2 \pi)^{2 s-1-2 \lambda} \frac{\Gamma(1-s+2 \lambda) \gamma(s-\lambda)}{\Gamma(s) \gamma(1-s+\lambda)}, \quad \omega(\lambda)=\omega_{F} e^{i \frac{\pi}{2}(1+2 \lambda)} \tag{6.25}
\end{equation*}
$$

we obtain that

$$
\begin{align*}
P_{0}(i y) & =\frac{\omega_{F}}{2 \pi i} \int_{\left(c_{2}\right)}(2 \pi)^{s-1-2 \lambda} \Gamma(1-s+2 \lambda) \frac{\gamma(s-\lambda)}{\gamma(1-s+\lambda)} F(s-\lambda) y^{s-1-2 \lambda} \mathrm{~d} s \\
& =\omega(\lambda) \frac{(i y)^{-1-2 \lambda}}{2 \pi i} \int_{\left(c_{2}\right)}(2 \pi)^{-s} \Gamma(s) F(s-\lambda)\left(\frac{1}{y}\right)^{-s} T(s) \mathrm{d} s . \tag{6.26}
\end{align*}
$$

Now, thanks to (6.7) and (6.25), recalling that $c_{2}-\Re(\lambda)>1$ we rewrite (6.26) in the form

$$
\begin{align*}
P_{0}(i y)= & \frac{(i y)^{-1-2 \lambda}}{2 \pi i} \int_{\left(c_{2}\right)}(2 \pi)^{-s} \Gamma(s) F(s-\lambda)\left(\frac{1}{y}\right)^{-s} \mathrm{~d} s \\
& \quad+\frac{(i y)^{-1-2 \lambda}}{2 \pi i} \int_{\left(c_{2}\right)}(2 \pi)^{-s} \Gamma(s) F(s-\lambda)\left(\frac{1}{y}\right)^{-s}(\omega(\lambda) T(s)-1) \mathrm{d} s  \tag{6.27}\\
= & (i y)^{-2 \lambda-1} f(-1 /(i y))+P(i y)
\end{align*}
$$

say. Since $\eta=1$ in this case thanks to Lemma 5.3, from (6.6),(6.24) and (6.27) we have by analytic continuation that

$$
\begin{equation*}
\psi(z)=\eta P(z)+L(z)+\omega_{F} Q_{\eta}(z) \tag{6.28}
\end{equation*}
$$

Hence Proposition 6.2 follows from (6.28) once we show that $P(z)$ can be written as in (6.3) and $Q_{\eta}(z)$ is holomorphic for $|\arg (z)|<\pi$.

To this end we first rewrite $P(i y)$ as

$$
\begin{align*}
P(i y)=\frac{(i y)^{-1-2 \lambda}}{2 \pi i} & \int_{\left(c_{2}\right)} \gamma(s-\lambda) F(s-\lambda)\left(\frac{2 \pi}{y}\right)^{-s}  \tag{6.29}\\
\times & \left(\omega(\lambda)(2 \pi)^{2 s-1-2 \lambda} \frac{\Gamma(1-s+2 \lambda)}{\gamma(1-s+\lambda)}-\frac{\Gamma(s)}{\gamma(s-\lambda)}\right) \mathrm{d} s
\end{align*}
$$

But, in view of (5.1), using the duplication and reflection formulae for the $\Gamma$ function and the fact that $\varepsilon \in\{0,1\}$ we have

$$
\begin{aligned}
\frac{\Gamma(1-s+2 \lambda)}{\gamma(1-s+\lambda)} & =\frac{\Gamma(1-s+2 \lambda)}{\pi^{s-\lambda-1} \Gamma\left(\frac{1-s+\varepsilon+2 \lambda}{2}\right) \Gamma\left(\frac{1-s+\varepsilon}{2}\right)}=\pi^{1 / 2+\lambda-s} 2^{-s+2 \lambda} \frac{\Gamma\left(\frac{2-s-\varepsilon+2 \lambda}{2}\right)}{\Gamma\left(\frac{1-s+\varepsilon}{2}\right)} \\
& =\pi^{1 / 2+\lambda-s} 2^{-s+2 \lambda} \frac{\Gamma\left(\frac{2-s-\varepsilon+2 \lambda}{2}\right) \Gamma\left(\frac{1+s-\varepsilon}{2}\right)}{\Gamma\left(\frac{1-s+\varepsilon}{2}\right) \Gamma\left(\frac{1+s-\varepsilon}{2}\right)} \\
& =\pi^{-1 / 2+\lambda-s} 2^{-s+2 \lambda} \Gamma\left(\frac{2-s-\varepsilon+2 \lambda}{2}\right) \Gamma\left(\frac{1+s-\varepsilon}{2}\right) \sin \left(\pi\left(\frac{1-s+\varepsilon}{2}\right)\right)
\end{aligned}
$$

and

$$
\begin{aligned}
\frac{\Gamma(s)}{\gamma(s-\lambda)} & =\pi^{s-\lambda-1 / 2} 2^{s-1} \frac{\Gamma\left(\frac{s}{2}\right) \Gamma\left(\frac{s+1}{2}\right)}{\Gamma\left(\frac{s+\varepsilon}{2}\right) \Gamma\left(\frac{s+\varepsilon-2 \lambda}{2}\right)}=\pi^{s-\lambda-1 / 2} 2^{s-1} \frac{\Gamma\left(\frac{s+1-\varepsilon}{2}\right)}{\Gamma\left(\frac{s+\varepsilon-2 \lambda}{2}\right)} \\
& =\pi^{s-\lambda-1 / 2} 2^{s-1} \frac{\Gamma\left(\frac{s+1-\varepsilon}{2}\right) \Gamma\left(\frac{2-s-\varepsilon+2 \lambda}{2}\right)}{\Gamma\left(\frac{s+\varepsilon-2 \lambda}{2}\right) \Gamma\left(1-\frac{s+\varepsilon-2 \lambda}{2}\right)} \\
& =\pi^{s-\lambda-3 / 2} 2^{s-1} \Gamma\left(\frac{1+s-\varepsilon}{2}\right) \Gamma\left(\frac{2-s-\varepsilon+2 \lambda}{2}\right) \sin \left(\pi\left(\frac{s+\varepsilon-2 \lambda}{2}\right)\right) .
\end{aligned}
$$

Consequently

$$
\begin{align*}
\omega(\lambda)(2 \pi)^{2 s-1-2 \lambda} \frac{\Gamma(1-s+2 \lambda)}{\gamma(1-s+\lambda)} & -\frac{\Gamma(s)}{\gamma(s-\lambda)}=\frac{(2 \pi)^{s}}{2 \pi^{\lambda+3 / 2}} \Gamma\left(\frac{1+s-\varepsilon}{2}\right) \Gamma\left(\frac{2-s-\varepsilon+2 \lambda}{2}\right)  \tag{6.30}\\
& \times\left(\omega ( \lambda ) \operatorname { s i n } \left(\pi\left(\frac{1-s+\varepsilon}{2}\right)-\sin \left(\pi\left(\frac{s+\varepsilon-2 \lambda}{2}\right)\right)\right.\right.
\end{align*}
$$

and clearly

$$
\begin{aligned}
\omega(\lambda) \sin \left(\pi\left(\frac{1-s+\varepsilon}{2}\right)-\sin \left(\pi\left(\frac{s+\varepsilon-2 \lambda}{2}\right)\right.\right. & =\frac{1}{2 i}\left(-\omega_{F} e^{i \frac{\pi}{2}(2 \lambda-s+\varepsilon)}-\omega_{F} e^{i \frac{\pi}{2}(2 \lambda+s-\varepsilon)}\right. \\
& \left.-e^{i \frac{\pi}{2}(s+\varepsilon-2 \lambda)}+e^{-i \frac{\pi}{2}(s+\varepsilon-2 \lambda)}\right)
\end{aligned}
$$

Recalling that in this case $\omega_{F}=(-1)^{\varepsilon}$, see Proposition 5.1, we have

$$
-\omega_{F} e^{i \frac{\pi}{2}(2 \lambda-s+\varepsilon)}+e^{-i \frac{\pi}{2}(s+\varepsilon-2 \lambda)}=0
$$

and hence

$$
\begin{equation*}
\omega(\lambda) \sin \left(\pi\left(\frac{1-s+\varepsilon}{2}\right)-\sin \left(\pi\left(\frac{s+\varepsilon-2 \lambda}{2}\right)=i e^{i \frac{\pi}{2} s} e^{i \frac{\pi}{2} \varepsilon} \cos (\pi \lambda)\right.\right. \tag{6.31}
\end{equation*}
$$

Gathering (6.29),(6.30) and (6.31) we see that $P(i y)$ has the required form (6.3).
Finally, from (6.4) and Lemma 5.3 we have that $Q_{\eta}(z)$ is holomorphic for $-\delta<\arg (z)<\pi+\delta$ with some $\delta>0$, hence the same holds for $\psi(z)$ by (6.28). But, as in the proof of Proposition 6.1, from the 1-periodicity of $f(z)$ we deduce that $\psi(z)$ satisfies the three-term functional equation (6.22), thus the argument at the end of the proof of Proposition 6.1 shows that $\psi(z)$ is holomorphic for $|\arg (z)|<\pi$ also in this case. Proposition 6.2 follows now from (6.28).

Remark 6.1. The computations in the proof of Proposition 6.2 are similar to those in Lewis-Zagier [19], pages 204-205. Apparently there are some slight differences, unimportant in our case, in the final formulae. The function $\psi(z)$ in (6.6) is a period function in the sense of Lewis-Zagier [19]. The fact that $\psi(z)$ in (6.28) is holomorphic for $|\arg (z)|<\pi$ follows from the results in Section 4 of Chapter 3 of [19]; the above argument gives an independent direct proof, which works also for certain functional equations more general than (6.22).

## 7. Conclusion of the proof

Now we are ready to conclude the proof of Theorem 1.1. Our aim is to show that the function $R(s)$ in Corollary 5.1 is identically equal to $\eta$. Indeed, if this is the case then $S_{F}(s)=\eta S_{\gamma}(s)$, hence Corollary 5.1 implies that $F$ satisfies the functions equation

$$
\gamma(s) F(s)=\omega \gamma(1-s) F(1-s) \quad \text { with } \quad \omega=\omega_{F} \eta
$$

We are therefore in the situation of Lemma 5.1. More precisely, by (5.2) and Proposition 5.1, if $\chi_{F}>0$ then case (i) of Lemma 5.1 holds, otherwise we are in case (ii). Moreover, if $\chi_{F}=0$ then $\kappa=0$ and hence by Satz 2 of Maass [20] we have that $F(s)=\zeta(s)^{2}$. Theorem 1.1 thus follows. Note that computing the invariant $\omega_{F}$ by means of (2.3), starting with the above $\gamma$-factor and $\omega$-datum, we obtain that $\omega_{F}=\omega_{F} \eta$, thus $\eta=1$ in all cases.

Suppose, by contradiction, that $R(s) \not \equiv \eta$. Let

$$
\begin{equation*}
G(z, s)=\Gamma(s) \frac{\gamma(1-s+\lambda)}{\gamma(s-\lambda)} F(1-s+\lambda)(-2 \pi i z)^{-s} \tag{7.1}
\end{equation*}
$$

Thanks to Lemma $5.4,(5.18)$ and (5.19), we rewrite the function $Q_{\eta}(z)$ in (6.4) as

$$
\begin{align*}
Q_{\eta}(z) & =\frac{1}{2 \pi i}\left(\int_{c_{1}-i \infty}^{c_{1}}+\int_{c_{1}}^{c_{1}+i \infty}\right)(R(s-\lambda)-\eta) G(z, s) \mathrm{d} s=Q_{\eta}^{-}(z)+Q_{\eta}^{+}(z) \\
& =Q_{\eta}^{+}(z)+\sum_{j=0}^{N-2} \frac{a_{j}}{2 \pi i} \int_{c_{1}-i \infty}^{c_{1}} \frac{e^{i \pi \omega_{j}(s-\lambda)}}{S_{\gamma}(s-\lambda)} G(z, s) \mathrm{d} s  \tag{7.2}\\
& +\frac{a_{N-1}}{2 \pi i} \int_{c_{1}-i \infty}^{c_{1}} \frac{e^{i \pi \omega_{N-1}(s-\lambda)}}{S_{\gamma}(s-\lambda)} G(z, s) \mathrm{d} s+\frac{1}{2 \pi i} \int_{c_{1}-i \infty}^{c_{1}}\left(\frac{a_{N} e^{i \pi(s-\lambda)}}{S_{\gamma}(s-\lambda)}-\eta\right) G(z, s) \mathrm{d} s \\
& =Q_{\eta}^{+}(z)+A(z)+B(z)+C(z),
\end{align*}
$$

say. In view of Lemma 5.3 , as $|t| \rightarrow \infty$ the integrand in $Q_{\eta}^{+}(z)$ is certainly

$$
\ll(|t|+1)^{c} e^{(\arg (z)-\pi)|t|}
$$

for some $c>0$ and hence

$$
\begin{equation*}
Q_{\eta}^{+}(z) \text { is holomorphic for }|\arg (z)|<\pi . \tag{7.3}
\end{equation*}
$$

Recalling (5.21), for $0 \leq j \leq N-2$ and $t \rightarrow-\infty$ we have

$$
\frac{e^{i \pi \omega_{j}(s-\lambda)}}{S_{\gamma}(s-\lambda)} G(z, s) \ll(|t|+1)^{c} e^{-|t|\left(\arg (z)+\pi\left(1-\omega_{j}\right)\right)}
$$

for some $c>0$, hence by (5.19)

$$
\begin{equation*}
A(z) \text { is holomorphic for }-\pi \min \left(1-\omega_{N-2}, 1\right)<\arg (z)<\pi \text {. } \tag{7.4}
\end{equation*}
$$

Moreover, recalling the value of $\eta$ in Lemma 5.3 and equations (5.15),(5.16),(5.17) and (5.20), we observe that the main terms of $a_{N} e^{i \pi(s-\lambda)}-\eta S_{\gamma}(s-\lambda)$ cancel, hence as $t \rightarrow-\infty$

$$
\frac{a_{N} e^{i \pi(s-\lambda)}}{S_{\gamma}(s-\lambda)}-\eta \ll e^{-\pi|t|}
$$

Thus a computation as above shows that

$$
\begin{equation*}
C(z) \text { is holomorphic for }|\arg (z)|<\pi \tag{7.5}
\end{equation*}
$$

Finally, to treat $B(z)$ we observe from (5.21) and (5.25) that as $t \rightarrow-\infty$

$$
\frac{1}{S_{\gamma}(s-\lambda)}=\rho_{1} e^{-i \pi s}+O\left(e^{-2 \pi|t|}\right)
$$

with a constant $\rho_{1} \in \mathbb{C} \backslash\{0\}$, hence

$$
\begin{equation*}
B(z)=\frac{\rho_{2}}{2 \pi i} \int_{c_{1}-i \infty}^{c_{1}} e^{i \pi s\left(\omega_{N-1}-1\right)} G(z, s) \mathrm{d} s+D(z) \tag{7.6}
\end{equation*}
$$

with a constant $\rho_{2} \in \mathbb{C} \backslash\{0\}$ and a function $D(z)$ holomorphic for $|\arg (z)|<\pi$. But as $t \rightarrow+\infty$ the integrand in (7.6) is

$$
\ll(|t|+1)^{c} e^{-|t|\left(\pi \omega_{N-1}-\arg (z)\right)}
$$

for some $c>0$. Thus, recalling from Lemma 5.4 that $\omega_{N-1}>0$, we have that

$$
\begin{equation*}
\frac{\rho_{2}}{2 \pi i} \int_{c_{1}}^{c_{1}+i \infty} e^{i \pi s\left(\omega_{N-1}-1\right)} G(z, s) \mathrm{d} s \quad \text { is holomorphic for }-\pi<\arg (z)<\pi \omega_{N-1} \tag{7.7}
\end{equation*}
$$

Therefore, gathering (7.1)-(7.7), from Propositions 6.1 and 6.2 we deduce that the integral

$$
\begin{equation*}
I(z)=\frac{1}{2 \pi i} \int_{\left(c_{1}\right)} \Gamma(s) \frac{\gamma(1-s+\lambda)}{\gamma(s-\lambda)} F(1-s+\lambda)\left(-2 \pi i e^{i \pi\left(1-\omega_{N-1}\right)} z\right)^{-s} \mathrm{~d} s \tag{7.8}
\end{equation*}
$$

represents a holomorphic function for $-\pi \min \left(1-\omega_{N-2}, 1\right)<\arg (z)<\pi \omega_{N-1}$.
Thanks to (5.7), Proposition 5.1, (2.10),(2.1) and Lemma 4.1, recalling that $\gamma_{F}(s)$ denotes the $\gamma$-factor of $F$ we have

$$
\begin{aligned}
\frac{\gamma(1-s+\lambda)}{\gamma(s-\lambda)} & =\frac{\gamma_{F}(1-s+\lambda)}{\gamma_{F}(s-\lambda)} \frac{S_{\gamma}(s-\lambda)}{S_{F}(s-\lambda)} \\
& =\eta^{-1} \frac{\gamma_{F}(1-s+\lambda)}{\gamma_{F}(s-\lambda)}+\frac{\gamma_{F}(1-s+\lambda)}{\gamma_{F}(s-\lambda)}\left(\frac{S_{\gamma}(s-\lambda)}{S_{F}(s-\lambda)}-\eta^{-1}\right) \\
& =\eta^{-1} \frac{\gamma_{F}(1-s+\lambda)}{\gamma_{F}(s-\lambda)}+O\left(e^{-\delta|t|}\right)
\end{aligned}
$$

with some $\delta>0$ by Lemma 5.3. Therefore, replacing $\frac{\gamma(1-s+\lambda)}{\gamma(s-\lambda)}$ by $\eta^{-1 \frac{\gamma_{F}(1-s+\lambda)}{\gamma_{F}(s-\lambda)}}$ in (7.8) adds an extra term which is holomorphic at least for $-\pi \min \left(1-\omega_{N-1}+\delta, 1\right)<\arg (z)<\pi \omega_{N-1}$. Thus, writing

$$
w=w(z):=-i e^{i \pi\left(1-\omega_{N-1}\right)} z
$$

the integral

$$
J(z)=\frac{1}{2 \pi i} \int_{\left(c_{1}\right)} \Gamma(s) \frac{\gamma_{F}(1-s+\lambda)}{\gamma_{F}(s-\lambda)} F(1-s+\lambda)(2 \pi w)^{-s} \mathrm{~d} s
$$

represents a holomorphic function for

$$
\begin{equation*}
-\pi \min \left(1-\omega_{N-2}, 1-\omega_{N-1}+\delta, 1\right)<\arg (z)<\pi \omega_{N-1} \tag{7.9}
\end{equation*}
$$

But by (2.1)

$$
J(z)=\frac{\omega_{F}}{2 \pi i} \int_{\left(c_{1}\right)} \Gamma(s) F(s-\lambda)(2 \pi w)^{-s} \mathrm{~d} s
$$

Therefore, recalling the choice of $c_{1}$ in (6.2) and shifting the integration line to $\sigma=c>1+\Re(\lambda)$, by Mellin's transform we get

$$
\begin{align*}
J(z) & =\frac{\omega_{F}}{2 \pi i} \int_{(c)} \Gamma(s) F(s-\lambda)(2 \pi w)^{-s} \mathrm{~d} s-\omega_{F} \mathrm{res}_{s=1+\lambda} \Gamma(s) F(s-\lambda)(2 \pi w)^{-s}  \tag{7.10}\\
& =\omega_{F} f\left(e^{i \pi\left(1-\omega_{N-1}\right)} z\right)-\omega_{F} \mathrm{res}_{s=1+\lambda} \Gamma(s) F(s-\lambda)(2 \pi w)^{-s}
\end{align*}
$$

Thus $f\left(e^{i \pi\left(1-\omega_{N-1}\right)} z\right)$ is holomorphic in the region (7.9), hence changing variable we get that $f(z)$ is holomorphic for $-\pi \min \left(\omega_{N-1}-\omega_{N-2}, \delta, \omega_{N-1}\right)<\arg (z)<\pi$. Recalling that $\omega_{N-1}>0$, see Lemma 5.4, this means that $f(z)$ is holomorphic for $-\delta_{0}<\arg (z)<\pi$ for some $\delta_{0}>0$. But $f(z)$ is 1-periodic, hence it is entire, a contradiction by Lemma 6.1. Theorem 1.1 is now proved.
