1. RECENTLY WERNER THEODOR GOETTISCH, BORN ^{DPOB:} 23 OCTOBER ^{CIT: WGERMANY}
^{GERMANY} 1912, ^{AUGERMANY} IN KIEL, RESIDING ^{CONSULATE} KIEL, ALTE LUBECKER CHAUSSEE 28, MEMBER
OF THE RAIFFEISEN VERBAND IN KIEL (STATISTICAL DEPARTMENT),
APPROACHED AN OFFICER OF THE LOCAL ^{CONSULATE} LMPURE WITH THE FOLLOWING
STORY. GOETTISCH (SUBJECT) WAS A MEMBER OF THE SCHELLENBERG
GROUP DURING WORLD WAR II, HAD CONTACT TO DR. ^{WILLI (?)} HOETTL AND
THROUGH HIM TO DULLES IN SWITZERLAND. ALSO HAD MANY OTHER
BWEHR AND RSHA CONTACTS, A NUMBER OF WHOM ARE ALLEGEDLY NOW
INVOLVED IN ONE WAY OR ANOTHER IN NPD ACTIVITIES. SUBJECT,
DESPITE HIS NAZI PAST, STATES HE BELIEVES NPD COMPLETELY
WRONG AND HE IS CONVINCED THAT IT POSES A THREAT TO GERMAN
DEMOCRACY. SUBJECT IS PRO-AMERICAN, DATING FROM HIS EXCELLENT
TREATMENT WHILE AN AMERICAN POW AT THE END OF THE WAR. STATES
WAS INTERROGATED FOR MORE THAN FOUR MONTHS IN WIESBADEN AT
WAR'S END, AND HE STILL GRATEFUL FOR TREATMENT AT THAT TIME
AND ESPECIALLY FOR THE FACT THAT AMERICANS DID NOT TURN HIM
OVER TO RUSSIANS FROM WHOM HE COULD HAVE EXPECTED DIRE THINGS.

2. SUBJECT STATES HE WAS RECENTLY APPROACHED AND ASKED TO JOIN THE NPD IN A FAIRLY HIGH POSITION. HE STATES HAS BEEN ASKED TO JOIN THIS AND SIMILAR GROUPS IN PAST BUT HAS NO DESIRE DO SO. STATED, HOWEVER, HE NOW SUFFICIENTLY CONVINCED OF THE POTENTIAL DANGER OF THE NPD THAT HE WILLING DIN SOLELY FOR THE PURPOSE OF REPORTING TO THE AMERICANS ON THE INTERNAL AFFAIRS OF THE NPD. IF AMERICANS DO NOT WANT HIM TO JOIN NPD AS A PENETRATION, HE WILL REFUSE.

AMONG OTHER THINGS, SUBJECT ALLEGES SOME CONTACT BETWEEN NPD AND OTTO SKORZENY IN SPAIN.

3. BELIEVE HQ HAS FILE ON SUBJECT WHICH GIVES HIS BACKGROUND IN CONSIDERABLY MORE DETAIL THAN PRESENTED ABOVE. REGRET ABOVE VERY SKETCHY, BUT RECEIVED SECOND-HAND VIA IMPURE OFFICER.

4. IF THERE IS ANY INTEREST OR REQUIREMENT FOR WOFAC T PENETRATION OF THE NPD, SUGGEST SUBJECT MIGHT BE GOOD CANDIDATE. IF THERE NO INTEREST IN WOFAC T PENETRATION OF NPD AS SUCH, WE CAN ATTEMPT TO PLACE SUBJECT IN CONTACT WITH LFV SCHLESWIG-HOLSTEIN.

5. IT SHOULD PERHAPS BE NOTED THAT OUR ABILITY TO RUN SUBJECT, OR ANY OTHER, UNILATERAL PENETRATION FOR A LONGER PERIOD OF TIME UNDETECTED BY THE LOCAL SERVICES IS PROBABLY NOT TOO GOOD, SINCE THEY APPEAR TO HAVE THE NPD WELL COVERED. HOWEVER, SHOULD WE DECIDE TO ATTEMPT TO RUN A UNILATERAL PENETRATION AND THIS SHOULD BE UNCOVERED BY THE LOCAL SERVICE, THE EMBARRASSMENT POTENTIAL WOULD APPEAR TO BE SLIGHT, PROVIDED, OF COURSE, THAT OUR RELATIONSHIP REMAINS ESSENTIALLY AS IT IS TODAY.

6. WE WOULD APPRECIATE COS, GERMANY AND/OR HQS COMMENT ON WHETHER THIS MATTER APPEARS TO WARRANT A UNILATERAL
