INTRODUCTION

This publication presents international merchandise trade statistics up to the March quarter of 2017. It follows on from Statistical Bulletin 5/2017.

This publication follows the United Nations definitions and compilation practice of merchandise trade statistics. Technical notes relating to data sources, classification of commodities, valuation, timing of recording and other technical issues can be obtained from the National Statistics Office on request.

The primary data source used in compiling merchandise trade statistics is the Solomon Islands Customs and Excise Division's import and export entries. Other secondary data sources used include the Central Bank of Solomon Islands' balance of payments data (BOP), administrative records from the Commodity Export Marketing Authority (CEMA) and import/export records furnished by major importers and exporters.

Major data limitations highlighted in previous bulletins are again noted as follows:

1. Data from Customs and Excise Division is in unedited format and validated only at the aggregate level. Statistics on the volume of trade cannot be compiled adequately given the poor quality of the volume data.
2. Data from Customs and Excise Division represents mainly trade through the Honiara port and to a lesser extent data from other outer island ports.
3. Data from 1998-2000 and the first two quarters of 2009 are unavailable or incomplete for the purpose of a time series covering these periods.
4. Data on illegal trading of goods, which may include significant quantities, is not captured in this publication.
5. A number of other secondary data sources are used to adjust for discrepancies in the data from Customs and Excise Division
6. Data from third quarter 2015 and onward are extracted from the newly introduced ASYCUDA system which is now adopted by the Solomon Islands Customs and Excise Division.
7. Data on major commodities such as fish, copra, cocoa, palm oil, rice, fuel and tobacco are sourced from the industries while the remaining commodities are sourced from the ASYCUDA system.

Small discrepancies between totals and sums of commodities in tables are due to rounding.

- Negative change if representing a percentage change
- + Positive change if representing a percentage change
- p Preliminary or provisional figure, subject to revision
- e Estimated
- r Revised
- n/a Not available or not applicable.





HIGHLIGHTS

The international merchandise trade balance recorded in the March quarter of 2017 shows a surplus of \$57.5m. This is an increase of \$109.4m (211%) over the deficit of \$51.9m recorded in the preceding quarter. In terms of the corresponding quarter a year ago, this represented an increase of \$21.1m (58%) over the surplus of \$36.4m in 2016.



The year-ended March 2017 recorded a deficit of \$119.9m, a reduction of \$110.1m (48%) compared to the deficit of \$230.0m recorded in the year ended March 2016.



Merchandise trade by major commodity in the first quarter of 2017 compared to the corresponding quarter of 2016 recorded the following:

Major Exports

- Round log and sawn timber exports declined by \$7.4m (1%) to \$604.7m.
- Total of fresh/frozen and canned fish rose by \$33.8m (62%) to \$88.7m. This increase is mainly attributed to \$52.1m of fish loin exports to Italy which accounted for 59% of total fish exports.
- Total of copra, cocoa, palm oil and other agricultural products has increased by \$40.8m (56%) to \$113.9m. This is mainly driven by a surge in palm oil and copra exports during the quarter.
- Gold increased by \$3.0m (63%) to \$7.8m.

Major Imports

- Food imports, which is comprised mostly of rice and canned meat, increased by \$0.7m (0.6%) to \$111.9m.
- Mineral fuel and lubricant imports rose by \$58.2m (55%) to \$164.9m.
- Machinery and transport equipment increased by \$33.6m (15%) to \$260.3m.

Merchandise trade balance with major trading partners in the March quarter of 2017 compared to the previous corresponding quarter records the following:

- The trade deficit with Singapore, the main source of fuel imports, increased by \$63.0m (57%) to \$174.5m.
- The trade deficit with Australia decreased by \$16.8m (11%) to \$132.2m.
- The trade deficit with Papua New Guinea was down by \$14.3m (58%) to \$10.4m.
- The trade surplus with South Korea declined by \$9.7m (86%) to \$1.5m.
- The trade surplus with China, the main destination of exported logs, rose by \$63.1m (15%) to \$491.6m.
- The trade surplus with Italy, the main destination of fish-loin exports, increased by \$13.2m (35%) to \$51.0m.


