The following note accompanies Part 2, Lines 37 and 38:

Many of the book tour and speaking engagements listed in Part 2 were ticketed events, and one of the ticket levels available was a "VIP Experience" level, which included preferential seating and a reception. An entity known as CAA Premium Experience sold that level of tickets and handled the logistics associated with the seating and the reception. A percentage of the revenue from the sale of these tickets was paid by CAA Premium to CelticCapri Corp., annually. Line 37 reflects income from the 2018 tickets; Line 38 reflects income from the 2017 tickets.
