Whereas, this authority had imposed restrictions on the Mashel Mahila Co-operative Credit Society Ltd., Deulwada, Marcel-Goa under Section 69 of the Goa Co-operative Societies Act, 2001 vide order read at Sr. No. 1 above.

And whereas, the society has vide letter read at Sr. No. 2 above represented and sought certain modifications to the restrictions.

After considering the request to overcome the difficulties that may arise due to inadequate liquidity, the directions are partly modified as under:-

- 1. The society is permitted to accept deposits upto Rs. 10,000/- per person per month.
- 2. The withdrawals shall be restricted upto Rs. 10,000/- per person per month.

All the other directions in the order at Sr. No. 1 above remains unaltered.

Whereas, the VPK Urban Co-operative Credit Society Ltd., Mardol, Ponda-Goa was registered on 30-03-1993 under registration No. ARCS/CZ/ /credit-8(a)/75.

And whereas, an inquiry dated 10-05-2017 referred to at Sr. No. 2 above was initiated in the affairs of society and based on said inquiry, a misfeasance report dated 2-08-2018 referred at Sr. No. 3 above was filed.

And whereas, the inquiry and the misfeasance report has revealed serious irregularities in the affairs of the society which are elaborated here below:

- 1. As per bye-laws No. 34(c) of the society, the loan sanctioning limit is fixed at ₹25.00 lakhs, whereas the society has sanctioned loan upto ₹ 60.00 lakhs to an individual by violating the provisions of above mentioned bye-law. The total sanction amount over and above ₹ 25.00 lakhs is works out at ₹ 71.50 crores.
- 2. Land admeasuring 7000 sq. mtr. is purchased at Mangeshi without having such objectives in its bye-laws. The said land was purchased

- at the total cost of \ref{total} 3.50 crores without obtaining prior permission from the Registrar of Co-operative Societies as required under the guidelines issued.
- 3. During the period from 8-06-2012 to 26-05-2016, 18 branches have been opened at various places by violating the requirements of circular dated 3-01-2011 issued by the Registrar of Co-operative Societies and has further incurred heavy expenditure of ₹ 34.85 lakhs towards inaugural function of the said branches.
- 4. During the period from 1-04-2012 to 31-03-2017, board of directors taking undue advantage of bye-laws No. 28(5) which empowers the board to consider cases of arrears and default of loan, has settled altogether 518 loan case under OTS scheme by giving huge benefits in the form of rebate amounting to ₹ 3.95 crores to the defaulted loanee members. These rebate was given on the strength of resolution passed in the Annual General Body Meeting held on 5-11-2006 under item No. 9 "any other subject with the permission of Chair" which was implemented during the period 2012-2017 with ulterior motive against the provisions of Rule 40 of the Goa Co-operative Societies Rules, 2003 with an intention to give benefit to particular choice of members thereby misappropriated funds of the society to that extent.

The Asstt. Registrar of Co-operative Societies, Ponda Zone, Ponda-Goa had entrusted the inspection of the aforesaid society to Shri Raju R. Magdum, Special Auditor of Ponda Zone. Accordingly, the Inspecting Officer submitted his report dated 05-12-2019 wherein he has pointed out following irregularities in the functioning of the society.

- The society has not adopted proper procedure while sanctioning loans to its members i.e. ascertaining of repayment capacity of loanee members, obtaining collateral securities etc. Pre-sanction verification/post sanction inspection of loans is not done, whereas credit appraisal was not also found adequate.
- 2. The number of defaulters as on 30-09-2019 were 7139 accounts who have failed to repay the dues to the society with overdue amount to the extent of ₹ 120,90,72,315/- and its percentage to loan outstanding works out to 19.32% as against the prescribed norms of 10% which is a matter of serious concern.

- 3. The interest receivable on advances has increased from ₹ 98,53,48,454/- as on 31-03-2019 to ₹ 123.65 crores as on 30-09-2019. No efforts are made to realize the interest receivable which is more than 25% over and above the previous year figure. There has been a drastic rise in NPA as interest is not received within the stipulated period.
- 4. During the period under audit as on 31-03-2019, the society had sustained loss of ₹ 8.73 crores whereas the society has incurred loss to the extend to ₹ 3.97 crores during the period under inspection. Thus accumulated loss of the society has increased to ₹ 12.71 crores which is increased by 45.58% as on 30-09-2019.
- 5. The society has defaulted in maintaining the resource and utilization as per the prescribed norms. The percentage of Share Capital maintained by society is 4% to that of required percentage of 5%. Further, Reserve & Surplus 3.03% against the requirement of 6%, Deposits & Borrowings 84.27% against the requirement of 84%, Other Liabilities 10.36% to that of 1%. The fund utilization is 1.16% of Cash at Bank as against of 5% prescribed. Similarly in respect of Investment 33.97% to that of 20%, Loans & Advances 58.08% to that of 70%, Fixed Assets 3.32% to that of 3% and Other Assets 3.47% to that of 2%.

And whereas, from the above financial parameters, it transpires that the society has collected excess deposits 84.27% to that of 84% then the prescribed norms and has advanced only 58.08% to that of 70% as per the standard norms which indicates that there is no prudent financial management.

As per the irregularities as pointed out by the Inquiry Officer and Inspecting Official, it appears that the management of the society has failed to perform their duties and functions as laid down under Act, Rules and bye-laws of the society. It appears from above that the financial affairs of the society are not being managed professionally and as per the requirements of the Goa Co-operative Societies Act and Rules.

Therefore, in view of the inquiry, inspection and other relevant reports/documents relied hereinbefore and upon the report received from the Registrar of Co-operative Societies, the Government is satisfied that in the interest of co-operative movement, to secure proper management of business of the society generally

and for preventing the affairs of the society being conducted in a manner detrimental to the interest of the members or of the depositors or the creditors thereof, it is felt necessary to issue certain directions and to impose certain restrictions on the society in larger interest of the society, shareholders and the depositors. Therefore in exercise of the powers vested under Section 68 of the Goa Co-operative Societies Act, 2001, the Government hereby gives following directions to the VPK Urban Co-operative Credit Society Ltd., Mardol, Ponda-Goa for an initial period of 6 (six) months.

- The society is barred from accepting any fresh deposits including pigmy collections except when such pigmy collections are adjusted towards recovery of loans.
- 2. The society's powers to sanction the loans/ /advances is restricted upto ₹ 5.00 lakhs in each case/per person/firm.
- 3. The sitting fees of the board of directors shall be restricted to ₹ 100/- per sitting with maximum sitting fees per month per director shall not be in excess of ₹ 500/- for all the sittings combined in a month.
- 4. Travelling Allowance if any shall be restricted upto 3 meetings in a month.
- 5. The society shall obtain prior permission from the Registrar of Co-operative Societies for any capital expenditure exceeding ₹ 50,000/-.
- The society is barred from carrying out any recruitment including to fill up vacant posts without prior permission of the Registrar of Co-operative Societies in case of exigencies.
- 7. The society is barred from opening new branches and carrying out any renovation work involving expenditure exceeding ₹ 50,000/- without prior permission of the Registrar.
- No major policy decision involving financial implications shall be undertaken without permission of the Registrar of Co-operative Societies.
- 9. The society has incurred ₹ 12.71 crores accumulated losses as on 30-09-2019 and the business of the society is likely to be seriously affected further due to impact of the COVID-19 pandemic. Therefore due to this exigencies, the staff salaries across the board shall be frozen at the present levels as on 1st June, 2020.

10. To overcome the issue of liquidity, the withdrawal of deposits during the period of restrictions shall be limited to ₹ 20,000/- per month per depositor.

These directions are interim and to confirm continuation of the directions for further period, the management of the society is given an opportunity of hearing before the Registrar of Co-operative Societies on 16-06-2020 at 3.30 p.m.

In case of default of your appearance on the above mentioned date and time, the matter will be heard and determined in your absence.

The Asstt. Registrars of Co-op. Societies, Ponda Zone, Ponda-Goa shall take review of the progress of overall functioning of the society every fortnight and submit a detailed report to the Head Office.

The above directions shall be strictly complied and any deviation and non compliance will be liable for strict action as per law.
