## GO-TO-SCHOOLS

How bad was it in 2009? *The National Law Journal*'s annual Go-To Law School List paints a pretty sorry picture of first-year associate employment at the nation's 250 largest law firms last year. The No. 1 law school sent just 55.9% of its 2009 graduates to NLJ 250 law firms. In 2008, the highest percentage of graduates heading to NLJ 250 firms was 70.5%. Importantly, the 2009 percentages include deferred associates, so an even smaller group actually went to work last year. Remember, the list consists of the very top performing schools, where job prospects in years past have proven recession-proof. Not so in 2009.

We've ranked the top 50 law schools by the percentage of 2009 juris doctor graduates who snagged jobs at NLJ 250 firms by Sept. 30, 2009. Numbers are based on information gathered from our annual NLJ 250 survey—statistics we get from the nation's largest law firms. We've also identified firm favorites—the schools from which the top law firms on the NLJ 250 recruited most of its first-years in 2009. —*Leigh Jones*

Columbia was the No. 1 go-to law school in 2008 and in 2007.

Vanderbilt was the only school to send a greater percentage of its graduating class in 2009 to NLJ 250 firms compared with 2008, when it sent 44.6% to NLJ 250 schools.

No. 1 ranked Northwestern jumped from No. 5 on the Go-To Law School List last year. It sent 62.9% of its 2008 grads to NLJ 250 firms.

Stanford climbed to the No. 3 spot from No. 11 last year. The reason? Consistency, in spite of the recession. In 2008, its graduating class had 176 students, 99 of whom went to NLJ 250 firms. Those numbers are very close to Class of 2009 results.

Georgetown had the highest number of 2009 graduates—289—hired by NLJ 250 firms. It also had the largest graduating class.

About 30% of graduates at Yale, Stanford and Harvard, combined, head to judicial clerkships right after graduation, according to *U.S. News & World Report*.

The average percentage of graduating classes from the top 50 schools hired by NLJ 250 firms was 30.3%. The total number of 2009 graduates hired by NLJ 250 firms from all law schools was 4,555. Law schools accredited by the American Bar Association awarded 43,588 law degrees in the 2008-2009 academic year.
