SUBJECT: Consider recommending approval to dispose of seventeen (17) revenue vehicles, three (3) non-revenue vehicles, and two (2) shop equipment.

RECOMMENDED ACTION: Briefing Item Recommended Motion

Recommend Approval to Dispose of Vehicles and Equipment via Sale, or by Means Most Advantageous to the District.

Budgetary/Fiscal Impact:

It is anticipated that, depending on what method the District selects to dispose of the buses above, this should result in a reimbursement of \$650 to \$3,500 per bus, based on the market at the time of sale. Sale of non-revenue vehicles should be in the \$500 - \$2,500 range per unit.

Background/Discussion:

The vehicles and equipment in the attached document have surpassed their useful life expectancy and are fully depreciated. Concessions to the applicable FTA funding source are not required from the District because of the equipments diminished return. Costs to repair these vehicles and equipment outweigh their value and are recommended for disposal in accordance with methods outlined in Board Policy 356.

GM 11-186 Consider Disposal of Two (2) El Dorado, Six (6) New Flyer, Four (4) Gillig, Sixteen (16) NABI, Four (4) "Heritage" Buses, and Five (5) Non Revenue Vehicles.
