1. Enter name of political committee making the independent expenditure.
2. Place committee identification number in the box marked POLITICAL COMMITTEE IDENTIFICATION NO..
3. Enter the name and mailing address of the vendor to which the expenditure was made.
4. Enter the date of the expenditure.
5. Enter the amount of the expenditure.
6. Enter the purpose of the expenditure.
7. Indicate if the expenditure was in support of or opposition to a particular candidate.
8. Enter the candidate's name.
9. Enter the office the candidate is seeking.
10. Enter the district the candidate is seeking.
11. Committee treasurer or candidate that is making this independent expenditure must **sign and date this report.**
