COVID-19

The attention of parties and practitioners is drawn to a new practice direction SC 21 (https://beta.courts.ie/content/conduct-proceedings-supreme-court-covid-19) which is intended to apply during the continuance of any special measures or guidance adopted by the government to deal with the COVID-19 pandemic.

The new Practice Direction facilitates the continuing work of the Court and, in particular, provides guidance concerning the conduct of remote case management and appeal hearings. Practitioners should familiarise themselves with the detail of its provisions and with other guidance when issued under its provisions. The Court is considering both how to identify and deal with urgent cases so as to avoid physical hearings if possible. If it is considered that an adjourned case is urgent the Court will consider granting it priority. Parties who contend such urgency should set out their reasons in writing by email addressed to the Registrar at supremecourt@courts.ie.

The default position until further notice is that all written judgments of the Court will be delivered by means of a copy of the judgment being sent electronically to the parties and being posted as soon as possible on the Courts Service website. The date and time of delivery to the parties will be notified in the Legal Diary.

The Supreme Court fully acknowledges that the family, friends and colleagues of newly appointed judges will wish to participate in the ceremony whereby the judge concerned makes the declaration required of them by the Constitution before entering onto their duties. However, in the current circumstances, the space available in the Supreme courtroom is very limited. The Chief Justice has invited a small number of persons to attend because of their very close connection to Ms. Justice Stack. Those persons will use up all of the spaces which have been assessed as being capable of being safely accommodated. For those reasons the Supreme Court would ask that other persons not attend the declaration ceremony. In that context it might be noted that it is the intention of the Chief Justice, when the current level of restriction has been relaxed, to organise ceremonies of welcome in respect of all of those judges who made their declaration under these limitations.

Ms. Siobhan Stack SC will make the Declaration required by the Constitution of a judge of the High Court, in the presence of the Chief Justice, in the Supreme Court at 10.30 o'clock on Friday, 26th March.

A "hybrid" hearing is where one of the parties to the appeal attends in the precincts of the courtroom to make legal submissions while the Court and the other parties to the appeal participate remotely. Parties should lodge the agreed books of appeal (including the books of authorities) in hardcopy (x 3) and also in soft copy via the ShareFile platform.

Pending such revision parties are asked to lodge agreed books of authorities with the books of appeal or no later than one week before the date fixed for the hearing of the appeal.

24 hours in advance of the hearing.
